

WILSON'S NAME IS OFFERED

COALITION LIBERALS AND CONSERVATIVES HAVE AN AGREEMENT

WILL NOT OPPOSE ONE ANOTHER'S CANDIDATES IN SOME DISTRICTS.

REPORTED ARRANGEMENT IS GIVEN PROMINENCE

Said to Indicate Great Britain Being Shepherded Back to Its Old Policy.

LONDON, Oct. 28.—Arrangements between conservatives and coalition liberals not to oppose one another's candidates in certain constituencies are given prominence in yesterday's anti-coalition newspapers. As they have it the arrangements for the mutual non-opposition are spreading with an obvious drift toward reinstating coalition in the government.

It is the contention of free liberals that this situation reveals that the country is being shepherded back to its old policy, the only difference being that it is in new hands. On the other side the extreme die-hard are clearly restive over this supposed tendency.

The central conservative executive committee, hoping to stem the growing dissatisfaction among the extreme elements of the party, issued a statement denying any pact existed between them and the coalition liberals.

Publication of the full list of candidates reveals that Lord Birkenhead, who is known in New York as the son of Edmund Burke Roche, and the grandson of Frank Work, from whom he inherited a large fortune, is the anti-coalition candidate for London.

Gwyn Lloyd-George, son of the former premier, is liberal candidate from the district of Pembroke, Wales.

H. G. Wells, the author, is running on the labor ticket for the university of London.

Two communists are running in Scotland—William Gallacher, opposing Winston Spencer Churchill in the Dundee district, and Mrs. Helen Crawford of Glasgow.

There are 35 women candidates for the House of Commons. Margaret Wintourham, the two women members of the last house of commons.

GOVERNMENT ISSUES GENERAL REPORT ON VOLUME 1922 CROP

WASHINGTON, Oct. 28.—Production of rye, barley and potatoes for all countries reporting is larger than for the same countries last year. The potato crop in the United States is reported to be 100 per cent of production for the same countries in 1921, but only 81 per cent of the average yield for 1922.

Production in the United States and Canada is 153 per cent of the 1921 crop, while in the European countries it is 103 per cent.

The potato crop is reported larger in nearly all countries, total production being placed at 123 per cent of that for the same countries in 1921, and 101 per cent of the 1922 average.

Wheat production in 1922, according to latest estimates, is 99 per cent of the 1921 yield, being 109 per cent in North America and 81 per cent in Europe.

The area planted to cotton up to about October 1 in India, which is usually about 83 per cent of the total area, is 77,412,000 acres. This is 98 per cent of the area of the corresponding date last year but only 84 per cent of the average area at the corresponding date for the five years 1916-21.

JUDGE RAMSEY DIES AT HOME IN DALLAS; FUNERAL ON SUNDAY

STRICKEN WITH INDIGESTION AT HOME ABOUT A WEEK AGO.

CHAIRMAN OF DALLAS FEDERAL RESERVE BANK

Death Marks Passing of One of Country's Leading Bankers and Jurists.

DALLAS, Oct. 28.—Death here last night of Judge William F. Ramsey, 67 years old, marked the passing of one of the most prominent bankers and jurists of the south. He was stricken with indigestion at his home here a week ago and his condition gradually became worse. Ramsey was born in Bell county, Texas.

Funeral services will be held at the family home in Oak Cliff Sunday morning at 10 o'clock. The body will be sent to Cleburne, Texas, for burial.

At the time of his death Mr. Ramsey was chairman of the board of the Dallas federal reserve bank, as well as federal reserve agent for the district comprising which he had held since 1915. Prior to that time he practiced law at Austin.

Mr. Ramsey had the distinction of having served as a member of the court of criminal appeals and the state supreme court. He was for several years president of the Cleburne National bank.

He is survived by his widow and five children.

One of the truly big men of Texas, whether it be as lawyer, politician, banker or jurist, was William F. Ramsey. He was of the class of big men known well and favorably throughout the length and breadth of the Lone Star state. His personal life was one of the searching and systematic kind and his professional life was one of the most successful of his generation.

Judge William Franklin Ramsey was born in Dallas, Texas, on January 1, 1855. He was the son of a prominent lawyer and banker. He attended the public schools here and then Trinity college. In 1876 he was graduated from the federal reserve law department in January, 1877.

After being admitted to the bar, Judge Ramsey practiced law in Cleburne from July 8, 1877, to January 1, 1907. In his profession he generally regarded as one of the most successful attorneys in the entire state.

Between 1900 and 1907 Judge Ramsey was a banker in addition to his large law business. It was this trading in the federal reserve bank that made him eligible to occupy his recent high position.

In 1908 Judge Ramsey was a member of the penitentiary board. He was judge of the court of criminal appeals from January 1, 1908, to January 5, 1911, and associate justice of the supreme court from January 5, 1911, to January 1, 1912. He resigned at that time to make the race for governor against Governor Oscar Branch Colquhoun.

Following his defeat Judge Ramsey was elected to the office of chief justice of the supreme court in Austin, continuing with marked success until his appointment in the summer of 1914 as federal reserve agent for the district comprising the Dallas. Shortly afterward he removed his family to the north Texas metropolis.

Judge Ramsey was an enthusiastic Mason, being a member of all the lodges and having received all the degrees. He was also a Knight of Pythias and Elk and Woodman. A few years ago Judge Ramsey purchased the magnificent 120-acre estate at Dallas, which he occupied until his removal to Dallas.

PROCLAIM MARTIAL LAW IN ITALY BUT LATER CANCEL ORDER

CABINET COUNCIL IN SESSION SINCE MIDNIGHT TO HEAR REPORTS.

URGE ORDER IN FACE OF INSURRECTION ATTEMPTS

Rome and Other Large Cities Have Escaped Serious Disturbances.

ROME, Oct. 28.—The cabinet council has been in session since midnight in order to receive reports from the provinces where the fascist movement has taken a subversive direction and to adopt necessary measures to meet the situation.

The cabinet decided first to issue a proclamation declaring a state of siege in all the provinces beginning at noon today but later this decision was modified and a proclamation was issued urging the public to maintain order in the face of insurrectionary attempts. The proclamation to the people says: "Seditious movements having manifested themselves in certain provinces of Italy with the object of the interruption of the normal functions of state powers and calculated to plunge the country into grave trouble, the government has as far as possible tried every means of conciliation in the hope of re-establishing peace and reaching a peaceful solution of the crisis.

In the face of such insurrectionary attempts it is the duty of the retiring government, by all means, at whatever cost, to maintain law and order, and this duty will carry out the full in order to safeguard the citizens and free constitutional institutions.

It is the government's expectation that the citizens will remain calm and have confidence in the measures taken for their safety.

"Long live Italy!"

Reports received by the cabinet council from a number of points in central Italy show that the fascists are extending their movement with a view to exerting pressure for the formation of a fascist cabinet. The fascists are active in Romagna, acting with energy to re-establish order.

Rome and all of the large cities up to the present moment have escaped the scene of any disturbances of moment.

MARTIAL LAW DECLARED THROUGHOUT ALL ITALY

LONDON, Oct. 28.—Martial law has been proclaimed in Italy to take effect throughout the country from noon today, says a dispatch from the Stefani agency, semi-official Italian news organization.

Special dispatches early this morning told of the beginning of a concerted movement by the fascist forces against several political leaders in Pisa, Cremona and other chief centers were declared to have been taken over by the fascist forces, who deposed the state authorities and assumed command. Apparently a cording to these advices, there was no resistance.

SECRETARY OF STATE WIRES COUNTY CLERKS FOLLOWING AN OPINION BY ATTORNEY GENERAL

AUSTIN, Oct. 28.—On advice of the attorney general, Secretary of State Staples this morning certified by telegraph to all county clerks the names of Earle B. Mayfield as democratic candidate for United States senator.

The telegram sent to the county officials, follows: "As secretary of state, I hereby certify to you the name of Earle B. Mayfield as the nominee of the democratic party for the office of United States senator from Texas. This name should immediately be printed on the official ballots for the general election."

The attorney general's opinion to Mr. Staples advising that Mr. Mayfield's name be certified, follows: "In response to your inquiry you are respectfully advised that it is now within your authority and is your legal duty to certify to the proper county officials the name of Earle B. Mayfield as the nominee and candidate of the democratic party for the office of United States senator to be printed upon the official ballots as such in the ensuing general election.

"The decision of the supreme court of Texas handed down yesterday is to the effect that the parties plaintiff in the case of state ex rel. B. BREWERY HEADS ARE SENTENCED TO TERMS IN PRISON

CINCINNATI, Oct. 23.—Sentences imposed upon three officials of the Schaller Brewing company by Judge Peck in United States district court here last night are said to be the first prison sentences pronounced in the United States against brewery heads charged with violation of the Volstead act.

Verdicts of guilty on both charges were returned by a jury against Michael Hilsinger, receiver, and Michael Keck and Joseph Herriman, officers of the brewery, who were indicted on a charge of having manufactured, possessed, transported and sold beer containing alcohol in excess of one-half of one percent and having maintained on the premises of the brewery a common nuisance in violation of the Volstead law.

Hilsinger was sentenced to one year and six months in federal prison and to pay a fine of \$1,000. Keck was sentenced to six months in jail and a day in federal prison and a \$500 fine. Herriman was sentenced to three months in jail and fined \$1500 and costs.

WILL REDUCE NUMBER OF HOUSTON JIBBERS

HOUSTON, TEXAS, Oct. 28.—City commissioners of Houston have agreed to take off a number of jibbers from the city streets to reduce the number to be allowed to operate to a maximum of 150. Believe Insanity Cause of Murder Of Church Rector

HAYRE, MONT., Oct. 28.—The Rev. Leonard Jacob Christian, rector of the Methodist church of the incarnation here and widely known as the "Bishop of All Outdoors," and Mrs. Margaret Carleton, wife of the former, were found shot to death yesterday in the clergyman's home within a few feet of the room occupied by the two. The two were victims of temporary insanity on the part of Mrs. Carleton, in the opinion of "best" officials.

Mrs. Christian opened the door and found the bodies, that of Mrs. Carleton fallen across the minister's body."

MILK DEALERS ADVISED NEW CITY PERMITS AND EXAMINATIONS REQUIRED

Notices have been sent out from the city health office advising all milk dealers that their permits to sell milk to the public have expired and that new examinations of their herds are necessary to secure new permits.

Confident that he has solved the murder which he says is "complex but not a mystery," Prosecutor Mott went ahead today with the work of assembling corroborative evidence. He indicated to newspaper men that no arrests will be made until he has presented the case to the Somerset county grand jury.

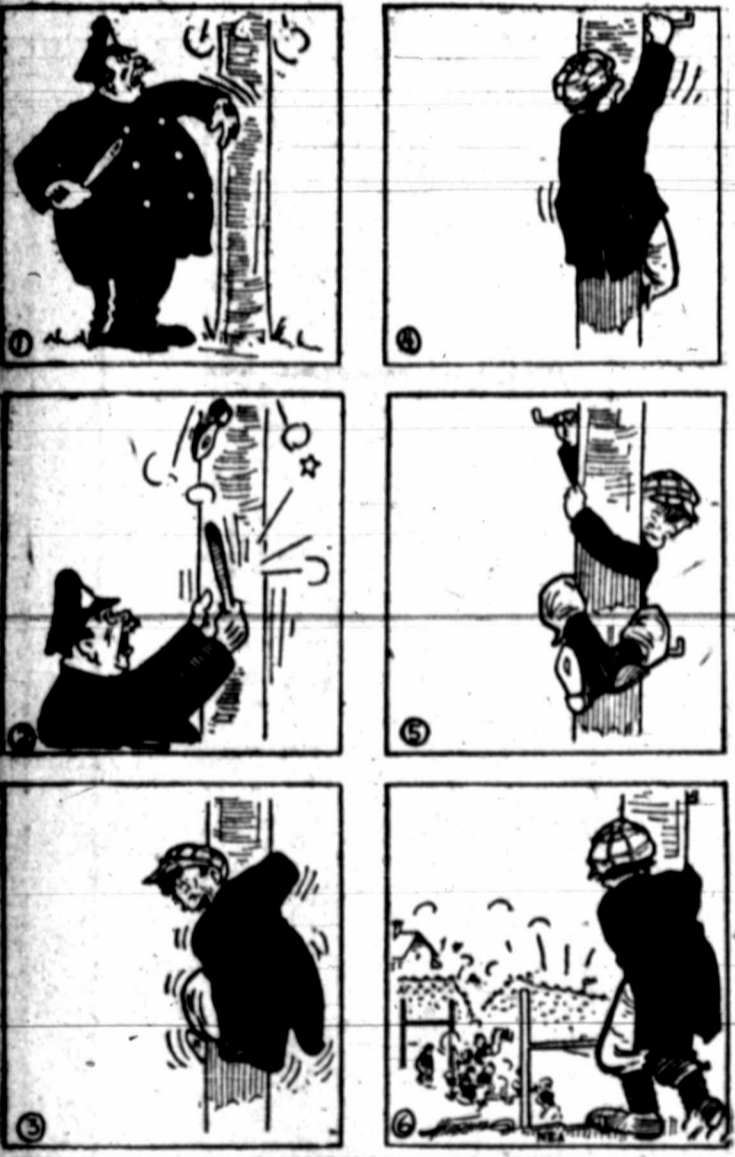

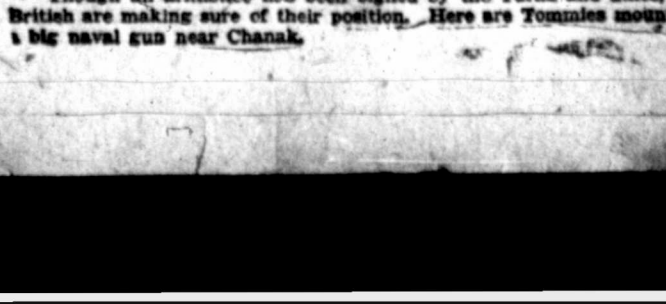
