### TO SUPPLY BOXES WITH INDIVIDUAL ELECTION BOOTHS

#### COMMISSIONERS TALK PLANS FOR CONSTRUCTION OF COMPARTMENTS

#### POINTED OUT THAT LAW MAKES IT OBLIGATORY

Various Precincts Will Be Split in Order to Comply With Election Statutes.

Individual collapsible voting booths will be supplied at the various precinct boxes in the county some time during the coming year. This decision was made at the meeting of the county commissioners Monday afternoon.

It was pointed out that under the strict interpretation of the law no least elections have been held in the county as the statute provides that individual booths be supplied so that a voter will be able to mark his ballot without another person looking on.

Under the system now in use in the county, it so happens many times that as many as half a dozen voters will be sitting at the same table marking their ballot and a number assisting the other in casting his vote.

It was decided by the members of the board to construct booths which would be collapsible and movable. Deaver boards will be used for the construction of the booths.

The law also provides that not more than 150 voters should comprise a voting precinct. There are a half dozen precincts in the county at present which contain between 400 and 1000 voters and in order to comply with the statute will divide these precincts at the August term. The new precinct numbers and boundaries will go into effect on January 1, 1934.

### No Offender in Police Court But Bonds Forfeited

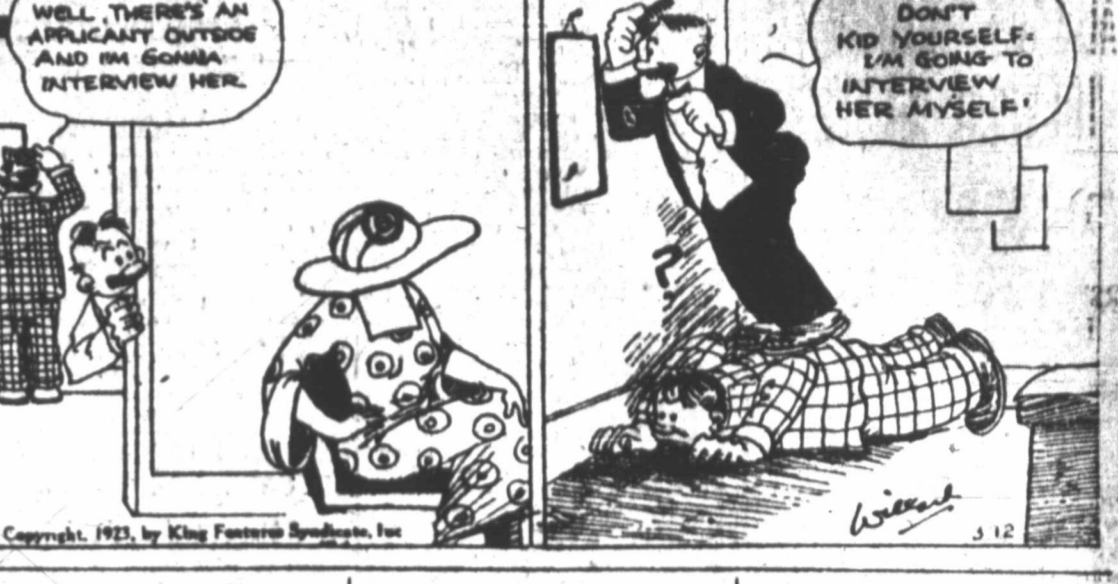
