RURAL HOUSING PROGRAMS PRESENTATION-Steve Mack, president of Citizens State Bank, Mary Graves, retired Rural Development employee, and Max Verzele, USDA Community development manager were active in the public meeting.

### **Rural Housing Program Presented Locally**

A public meeting on Rural Housing Programs was presented by Max Verzele, a community development manager with the United States Department of Agriculture on Tuesday, March 25, at the Senior Citizens qualified very low to moderate in-Center. Citizens State Bank sponsored the meeting.

Steve Mack introduced Mr. Verzele and Mary Graves, a retired employee of Rural Development, to the group. Verzele briefly explained that home loans are available for new construction, existing home purchase, and repairs for home owners.

New construction or existing home purchase has up to 100 percent financing, no down payment, no mortgage insurance, low to no closing costs, up to 38 year repayment term, and non-cash subsidy to reduce mortgage payments.

Home repair and improvement loans are available with low interest rates, up to 33 year repayment term, signature loans of up to \$2,500.

The programs are designed for come applicants in designated rural areas. This includes homes in and outside the city limits in Callahan County. The programs are available for home repair loans for very low income applicants; home repair/improvement loans; direct rural housing loans; and guaranteed rural housing loans

### **New TxDOT Registration Renewal Forms Begin**

Texas motorists whose vehicle registrations expire in May will be among the first to see the state's new and improved registration renewal notice. The Texas Department of Transportation (TxDOT) has dramatically changed the form to make it more customer-friendly and will begin distribution during the first week in April.

Gone is the multi-part card Texans have been getting since 1970. The new notice is a standardized 8-1/2" x 11" document, similar to a tax, utility, or credit card statement.

"The state has developed a renewal notice that's convenient to use," said Bun Barry, Callahan County Tax Assessor-Collector. "The form has many features that weren't available before.'

The new renewal notice simplifies registration. Key pieces of information are highlighted in red, including special instructions, fees, and proof of insurance requirements. The name, address, and phone number of the recipient's tax assessor-collector is printed on the form, providing a local contact for registration questions. Each mailing address on the nenewal notice is printed with barcode technology to assure accuracy and to speed delivery through the postal system. And, for the first time, a return envelope is enclosed for customers who wish

to renew by mail. "We believe the public will appreciate the new form" Barry said. "There are many features on the new form that make it more customer-friendly."

Some Texans have already seen a prototype of the new renewal notice. TXDOT showed the form to several focus groups last summer in the Dallas-Fort Worth area. The state also invited all county tax assessor-collectors to give their input.

An insert with a graphical explanation of the new form will be included with each renewal notice. Anyone with questions about the new renewal notice should contact the Callahan County tax office at 915-854-1020.

The VLB will finance the entire loan amount of all winning bids. There is no limit on the amount loaned or on the number of tracts that an individual can bid on. However, engible Texas veterans are limited to one purchase in the sale.







### 42 Mile Car Chase Ends In Jones Co.

led Baird's City Marshal and many other area law enforcement officers on a 42 mile chase that ended with the suspect wrecking his car in Jones County on Wednesday, March 19th.

Daniel R. Podlevski, 22, was transported to Hendrick Medical Center in Abilene, where he was treated and released, by a Stamford EMS ambulance following his wreck and arrest for numerous charges stemming from a gas drive-off in Baird about 6:30 a.m. Wednesday morning. The suspect failed to pay \$14.59 for gasoline at the Baird Allsup's store. Baird City Marshal Dale Coley and Callahan County Deputy Buddy Croft attempted to stop the 1996 white Ford Escort near Clyde and the vehicle would not pull over and tried to hit Coley's car when he attempted to pull up beside him. Taylor County Sheriffs Department joined the chase near

BAIRD-A Burkett, Texas, man Abilene, that at top speed, Coley said, was about 100 mph but most of the time was near 80 mph. The suspect ran through the intersection at IH-20 and Highway 351, narrowly missing many vehicles, said Coley, and then traveled to Judge Ely turning again toward the interstate and then turned north on FM 600. A road block near the Jones

County line failed to stop the vehicle and it continued north almost 25 miles before running off into a wheat field at another road block and then striking a telephone pole when trying to reenter the roadway. The car was said to be totaled when it hit the pole, snapping it off level with the ground, and the car rolled onto its side. The chase lasted about an hour

The suspect ran 3 red lights, 5 stop signs, along with the other traffic violations according to the arrest report. Coley said he was

very glad no school children were injured as the suspect passed some school busses that were loading for school on FM 600. We still don't have a reason for him to run like he did, said Coley, but the investigation will continue.

Podlevski is now in Callahan County Jail with a \$50,000 bond on charges of aggravated assault. on a Peace Officer and theft in Callahan County and Jones County filed assault on a Peace Officer charges. ### Four Cows Gunned Down Near Highway

It has been an eerie sight to all motorists traveling State Highway 36 this week -- three large dead cows just barely inside the fence only a few feet off the south edge of the road.

Four cattle were shot some time Tuesday (March 25), said Callahan County Deputy Sheriff John Windham, who is investigating the case.

The cattle were on the Twin Mountain Ranch. Three of the four died where they fell, about midway between Abilene and Cross Plains. "They all had bullet wounds '

Windham said. The fourth animal was taken to a

veterinarian and -- as of Friday -appeared to stand a good chance of recovery. That animal was just lucky, Windham said, noting that the bullet entered behind the ear and exited above the eye.

All four animals were pregnant females. The three dead cows had been expected to calve any day, at the time they were shot.

As far as leads, investigators knew little by Friday -- other than that the animals had been shot.

It remains to be determined whether this was a random, drive-by shooting three big heifers were pregnant, their value likely would be in a range of \$600 to \$700 each with the current strong cattle market -- even a bit more

if they were fancy females. Carson said that would give the bred heifers a value of \$2,000 or more as commercial females.

With the additional injury and vet-

crinary expense with the fourth animal, it certainly was an expensive, shooting.

Windham urges cattlemen to be on high alert to any strange vehicles or suspicious individuals on or near their property -- especially carrying any fircarms.







Ron Rose, director of a Families Ministry in Dallas/Fort Worth, shared "Three Unforgettable Principles of Parenting." Although he made special application of these principles to parent and child relationships, they are applicable to others also.

The first principle is: "Nobody is perfect." For some of us perfectionists (who are far from perfect also), that's hard to accept. Even though we realize that we're not perfect (?), we leel everyone else should be -- and when they're not, we're liable to "write them off."

The second principle is: "Don't label people." Many are not only guilty of labeling others, but also of leaving them there. It goes like this: "You're no good and you'll never amount to anything!" Ron used this illustration: Someone said they liked for people to treat them like his tailor, measuring him anew each time he came to be fitted.

The third principle is: "Always look for options -- ways out of a bad situation or trait." One doesn't have to stay in a rut. (A rut, unlike a grave, is open on both ends and the top!) One can seek help and look for outs.

All of this is Christian in principle -- and so applicable to Christianity itself. Concerning perfection, while God always demands perfection (passages too numerable to list!), He always accepts less than perfection (He has to!). And even though Jesus may have lat some -- like calling some of the Pharisees "hypocrites" -- He thoroughly knew what He was talking about, and even then didn't add, "And you'll always be!"

Regarding the third principle, Christianity is a freedom religion. It doesn't lock emeene in, it frees people copecially from sin, but also from past bad traits. We will "never get out of this world alive" -- but Christ is the way out! Come share in the "freedom religion" with us... 



### Channel Earth Added To DIRECTV

Ellis, Manager, Coleman County Broadcasting Systems. Orion Samuelson, currently with

WGN-Tribune Broadcasting and chairman of the board of Channel Earth Communications, Inc., will serve as anchor and chief correspondent for Channel Earth. Samuelson, along with WGN colleague Max Armstrong, will lead a team of regional and national correspondents, livestock and commodity market experts, meteorologists and talk show hosts, when the channel goes on the air this spring. "We intend to become the nation's authoriative source of agricultural news and information," says Samuelson. "We are about to do something that has never been done before: provide farmers, ranchers and other rural consumers with a steady, reliable, up-to-the-minute source of critical information that affects their lives every working day. The need is enormous and Channel Earth will fill it."

According to Mr. Ellis, the new channel will air exclusively on DIRECTV and its DSS\* brand minidish satellite system. DSS took Brown, Coleman, Runnels, Callahan, and Southern Taylor Countles and the entire home entertainment industry by storm almost three years ago, setting sales records for a newly introduced consumer electronics product. Today, more than 2 million people nationwide subscribe to DIRECTV, which industry experts regard as the most serious threat ever mounted by an alternative to cable




Channel Earth will broadcast programming from studio production facilities in Chicago and air live reports from throughout the country, including regional reports and regular news updates from Capitol Hill.

### Water Line Construction Bids To Be Opened April 30

Barring no further delays, the treated water pipeline from Abilene to the communities of Clyde, Baird and Callahan County Water Supply Corporation, will be bid sometime this week, according to the engineer for the project.

Billy Jacob, of Jacob & Martin Engineering in Abilene, said bids for the \$5.2 million project will begin the advertising process this week. The bids are expected to be opened April 30.

Jacob said once the low bidders are announced, work could begin around the first week of June. He estimates construction of the pipeline to be completed around April 1, 1998.

Talk of constructing the treated water pipeline was first brought up by the Clyde City Council some nine years ago when the Clyde Lake water level was extremely low and water had to be rationed here.

The project was first scheduled for bldding April 1996, however problems arose with obtaining easements and specifications for the project.

Clyde City Administrator Tim Powers said Clyde Mayor Merv Warrick was instrumental in correcting the delays by his enlisting the support of Congressman Charlie Stenholm.

Jacob said the project will be bid through eight separate bid packages. Clyde's portion of the pipeline will be bid in two packages, Baird's portion will be bid in two packages and Callahan County Water Supply Corporation's portion will be bid in four packages. He said once bid winner are announced, the cities of Clyde and Baird and the water supply corporation must then approve more loan ordinances.

Administrator Powers said Clyde will receive a grant in the amount of \$762,000 (49%) and a loan totalling \$763,000 (51%) to construct its portion of the pipeline.

The City of Baird will receive a grant of 37% and a loan totalling 63 percent for its portion of the cost. Callahan County Water Supply Corporation will receive a grant amount to 72% of the project and a loan of 28% for its portion of the pipeline's cost.

The engineer said an 18" water line will begin at the Elmdale water tower. The water pipeline will travel east along the south access road of Interstate 20. A 12" pipeline will connect to Clyde's water tower. From there, a 12" pipeline will cross I-20 and travel east along the north access road and County Road 120 to connect Baird and the water supply corporation.

Administrator Powers said initially, Clyde will not purchase a lot of water from Abilene. "It's a secondary water supply for us," Powers said. For Baird, the pipeline is also a secondary water supply. However, for Callahan County Water Supply Corporation, the pipeline is its only water source.

### Aggressive Honey Bees Force Family To Flee Home

BAIRD—A Baird family was forced to flee their home March 6th due to some very aggressive honey bees that they had coexisted with for the three years they had lived in the home about three miles east of town.

Caprice Hammett said she and her two children were at home when they heard the dogs outdoors barking and whining. When a daughter opened the door a puppy ran in carrying bees on him into the house. Then they noticed all the other dogs being attacked. They called 911 and the two sheriff's deputies that were dispatched to the call were both stung but helped the family leave the scene, none of the family members were stung. Deputy Darroll Ratto, who was stung three times, was the first to arrive and said there was a "big bunch of bees" all around with a cluster on the back of the house about 4 inches wide and four foot tall.

Mrs. Hammett said the bee hive was in the walls of the home when they moved there three years ago but they had never acted like this before. It was a very scarey situation and I was worried about my children and wish I could have helped the dogs, but we couldn't get to them.

Jeff Hammett lost his one year old Catahoula cow dog, "that was just starting to work real good", due to the severity of the over three hundred bee stings that the veterinarian said the dog suffered. Jeff's dog died Saturday and the same day another family dog that had young pups dissappeared from the residence and hasn't been seen since. Caprice said she

feared that dog, which had also been stung repeatedly, went off and died but it is not known for sure.

Texas A&M University Apiary Department was called to check the report. Apiary Inspector Bill Baxter took samples of the bees last week, March 10th and 11th, before killing the hive in the wall of the home and another hive nearby in a tree.

Assistant Chief Apiary Inspector John Fick said Thursday that test results showed the bees in the wall of the house were Africanized bees as were the bees that were taken off the dag that died. The bees in the tree near the home were European bees.

Fick, who has been with A&M since 1975, stressed this is no cause for panic and is quiet probably an isolated incident caused by the Africanized bees being accidently "trucked" from South Texas. Fick said this is the time of year when a lot of the "snow birds" (retired people that spend their winters in the South Texas Valley in camper trailers and then head north during the spring) are traveling through the North Central Texas area near Baird. The bees could also have hitched a ride on an 18-wheeler or any other type of vehicle that had been sitting long enough in the south Texas area for them (the bees) to gather in and then stopped near Baird long enough for the bees to have left their "taxi" and looked for a new home.

The only way to tell an Africanized bee from a European bee is under a microscope, Fick said, and also by their aggression. The Africanized version are very territorial and tend to attack an intruder much more viciously than the common European bee. Neither type of bee usually attacks unless being provoked in some way, although the one being stung may not do the provoking.

An A&M Apiary Inspector will return to Baird this week to set out bee traps and take samples from other bee hives in the surrounding areas of Callahan County. If these samples turn up any established African bee hives the county could be quarantined, meaning that there could be no movement of

any bees from Callahan County into other areas without first being tested. Bee movement from county to county, by bee keepers, is already restricted to "by permit only". Fick said it would take about a month after the testing before a quarantine would be enacted and then only if there was evidence of established Africanized bees which, Fick added, is highly unlikely as they have not had any Africanized bees in their trap line

between Temple and San Angelo in more than a year and a half. Which adds to the theory of the bees being trucked in, instead of migrating to this area.




