The Cross Plains Buffaloes, now 13 and 2 on the year, have been playing some good basketball. Before the Christmas break the Buffs played Zephyr winning the game rather easily 85-46. Three of the Buffs were double digit scorers -- Benji Blackstock 14, Zach Edington 18 and Joseph Turner 21.

The Buffaloes then played Gordon at Gordon and once again claimed the victory. This time the Buffs had a pretty tough time, winning only by a single free throw \$5 £4. Blackstock was top scorer on the night with 17 and Turner was close behind with 15.

On December 30th Cross Plains hosted the Ranger Bulldogs and lost the second game of the year by 4, 6056. Again three players were in double figures -- Dusty Hargrove 10, Blackstock 13 and Edington 16.

The Buffs won the game 62-46, advancing into the championship bracket. Edington led the Buffaloes with 20 points and Blackstock 13.

In the second round of the tourney C.P. paired with the May Tigers. The Buffs started out well and led at halftime 32-23, but the 3rd quarter work its toll on the team as May outscored the Buffaloes 21 to 11 -putting C.P. down by 1 at the end of the 3rd quarter. Coach Bill Boyd was proud of the effort put forth by his team and also stated this was the first time since he has been here that Cross Plains won all three tournaments in a single season. Congratulations on a great job of coaching and even a greater job by our Buffalocs.



## Drinking by minors will not be tolerated


"Zero Tolerance" for anyone under the age of twenty-one when it comes to drinking and driving under a new Texas law that became effective September 1, 1997.

Texas Senate Bill 35 provides a new offense for minors driving under the influence of alcohol and increases the penalties fro juveniles driving while intoxicated. Amendments were also made to the laws pertaining to minors attempting to purchase, possess, or consume alcoholic beverages.

Minor, as referred to under this law, is a person under the age 21 years old.

Currently Texas leads the United States in the number of alcohol-related traffic fatalities among the nations youth.

National Highway Traffic Safety Administration research has shown that younger, less experienced drivers have more than twice the number of fatal crashes per mile as do experienced adult drivers. When alcohol becomes a factor, these statistics increase.

Texas previously (before September 1, 1997) allowed drivers under the age of 21 to drive a vehicle with a Blood Alcohol Content (BAC) of up to .07. This BAC amount was legal even though it was against the law for anyone under 21 to purchase, possess, or consume alcohol.

The National Highway System Designation Act of 1995 mandates that all states adopt a "Zero Tolerance" law by October 1, 1998, or lose federal highway funding. Failure to comply with these federal requirements would result in the State of Texas loosing \$38.5 million, of highway funds, in 1998 and increasing to \$77 million in 1999. Under the Senate Bill 35;

\* Minors commit an offense, of driving under the influence of alcohol, if the minor operates a motor vehicle in a public place while having any detectable amount of alcohol in the minors system. The minor is charged with a Class C misdemeanor, fines of up to \$500, for the first offense and may be required to attend an alcohol awareness class.

The second offense brings stiffer penalties, including an alcohol awareness class, and the third offense carries fines of up to \$2,000 and jail terms of up to 180 days.

If the defendant is less than 18 years of age the court may require the parents to also attend the awareness class.

If the defendant does not comply with the orders of the court, as pertains to the awareness program, the court shall order the Texas Department of Public Safety to suspend the defendants drivers license for up to six months. If the minor does not possess a drivers license he can be blocked from receiving one in the future

- \* A minor commits an offense by attempting to purchase alcohol.
- \* A minor commits an offense if he purchases an alcoholic beverage.
- \* Misrepresentation of age by a minor, in relation to purchasing alcohol, is a violation of the law.
- \* Consumption of alcohol by mi-

All four of the above violations carries Class C misdemeanor charges for the first two offenses and up to a \$2,000 fine and/or 180 day jail term maximum penalties for the third offense. Drivers license suspension and community service of up to 40 hours can also be implemented, in addition to the other penalties, if the court deems fit.

- \* Sale of alcohol to minors brings Class A misdemeanor charges, up to \$4,000 fine and/or 1 year in jail, for the seller.
- \* Possession of alcohol by minors warrants being charged with Class C misdemeanor unless:
- 1) he or she is an employee of a licensed alcoholic beverage sales establishment and is performing duties of employment.
- 2) the minor is in the visible presence of their adult parent, guardian, or spouse.

This bill was among 1,030 bills that became law on September 1, 1997 with some others, like the minor and tobacco Senate Bill 55 and House Bill 793 that ruled Purple Paint Strips can replace No Trespassing Signs.

laws has been limited by a lack of information, but that is changing.

To add to the confusion most of the new laws have different implementation dates. The Purple Paint Statute can't be fully enforced until September of 1998. ## **Texas Traffic Laws Taking** Effect January 1, 1998

Three new traffic laws that took effect January 1, 1998 were:

· Traffic fines will double for moving violations that occur in highway construction zones where workers are present. Fines in those areas could increase from a range of \$1 to \$200 to \$2 to \$400.

· Teenagers who smoke could be fined and lose their driver licenses. Anyone under age 18 who is found to possess, buy or consume tobacco products can be fined up to \$250 and community service or attendance at a smoking-awareness class. Later violations could result in suspension of the teen's driver license.

· Traffic signs on highways with more than one lane of vehicles travcling in the same direction should indicate that the left lane is for passing only, and that slower traffic should keep to the right (This law took effect on September 1, 1997.)


