


She was a homemaker. She married Connie Alton "Red" Taylor in 1944 in Lueders.

Dear Editor,

When we think of drugs, most of us think of marijuana, heroine and crack cocaine. But some of the most lethal drugs are far simpler and easier to obtain. In fact, they are in every home in the nation. Things such as magic markers, white out, lighter fluid, paint and cooking sprays are a few of the products that when inhaled have

proved fatal. Today, many young people in our community abuse such products to get a quick high. Unfortunately, kids are not aware of the high risks that come with this behavior. The fact is each year hundreds of children die from inhalant abuse.

Inhalants are the third most abused substances among 12-14 year-olds in the United States coming right behind alcohol and tobacco. And as many as one in five children have "sniffed", "huffed" or "bagged" (inhaling the product intentionally) by

the time they have reached the sev- " enth grade. While many kids admit to sniffing toxic items, they do not consider this to be "inhalant abuse." That is because these products are readily available, inexpensive and legal to purchase.

Children, and all people, who abuse inhalants and do not dic, put themselves at risk for permanent and severe brain damage. Inhalant vapors react with the fatty tissues in the brain, literally dissolving them. Therefore, chronic inhalant abusers may permanently lose the ability to perform everyday tasks such as walking, talking and thinking.

We must warn our children of the. dangers of inhalant abuse, and make sure they know enough not to try them.

If you suspect your child, or someone else is using inhalants please consult a school counsclor, a drug counseling center or the Poison Center for help.

LEST WE FORGET-Fort Worth Veteran Fiske Hanley II has written a book detailing his experiences as a prisoner of the Japanese during the last months of World War II. Vetcran Hanley was flight engineer in one of three B-29s shot down over Japan on March 27, 1945. The B-29 crews were hated because they had firebombed Japan in the Superfortresses, killing innocent women and children. They were considered war criminals. Less than 200 of over 3,000 missing crewmen from missions over Japan survived. Veteran Hanley ended up in the Tokyo prison run by the Kempel Tai, who he says were comparable to Hitler's Gestapo. During his five month imprisonment his weight

dropped from 165 pounds to 95. Death from beatings, infections and starvation was always close.

Early that April, 62 American airmen were shipped out of the prison. They were told they'd be taken to better facilities. Only Veteran Hanley and one other airman were left, and they protested. They were told later that there had been a mixup and that the two of them should have also gone. It was later learned that all 62 had been killed. They were left to die in a prison which caught on fire during an American

Services were held at 2 p.m. Monday in Higginbotham Funcral Home Chapel with Dick Williams officiating. Burial was in Rising Star Cemetery.



Fatty acid and attention-deficit/hyperactivity disorder

"Some studies have shown children with ADHD have lower levels of DHA in their plasma and red blood cells," said Dr. Robert Voigt, a Baylor assistant professor of pediatrics. "We want to see if DHA supplementation of children with ADHD might improve the symptoms of inattention, impulsivity, and hyperactivity.'

DHA is one of the predominant fatty acids in the brain and retina.

Many researchers believe DHA is necessary for the central nervous system to function properly.

"Three-to-five percent of the population is affected by ADHD," said Voigt, a developmental pediatrician at the Meyer Center for Developmental Pediatrics at Texas Children's Hospital in Houston. "Many children with ADHD continue to have problems in adulthood with employment, family relationships, and anti-social behavior, and society ends up paying a high price. If this simple dictary intervention has any effect, the impact on society could be enermous."
