"A Wake-up Call to Americans"

"Saving Private Ryan" is not a movie for everyone, as it is graphic, shocking and the language is rough. Richard and I decided to attend because both our dads served in World War II in the Pacific and we went out of respect for their dedication to our country.

The movie took place in Omaha, France but the story that unfolded was similar to facts Daddy shared. His description of soldiers unloading from the PT boats under heavy fire was recaptured in depth.

World War II was frequently discussed at our home but its real horror never touched me until I saw it on the big screen.

Daddy had nightmares if he spoke about the war and he suffered from the effects of malaria his entire life. His life was changed by this traumatic experience.

There was an atmosphere in the theatre of sadness and you could not help but cry. Wives were clinging to their mates for moral support. There was a reverence and sense of grief upon the crowd as everyone watched in awe.

I felt like this film was a wake-up call for Americans who have simply forgotten the World War II, Korean, and Vietnam Veterans. It has been a long, long time since World War II and we have taken for granted the wonderful freedom we enjoy in the United States. However, others sacrificed, even their lives, for our benefit. I feel that patriotism seems to be a thing of the past. If you are a baby boomer like me, you will recall saying the Pledge of Allegiance to the U.S. Flag every day at school. I don't think that happens in today's society. Somewhere along the way we have failed to teach pride in our country and respect. I don't know how any men or women returned home from the tragedy of World War II, except for the grace of God. Daddy said he prayed all the time. I know his prayers were answered because he was one of only nine in his platoon who lived. He always felt guilty because he survived. So many things I never understood about my dad have become clear after seeing this film. I know they all returned home different people, transformed by the sorrow of war. No wonder daddy was so upset when he received his official draft notice several months after he returned home from duty. Our youth do not realize how their freedom of choice was attained. High school students should see "Saving Private Ryan" to be appreciative, and the rest of the adult world need to remember. This could all be destroyed if we are not careful. The movie "The Postman" presents an insight into what might occur if we lost our democratic government and it is not a pleasant prospect. I want to salute our veterans and thank them for all their sacrifices and challenge everyone to devote some time to counting our blessings Let's not allow apathy toward our country and fellow man leave us cold and incompassionate.

Commissioners Adopt Budget for Fiscal Year

Callahan County commissioners adopted a budget set for the fiscal year and chose a date to approve a tax rate during their regular meeting Monday, September 14.

Commissioners adopted a \$1,891,535.84 budget for the fiscal year 1998-99. This was nearly \$160,000 over the previous budget of \$1,531,798.

Tax values higher

Taxable values in six of the seven taxing jurisdictions of the Central Appraisal District in Callahan County were higher in 1998 compared to 1997.

Central Appraisal District Chief Appraiser Rodney Lewallen reported 1998 taxable values after all exemptions were up in all but one taxing jurisdictions compared to last year. Lewallen reported higher taxable values in 1998 for the taxing jurisdictions of Callahan County, Cross Plains ISD, Clyde CISD, City of Baird, City of Clyde and the City of Putnam. Only Baird ISD had taxable values lower in 1998 from the previous year, Lewallen reported.

"The numbers indicate that the county and cities are all up from last year while the schools, Baird and Cross Plains in particular, are very close to last year in value," Lewallen said in a press release prepared last week.

"This is due to the loss in oil and gas values (average price per barrel for 1997 valuations was \$21 while price used for 1998 was \$18.50), declining production of existing tinued, "Also affecting values in the rural areas is the consolidation and mergers of several pipelines (Ensearch was acquired by Texas Utilities Fuel Co., Valero was bought out by Pacific Gas and Electric). The continued management problems with Union Pacific since their merger also hurt valuations in Baird and Clyde."

"Real estate markets continue strong and are forecast to continue with solid growth due to completion of Callahan county Water Supply line, population growth and continued low unemployment numbers. Present expectations for 1999 values anticipate, however, that increase in real property will continue to be offset by declining oil prices (1999 values will use \$12-\$13 in all probability) and the continuing drought and its effects on cattle producers," Lewallen reported.

The chief appraiser concluded, "The brightest outlook for an increasing tax base is the City of Clyde with several million dollars in new construction on the I-20 corridor. This may be slightly offset by the closing of some downtown businesses but that effect should be minimal overall."

Individual precincts were budgeted as follows: Precinct 1 \$160,375; Precinct 2 \$204,833; Precinct 3 \$206,633; Precinct 4 \$205,133.

September 28 was set as the date for commissioners to set a tax rate. A proposed \$.357 rate will be an increase over last years rate of \$.344 per one hundred dollar value.

The average Callahan County Home will see about \$3.16 increase on their overall tax bill.

A public hearing concerning the tax rate drew no input, but representatives of the Tax Appraisal District and Clyde and Cross Plains School Districts requested that commissioners not cut an employee from the County Tax Assessor Collectors Office.

Commissioners said that the action had already taken place at a previous meeting and the Assessor Collectors office would be losing an employee at the first of the year and she would not be replaced. (Current Tax Office employee Sharon Owens will take the District Clerks job in January.)

Other items on Monday's agenda; A Right of Way Agreement between the county and the Eula Water Supply Corporation was tabled pending the gathering of further information.


Local Library Provides Services for Visually Impaired Patrons

Last April the Cross Plains Public Library received a survey from the Texas State Library <u>Talking Book</u> <u>Program</u> (TBP), outlining the accessibility for Texans' visually impaired patrons.

In a recent letter, Joyce Spears, Reader Services Librarian for the Texas State Library Talking Book Program, replied, concerning the Cross Plains survey: "After reading your survey and comparing your needs to those of libraries across the state, we are pleased to announce that your library has been selected to participate in the Print Access for Texans Program."

As a participant the library has received a magnifier to aid visually impaired patrons, which will be on loan for an initial period of two years. The library will be

responsible for assisting patrons with the use of the equipment and for keeping records and sending a report on the usage to TBP.

The library will keep statistics on (1) the number of patrons using the equipment, (2) an estimate of how long each patron uses the equipment, (3) whether the library produces promotions for the program, (4) the number of maintenance calls needed, (5) a satisfaction rating for the service received from the Talking Book Program, (7) a satisfaction rating of the service received from the vendor.

The Library Board is pleased to have the aid for visually impaired patrons and invites the visually impaired and other citizens to visit the library to see the lighted magnifier stand.



David Berten, 76, of Rising Star, passed away Wednesday, September 9, 1998, at his residence in Rising Star.



VETERANS CEMETERIES — The Texas Veteran's Commission has authorized a \$20,000 study to examine the possibility of Texas building and maintaining State Veteran's Cemeteries. The contract for the study, which was mandated during the last legislative session, was awarded to Komatsu Architecture of Fort Worth. The firm will examine potential locations across Texas, the potential costs to build and maintain the cemeteries and the demand by Veteran's population. Under this program, the Department of Veterans Affairs will match state contributions, to include land, for start-up costs for the cemetery. After that it is incumbent upon the state to maintain the cemeteries by legislative appropriations and/or private contributions. Proposals will be submitted to the next session of the legislature which is scheduled to convene in January 1999.


"Cooking, Idea, Disasters and the Aftermath"

Dumping

Callahan County does not have a landfill nor does the county provide garbage disposal, although several private companies offer refuse collection for a fee.

Anyone caught illegally dumping trash will be cited and face fines with possible jail sentences, depending on the situation, according to Curtis and Callahan County Attorney Allen Wright.

We've issued warnings and allowed people to go pick up the dumped trash without filing charges in the past," said Curtis, "but it hasn't slowed down the dumping." "In fact it has gotten worse lately," he said. Wright said, "Someone dumped a whole house in the Admiral area." That particular incident would be classified as a Class A Misdemeanor and could have a punishment of up to \$4,000 fine and one year in jail. Admiral is a small community southeast of Baird.

Punishment for all dumping, which could be as small as a soda can, ranges from a Class C Misdemeanor, with a fine of up to \$500, up to the Class A & B Misdemeanors penalties which carry fines and jail time.

Wright said, "Probated sentences have provisions for restitution (the dumper would have to pay for the trash cleanup) and Community Service of not less than 80 hours for a Class A offense." "In these cases we would probably require the community service to be in the form of picking up trash off the county roadways," said Wright.


Curtis said, "We've been covered up with calls (in the past few weeks) about people dumping on county roads." "They even dump in the roadways making a traffic hazard," he added. A load of roofing shingles was recently dumped on County Road 110.

All parts of the county have been atfected by the illegal dumping say officials, but "hot spots" are in Eula, Oplin, and Union Hill areas, said Curtis.

Baird City Officials say that they will prosecute anyone dumping illegally on city property also. The city's T&P Lake area has been victim to illegal dumping.

Clyde and Cross Plains officials echoed Baird's feelings on the matter. All three cities have experienced problems with non-residents dumping in their dumpsters also and handle the matters on a case by case basis.

Anyone with information on illegal dumpers are requested to call the Callahan County Sheriff's Department at (915) 854-1444. Information needed is a description of the vehicle and persons, a license plate number, location (county road number) of the dump site, and time of the dumping.

New I-Bonds go on sale will earn 3.40% over inflation

above inflation. The fixed rate for I-Bonds purchased in September and October 1998 is 3.40 percent, and the Earnings Rate is 4.66 percent. I-Bonds have features that make them attractive to many investors. They are sold at face value in denominations of \$50, \$75, \$100, \$500, \$1,000 and \$5,000 and earn interest for as long as 30 years. Two new denominations, \$200 and \$10,000, will go on sale in May 1999. I-Bond earnings are added every month and interest is compounded semi-annually. They are free form State and local income taxes, and Federal income tax on I-Bond earnings can be deferred until the bonds are cashed or they stop earning interest after 30 years. Investors cashing I-Bonds before five years are subject to a 3-month earnings penalty.

The Earnings Rate for I-Bonds is a combination of a fixed rate, which will apply for the life of the bond, and the inflation rate. The 4.66 percent Earnings Rate for I-Bonds bought in September and October 1998 will apply for the first six months after their issue. The Earnings Rate combines the 3.40 percent fixed rate of return with the 1.24 percent annualized rate of inflation as measured by the consumer Price Index for all Urban consumers (CPI-U). The CPI-U increased from 161.2 to 162.2 from September 1997 to March 1998, a six-month increase of 0.62 dercent.

Fixed and Earning Rates for I-Bonds are announced each May 1 and November 1.


