Project Pride Receives Robert E. Howard Manuscript Donation

FEBRUARY 15, 1999-Project Pride of Cross Plains, today announced that it has added part of the original manuscript of Robert E. Howard's "The Blue Flame of Vengeance," a Solomon Kane story, to its collection of Howard memora-

The new addition consists of one original page from Howard's typed, 31-page manuscript, and a photocopy of the remaining pages. The items was donated by a collector who asked to remain anonymous. The donor purchased the item from a Maryland fantasy and science-fiction book dealer and publisher in

"Project Pride is pleased to add this manuscript item to other Robert E. Howard memorabilia in our care," said Billie Ruth Loving, Howard hostess. "We will include it among the materials that are available for review on-site by students and scholars engaged in manuscript studies of Mr. Howard's writings."

Ms. Loving noted that the month of August 1998 represented the 70th anniversary of the publication of the first Solomon Kane story, "Red Shadows," in Weird Tales magazine. "It is fitting that Solomon has returned home to Cross Plains, in a sense, on this anniversary of his first appearance in print."

"I am proud to contribute this item of memorabilia to the organization that has done so much to keep the spirit of Howard alive in his hometown," the donor said.

Created by Howard in boyhood, Solomon Kane was a 16th Century English Puritan whose restless spirit and expertise with the sword carried him to fantastic adventures around the world. "Solomon Kane...I created when I was in high school, at the age of about sixteen, but...several years passed before I put him on paper," Howard once wrote. "He was probably the result of an admiration for a certain type of cold, steely-nerved duellist who existed in the sixteenth century."

Seven Solomon Kane stories were published in Weird Tales from 1928 to 1932, when Howard's best-known fantasy character, Conan the Cimmerian, debuted in the magazine. Marvel Comics published several Solomon Kane comic books in the 1970s and '80s.

Many of the Solomon Kane stories are fantasy adventures in the style of the Conan tales, but "The Blue Flame of Vengeance" is a pirate adventure with no overtly fantastic elements. Unpublished during Howard's lifetime, it first appeared in print in a 1964 anthology Over the Edge, heavily rewritten by fantasy author John Pocsik.

Howard's original text was restored for inclusion in the first collection of Solomon Kane stories, Red Shadows, in 1968. For that appearance, it was retitled "Blades of the Brotherhood" to avoid confusion with the rewritten version.

The story was reprinted most recently in Solomon Kane, a 1995 softcover volume. It will also appear in The Savage Sword of Solomon Kane, a limited-edition hardcover collection scheduled to be published later this year.

Beta Sigma Phi Hears **About Barbarian Trade** Festival & Wild Man's Cook-Off At Meeting


Beta Sigma Phi held its regular bimonthly meeting Monday, February 8, in the home of President, Wanda Merryman, with Debi Bennett as hostess.



The 1800's saga of Fred Cutbirth, born May 13, 1886, at Pilot Point and Hugh Henry McDermett, born August 23, 1887, in Coleman County, or on the line between Coleman and Callahan Counties:

Both were sons of ranchers. There were twelve children in Fred's family, four who died at birth. There were ten in Hugh's family. Hugh was the fourth in line and was said to have been premature. He grew to be the largest in the family as an adult.

Fred was a neat, medium-sized built man and always immaculate. Hugh was a large man who was very handsome when "dressed up" which was very seldom. One of Fred's granddaughters said he reminded her of an "unmade bed".

Their unspoken love for each other was very touching and unique. This friendship began when they were eleven years old, and Fred spent the night with Hugh. Hugh got a pair of his 200 pound father's drawers for Fred to sleep in. They went around him three times. They giggled so much Mr. McDermett told them to hush and go to sleep.

Hugh went to country schools until they closed after about four months. After that, Mrs. McDermett and the children moved to Coleman and finished out the school year.

Fred attended Baird schools and Baird College. Hugh and Oscar, his older brother, attended Daniel Baker, a Presbyterian school where they played football in 1901 and 1902. Later, Fred, Hugh, Oscar and Otis Odom, a Methodist's minister's son from Cross Plains, attended Draughan's Business College in Fort

Hugh was proud of his Spencerian handwriting he had learned there. He learned little else, as he and Fred spent their tuition money on dancing

Fred was the foreman and manager of the Cutbirth Ranch, which was growing at a rapid rate. Freu nad a very responsible job taking care of his sister's cattle, as well as all the rest of the cattle. He also worked as

a cowboy with the rest of the hands. Hugh worked with his father and his brothers on the McDermett

Ranch. Hugh also did work on neighboring ranches.

Mr. J.B. Cutbirth, Fred's father, was quite a diplomat. He'd ride by Hugh and brag about what good hand Fred was with cattle. Later he would ride by Fred and brag about Hugh's talents with stock. They would work "their tails off" trying to out-do the other.

No story about Hugh and Fred would be complete without their funeral and pallbearer experiences. Two handsome, single men were always in demand. This particular one was a funeral for a devout minister who was always talking to them about their souls.

Of course, they were not too fond of him. When Fred got tickled, he would cry and tears would run down his cheeks. So, as they came out with "the good minister's" body, tears were filling Fred's eyes.

Hugh's sister, Kate, was sitting near the front with several ladies who remarked, "Isn't it touching how the young men are grieving over the Brother's death."

Kate had her doubts, which were justified. Fred said at a critical moment, Hugh punched him and said, "Lets's drop the ole son of a gun."

They never missed a funeral and talked to each other all during the service. At one service, this conversation was overheard. Fred said, "Well, Hugh, this one hole we can't get him out of."

The last outdoor visit they had was on a rainy cold day at a Masonic funeral. They were both ailing. Hugh said, "Fred was so cold, I unbuttoned my overcoat and put it around him."




