It isn't necessary to be your child's friend -- you are the parent. You can maintain a good relationship without being their best buddy.

You see many two to four-yearolds who make all the decisions instead of their parents. One thing I learned was the child is not mature enough to make decisions and letting them do so is a big burden on them. Get the roles straight -- you are the adult and they are the child. If you are afraid of them, they will know it and take advantage.


Don't wait too late to get the respect idea across, as you will find it next to impossible to change later. Your child will love you more if you demand their respect and they will also demonstrate respect for rules,

laws and other people's rights. Set boundaries! The child should not have a free rein of your home. Your furniture, etc. should not be their personal playground. If you can accomplish this, you will be surprised how much easier life will be for them and you.

You don't want people to hate to see you and your children come for a visit. Once I had a friend who would call and say, "Put up all your pretty things, we are coming over." That is not fair to the child. How will they ever learn to respect other's

property if they are not taught? You see youth who do not respect their elders and that is so sad. The seniors are a wealth of wisdom and they certainly deserve to be honored. Encourage your children to speak to these treasured individuals and listen to what they have to say. You will never regret it. When an older person tells you they talked to your child and notes what a nice kid they are, you will be proud!

Nicholas is a sophomore and the son of Rusty and Dana Dimitri.


Revival Set For April 21-25 At Believer's Fellowship

Third Defendant In School **Arson Case Sentenced**

The final defendant in an arson case involving the Cross Plains High School fire on December 7, 1997, was sentenced here last week.

Twenty-year old Cross Plains High School graduate Cory Lee Switzer pled no contest to charges of arson in the 42nd District Court of John Weeks.

The court heard testimony from several witnesses including the Cross Plains Superintendent Jackie Tennison, Cross Plains Police Chief Don Gosnell, Cross Plains City Judge Bob Hill and Cory's mother, Sylvia Switzer, all requested the court to assess the young man a probated sentence without any incarceration.

Callahan County Attorney Allen Wright said, "I felt very strongly that he (Switzer) needed to do time in the TDC (Texas Department of Corrections) and earn his probation."

Switzer was sentenced to 8 years in the Texas Department of Criminal Justice by the court. "He will attend a "Boot Camp" facility for 75-90 days," said Wright, "and then will re-appear before the court."

"If he completes the boot camp the rest of his sentence could be suspended," Wright said, "he could also be placed on probation and have

to pay some restitution."

Switzer was accused of arson in the 1997 fire, along with two Cross Plains juveniles who were sentenced to time in a Texas Youth Commission Maximum Security Facility in March of last year. Cory was accused of helping furnish fuel for the fire, but did not enter the buildings where the fires were set.

Two adults were charged with making alcohol available to minors in connection with a party 7 miles north of Cross Plains that preceded the burning of the Cross Plains School. J.J. Higgins and Deidre Switzer were charged in an Eastland County Court on the alcohol charges, as the party took place in southern Eastland County.

Deidre was given a probated sentence and Higgins had his probation revoked due to the alcohol charges and was sentenced to 4 years in TDC on previous charges.

The alcohol charges were filed by the Texas Alcoholic Beverage Commission whose investigation was spurred by the arson fire in Cross Plains. An estimated 50 Cross Plains youths attended the party said officials.

Cory Lee Switzer's case was the last one connected to the fire which resulted in approximately \$1 million in damage, and required aid from Rising Star, Baird and Brownwood to assist the local fire department extinguish the flames.

City Hall Explains New Street Signs

At the October regular meeting of the Cross Plains City Council a lengthy discussion was held concerning the need for installing new street signs in the city. The placement of signs at each intersection for 4th and Main Streets was considered. During the discussion it was noted that the current 911 maps, for the City of Cross Plains, were incorrect which was a cause for confusion. The council investigated correcting the maps before buying and installing the new street signs. The council instructed City Secretary, Debbie Gosnell, to contact the 911 office in Abilene to see what the effects would be if the city changed the names of the streets to correspond with the new 911 addressing

At the November regular city council meeting Gosnell informed the council that she had spoken with the 911 office and according to them, it would not be difficult to change the street names and that whatever the city decided to do would be fine with them. The discussion was tabled until the next meeting so further information could be gathered on whether to change the street names or to change the house numbers to correspond with the

The December regular council meeting brought more discussion on the matter and the council then decided to change the names of the streets, that run east and west, from 1 through 16 to correspond with the 911 addressing system.

Since the December meeting the city has been working on getting the names changed, signs ordered and other details that would need to be worked out for the transition.

At the regular April meeting of the city council a concerned citizen met with the council and expressed her interest concerning the changing of the street names. The citizen stated that no one she had spoken to was in favor of the name change and most weren't aware that the change was taking place.

The council felt it appropriate to address the issue in an article to inform the citizens of Cross Plains of what they (the council) were trying to accomplish with their decision

The council had three options in this matter:

1. Do nothing and leave the addresses as they are, which would leave incorrect maps and street numbers causing confusion in finding addresses.

2. Change the street numbers 1 through 16 to correspond with the current house numbers and addressing system.

3. Change all the numbers in town, and leave the street names as they are.

It was the feelings of the council that the most economical and logical solution was to change the street names and be done with the matter. This would inconvenience the least number of people and therefore, the council thought this was the best solution for the problem.

Cross Plains Postmaster Sammy Bien said, "We will work with the city in any way possible to make a smooth transition to the 911 addressing system." The local post office still uses the 1 through 16 street numbering system in the

"We have changed to the 911 addressing on the rural routes already," said Bien.

Callahan County Dispatch Supervisor Linda Dennis said, "We have had some problems finding addresses in Cross Plains possibly due to the confusion on the street numbering." Callahan County Dispatch handles the local 911

"When the city's 911 addressing system was set up, by an Abilene company, they divided Cross Plains at 8th Street and started north and south numbering on the streets," said Cross Plains City Secretary Debbie Gosnell.

"The way all the 911 maps are drawn up, the old 8th Street will become 1st Street," said Gosnell, "then the first street to the south will be South 2nd and the first street to the north will be North 1st." Highway 36 will become South 5th Street instead of 4th

The streets will then be numbered progressively to the edges of town. Address numbers on homes will not change, just the street numbers on the streets that run east and west.

The council always welcomes any comments from citizens either at the council meetings or just a phone call to the City Hall. However, when discussions such as these are being addressed by the council, please let your feeling be known before action is taken by the governing body so that inconveniences can be avoided.

The members of the Cross Plains City Council know that not everyone will agree with this decision. The matter was decided on what the council thought would be the best solution for the city as a whole with the information that was on hand at the time.



County Volunteer Honored by State Legislators Recently

A Resolution honoring Mrs. Betty Hardwick of Baird was read on the floor of the House of Representatives and again in the Senate Chamber on April 22 in Austin. The Resolution was written by State Representative Bob Hunter to recognize Mrs. Hardwick for years of work on behalf of Texas with mental disabilities.

Mrs. Hardwick has been a member of the board of trustees of the Abilene Regional MHMR Center since 1982, has served on the Board of Directors of the Texas Council of Community MHMR Centers since 1985 and the National Community Mental Healthcare Board of Directors since 1996.

The Resolution recognizes Mrs. Hardwick's exemplary civic dedication, remarkable accomplishments, and ner tireless and dynamic advocacy for individuals with mental disabilities. She was instrumental in getting legislation passed that improved treatment and daily living

conditions for all Texans with mental retardation living in Intermediate Care Facilities. Mrs. Hardwick led the effort that established a self-insurance risk pool for Texas community MHMR centers, which has saved hundreds of thousands of dollars in operational costs and allowed these savings to be redirected to consumer services. She helped establish a statewide retirement program for employees of MHMR centers, and she led the initiative to get legislation passed that established a bond program to enable community MHMR centers to finance capital improvements.

Other honors include: 1974 -Outstanding Young Women in America; 1989 Governor's Public Service award; 1992 Frank M. Adams award for outstanding volunicer service, 1994 Mary B. Butt award for outstanding service by a board member in the Texas MHMR system; 1995 - Leadership for establishing the Texas Council Risk Management Fund.




Anymore, I'm really careful to shake out the laundry before it goes in the washer.
