I don't think we give cattle enough credit for intelligence -- they remember well. Ferdinand and Rudy always came up to us in the field and didn't have any reservations. After all, we were their life-line until they could fend for

Taylor Electric customers suffered outage during storm on March 10

Taylor Electric customers in the Cross Plains area suffered an extended outage on Friday, March 10. Around 7:30 a.m. electric power to approximately 700 Cooperative customers went off and remained off until Friday night, when power was restored around 8:20 p.m.

The problem started with a storm that went through the Callahan County area and knocked down six transmission line poles just south of Putnam belonging to West Texas

phase distribution line which also is owned by West Texas Utilities. This three phase line distributes power to Taylor Electric customers from the Cooperative's Scranton metering point. The distribution line was also knocked down along with the 69,000 volt transmission line. Although Taylor Electric purchases it's power from WTU for this area, the lines that were damaged belonged to WTU. Therefore, the Cooperative could not work to repair them and had to rely on WTU to make the repairs and restore power to our metering point which in turn would restore our customer's electric service. Taylor Electric had a crew standing by all day to assist if asked and to make sure we didn't have lines downs as well, as it turned out no Cooperative lines were down. The poles to replace the six that were destroyed did not arrive on the scene until after 3:00 p.m. Friday afternoon. Once the poles arrived, the WTU crews went to work and restored power to our metering point at 8:30 p.m.

Taylor Electric officials have been in consultation with WTU officials to see if we can work together to avoid this kind of situation in the future. We strive to meet the needs



National Agriculture Week is time to honor our farmers & ranchers

AUSTIN -Agriculture Commissioner Susan Combs announced that March 19-25 is National Agriculture Week in Texas, the nation's second leading state in agricultural production. Texas accounts for about 7 percent of the total U.S. agricultural income.

'Agriculture is important to Texas 52 weeks a year, but National Agriculture Week is the time set aside each spring to honor the hardworking individuals in our nation's food and fiber industry," Combs said. "It's also the time to recognize the impact agriculture has on our daily lives."

"The food we eat, the clothes we wear, the wood for the houses we live in, the flowers and plants we enjoy are all rooted in one industry-agriculture."

Agriculture is the second-largest industry in Texas generating \$80 billion throughout the state's economy. Texas is the nation's leading producer of cattle, sheep, goats, horses, wool, mohair and cotton. The state is also one of the top producers of vegetables, citrus, peanuts, pecans, grain sorghum, rice, sugarcane and wheat.

"From the Gulf Coast to the Panhandle, Texas is the most diverse state in the nation in agriculture production," Combs said.

The Lone Star State leads the nation in the number of farms and ranches, and approximately 80 percent of the land is involved in some form of agricultural production.

Although agriculture provides a job for one out of every five working Texans, less than 2 percent of the population is involved in day-to-day farming or ranching.

"It's incredible when you think that only a small number of people produce our food and fiber," Combs said. "Andy many times they do it against difficult odds.'

"This year producers are facing another drought and some of the lowest commodity prices in the past 20 years. But because of their commitment and their love of agriculture, Texas farmers and ranchers will continue to do what they do best -- produce food and fiber to meet a growing global demand," Combs said.

"We all depend on agriculture. National Agriculture Week gives us an opportunity to recognize those producers who help enrich our



City Council Minutes

March 7, 2000

This was a regular meeting of the Cross Plains City Council. All members of the council were present. Minutes of the last meeting were approved as read.

Don Gosnell, Chief of Police met with the council to give the monthly police report. He reported sixtythree calls for service, two assaults, one burglary, two criminal mischiefs, one terroristic threat, one theft, sixty-two warning citations, and sixty citations. By general consent the council approved the report as presented.

Bob Hill also met with the council to give the Judge's report. He reported sixty citations being given for the month of February with twenty-six remaining outstanding. He also reported twenty-one remain outstanding for January and twelve for December. He reported twentynine reminder letters being sent. By general consent the council approved the report as presented.

Sam Miller, with Energy Savings Consultants, Inc. met with the council to discuss a device his company provides that will save on the City's energy bills. He estimated that the city would be able to save a minimum of \$216.00 monthly by using their system. He informed the council that for \$295.00 his company would do a proposal on the entire city's electrical system and present it to the council at the next regular meeting. If the council rejects the proposal the \$295.00 will be refunded. If the proposal were accepted, then there would be other costs associated with the system that will be discussed at the time of the proposal. Jerry Cassle moved to allow Energy Savings Consultants to do the proposal. Joe Ingram seconded and motion carried. Cecil Barton met with council to

discuss the Cross Plains Public Library's annual report, the statistics report and the annual budget. Also meeting with the council was Mary Chaffin and Joan McCowen. Mr. Barton gave a very informative report on the hopes and dreams of the Library. He thanked the council for their past support and asked that the council consider increasing the city contribution from \$2,500 to \$5,000 when working on the City's budget. The council thanked Mr.

Barton for coming and stated they would consider his request later in the meeting when working on the budget for the city.

Bob Harrell, Fire Chief, met with the council to ask their permission to apply for a tax identification number for the fire department. He informed the council that he had discussed with an attorney the benefits of getting a tax number and was informed that the fire department would be more likely to receive grants if they weren't operating under the city's ID number. Ray Womack moved to allow the fire department to file for their own tax identification number. Joe Ingram seconded and motion carried.

Frankie Hyles met with the council to discuss that the Roping Club and the Barbarian Festival would like to have the portion of Turkey Creek that runs through Treadway Park cleaned out and a bridge put across the creek to use during the events; that are held throughout the year. He stated that they would like to request that the prison inmates come and clean out the creek but was informed that they could not make the request and ask that the City make the inquiry on their behalf. James Nichols moved that the city would make the request to the prison system. Jerry Cassle seconded and motion carried.

Jerry Cassle moved to pay the bills. Edwin Weiss seconded and motion carried.

Joe Ingram moved to go into executive session to discuss personnel at 8:20 p.m. Edwin Weiss seconded and motion carried.

Discussion concerning personnel was held at length.

Jerry Cassle moved to return to open meeting at 9:55 p.m. Edwin Weiss seconded and motion carried.

By general consent the council agreed to meet for a budget workshop on March 14, 2000, at 6:30 p.m. and to hold the Budget Public Hearing on March 30, 2000,

Jerry Cassle moved to adjourn. Joe Ingram seconded and motion carried.



Perhaps you've heard the "story" (fictitious?). The marriage counselor was trying to surface the basis for problems a couple was having. There were more problems than he even anticipated for when he asked if they had a grudge, the husband thought he said "garage" and answered, "No, but we have a carport." And the rest of the "story" gets even worse!

Willard Tate, in his book, <u>Habits of a Loving Heart</u>, identifies the seventh "habit" or characteristic of love as "holds no grudges." He lifts these qualities of love from the great "Love Chapter of the Bible," I Corinthians 13. The last of verse 5 states that "it (love) keeps no record of wrongs" (NIV). In other words, love holds no grudges. In a nutshell, love forgives. In a more realistic marriage counselling session, each mate was asked to make a list of the other's faults. They each began to make their list, the wife not noticing that her husband was erasing as much as he was writing. The counselor asked them to each read their list to the other and the wife obliged by reading her long list of "grudges." Then the husband displayed a sheet of paper that was blank, basically, because everything he had written down had also been erased. He explained that he loved her so much that he could not hold her faults against her. Perhaps the only improvement for him in that respect would be not seeing her faults in the first place.

Mark Twain said it well: "Forgiveness is the fragrance the violet sheds on the heel that has crushed it." Learning to forgive others can be a life-changing experience -- and probably begins by accepting God's forgiveness and forgiving oneself. Remember, you cannot afford to have



Betty Beggs to Receive Howard Payne University Degree at age 76

In many ways, Betty Beggs is a typical college student. This spring, she's enrolled in Childhood Development, Introduction to Sociology and Computer Graphics. She spends hours surfing the Internet, and she's making plans for life after graduation. The only thing that separates Betty from the rest of her classmates is her age.

At 76, Betty will fulfill a lifelong dream in May when she completes her studies for the Bachelor of Applied Arts and Sciences degree at Howard Payne University.

"Usually on the first day of class, students who do not know me look me over pretty good," said Betty, who commutes to class three days a week from her farm near Cross Plains. "But, they always accept me and treat me as just one of the

Betty's pursuit of a college degree began in 1940 when, upon her graduation from high school, she studied medical technology for one year at a junior college. She then worked several years in clinics and hospitals while her husband, J.T. Beggs, managed Singer stores. He was often transferred in his job, so Betty would attend nearby colleges to work on her degree. She earned most of her college credits at Texas

Christian University in Fort Worth. When her husband decided to purchase a farm near Cross Plains in 1956, Betty chose to stay at home with their young sons. During this time, she completed a correspondence course in art and worked toward certification in medical technology. When her sons entered school, she worked as a medical technologist in De Leon until 1975 when she resigned to help husband with the responsibilities on the farm as their sons moved away.

Following her husband's death in 1994, Betty wanted to find something to keep her busy. She recalled earlier days when she shared stories with her family of her days as a college student. Those memories, along with the desire to finish her degree, led to Betty's decision to pick up where she left off

In 1998, Betty enrolled at HPU where she will earn the B.A.A.S. degree, a program designed for nontraditional students who can receive college credit for prior study and life experience. For Betty, that was an open door.

"The thought of returning to college to earn my degree was always in the back of my mind," she said. "And, I've realized it's never too late to learn.'

A challenge during Betty's recent transition into college was like that of every college student - deciding on a major. Her work experience and courses in medicine provided an option, but a lifelong interest in painting seemed more appealing. She enrolled in the B.A.A.S. program where she received credit for her previous college work, which included enough hours for a major in

"I decided that producing art was a lot easier then running up and down the halls of a hospital," said Betty, who has sold nearly 90 paintings through the years and currently has artwork displayed in the Sonshine Tea Room in Brownwood.

Following graduation, she would like to serve as a short-term missionary where she could utilize her background in medicine or art, and start a freelance commercial art

"It will have to be a part-time business, though, because I want to be the boss," she said. "I don't want to punch a clock. I"ve punched enough clocks in my life."

Betty said she found a home in HPU's computer lab, where graphics courses enable her to combine her artistic talents with design programs.

"I could easily spend four hours a day on the computer," said Betty, who admits she enjoys surfing the internet on her home computer.

Betty appreciates the willingness of faculty and students to help her succeed in her courses.

"I am very comfortable talking with teachers and students," she said. "There have been times when

a teacher has assigned a project and I've thought, 'What am I doing here?' But every teacher has expressed a personal interest in me and encouraged me along the way."

One of her most rewarding expereinces occurred last spring when she worked on a class project for the Brown County Historical Society's opening of the Brown County museum. Betty represented her student group on that project.

"I enjoyed that opportunity to meet poeple in the community and to work with students to design those materials," she said.

Betty looks forward to May 6 when she will walk across the stage to accept her diploma. Her cheering section will be full of family and friends.

"It will be a big thrill when I receive my diploma," she said, "but I will also take away more than a diploma. Howard Payne is a place where I like to be. There is something special about being a part of this school, and it will make my diploma that much more meaningful."
