

My name is Robert Irvin. I'm 10 years old and I live 7 miles north of Cross Plains.

My Mom read to us the story of <u>The Empty Egg</u> and it reminded me of my little guinea chick named "Little Fellow" that died and went to heaven the day after Palm Sunday.

He was born real sickly and blind in one eye. I would get up in the middle of the night to make sure he was OK but deep in my heart I knew he was going to die. I prayed he

wouldn't die.

We buried him in my back yard but

WAY, the TRUTH and the LIFE.

The Cross Plains Economic Development Corporation currently owns two buildings located at 400 South Main and 209 North Main Street. The ongoing goals of the Economic Development Corporation are to encourage, assist and create more jobs in Cross Plains. The Economic Development Corporation plans to grant these building, subject to certain conditions, to individuals or companies who will renovate, relocate and operate out of the subject building(s).

Requirements for all applications will be as follows:

\*Start-up businesses must have a business plan, projected number of employees, and a projected financial statement.

\*Existing businesses must have a business plan, current employment status and financial statements.

The Economic Development Corporation will provide interested businesses or individuals an application package which will include details about the subject buildings and the terms and conditions of the grant. The Economic Development Board will review all applications and approval will be at their discretion. The decision of the board will be subject to a public hearing and final approval of the Cross Plains City Council.



# State Qualifier's Results Announced for Local Athletes

Friday four Cross Plains High School track members traveled to McMurray University in Abilene to compete against state qualifiers from 1A to 5A in track and field. It was a quality practice meet because of the experience gained when you compete against the best people in the state, regarless of school classification.

Candice Francy finished 5th out of 9 in the discus throwing with 122'8". Brandi Richey finished 4th out of 9 in the 100 hurdles with a time of 15.14. Brandi won the 300 hurdles finishing 1st out of 5 with a time of 45.22. Brandi's 45.22 in the 300 hurdles set a new school record, beating her old record and state record of 45.65. You can only beat and set new state records at the state

meet in Austin.

Chris Kitchens placed 4th in the 300 hurdles with 39.31. Brandon Mahler placed 7th in the pole vault with 13' 6".

Ray Purvis received 140 votes and Gene Dillard 68. Dean Dillard garnered 132 votes, Jerry Cassle







## Final phase of Texas **Tommorrow Fund Told**

AUSTIN-Texas Comptroller Carole Keeton Rylander today kicked off the final phase of the current enrollment period for the Texas Tomorrow Fund, the state's pre-paid college tuition program. Enrollment ends June 5.

Comptroller Rylander also announced the fourth annual Texas Tomorrow Fund poster contest, and urged elementary and middle/ junior high school students throughout Texas to submit drawings of "What I Want to Be After College." The entry deadline for the poster contest is May 10. Contest rules and official entry forms can be obtained at local schools or on the Texas Tomorrow Fund In-Web site <www.texastomorrowfund.com>.

The elementary school winner and the middle/junior high school winner will each receive a four-year Texas Tomorrow Fund scholarship.

Rylander enrolled her 5-year-old granddaughter Kathryn Keeton McClellan in the program during an Austin news conference.

"Like most folks, I have waited until nearly the end of the Texas Tomorrow Fund enrollment period to sign up my eldest granddaughter," Comptroller Rylander said. "But now is the time to lock down Kathryn's 2013 college tuition and fees at today's prices and ensure that, when she is ready for college, those expenses will be covered."

"Nothing is more important than education," she said. "This generation will have to compete not only with those from New York and California, but from Europe and Asia as well.

"The U.S. Bureau of Labor Statistics predicts that by the year 2030, nearly 60 percent of Texans will have only a high school diploma or less," Comptroller Rylander said. "Yet in the next decade, 25 percent of the state's new jobs will require at least a bachelor's degree. The Texas Tomorrow Fund can help close the education gap by giving families a convenient, affordable way to ensure that their children and grandchildren get the college education they will need to plug into the jobs in the new information-based Texas economy.~

"Even if your child is a high school senior, it is not too late to enroll him or her in the Texas Tomorrow Fund, and avoid the tuition and fee increases some universities have announced for next fall," Comptroller Rylander said. "Obviously, the earlier you enroll your child, the more affordable the program is. ## Local Couple's Grandson to Play on All-Star Football Team This Summer in Germany

Caleb Taylor was one of two young men from Sonora Bronco's Varsity Football Team who accepted an invitation to play on an All-Star Football Team in Germany this summer. He will leave the states on July 10th for a week long stay in Frankfurt, Germany. They will join approximately forty-one other young men from the West Texas area, who played 2A football last season, to compete against a team from Germany.

Mr. Woodie Caffey, who teaches in Eustace, has a friend who coaches professional football in Germany. Football is not sponsored by the German schools, but instead, by businesses and the government. In fact, there are no athletics in their schools. They began football on military bases and it has developed into minor sports there.

Mr. Caffey's friend asked him to put together an all-star team and invited them over to play against their Junior Club team, which

consists of 16-19 year olds. This is equivalent to high school senior boys. Mr. Caffey prefers to select from 2A teams and to gather his team from around the West Texas area. This endeavor is done to create more interest in football among the Germans. About 25 football players were recruited from Germany. This has been considered a success and they are very excited about the tournament this year.

The U.S. boys will have practice each day and on the final day, they will compete in two games. The Germans contribute to much of the cost of the trip; however, the boys will need to come up with about \$1,600.00 each to help with the airfare, hotel and meals. # **County Extension Agent**

Time is approaching to start scouting for one on the most important nut-infesting insects of pecans, that is the pecan nut casebearer. The adult casebearer is a gray to almost black moth about 1/3 inch long. The moths are active at night, when they mute and lay eggs on pecan nuts. From research and working with producers we are confident that egg lay will occur 7-10 days after the first catch of the moth using pheromone traps. In Callahan County our first catches were made around May 5th. Eggs are oval, flat and tiny, just large enough to be seen with the unaided eye. Nut clusters with eggs can be tagged with a piece of ribbon and checked each day to determine exact hatch date. InsecCounty Extension Office at (915)

ticides need to be applied 1-2 days after first egg hatch. With catches on May 5th nut entry is predicted to occur 12-16 days after first catch which will be about May 17-21. However, proper scouting is suggested to determine the best time for insecticide applications. There are several formulations of products containing carbaryl, malathion, chlorpyrifos or diazinon that are labeled and packaged for homeowner use. Before purchasing and applying any insecticide, always read the label to determine if the product is labeled for use on the target plant or site. For more information contact the Callahan





# Callahan County's Jobless rate Falls to 4.1% in Month of March

The unemployment rate in Callahan County for the month of March 2000 fell to 4.1%, down three-tneths of one percent from the February rate of 4.4%, according to jobless figures released Monday, May 8 by the Texas Workforce Commission.

Of the 6,032 civilian labor force in Callahan County, 5,785 were employed during March 2000, and 247 were unemployed, giving the county an unemployment rate of 4.1%. The county's unemployment rate one year ago in March 1999 was 4.1%.

Callahan County's unemployment rate was 4.4% in February 2000. Of the 6,013 civilian labor force in the county during February, 5,746 had jobs while 266 or 4.4% were unemployed.

Previous monthly jobless rates in Callahan County included: 4.4% in January 2000, 3.9% in December 1999, 4.3% in November, 4.5% in October, 4.4% in September, 4.8% in August, 5.0% in July, 5.8% in June, 4.8% in May and 4.2% in April, according to the unemployment figures.

Big Country area counties, bordering Callahan County, and their unemployment rates for March 2000 include: Brown, 4.0%; Coleman, 4.8%; Eastland, 4.0%; Jones, 3.8%; Runnels, 6.0%; Shackelford, 2.7%; Stephens, 4.4%; and Taylor County, 3.6%.

The unemployment rate in Texas for March 2000 was 4.4%, down from the 4.6% unemployment rate reported in February 2000. The state's unemployment rate one year ago in March 1999 was 4.4%.

Of the 10,315,800 civilian labor force in the state, total employment was 9,860,500 in March. Total unemployment in March 2000 was 455,300.

The United States unemployment rate was 4.3% in March 2000. The U.S. unemployment rate for the previous month of February 2000 was 4.4%. The United States unemployment rate one year ago in March 1999 was 4.4%





#### *In the corner...*

Sometimes I just have to go stand in the corner. The corner !'m talking about is the southwest cornerstone of the property. It's way out back, out of sight of the house. A quiet place. A dreaming place.

We took an exploratory walk around the property the first week we were here, MyKeeper and I, and we ended up at that place. It seemed like the farthest point I have ever set my foot on this Earth. I stood and stared across the fenceline, feeling disconnected somehow, like we had come upon the gateway to the vast outer reaches of the uni-

Every time I go out there, the poet's questions begin. Who am I? Why am I here? What is the meaning of life? And mostly, how did I ever get here??

No road noises, or house noises, or town noises are heard this far out. From a long ways off the wind can be heard, whispering wait for me, I'll be there soon. Birds sing their songs with an enchantment that can't be discerned in the busy places back by the house. I always marvel at the remote feeling the place instills in me.

Right at this cornerstone, a solid, permanent stake pounded into the ground many years ago, I begin to wonder who has stood in this place besides me? I lean my elbows on the fence and before my eyes arises a watercolor mural that comes to life in brilliant color

First was probably the former owner, and before that, the surveyor who drove the stake into the ground. Then the days before fences parades before my eyes.

Visions waver in and out, a woman in a sunbonnet with her children, The People trailing a buffalo herd, a cowboy on horseback at dusk, soldiers with muskets. I always want to see an antelope playing, but I haven't yet.

Scenes change with a pattern of ocean waves. The time warp carries its own breezes, its own blue sky and waving grasses.

Years of storms have moved loudly across this ground. Billions of seeds have popped and crackled in the sun, right here. The hooves of the small cattle herd in the next pasture have likely sunk into the same footprints of other herds. The years have dragged a long line of seasons past this spot on the planet.

Beyond are the eons which laid down layer upon layer of earth's history, peopled and even before that. I float over the ages when coal was being pressed, and oil first greased the joints of continental crusts. I'm watching the surgings and ragings of a birthing Earth.

I find myself wondering if dinosaur feet have stood at this very spot in some ancient overlay of the Earth's historical geography. Before that time the world must have been without form and void, and I can't even imagine it. It is that incomprehensible thought which breaks my reverie, and I am back in the present, wondering how long I've been gone.

What a lot of life has happened in this spot where it seems nothing is happening. It makes me want to take off my shoes and bow my

# County to seek Attorney General's opinion

## **Hays Road name** change ends in 2-2 tie

Callahan County Judge Roger Corn did not cast a vote to break a 2-2 tie vote of the Commissioners' Court to change the name of Hays Road to Hays/Dugan Road, but the County Judge instead is requesting an Attorney General's opinion on whether the Commissioners' Court has the authority to change the name of the county

The Callahan County Commissioners' Court met Monday, May 8 at the County Courthouse in Baird to discuss approving a name change for Hays Road in Commissioner Harold Hick's Precinct #1. Hays Road begins on the north access road of I-20, runs north and turns back to the east where it intersects with FM 604 North.

Last month, commissioners received a request seeking the roadway name change from Hays Road to Dugan Road. Commissioners agreed to post a petition seeking public comment on the road change.

Judge Corn reported receiving several comments from individuals on both sides of the name change. Judge Corn said 11 individuals appeared before the Commissioners' Court asking Hays Road not be changed, while there were three individuals present at the meeting requesting the roadway's name change to Dugan

In an effort to appease both parties, County Commissioner Harold Hicks made a motion to change the name of Hays Road to Hays/ Dugan Road. The motion was seconded by Bryan Farmer.

However, the motion was deadlocked at a 2-2 vote with Hicks and Farmer voting yes and Commissioners Tommy Holland and Charlie Grider voting no to the name change.

Judge Corn, who has the authority to cast the vote to break the tie, decided not to cast a vote to break the 2-2 tie. Instead, Judge Corn will ask the County Attorney to obtain an Attorney General's opinion on whether the Commissioners' Court has the authority to change the name of a roadway. Judge Corn said he is requesting an Attorney General's opinion because he doesn't know if the Commissioners' Court has the authority to name a county road or change the name of a county road.

Judge Corn said he believes the Attorney General's opinion can be received in a timely manner. The County Judge said the item will be placed on the June Commissioners' Court meeting agenda.

#### **Bun Barry Resigns from County**

Callahan County Commissioners voted to accept the letter of resignation from County Tax Assessor/ Collector Bun Barry and appointed Tammy Walker temporary County Tax Assessor/Collector

The action was taken Monday, May 8 during the Callahan County Commissioners' Court meeting held at the County Courthouse in Baird.

Barry, who is completing his second term as Tax Assessor/Collector, will resign from the post effective July 1, 2000. Walker, the Democratic Party primary winner for the office of Tax Assessor/ Collector, is running unopposed for the position in the November General Election and will take the office of Tax Assessor/Collector permanently on January 1, 2001.

On a motion by Charlie Grider and second by Tommy Holland, commissioners voted 5-0 to accept the letter of resignation of Tax Assessor/Collector Bun Barry effective July 1. Commissioners, on a motion by Holland and second by Grider, voted 5-0 to appoint Tammy Walker temporary Tax Assessor/Collector effective July

Tax Assessor/Collector Barry has held the office seven years and seven months. He announced in December 1999 he would not seek another term as Tax Assessor/Collector. He would have relinquished the office of Tax Assessor/Collector December 31, 2000. Barry said he's resigning early to take a position with the Central Appraisal District of Callahan County

Central Appraisal District Chief Appraiser Rodney Lewallen confirmed Tuesday Barry will join the appraisal district as a staff ap-

praiser effective July 1. Lewallen said the position of staff appraiser has been open here since last August. Lewallen reiterated the appraisal district's budget will be unaffected by Barry's employment. In fact, Lewallen said next year's budget would be smaller than this year's budget. "There will be no increase in cost to the taxpayers or entities," Lewallen said of Barry's employment.

Lewallen reported he will be retiring from his position as chief appraiser here soon. The chief appraiser said he will become a parttime employee of the Central Appraisal District on January 1, 2001. Lewallen reported his retirement is tied to a business purchase recently in the Fort Davis area. Although working part-time, Lewallen said he will continue to appraise the oil and gas and utilities for the appraisal district as well as the administrative end of the chief appraiser.

The chief appraiser said the Central Appraisal District's board of directors will begin taking resumes for the position of chief appraiser in late 2002. Lewallen stated the Central Appraisal District will not automatically give Barry the job of chief appraiser when he retires.

Lewallen said all the school superintendent's in the county know about Barry's employment with the appraisal district and reported they have no problems with Barry taking the position.

Lewallen reported with Barry

moving one building west of the County Courthouse, he will still be available to help the tax office during their transition to a new Tax Assessor/Collector. "He will fill our needs and offer a smooth transition through the tax office," Lewallen said.

Lewallen said the hiring of Barry will expand the appraisal district's field appraisal force from 2 1/2 employees to 3 1/2 employees.

Other agenda items brought before the Commissioners' Court included:
