Several months ago we had a little calf whose mother either stepped on it after it was born and broke both back legs, or it was born that way. The first time Richard saw it on its feet it was walking on its knee joints and trying desperately to keep up with her mother.

He decided to place some splints on the little legs and see if they would heal. The heifer calf seemed to have a great desire to live. The wooden splints only lasted for a while before one was broken and not aiding the healing process.

The mother cow began leaving the calf by itself for long periods of time, and when the rain started she left her in a low place that usually floods. We found the calf, but she was too heavy to carry for such a long distance. Richard held her tail and she walked on her front legs to the pickup and he loaded her. He couldn't stand for it to drown after the struggle it had already survived. In the shelter of the barn, I held it while he took off the old splints and replaced them with plastic ones. This brave little calf never cried throughout the painful procedure. She did struggle a time or two when he was trying to straighten the worse leg.

Richard couldn't bring himself to destroy the calf because it had fought to live so valiantly. He called Clayton Thomas, a neighbor's son, and asked if he would like the calf.

Clayton gladly accepted and he and his dad, Carl, came in the pouring rain to pick up the new project. Clayton has done a remarkable job of caring for the calf and it is doing well. She can use all four legs at this point.

Clayton suitably named her "Stormy" because of the weather conditions on the day he received her, and due to the trials she has experienced in her short life.

Isn't it amazing what a little tender love and care will do?

Judge Corn reminded County residents if the Texas Legislature approves some type of Groundwater Legislation, a County referendum would have to go before County voters for their approval as well.

## Cross Timbers Southern Baptist Association Rally Meeting set for Tuesday, January 18 in Abilene

For a while the library "worm" has teased about Quanah Parker. Now it is time to "tell the whole story." The next book review sponsored by the Cross Plains Public Library is scheduled for Tuesday, January 30, at 7:00 p.m. at the Community Center.

And this is "double for nothing!" Not only will Bill Neely, the preeminent authority on Quanah Parker be there, but also Drew McDaniels, who is writing about the Comanche Indians of this area.

Neely is known as the preeminent authority on Quanah Parker, son of Cynthia Ann Parker, who was kidnapped by Comanches and grew up with them. His The Last Comanche Chief: The Life and Time of Quanah Parker is an outstanding book, with a foreword written by James A. Cox, grandson of Quanah Parker.

After a trip to the Panhandle-Plains Historical Museum in Canyon at the age of 7, Neely became interested in the people and history of the area. Through the year, he felt a kinship with the Comanche people, who had once made this land their territory. In 1986, he wrote a book about Parker, Quanah Parker and His People, and

has continued his study until today.

Appearing with Neely will be Drew McDaniels, until recently the Curator at the Museum of the Great Plains in Lawton, Oklahoma. He is also a consultant with the University of Illinois at Champagne-Urbana, in charge of the overall layout of their North America Indian Gallery.

Currently, McDaniels is working with the Callahan Historical Commission on several sites, prior to finishing his book about the Comanche-Spanish relations in the borderlands of Texas and New Mexico. McDaniels has been adopted into the Quanah Parker family of the Comanche tribe by Baldwin Parker, the oldest living grandson of Quanah Parker. Baldwin Parker has given McDaniels the name of "Quiseicay," meaning "soaring eagle."

The Library Board is fortunate to have both of these men here at the same time. Please share the information with friends and encourage them to come. As usual there will be refreshments and available books for sale. Please come.

The appointment of members to the Callahan County Salary Grievance Committee, the County Historical Commission and appointment of two directors to the Weather Modification Association highlighted the Callahan County Commissioners' Court meeting held Monday, January 8 at the Commissioners' Courtroom at the County Courthouse in Baird.

On a motion by Commissioner Bryan Farmer and second by Commissioners Tommy Holland, Commissioners voted 5-0 to approve the composition of the nine-member Callahan County Salary Grievance Committee. The committee is made up of six elected County officials and three public members.

County Judge Roger Corn said the three public members are drawn from the Grand Jury list of registered voters. Those three public members include: Leona Breeding of Clyde, Priscilla Alldredge of Clyde and Tommy Hudspeth, who lists an Abilene address.

The six elected officials named to the committee included: County Sheriff Eddie Curtis, Tax Assessor/Collector Tammy Walker, County Treasurer Diane Alexander, County Clerk Jeannie Bohannon, County Attorney Allen Wright, and District Clerk Sharon Owens.

County Commissioners, on a motion by Commissioner Harold Hicks and second by Judge Corn, also voted 5-0 to reappoint the current list of County residents to the Callahan County Historical Commission.

—On a motion by Commissioner Farmer and second by Commissioner Holland, County Commissioners voted unanimously to adopt the existing rules for on-site sewage facilities in Callahan County.

—On a motion by Judge Corn and second by Commissioner Farmer, County Commissioners voted 5-0 to approve the bonds for the newly elected County Officials.

—Commissioners received a petition from Butch Nelson to close County Road 711, which is located in Commissioner Hicks Precinct #1, to public traffic. The roadway, which is approximately 1/2 mile long, is located between County Road 110 and County Road 112. On a motion by Judge Corn and second by Commissioner Hicks, Commissioners voted 5-0 to post the petition for 20 days to receive public comments on the road closing. The County Commissioners will take up the petition matter at the February Commissioners' Court meeting.

—Commissioners were to meet with John Young concerning possible maintenance on a neighborhood road in Commissioner Precinct #1, however Mr. Young was not present at the meeting and no action was taken by the Commissioners' Court.

—On a motion by Commissioner Hicks and second by Commissioner Grider, County Commissioners voted unanimously to pay all approved bills.

—On a motion by Commissioner Farmer and second by Commissioner Grider, County Commissioners voted 5-0 to adjourn the Commissioners' Court meeting.

# TxDOT announces 2001 call for enhancement projects

ABILENE, Texas - The Texas Department of Transportation (TxDOT) has announced the 2001 Call for Project Nominations under the Statewide Transportation Enhancement Program.

The Transportation Enhancement Program is a statewide competitive program and is administered by TxDOT in accordance with applicable federal and state rules and regulations. Approximately \$130 million will be available for the selection of eligible candidate projects under this Call.

Bill Leach, Abilene district enhancement coordinator, said that transportation enhancements are provided under the federal transportation legislation Transportation Equity Act for the 21st Century (TEA-21).

"The program includes transportation-related activities that contribute to the livelihood of communities, promote the quality of our environment and enhance the aesthetics of our roadways. Transportation-related activities include landscaping and scenic beautification, bicycle and pedestrian facilities, historical preservation and rehabilitation and operation of historic transportation buildings, structures, or facilities such as historic railroad facilities and canals," Leach said.

Currently, transportation enhancement projects in the Abilene district include a visitors center at Fort Phantom Hill, historic walk trail in Albany, Forts Trail museum in Abilene, and phase two of the preservation of a World War II hangar in Big Spring. Past transportation enhancement projects in the Abilene district include historic preservation work at the Jones and Shackelford county courthouses.

Leach also stated that the funds provided by this program is on a cost reimbursement basis and is not a grant. Projects undertaken with enhancement funds are eligible for reimbursement of up to 80% of allowable costs. The governmental entity nominating a project is responsible for the remaining cost share, including all cost overruns.

Completed nomination forms are due at the Abilene district office located at 4250 N. Clack in Abilene no later than 5:00 p.m. on June 18, 2001. Project selection will be made by the Texas Transportation Commission in November 2001.

Program guidelines, eligibility requirements and nomination forms are available at the Abilene district office or by calling Leach at 915/676-6831.

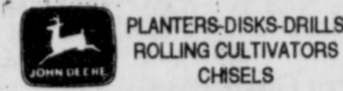

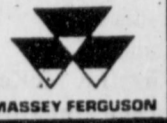

## Direct deposit more important than ever

Social Security and Supplemental Security Income (SSI) benefits for almost 50 million Americans will increase this month. Now, more than ever, it is wise for folks who receive SSI and Social Security to get their payments the 21st Century way. That means electronically, through Direct Deposit. Leave the 19th Century horse-and-buggy paper check method behind.

Direct Deposit is the safest, simplest and most convenient way to receive a payment from the U.S. Treasury. Anyone who receives Social Security, SSI, Rail Road Retirement or Veterans benefits is eligible to use Direct Deposit at a bank, credit union or savings and loan. If you already have a bank account and want to sign up for Direct Deposit, simply tell your banker the next time you go in to deposit your Federal payment. Most banks offer low cost or no-cost accounts to senior citizens and people with low incomes.

The U.S. Treasury has created a new type of account that is completely electronic. It is called the Electronic Transfer Account or ETA. Any financial institution who agrees to offer the ETA must allow any Federal payment recipient to open an account. ETA accounts include a minimum of four transactions per month at a bank or ATM and at point of sale (POS) stores such as grocery stores and other chain department stores. The monthly fee for an ETA may not exceed \$3.00. This account is accessed by an ATM card or at the bank teller window, and there is no check writing. The fees may be lower and more transactions may be allowed depending on the institution.

By January 1, 2001, Texas will have a total of 64 federally insured financial institutions at 670 locations offering the ETA. To find a location in your area, call your local bank or credit union. You can also call 1-888-382-3311 or go to [www.eta-find.gov](http://www.eta-find.gov) on the World Wide Web. Texans who receive federal benefits can call 1-800-252-9240 for information.

## Holiday credit card bills will shock many

Rockville, MD- "The gifts are opened. The parties are ending. The decorations are being put away. Now comes the reality of facing the bills for all of the guilty pleasures from your holiday shopping trips," said Steve Rhode, president and co-founder of Myvesta.org, a nonprofit financial services organization. To help people deal with their money troubles, Myvesta.org is offering a free publication called *Avoiding Post-Holiday Headaches*.

"Many holiday shoppers will be shocked when they open their credit card statements in the next few weeks," Rhodes said. "January is one of our busiest months because holiday overspending pushes people into debt problems." A Myvesta.org survey found that the average holiday shopper planned to spend \$1,220 on holiday gifts.

The free publication coaches people to take control of their spending and track expenses so they can find enough extra money to pay off their bills in six months. "The most important thing," Rhode added, "is to pay more than just the minimum payment due on your credit card bill. If people pay just the minimum on their holiday debts, their total cost skyrockets." By making minimum payments on \$1,220 at 18 percent interest, it will take 22 years to pay off and interest payments will top \$2,500.

"Make 2001 the year to break free and rise above the superficial 'stuff' that drains wallets and keeps you in a perpetual cycle of debt," Rhode said.

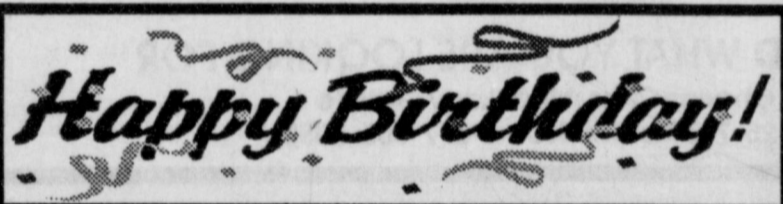
