Reeves Well Flows On Drillstem Test

The Superior Oil Co. No. 1 Brennand-State, one-mile south outpost to the three-well Chapman Deep (Fusselman) gas field of Reeves County, was bottomed at 15,875 feet, and operator was preparing to perforate opposite the Fusselman.

It has a 5-inch liner hung from 15,161-15,875 feet, and is plugged back to 15,870 feet.

It indicated production with the flowing of gas at the estimated daily rate of 6 to 8 million cubic feet, on a 1/2-inch choke, during a seven hour and 20-minute drillstem test from 15.725-15.875 feet. Gas came to the surface in nine minutes and the 2,000-foot water blanket began surfacing in 12 minutes. Recovery was 1,448 feet of drilling water, plus 13.2 cubic feet of gas from the sample chamber.
