CONSCIENCE MONEY SENT AFTER PERIOD OF THIRTEEN YEARS

Money Enclosed in a Letter to a Local Firm to Pay for Small Articles Man Says He Took From Their Store When He Was a Boy — Says He Has Found the Lord.

Here is a text for any minister of the gospel today, anywhere. It is a continuous sermon in itself. There are many stories of "conscience money" returned after many long years. Many communications of this kind find their way to the national treasury, from persons who may have defrauded the government in all sums, from that of a postage stamp to thousands of dollars, but it is seldom, if ever, that there has been noted a letter of this kind in apparent greater sincerity than one received by the Red Front Drug company of this city, yesterday.

The name of the town from whence it came, and the name of the writer of the letter, which was signed in full, will not be disclosed, although, from the tenor of the letter, he would not hesitate to tell the story to the world, because the letter is written in a hand indicating education and it carries with it that something about a letter, which the recipient can not tell what it is, nor why it so impresses him, as he reads it, but it ever does.

The act to which he refers was an occurrence of almost thirteen years ago, when the man writing the letter was probably only a boy and the little, petty pick-up theft was trivial, or at least, would be very generally so considered, but how it has weighed upon his mind, since he came to the realization of it being a wrong is seen by the letter in which he enclosed money, seeking to make restitution and secure forgiveness, following his conversion to belief in the Christian religion. The letter is as follows:

"Dear Sirs—Enclosed is check for two (\$2) dollars.

"Christmas week, about 1907, I was in Cisco with some other boys, and took from your store a box of checkers, the price of which was 20 cents. I took, also, a writing pad and pencil, and know not whether I took anything else or not.

"I do not mean to go to the judgment with these things on my life. I promised God if He'd forgive my sins and save my soul I'd straighten up the past as far as possible and by His grace, as these things come to my remembrance, I'll do it.

"I beg your forgiveness, and if you are a Christian, pray for me, if not, give your heart and life to God, because there is something in it."

LARGE COMMITTEES NAMED TO PREPARE FOR THE EXCURSION

General Committee Met Tuesday Afternoon and Named Many Others — Everybody Requested to Work Energetically to Make This the Largest Excursion Ever Going Out of a West Texas Town.

If the activity noted in the meeting of the committee from the Chamber of Commerce and Production yesterday afternoon at 4 o'clock is continued until the day of the excursion to Breckenridge that town is going to be literally overrun with people from Cisco.

The committee had been given authority to add to their number or appoint other committees. They appointed several committees and these will all find something to do to keep them busy, for it is expected that every individual will put forth his or her best efforts to make this the largest excursion ever going out of a West Texas town.

The date of the excursion has not been fixed nor can it be until word is received that the remainder of the track into Breckenridge has been laid and that trains can run over it. This is expected daily. When this word is received notice will be given the members of all the committees when they will meet together and arrange for the final efforts to make the excursion a big success.

As has been stated, Waco is going to send a large number to join with the Cisco people here and go to Breckenridge. There will no doubt be many people there from other towns and cities and it is going to be a big day in Breckenridge.

Breckenridge is Cisco's neighbor, only a few miles away, with that distance to be virtually wiped out with the laying of the last rail on the Cisco & Northeastern railway.

AN ORDINANCE TO PREVENT PEDDLING, HAWKING, OR AUCTIONEERING WITHIN THE CORPORATE LIMITS OF THE CITY OF CISCO.

Be it ordained by the City Commission of the City of Cisco:

Section 1. It shall hereafter be unlawful for any person to peddle, or auction off, on the streets, alleys, sidewalks or parks, within the corporate limits of the City of Cisco, Texas, dry goods, notions, wearing apparel, jewelry, patent medicines, nostrums, appliances for healing, spectacles, eye glasses, hardware, chinaware, glassware, pictures, crockery, groceries, leather goods of any kind, sewing machines, talking machines, kitchen utensils, furniture, electrical utensils and appliances, heating irons, or any produce or fruits bought for resale, excepting, however, articles, wares, or products manufactured, produced or raised by a manufacturer, mechanic, nurseryman, farmer or butcher, when sold by the manufacturer, mechanic, nurseryman, farmer or butcher, manufacturing, producing or raising the articles or products, sold.

Section 2. Any person violating any of the provisions of this article, shall upon conviction, be fined in any sum not less than \$5.00 nor more than \$50.00, provided, moreover, that each sale in violation of this article shall constitute a separate offense.

Section 3. All ordinances, or parts of ordinances, in conflict with any provision of this ordinance, are hereby repealed.

This ordinance shall take effect on and after its passage and publication.
