

Nelson, like all the greatest commanders on sea or land, made his mistakes and his failures, but there is only one instance on record of his having been actually defeated in a direct attack. This occurred at Santa Cruz, in the Canary islands, on July 24, 1797. The place was very strongly fortified, and Nelson, in the face of a fire of fifty guns from the batteries, attempted to storm the town by boats. The attempt was frustrated by the strength of the mole and the nonappearance of a land force which should have co-operated. A hundred and fifty men were killed and a hundred wounded on the British and Nelson fost his right arm Two flags were also captured, and these are still kept in the Cathedral of Santa Cruz.




