Some species grow altogether beneath the water, attaching themselves below the lowest tidelevel; others frequent heights where they are left dry at every retreating tide, while others yet are found in situations where they are searcely ever covered by water. Whereas most of them attach themselves to rocks or solid bottom, keeping to the shallows, there are exceptions to the rule, among which the most remarkable is the sargasso or gulf weed, which floats on the surface of the ocean. Immense fields of it are seen by the navigator, extending as far as the eye can reach.
