

When the Lady Broncos arrived at the San Angelo Central Softball Complex last Friday, they were met with the visiting Wall team in the home dug out, a large air horn parked outside the gate, and several banners proclaiming the attributes of the team from Wall. One of the banners proclaimed that "Only Champions Walk Through These Gates". The Lady Broncos proved that banner correct, as they walked through those gates to get to the other dug out. (Even though being the Home team - they were forced to sit in the hot sunshine of the Visitor dug out.) The tone was set for what was to be another classic 2-A softball match up.

Meghan Krieg would strike out the next three batters to end the top of the inning. In the bottom of the second, the Lady Broncos would go in order to leave the score knotted at one run apiece. In the top of the third, Wall would open up with a single to right field by Zapata. Zapata would steal second and advance

## Sonora High School learns about Shattered Dreams in reinactment

The Shattered Dreams program was presented to Sonora High School last week. Shattered Dreams is a Texas statewide program aimed at the reality and consequences of students who drink and drive. It also shows what can become of anyone who chooses to ride with a drunk driver.

The program started with sounds of the crash and Dispatch toning out the police, fire and ambulance services. The junior and senior students were then directed to the crash scene.

Four students volunteered to be the victims in the vehicles. Zed Snodgrass portrayed the drunk driver.

As Zed was having his

rights read to him and subsequently arrested, emergency personell were removing the "injured" and "dead" victims and placing them on the ground in front of the students. One student was covered with a white sheet and put in a body bag, before being taken away by Kerbow Funeral Home. Other emergency personnel used the Jaws of Life to extricate the victims of the second vehicle involved. Norbert Ortiz portrayed the driver of the second vehicle. He was the second fatality after being pronounced "dead" at the hospital. The other passengers in Norbert's vehicle sustained numerous injuries. They were Perla Perez and Courtney Caruthers. Laura Word

was pronounced "dead" at the scene.

All patients were extricated just as if it were a real accident. Everyone was C-collard and then backboarded with all being taken by ambulance.

All patients were transported to the hospital and stayed overnight at the Lighthouse Community Church as part of the program.

The Grim Reaper played Texas State Trooper, Earlie Williams, was also on scene with five souls he had already collected that morning. The Reaper went from classroom to classroom every 15 minutes to "touch" a student volunteer. They would then leave the classroom and have death

makeup applied to their faces. Then return to class and not talk to anyone, as they were "dead.'

The next morning a wrapup assembly was held featuring those who played roles in the previous day's drama, including the "crash" victims, the drunk driver, their parents, and participating law enforcement and medical personnel. The comments and impact statements from community members whose lives have been affected by teenage alcohol use and teenage DWI helped bring closure to the program and reinforce its dual message for the teenage audience -- Don't drink until you are 21, and never drink and drive.



I just walked up to a machine, did not sit down, and put a hundred dollar bill in. It was a ten dollar machine and I pressed the button once and that was twenty dollars and I pressed it again and that was forty dollars and then I hit \$19,600." Thirty minutes later, she was at another slot machine on the opposite

side of the ship. "I played that machine and hit \$2,800. I had a lot to show for thirty minutes of playing. Then I went back to Bossier City when Willie Nelson was there and hit the jackpot again. On that machine where I won the nineteen thousand dollars, I've hit three other jackpots on that same machine." When someone wins a jackpot, the casino takes a picture of the player standing by the slot machine, which shows the amount won.

Jan has stacks of those pictures. She giggles when she shows them to guests. "I'm pretty lucky. Everybody wants to go with me. People will ask me if they can touch me for good luck."



Q. Were there really saloons on Main St. in the old days?

A. Yes. But they weren't supposed to be there. When the town was founded and the first deeds were issued, there was a special clause in each deed that forbid the establishment of a saloon on Main St. of Sonora in the business district. Somehow this clause was dropped from the deeds during some future transfers of the property. It was not the intent of the founding fathers to have any alcohol sold on Main St. of Sonora. By 1914 we find 3 saloons on Main St., The Favorite Saloon with Theo. Savell, Proprietor; The Bank Saloon with J. W. Trainer, Proprietor; and The Rock Front Saloon with J. G. Barton, Proprietor. J. P. McConnell, L. L. Russell and George Allison and a few others had saloons on Main St. in the 1890's. Before the 1902 fire there was one saloon called the Maud S, named after a famous race horse. In the early days there were horse races, with side bets and a lot of gambling in the saloons on Main St. along with more than one shoot-out and a lot of trouble caused by the drunken cowboys. The early citizens were quite upset about the clause in the deeds being dropped, but since the men who had been behind it were the sheriff of Sutton Co. and his brother-in-law and another influential citizen, they couldn't do much about it.

Wentworth was founded by a group of citizens from Sonora who were angry that the sale of alcohol was allowed in the main part of town. Seems they didn't mind the cantina in Santa Rosa de Sonora but they didn't want it in their part of town. So they picked up their houses and moved them to Wentworth and put their new little town up against Sonora in the race for county seat. When they lost the race, and the ability to declare Sonora a dry county, some moved their homes west into Shamrock or Ozona. Some sold out their property and their houses were moved back into Sonora. The school/Masonic Lodge building was moved into Sonora and put next to the existing wood school building. The downstairs was used for classrooms and the upstairs for the lodge. When plans were made to build the Rock School, E. F. Vander Stucken bought the school/Masonic Lodge building. He sold it to the lodge with a small section of land with the condition they had to move it to that section. The current Masonic Lodge, built in the

1930's, is on the same piece of property.

Q. Do you have any information on the death of Susan Jane White?

A. Mrs. Susan Jane White departed her life on Saturday, March 8, 1914, at her home in Sonora, aged 73 years and 2 months. Deceased was survived by her daughter Mrs. W. A. Glasscock. Funeral services were conducted from the Methodist Church by Rev. J. L. Burns. Interment was in the Sonora Cemetery. The funeral was attended by a large number of friends and acquaintances. The pall bearers were E. F. Vander Stucken, Walter Davis, J. E. Grimland, W. M. Holland, E. S. Briant and A. Meckel.

Q. Do you have any information on the death of Ed Decker?

A. Ed Decker, who had been conducting the meat market in Sonora for the past few months, died at the Decker Hotel Monday night June 8, 1914, age 26 years. The young man came to Sonora from Menard where he was raised, and about three weeks ago was advised that he had been awarded the contract to carry the mail. from Menard to McKavett and was preparing to leave to fulfill that contract. Sunday evening he was stricken when at the Sonora restaurant with his friend H. H. Snow and was cared for by Mr. Snow until Monday evening when he was taken to the Decker Hotel.

Previous to coming to Sonora the young man had been stricken with paralysis on two occasions and had improved during his stay in Sonora. His mother, who lives in Fredericksburg, could not reach Sonora in time because of high water and road conditions and the interment was had in the Sonora Cemetery Tuesday at 2 o, clock. There was a large atten-

dance at the funeral, the stores having closed, the services at the grave were conducted by Rev. J. L. Barns of the Methodist Church and H. H. Snow also made a few appropriate remarks. E. F. Vander Stucken made all arrangements for the funeral at the request of the mother of the deceased, Mrs. A. Barnawsky of



We also found that H. R. Wardlaw, M.D. had his practice of medicine and surgery at the Corner Drug Store in Sonora. He was formerly House physician at John Sealy Hospital in Galveston. Dr. W. T. Chapman, the dentist, had his practice in the B. F. Meckel residence. Ota Smith of Eldorado was in Sonora a few days that week visiting his parents Postmaster and Mrs. G. W. Smith.

Hill and North, the local agents for the Ford sold a fivepassenger Model T. to L. P. Valliant this week. This business existed before Hull bought into the partnership. It was located across the street from the old Hull Ford House building. There was a small garage and sales area.



season. The Hospital Ranch Board has already given approval to fund the project. Carrasco moved, seconded by Faris to proceed with the completion of Suite B of the clinic.

Butler was pleased to report the accounts receivable average collection was at 66 days and the revenue was still holding steady. He also reported on the need to look for funding sources for new equipment in the new hospital. The board gave their approval for Keith to apply for grants to help purchase the new equipment and expressed their gratitude to him for his hard work on finding funding without costing tax payers.

Butler also reported that the hospital and wellness center construction is ahead by two weeks. There have been some unforeseen problems, with the existing water line for the fire sprinkler, meeting inspection codes. According to the architect, the cost to fix the existing line would be more than to just replace it with a new line. There is money in the contingency fund for this expense. The first level of fill for the wellness center is complete and the demolition of the old building is near completion.

The financial report for March was given by Michelle Schaefer. She pointed out the major increase in labor and radiology revenue over March 2003. Also noted was an increase in contractual due to the increase in revenue from the previous months. The Dispro payment received was above the amount expected.

April expenditures were approved as presented.

During visitor comments, Noemi Samaniego reported that Ms. Polonis had been in our emergency room a few weeks ago and was very pleased with our services. To show her appreciation she purchased a new Merck Manual for the hospital.




























I WENT TO A PARTY - The following poem was requested by a parent who attended the Shattered Dreams program.



# EXTENSION

The pecan nut casebearer is significant pest on pecans. The adult is a gray moth about 1/3 inch long. A ridge of dark scales followed by a band of lighter color runs across the forewing. This insect completes two to four generations a year. Overwintering larvae develop into moths that emerge in April or May.

Moths are active only at night, when they mate and lay eggs on pecan nuts. Eggs are oval flat and tiny just large enough to be seen with the unaided eye. When first laid, eggs are greenish-white. Tiny red spots soon appear on the egg, giving it a pink color before the hatch. Each female moth lays from 50 to 150 eggs during her five-to eight-day life.

First-generation casebearer eggs are typically deposited on the nutlets soon after pollination. Eggs hatch in four to five Young larvae crawl to days. nearby buds, and begin feeding, leaving empty white egg shells on the nut. The tiny larvae feeds for a day or two on a secondary bud at the base of a compound leaf before it enters the pecan nut. Larvae generally tunnel in at the base of the nutlet. They often destroy all nutlets in a cluster.

Casebearer larvae feed for about four to five weeks. Full grown larvae then enter the Pupa stage inside the nut. The new moth emerges nine to fourteen days later.

The most effective and reliable control method is a welltimed insecticide application(s) in Spring to hatching larvae before they tunnel into the nutlets. However, insecticides should be applied only if infestations and nut load justify treatment. These insects do not damage a tree, so, if only shade rather than a pecan crop is desired, treatment is unnecessary.

If a pecan crop is desired, treatment should be made for the first generation. It appears that for this year the window for spraying should be between May 19 and May 23. If you need a list of available insecticides, call the local County Extension Office at 387-3101.






