



### FOOD TOPICS By JUDSON STRONG

Mony of us think of nuts as a holi day treat but there is one nut which is a year round favorite.

is a year round favorite. The humble peanut, which is not realy a nut at all but a tuber, is our leading nut if we want to consider the matter statistically. We consume more peanuts than all other nuts to-gether. It is more of a year round product than a holiday specialty and it is never despised by the younger members of the family. There are two distinct types of peanuts, the larger type being known as the Virginia and the smaller as the Spanish. The and the smaller as the Spanish. The Virginia is the large nut that is sold in the shell while the smaller Spanish type is, usually encountered in salted peanuts and in peanut bars and brittle.

Peanuts are grown in a number of Southern States, as far south as Tex-as and Florida and north including Tennessee and Arkansas. Approximately one million and a half acres of farm land are used for raising peanuts. Recent crops have been in excess of a thousand million pounds

At present, picking peanuts is a commercial proposition. Picking mach-ines do the work-huge affairs driven by steam or gasoline engines, look-ing like threshing machines, go right into the field and do the job in days which used to take weeks by hand. The stacks are pulled up, pole and all, and carted to the packing mach-ine and before you would realize it the peanuts are in a large sack, ready

to be hauled to market. Not only are peanuts a universal favorite, eaten salted and in candy but peanut butter is one of the favorite American spreads for bread and a great favorite with children.

The decline here was due to lower gross revenue and net income, but motor vehicle taxes generally disregard either valuation or use and thus, while 8.9c of every railroad revenue dollar in 1932 went for taxes, the gasoline tax, one of 27 levies imposed upon motor vehicles, took 29c from every gasoline dollar.

WASHINGTON-An appeal to the young people of the Nation to unite, vithout regard for partisan political

affiliations, in supporting the Gov-ernment's recovery campaign, was sounded recently by Postmaster General Farley.

Speaking over a Nation-wid radio hook-up, Mr. Farley, who is chairman of the Democratic National Committee, said: "There are two points about which

I wish to speak to the youth of America.

"The first is that there are no politics in this movement. There is no desire for either party or a partisan advantage. The Chief Executive is just as much interested in the prosp rity of a Republican or a member of any other party as he is in the prosperity of a member of his own party. Humanity and justice and patriotism know no party, race or creed. This is a national movement. It is an American movement.

## **Grass** Project In Progress At **Experiment Station**

The Spur Experiment Station has 53 short steer yearlings on a grass feeding project. The cattle were purchased from the Swenson Ranch in


the Spring. The cattle are being used to convert pastures and surplus rough feeds into beef in preparation for next winter's feeding experiment. No grain more than is found on the bundle cane is being used in this work. The object is to get the cattle to put on as much gain as possible and very cheaply. Alfalfa, sudan and native grass are being used with the bundle

March 6 the cattle average weight was 413.5 pounds. Last Monday they were put over the scales and averaged 708.7 pounds. This made the gain average of 295.2 pounds per animal during the time, or a gain of 1.76 pounds per day.
