



The farmer's job used to be keep ing the nation's dinner table sup-plied. During 1935 he will work to help supply materials for one mil-lion Fords.

lion Fords. Ford dealers point out that the Ford Motor Company will purchase many products of the farm and the forest in order to complete its an-nounced intention to build one mil-

forest in order to complete its an-nounced intention to build one mil-lion cars this year. Here are some of the things that will have to be purchased: "3,200,000 pounds of wool requiring 800,000 sheep to produce it will go into upholstery, floor-coverings, lu-bricants and anti-rust preparations. The production of glues made from hides, glues made from milk, stearic acid, greases, glycerine, soap chips and 1,500,000 square feet of leather for upholstery will utilize 30,000 cattle. 20,000 hogs will supply lard oil for lubricants, oleic acid and briatles for brushes. The goat will yield 350,000 pounds of goat's hair for the mohair upholstery. This means that farms will sheat \$7,500 goats. Beeswax is not so much used as it was, but tons of beeswax will be used for electrical imbedding compounds. \$3,000,000 industious honeybees will produce this

No. 3 A JOINT RESOLUTION proposing an Amendment to Article XVI of the Constitution of Texas by XVI of the Constitution of Texas by striking out Section 20a to Section 20e, both inclusive; prohibiting the open saloon and vesting in the Leg-islature the power to define and en-act laws against such; vesting in the Legislature tre power to regulate the manufacture, sale, transportation and possession of intoxicating liquors, in-cluding the power to provide for a State Monopoly on the sale of dis-tilled liquors; providing that intoxitilled liquors; providing that intoxi-cating liquors shall not be manufac-tured, sold, bartered or exchanged in tured, sold, bartered or exchanged in any county, justice's precinct or in-corporated city or town wherein the sale of intoxicating liquors had been prohibited by local option election held under the laws in force at the date of the taking effect of Section 20, Article XVI of the Constitution of the State of Texas, until a major-ity of the qualified voters of such county or political subdivision shall county or political subdivision shall determine such to be lawful at an election held for that purpose; pro-viding that such shall not prohibit the sale of alcoholic beverages contain-ing less than 3.2 per cent alcohol by weight in cities, counties or political subdivisions in which the qualified voters have voted to legalize such sale under the provisions of Chapter 116, Acts of the Regular Session of the 43d Legrislature: providing for an the 43d Legislature; providing for an election on the question of the adop-tion or rejection of such Amendment; prescribing the form of ballot; providing for the proclamation and pub-lication of such by the Governor and making an appropriation thereof. 
Section 1. That Article XVI of the Constitution of Texas be amended by striking out Section 20a to Sec-tion 20e, both inclusive, and substi-tute in lieu thereof the following: "ARTICLE XVI Section 20. "(a) The area calcar chall be and

"(a) The open saloon shall be and is hereby prohibited. The Legislature shall have the power, and it shall be its duty to define the term 'open saloon' and enact laws against such.

Subject to the foregoing, the Legislature shall have the power to reg-ulate the manufacture, sale, posses-sion and transportation of intoxicating liquors, including the power to es-tablish a State Monopoly on the sale of distilled liquors.

"b) The Legislature shall enact a law or laws whereby the qualified voters of any county, justice's prec-inct or incorporated town or city, may, by a majority vote of those voting, determine from time to time whether the sale of intoxicating liquors for beverage purposes shall be prohibited or legalized within the pre-scribed limits; and such laws shall
