TEXAS STONE

As might be expected in the case of a State as large and as varied in nature as Texas, there are a good many things to be learned about it not noly by residents of other States but by Texans themselves as well. The Centennial offers a natural opportunity for teaching some of these things. So there is some thing peculiarly fitting in the announcement that selling to Texans as well as visitors the fact of how fabulously rich the State is in natural wealth and how these treasures in the main are practically undeveloped will be one of the major purposes of the natural resources exhibit at the Texas Centennial Exposition.

It is true enough that comparatively few Texans realize fully the tremendous range of their State's natural resources. For instance, there is likely to be a large element of surprise in the collection of the thousands of types of marble, rock and stone native to Texas that is being assembled for showing at the Exposition. This stone is declared by authorities to be ideal both for the important purpose of construction and for use in the manufacturing of novelty goods such as ink stands, ash trays and the like.

DETERMINATION OF MAXIMUM DEMAND

The maximum demand for billing purposes shall be the average number of kilowatts consumed during the fifteen (15) minute period of maximum use between the hours of 6 A. M. and 9 P. M., Sundays excepted, during current month. The Company will install a recording demand meter for the determination of Customer's maximum demand monthly.

RATE

\$2.00 per month per kilowatt of maximum demand for the first 100 kilowatts of maximum demand in any month

- \$1.75 per month per kilowatt of maximum demand in excess of first 100 kilowatts of maximum demand in any month
- .03 per kilowatt-hour for the first 1,000 kilowatt-hours used per month
- .02 per kilowatt-hour for the next 2,000 kilowatt-hours used per month
- .015 per kilowatt-hour for the next 12,000 kilowatthours used per month
- .01 per kilowatt-hour for all energy used per month in excess of the first 15,000 kilowatt-hours.

FUEL CLAUSE

The net energy charge per kilowatt-hour will be increased or decreased one-quarter mill (\$.00025) for each 1c, and proportionately for fractional part thereof, by which the average delivered cost of fuel to the Company exceeds 12c, or is less than 8c for that quantity of fuel containing 1,000,000 B. t. u.' s.

The Customer's monthly maximum demand shall, at the option of the Company, be determined either by estimate or measurement. If determined by estimate, 80 percent of the kilowatt equivalent of the Customer's connected load shall be used as the maximum demand. If determined by measurement, the average number of kilowatts utilized during the 15 minute period of maximum use during the month shall be taken as the maximum demand.

Under no condition shall a bill be rendered on a basis of less than (15) kilowatts of maximum demand hereunder.

MINIMUM MONTHLY CHARGE

Where customer's monthly maximum demand is determined by estimate, the minimum monthly charge shall be the demand charge.

Where Cutomer's monthly maximum demand is determined by measurement, the minimum monthly charge shall be in accordance with the demand charge covering the Customer's contract power requirements specified in contract covering service hereunder, which charge shall never be less than:

\$1.00 per month per horsepower for the first fifty (50) horsepower connected

.50 per month per horsepower for all over the first fifty (50) horsepower connected.

TERM OF CONTRACT

The obligations of both parties shall continue for a fixed term of three (3) years and thereafter from year to year until six months written notice is given by either party to the other of its intention to discontinue service.
