\$1137 more from the state this year to operate its schools than it did last year, State Supt. L. A. Woods estimated today. This is based on the assumption that the county will have the same number of students next year as it had last year.

Supt. Woods said the action of the state board of education in raising the per capita from \$22 to\$ 22.50 was another step toward bettering the educational faciliies of Texas.

Supt .Woods has led the fight r increased state per capita appropriations to schools since he came into office. The per capita when Supt. Woods was first elected was \$16, and it has been raised year by year until the \$22,50 mark has been established.

Supt. Woods pointed out that increased state assistance to schools, plus more efficient management and improved teaching methods have been largely responsible for ulum the student is now able to Texas being raised to the 18th educational rank in the union from the low mark of 36th which it held in 1932.

It is not expected that the additional per capita appropriation will increase state exependitures as a whole, Woods pointed out, since the scholastic population has decreased in some localities.

Summary Of Rearmament Bill The Patton Springs FFA chap- Recently Introduced To Congress

The Possum Kingdom Dam which is one of the project dams for Texas is reported completed at this time. The dam, however, will not start at present to serve the purpose for which it was built as a few tracts of land that were needed to complete the project could not be secured. However this matter has been taken

to a higher court, but no assurance of how soon it will be settled can yet be determined. The Committees for the dam

project met last week and made a trade with the contractor to release him, as his part of the contract was completed except for

the closing of the gates. The Park that is being worked in connection with the dam, consisting of some 5,000 acres, is going ahead as planned. This park when completed will be rated next to the best. At present the Federal Government has charge of it, and works some 125 men. It is thought that this work will later be done by the CCC boys.

These projects are one of the largest ever undertaken in Texas and the committees and everyone co-operating on this work should be given just credit.

EDITOR'S NOTE: The following is the summary of the Rearmament Bill introduced into congress by Senator Burke. Little action has been taken as to yet on the bill but it is being talked about more each day:

The Bill does not undertake to determine the number of men who should be in training or service in the Army or Navy. That is to be determined by the President and his military advisers, subject always to the provision that the President shall not call any persons for training or service until Congress has appropriated funds for such purpose.

The essential feature of the Bill are:

REGISTRATION. All male citizens and resident aliens between the ages of 18 and 65 except those enrolled in the armed forces of the United States, including National Guard and reserves, shall register.

CATEGORIES. Men registered shall be divided into two categories:

(a) Men between 21 and 45, for training and service in the land and naval forces.

(b) Men between 18 and 21, and 45 and 65, who shall be liable only for training and service in home defense units near their residences.

SELECTION. The men required at any time for training in peace and service in war shall be selected by lot, subject to the deferments and age groupings below referred to. Until completion of the registration and classification of the men between 31 and 45, the selection will be made from those between 21 and 31. In order that each group called for traning will represent a cross section of the eligible age groups, it hour and pictures made in the afshall be the ultimate objective that in the selection of men not more than 87% nor less than 78% shall be between 21 and 31(not more than 15% nor less than 10% between 31 and 38 and not more than 7% nor less than 3% between 38 and 45. DEFERMENT. The training and service of men whose employment in industry and agriculture is necessary to the national interest, ministers of religion, those with dependents and those who are unfit shall be deferred under regulations made by the President. Local boards shall pass on deferments TRAINING. Men who are selected and whose training is not deferred shall be trained during peace time for eight consecutive months. The period may be extended if Congress declares the national interest is imperiled. Vocational and educational training will be included and the men will have an opportunity to qualify for officer rank. Pay will be \$5.00 a month plus traveling expenses.

WHY AMERICA HAS A FARM PROBLEM

One of the big reasons for America's farm problem is the decline in the foreign market for agricultural products.

Prior to the World War, the United States was a debtor nation, and paid her debts by selling her agricultural products to her creditors.

After the war, America changed to a creditor nation. Up to 1929 at least part of the foreign market was held by making loans to other nations. When the loans were stopped, the farm export market fell off sharply.
