The first day we were issued our clothes and other things. Shoes, Socks, underwear, pants, shirts, ties, jackets, overcoats, hats, sweat shirts, towels, soap (hand and laundry), clothes pins, paper and pencil, tooth brush and paste, shoe polish, razor blades, foot powder, thread and needles and other things.

Sixteen men stay in a hut in double decked beds. We each have a job to do and we do it well. We keep our huts spotless. We have to have our sacks (beds) made a certain way, and we make them up every morning. We hit the deck (ground floor) at five thirty every morning. We then go to "chew" (meals). Twelve men eat at a table in our dining room which is a block long. We sure do get the eats, too. Chicken steak, fish, meat leaf, and all the trimmings. You get just as much as you want-second and third helpings. All the coffee and tea and milk you can drink. Ice cream for dessert, and we have the sugar bowl out in front of us which never goes empty.



Postal Department has devised a combination letter and envelope to be use by any person desiring to write men in service. This is known as V-Mail Service and is proving very economical in many respects.

Any one desiring to write to their son who isnow in service, or a wife, or sweetheast who desires to write any one in service, can secure one of these letter-envelope froms at the post office free. However, no person may secure more than three sheets at any one time. That is what is allowed for three letters. There is room for a nice message, a place to write the correct address of the one written to, and a place for your ENTERTAINED return address, all of which is required. Then fold the sheet in a
