



RED CROSS AIDS SEA SCOUTS.

In order that all the older boys in the sea scouts of the Boy Scouts of America may be thoroughly grounded in life-saving and the kind of swimming necessary to help another in the water, the First Aid division of the American Red Cross in Washington has detailed Field Agent W. E. Long fellow to co-operate.

He is at the national headquarters of the scouts in New York, and working with Chief Sea Scout James A. Wilder, whose scouting experiences in the South seas makes him a mine of information and source of inspiration to scout leaders all over the world.

Commodore Longfellow has been in Red Cross service for five years and has just completed a tour of army posts and navy stations along the eastern coast, teaching Red Cross lifesaving methods for water and land emergencies. More than 120,000 fighting men and civilians came under his instruction during the last year.

In the sea scouts, a boy who cannot swim and do life-saving cannot graduate from shore to rowboat activities; so that life-saving ability is one of the foundations of the sea scout training which the scout movement is offering the boys of America.





of New York, thi military training commission, is willing to recognize scout training as equivalent to the requirements of the military training law where the leader ship is adequate and it can be established that the members of the troop

actually receive the training made possible by the boy scout program. Under no circumstances will the Boy Scouts of America permit the en-

rollment of boys as members of a troop merely for the purpose of seeking exemption from the provisions of the military training law. As is made clear in the letter of

the Boy Scouts of America to the military training commission, the primary motive in asking for the special arrangement by the commission was to conserve for the leadership in the Boy Scouts of America those scouts sixteen years of age and over who were needed as patrol leaders, expert instructors and assistant scoutmas ters, and who could not in many cases maintain membership in two organizations.

BIG BOOST FOR SCOUTS.

National headeviarters received a letter recently from Gen. S. M. Foote, United States army, in which he says: "I have looked through the boy scout handbook and read a great part of it. One regret follows me all through the book, and that is that there was no boy scout movement when I was a boy. I shall keep the handbook as a book of reference for my own information."

Would that every man of high character who feels that regret should interest himself as General Foote is doing in making the boy scout movement known to more boys. 

The special narcotic committee appointed by former Secretary of the Treasury McAdoo to investigate the drug traffic in the United States has completed its report and presented it to Secretary of the Treasury Glass.

The report is of a most sensational character. It shows the United States as the largest consumer of drugs in the world, with more than a million addicts, and more than \$61,000,000 spent annually by drug users to satisfy the habit.

It also shows a national organization of "dope peddlers," who carry on a lucrative trade in drugs smuggled from Canada, Mexico and along the Atlantic and Pacific coasts.

Although the peace conference has already taken action to protect China from the spread of the opium habit, the report shows the United States to exceed China and lead the entire world in the consumption of opium. Our annual consumption of opium is so extensive as to be able to furnish 33 grains of opium yearly to every man, woman and child in

The committee's table for the per capita consumption by the United States and foreign countries is a grim story in itself. The table follows:

Ninety per cent of the drugs consumed in this country are used for other than medicinal purposes, and opium comes in this category, according to the report.

The traffic is increasing by leaps and bounds. Practically all of the larger cities report increase, and one estimate of the nation's number of addicts included in the report is 4,000,000 persons. The committee's figure of 1,000,000 is thereby shown to be conservative. One-quarter of these 1,000,000 drug users, or 250,000, are unemployed. In this respect alone the traffic caused the country an annual loss in wages of more than \$150,000,000.

It is estimated that 237,655 persons are receiving treatment in an effort to loosen the hold drugs have on them. The strides the peril is taking, though, are shown by the estimate that 18,299,397 narcotic prescriptons were filled in the last year.

One of the most painful features of the report is that depicting the native-born American as leading in the consumption of drugs.


