#### Feral Hog Hunters Should Take Precautions Against Swine Brucellosis

bodily fluids, concentrating in reproductive organs and milk. The bacteria can enter the human body through cuts, nicks, abrasions or other breaks in the skin. Hunters should be aware of the potential threat and use simple safety precau-

Everyone who field dress-es hogs should wear gloves and eye wear. Heavy rubber gloves are preferred in case of nicks from a knife. After field dressing the hog, hands should be washed with soap and hot water. Swine brucellosis apparently does not affect the edibility of the meat. As with all pork, it should be thoroughly cooked. The U.S. Department of Agriculture recommends cooking pork to an internal temperature of to an internal temperature of

160° Fahrenheit. Eight Florida hunters were diagnosed with swine brucellosis in 2007, while this year, a Texas man contracted the disease as he did not wear gloves while skinning a hog. Because swine brucellosis can have a long incubation time, symptoms may not be immediately apparent. Although few humans die of infection,

the disease is often chronic and debilitating.

This was the case for the man from Tomball, Texas, who did not feel symptoms until two months after field dressing a feral hog. As reported in the Houston Chronicle, his symptoms included a fever, chills, sweating and severe joint pain. It took doc-tors several days to diagnose swine brucellosis, which they treated with massive intravenous doses of antibiotics. Later, the brucellosis triggered an infection on his spine, and his prognosis remains ambigu-

Don't let the threat of swine brucellosis keep you from killing feral pigs. The feral hog population continues to expand, so it needs to be controlled. Just be aware that even though contraction of swine brucellosis is unlikely, preventive measures should be standard for those handling hogs. Also, if a hunter develops symptoms, he should tell doctors about any contact with feral hogs. Using safety measures after harvesting will significantly reduce the risk of contracting swine brucellosis.

## Flood Protection for Sonora

Recently, the Edwards Plateau Soil & Water Conservation District sponsored a tour of two of the Flood Control Structures that protect Sonora. Participants from county and city governments as well as interested citizens attended. Tom Payton, NRCS District Conservationist in Sonora, and Don Ford, NRCS Engineer from San Angelo provided information on how these structures function and answered questions.

There are two main watersheds that start north of Sonora, the Dry Devil's River and Lowrey Draw. These watersheds cover approximately 233 square miles or 149,210 acres in Sutton and Schleicher Counties. The two main tributaries of these watersheds come together at the southern end of the city limits.

There are 13 flood prevention structures located on these two watersheds. The estimated aggregate capacity of all these structures is estimated to be about 37,000 acre feet of water. Eight structures are on the Dry Devil's River and five are located on Lowrey Draw. These structures were built as part of Public Law 566 which is the Watershed Protection Act of 1954. This Act authorized a permanent nationwide program to provide technical and financial assistance to local watershed groups. The lead agency for carrying out this mission is the USDA-Natural Resources Conservation Service (formerly the Soil Conservation Service).

Since Sonora was founded, the city and nearby areas have suffered damage and loss of life when rainfall events on one of both of the watersheds sent flood waters into town. In 1954 Hurricane Alice dropped 12 inches of rain on the Johnson Draw Watershed in Crockett County. The subsequent flooding killed 15 people in Ozona and caused millions of dollars in damages. It has been said that if this amount of rain fell on the dry Devil's River/Lowrey draw watersheds, Sonora would have suffered a similar fate. Flooding in 1936 displaced about 100 families and a 3.5 inch rain in May of 1957 forced the evacuation of 22 homes. In 1958, the USDA-Soil Conservation Service (currently USDA-NRCS) entered into an agreement with the Edwards Plateau Soil and Water Conservation District (SWCD), Sutton County Commissioners Court, City of Sonora, Eldorado Divide SWCD and Schleicher County Commissioners Court to provide technical and financial assistance to build the 13 flood prevention structures. The Sutton County Commissioners Court was to be the primary sponsoring agent with the other organizations service as secondary agents. Work on gathering agreements and easements began in 1958. Design and construction of the dams began in 1959 with the last structure being finished in 1962. The original estimated cost of completing the 13 structures in 1958 was about 1.2 million dollars. The 13 dams were originally designed to control about 77% of the estimated runoff of a 100-year rainfall event. Should the rainfall event become too much for the principle spillway to handle, each structure has either one or two auxiliary or emergency spillways associated with them to take care of the flow.

Each dam is located on private property and owned by the individual. However, operation and maintenance of each structure falls upon the local or primary sponsoring agent. Each year the Sutton County Commissioners Court allocates funding to do any required maintenance. Inspections of the structures are done annually to see what work might need to be done. Primary maintenance practices include brush and weed control and fence repairs.
