## Second Degree Felony Theft: Ex Sonora City Manager Pleads Guilty

Former Sonora City Manager Dean Carrell pled guilty to second degree felony theft on February 10, 2012 in the 112th District Court in Sutton County.

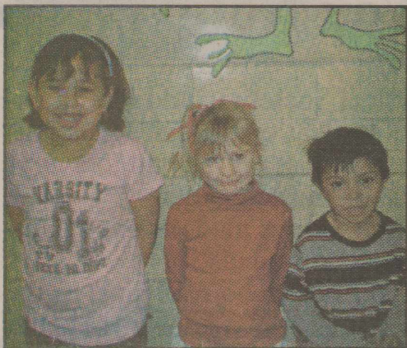
Mr. Carrell acted as the City Manager for Sonora in 2009, and was released of his duties within that same year. The specific date of the offense Mr. Carrell was charged on was

stated to have occurred on July 23, 2009.

The terms of his plea agreement are as follows:

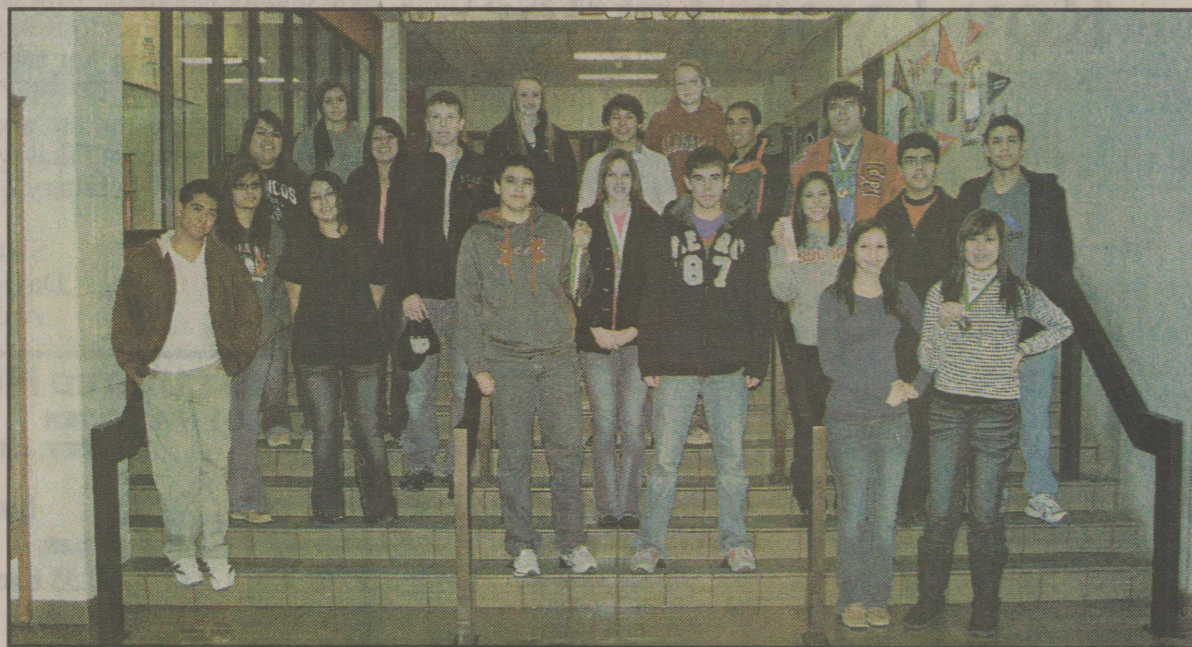
“Confinement in the Institutional Division of the Texas Department of Criminal Justice for a term of 10 years, suspended for 8 years on community supervision; \$1,000 fine; \$20,000 in total restitution (with \$10,000 of total restitution being owed solely by defendant [Carrell]; the remaining \$10,000 restitution shall be paid jointly and severally along with co-defendants; Defendant [Carrell] shall pay \$5,000 of his portion of restitution up front at time of plea, 240 hours of community service; \$249 court costs. A \$60 monthly supervision fee is required by the Court.”

## Regulations for Political Signs

The campaign season for the 2012 elections has begun. Candidates who are running for office are eagerly reaching out to their constituents to win their votes. There are many forms of “advertising” that candidates utilize to make their candidacy known.

Yard signs tend to be one of the most common method candidates use to get their name out to the voting community; however, there are rules and regulations that must be followed in order to use these signs.

The State of Texas has set the following rules regarding the use of political yard signs:

- Signs may NOT be placed on or within the right of way (including trees, telephone poles, traffic signs and any other object on the right of way)
- Signs may be placed on private property with the owner's permission
- Signs must be made of lightweight material and can be NO larger than 50 square feet
- Signs may be posted as early as 90 days before an election (NO EARLIER) and must be removed within 10 days after the election

It is also important to check with city officials for applicable ordinances before placing a sign inside of incorporated city limits.

Any placed signs that are a traffic hazard or in the right of way will be immediately removed at the sign owners cost, with no prior notice.

From 2007 to the present the city has lost a large part of its tax base. In fact the city has lost so much that it had to go into reserves for \$300,000 in 2010 and \$400,000 in 2011. Good policy and procedures require a certain percentage of the budget in reserves for a six month period and our city is already beneath that amount. The decisions that the people of Sonora must make in the near future are raise taxes, annex area around the city, cut services, or consolidate.

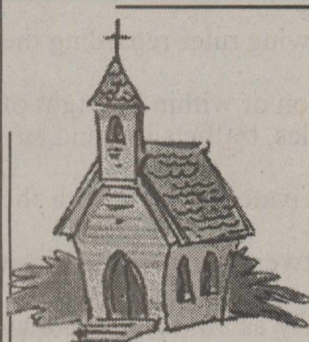

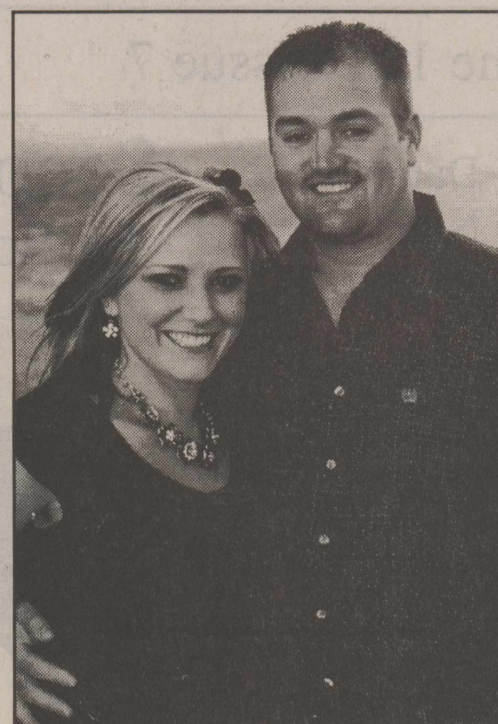

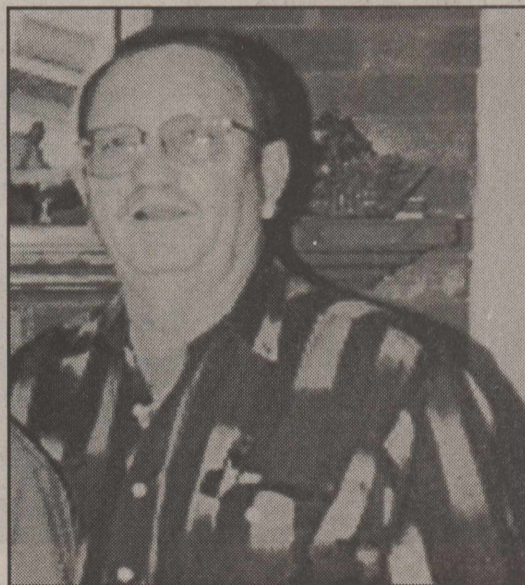

# Frank Otis Cloudt

Frank Otis Cloudt, lifelong resident and rancher of Edwards County, died Monday, February 13, 2012, at the age of 97. Born on the Cloudt Ranch, November 4, 1914, to pioneer ranchers, Frank and Theodore and Winnie Page Cloudt, he was educated in Rock Springs and Christoval schools, graduating from The Agricultural & Mechanical College of Texas in 1938, with a degree in Agriculture. While at A&M, he played football and lettered in track.

During World War II, Mr. Cloudt served his country in the US Army's 773rd Field Artillery, XX Corps, part of Patton's Third Army, receiving the Bronze Star Medal, the American Defense Service Medal and the EAME Campaign Medal with five Bronze Service Stars. After serving in the US Army Reserves, he was separated from the Service with the rank of Lt. Colonel. While teaching gunnery and survey at the Officers' Candidate School in Fort Sill, OK, he met and married the love of his life, Ruth Allison Fraser.

Frank Otis was preceded in death by his wife; a son, Frank Monroe Cloudt; his parents; sister, Wilma; and daughter-in-law, Dava West Cloudt.

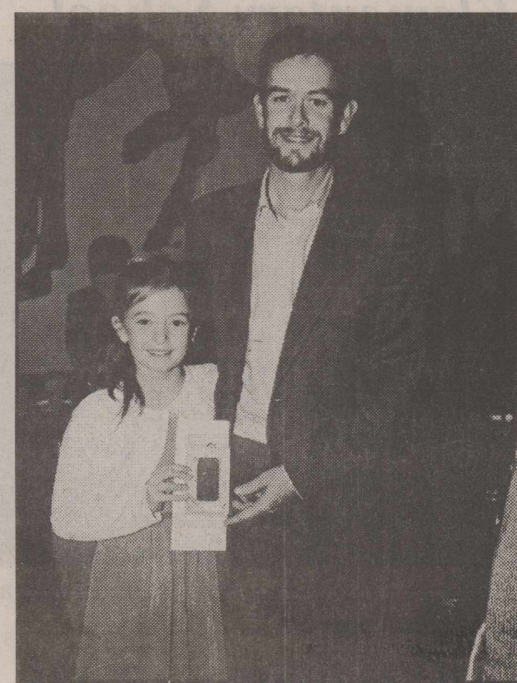

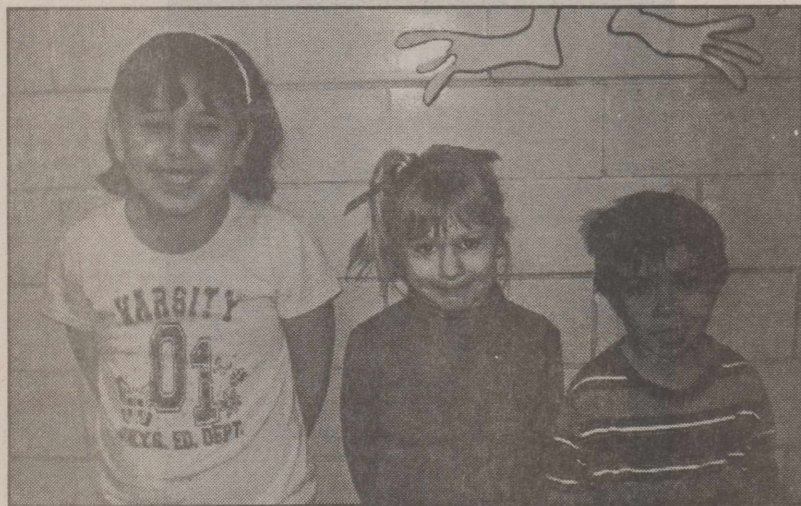

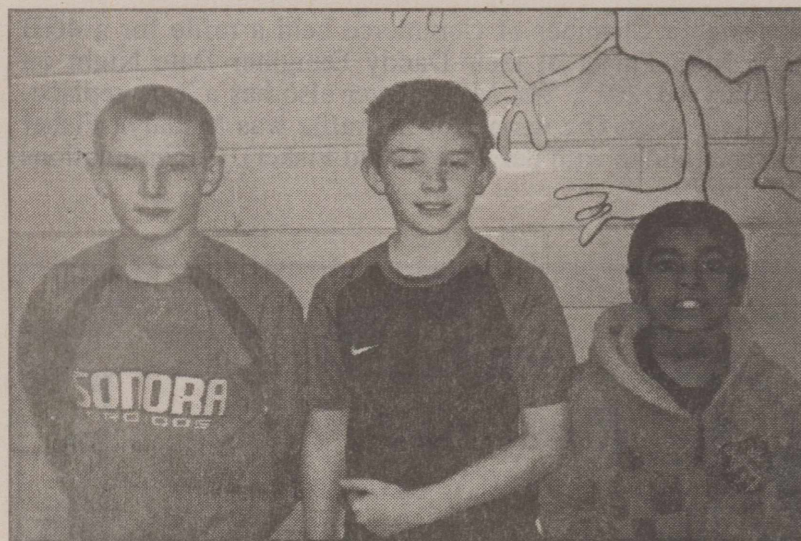

# Stomach Worms May Be Problem This Spring

Last year's drought did help in one manner- "stomach worms" were not a problem for livestock. However, with the recent rains and spring not far away, they soon may be. In warm, moist climates, the internal parasite that causes the most problems to sheep and goats is usually Haemonchus Contortus, better known as the "barber pole" worm. It is a blood-sucking parasite that causes blood plasma and protein loss. It is also the largest and most deadly stomach worm.

The symptom most commonly associated with barber pole worm infection is anemia, characterized by pale mucous membranes, especially in the lower eye lid; and "bottle jaw," swelling of fluid under the jaw. The barber pole worm is difficult to control because it has a short, direct life cycle and is a prolific egg producer.

A female barber pole worm can produce thousands of eggs per day. The barber pole worm is also capable of going into an arrested state when environmental conditions are not favorable to its development and resuming its life cycle once environmental conditions improve. These larvae do not feed or lay eggs and do no damage to their hosts while in this state. However, in spring they resume development and large numbers of eggs are shed into the pastures. When the weather warms up, larvae will be waiting to be ingested. They are less of a problem in arid regions, because parasites require moisture for their development.

Sheep are more susceptible to internal parasites than most other types of livestock. Their small fecal pellets disintegrate very easily thus releasing the worm larvae onto pastures. They graze close to the soil surface and to their feces. They are slow to acquire immunity. Sheep also suffer a loss of immunity at the time of lambing, which does not restore itself until approximately one month after lambing.

In the past, producers relied heavily on anti-parasitic drugs, called "anthelmintics" to control internal parasites. But the long-time use and in some cases misuse of these drugs has resulted in parasites that have become increasingly resistant to anthelmintics. That makes it important to use fecal counts to determine if treatment is necessary. You should also treat before parturition to destroy dormant larvae. (Read the label as using some dewormers during pregnancy may cause abortions). And remember to dose correctly and rotate dewormers. The dosage selected for all animals should be appropriate for the heaviest animal in that group (grouped by weight).

In the U.S., few anthelmintics are FDA-approved for use in sheep and lambs, and no new drugs are likely to be developed. As a result, producers must develop more integrated programs for controlling parasites, which do not rely exclusively on drug therapy.

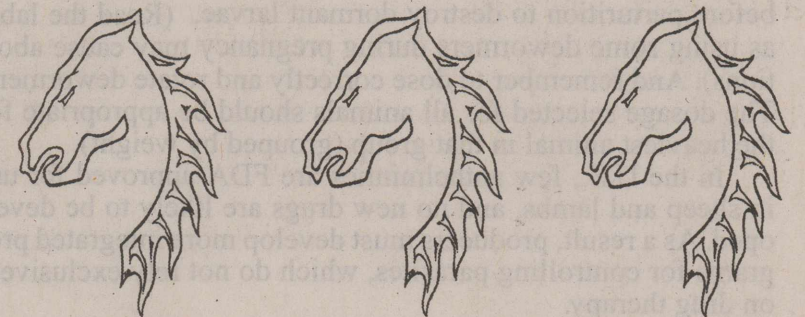
## Mother Nature Gets The Best Of Austin Golfers
