Long Jump:


Jared Willey leaped 19'1" for fourth place.





Since 1938, 272 TxDOT employees were killed in work zone-related crashed; 103 were killed by distracted drivers, 28 were killed on the shoulder or right of way, and 19 were killed while flagging traffic, the release stated. Three TxDOT employees have been killed in work zone areas in the San Angelo district, Threlkeld said. Charles Cobb died in 1964.

Carroll Jones, a 25-year veteran of the department, was killed in 1983. Vicente Morales, a 21-year old veteran of the department, died in 1990. A lack of respect

In addition to near-miss crashes and fatalities in work zone areas, TxDOT workers have to deal with disrespect from passing drivers.

"You just got to let it roll off your shoulders," said Israel Ortegon, maintenance supervisor. "It happens all the time. It seems like we are an obstacle between people and their destinations.

There is a disconnect, Ortegon said, between TxDOT workers and the public. "The public sees us as an inanimate object, like we're a cone, like we're not people."

Ortegon, a 16-year veteran for the Eden and Menard offices, has had two close calls while on the job.

"My first near-death experience we were called out to work on an incident involving a truck that lost a load of material," Ortegon said. "I was in the grassy area, and I heard a screech. I looked up and (a pickup) was rolling toward me. By the grace of God, I was able to see the truck and
