## Scrappy Eagles No Match For Thundering Broncos



At 7:05, a hot, calm summer-like day changed to a cold, windy evening. The Sonora Broncos were getting ready for a district game against the Grape Creek Eagles. The Eagles came into the game with a 3 and 2 record while the Broncos entered with a 2 and 3 record. The Broncos had faced four larger teams

and one smaller. This was the first game where Sonora faced an opponent in the same classification.

The game started with the Eagles kicking off to the Broncos with a howling north wind at their backs. The ball sailed into the end zone for a touchback. The first two runs by quarterback Andres Acevedo resulted in two first downs. The first play of the next series was an option pitch to Brett Castillo. The Eagles were ready for it, and the play lost yardage. The Eagles forced Acevedo to scramble on third down, and his pass to

The Sonora Broncos Junior Varsity football team has won and tied the previous two games after getting off to a rough start. The coaches have the team clicking both offensively and defensively. Last Thursday's game against the Grape Creek JV Eagles was the Broncos' district opener. It proved to be a good one.

The Broncos scored twice in the first quarter. After the eagles went three and out, a pitch to Jarrett Jackson, a quarterback keeper, Jose Hernandez on a counter play, and another option pitch to Jack-

son put the ball in the red zone. Kade Creek kept the ball and took it in for the score. The drive was capped off with a successful pass to Hernandez for the PAT at 3:36 in the first quarter.

The second Bronco touchdown happened shortly after the snap sailed over the head of the Eagle punter. Dakota Castro and Tanner Cain converged on the punter who was trying to cover the ball. They smothered both punter and ball on the three-yard line. Creek then handed the ball to Drew Buitron for the easy touchdown with the help

Noah SanMiguel on the sideline was incomplete. An Eagle broke through the Bronco line and subsequently blocked Acevedo's fourth down punt. Acevedo scooped up the football and tried to run for the first down.

The Eagles started their drive at the Broncos' 25-yard line. They used the spread formation primarily throughout the game. After two incomplete passes and one run for no gain, they completed a pass for first and goal at the Bronco seven-yard line. They scored a touchdown on their third running play. The scoring play was a run to the right between the center and the right guard. This would be a popular scoring play for the rest of the game. Grape Creek initially lined up in the swinging gate formation, and then they shifted into the normal kick formation. They kicked the PAT, and led 7 to 0 with 8:05 left in the first quarter.

After another touchback, the Broncos opened with handing the ball off to Castillo on the second man through. Castillo gained about 20 yards and a first down. Acevedo bobbled the next snap, but Elijah Cross picked it up and bulled his way for a nice gain. Moving into the shotgun, Acevedo faked the run and threw a quick, sideline pass to SanMiguel who gained enough for a first down. Back under center, Acevedo ran the quarterback keeper behind Cross as the lead blocker. Acevedo was run out of bounds near the 13-yard line. Acevedo scored untouched on the midline keeper to the left side of the line. As Grape Creek had done, Sonora lined up in the swinging gate, but HL James centered the ball to Acevedo who smashed his way into the end zone for the winning score. Sonora led 8 to 7 with 6:10 left in the first quarter.

Hunter Hughes got his first chance at kicking off into a hurricane. Whether it was an intentional onsidies kick-off or not is known only to the coaches. There was a big scramble to cover the football. When the pile finally got up, the Eagles had the ball with excellent field position.

If the Eagle coaches had been concerned that their offensive line could not run against the Bronco defensive line, they quickly saw it live when Ethan Patlan made the first tackle for no gain. Cross then blocked a pass and hurried a pass. The Eagles pooch punted on fourth down.

After a Bronco motion penalty moved the line of scrimmage back to the Bronco 15 yard line, Acevedo looked for a receiver. He was forced to scramble. With Johnny Manziel type moves, he made it past the offensive line and into the secondary. Once into the open, he sprinted the 85 yards for his second touchdown of the night. The Broncos lined up in the swinging gate. James direct snapped the ball to Kevin Martinez who made it into the end zone. But, the Broncos had lined up on the five-yard line instead of the three. The officials decided that one lineman (the center) and ten running backs/receivers was not a legal formation. After the five-yard penalty, the Broncos stuck with the swinging gate. Acevedo's pass was knocked down incomplete. The scoreboard showed that Sonora had a 14 to 7 lead with 4:45 remaining in the first quarter.

Hughes' kickoff was fair caught by the Eagles massive tight end. The first play was an incomplete pass. Grape Creek tried to run wide using a mis-direction handoff. Patlan and Martinez shared a tackle for a loss. Two incomplete passes then turned the ball over on downs.

Three plays later, Castillo scored a touchdown on the second man through. Hughes kicked the PAT making the score 21 to 7 with 1:25 left in

the first quarter.

On the first play after Hughes kicked off, Cross smashed some poor Eagle runner for a loss. After an incompletion, Martinez decided not to wait on Patlan as he recorded a solo sack for a big loss. For some reason that I cannot fathom, the Grape Creek quarterback tried a pooch punt on fourth down. Since he was at normal passing distance behind the line of scrimmage and without the element of surprise, Jonathan Martinez easily blocked it. Several Broncos tried to pick it up, but the ball kept squirting out toward the goal line. Finally, Michael Mungia recovered it at the two-yard line. Hughes came in as quarterback. He ran through the same hole as Grape Creek had done earlier for a three-yard touchdown. His kick made it just inside the right goal post, and Broncos led 28 to 7 with 23 seconds left in the first quarter.

The Eagles went three and out and punted to the Broncos. The strong wind caused SanMiguel to misjudge the punt, and the Eagles caught a break recovering the muffed fair catch. They managed to make a first down on their first completion. One incompletion and two sacks later, they punted into the wind.

Cross took the handoff from Hughes and sprinted around the left end for a 25-yard gain. Hughes completed his first pass of the night to Gus Barrera who moved the chains. A handoff to Bryan Garcia, followed by a keeper by Hughes, setup a first and goal from the eight. Hughes scored the touchdown on the same running play as he used on his previous touchdown. Grape Creek blocked the PAT. With 4:25 left in the half, Sonora led 34 to 7.

Hughes got his first kick-off with the north wind at his back, and he sailed it into the end zone for a touchback.

After three hopeless attempts to run against the Bronco line, Grape Creek punted. Like a golfer trying a knockdown shot to stay below a tree limb, the low punt hit one of the Eagle offensive linemen. Once again, the Broncos had great field position.

Hughes and Gabe Rollert hooked up on the pump and go. Rollert caught the football and was wrestled to the ground at the one-yard line. Castillo got the touchdown on the half back dive between the center and right guard. After the score, Castillo and James executed a perfect leaping, chest bump. Hughes kicked the PAT, and the score was 41 to 7 with 1:47 left in the first

half.

Sonora kicked off to the start of the second half. On Grape Creek's fifth play, Kevin Martinez intercepted and returned it 54 yards for a Bronco touchdown. He earned a chest bump from Castillo and Mungia. Hughes added the PAT. The scoreboard read 48 to 7 with 10:40 left in the third quarter.

Hughes kicked off with the wind, and the returner brought it out. Louis Castro made a solo special teams tackle. On the next series, sophomore Josh Galindo and David Torres helped stop the Eagle drive with tackles. After a couple of first downs, the Eagles managed a very good punt into the howling wind.

The Broncos started their last scoring drive from their 40-yard line. Carter Zook got a carry and gained seven yards. Hughes gained 15 yards on the quarterback draw. Garcia finished the scoring on the second man through run play. Garcia and Rico Rodriguez celebrated with a leaping side to side bump. To top off a fun night of football, Kevin Martinez and Garcia also bumped side to side. Hughes had his last kick of the night blocked. The final score of the game was 54 to 7. The game was suspended at 1:38 after a massive lightning bolt signaled the start of a down pour. Even though it was a district game, the schools decided to call the game due to the weather.

Hughes completed 4 of 6 passes for 59 yards while Acevedo completed 1 of 2 for seven yards.

Acevedo led all rushers with 154 yards on six carries and scored two touchdowns and one two point PAT. Hughes ran seven times for 43 yards and two touchdowns. Garcia gained 51 yards on three touches. He scored one touchdown. Castillo had 63 yards on five carries and two touchdowns. He also led the team in celebration jumps. Cross had 50 yards on four crushing runs.

SanMiguel, J. Martinez, Rollert, Barrera, and Zook all had one catch for 7, 8, 30, 14, and 7 yards respectively.

Fourteen Broncos made tackles. Cross led all tacklers with eight tackles with four being solo. Also, three of his tackles were for a loss. Jerrad Willey and Patlan each had seven tackles. Patlan had five solo and two for a loss, while Willey had one for a loss. K Martinez had four tackles with two being for a loss. He also had a pick six that covered 45 yards.

This Thursday, the JV Broncos travel to Crane, and the Colts are at home.

This week is our Homecoming as the Broncos continue their quest for a district championship when they play the Crane Golden Cranes. The Cranes enter the game with a record of three and three as do our Broncos.

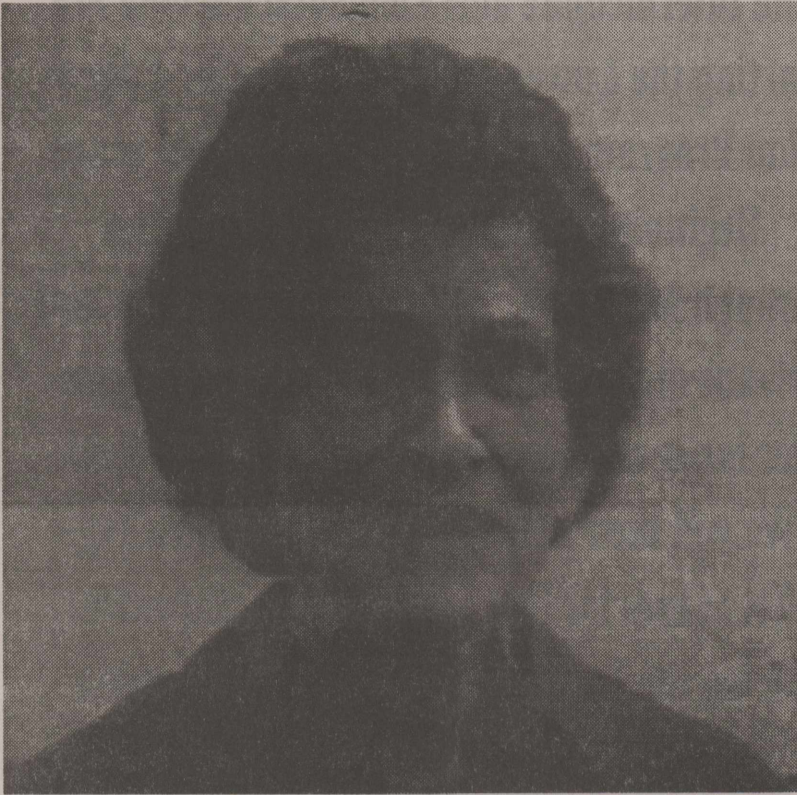

## Managing Habitat For Multiple Species Requires Planning

Excessive numbers of grazing or browsing animals is a concern for sound rangeland management. Many of our ranches have been impacted by years of overgrazing and drought. Managers have to account for livestock and whitetail deer. And for many, there is also the exotic game to contend with.

To be sure, this multi-species use of habitat provides opportunities, but it also requires planning. Current methods for estimating carrying capacity may not adequately predict stocking rate where flexible feeders such as goats and many exotics inhabit rangeland. Stocking decisions must reflect the unique arrangement of the ranch's resources and the manager's objectives. This requires an understanding of all species involved and of the rangeland resources.

For that reason, Texas A&M AgriLife Extension Service will conduct Wildlife Ranches: The Good, The Bad and The Ugly on Oct. 28 at the Sutton County Civic Center in Sonora. Registration starts at 8:30 a.m., and the program begins at 9 a.m. Some of the area's top professionals to answer some of the questions most frequently asked by game and wildlife managers, as well as those seeking information on feral hog biology and control.

The program's morning topics and speakers will include: White-tailed Deer Research, Ryan Reitz, Kerr Wildlife Management Area biologist, Kerrville; Basic Biology of Texas' Main Exotics, Mark Mitchell, Mason Mountain Management Area, Mason; and Managing Habitat for Multiple Species, Dr. Charles "Butch" Taylor, superintendent of the Texas A&M AgriLife Research Station at Sonora.

Following a catered lunch, the program will resume with presentations on feral swine research by John Kinsey, Kerr Wildlife Management Area research biologist, and conclude with a hunting season forecast by Mary Humphrey, Texas Parks and Wildlife Department game biologist at Sonora.

Three Texas Department of Agriculture continuing education units will be offered, one integrated pest management and two general. Individual registration is \$20 by Oct. 23 and \$25 thereafter and includes lunch.

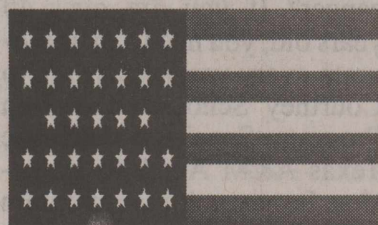
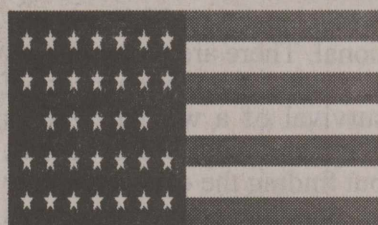

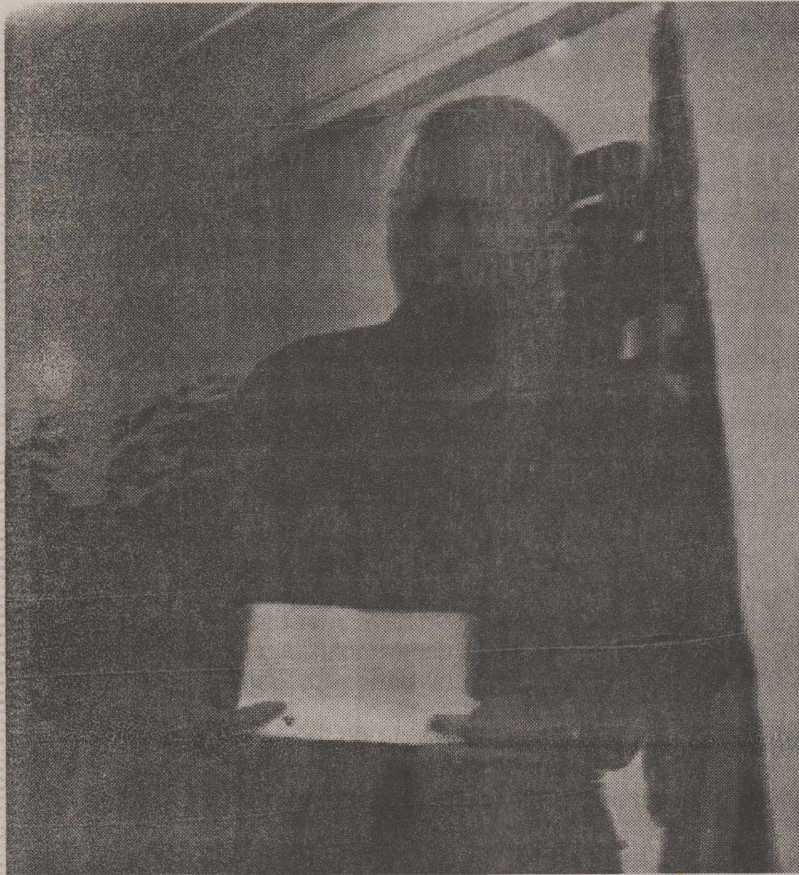

## National Breast Cancer Awareness Month

This following article was provided by Courtney Schoessow, Extension Program Specialist - Health, Texas A&M AgriLife Extension Service. It is being published in Sonora, TX for National Breast Cancer Awareness Month.

With the fall season now upon us, it is important to remember that October is National Breast Cancer Awareness Month. Today, breast cancer is the most common cancer among women in the United States and the second leading cause of cancer death among North American women, according to Jessica Stapper, Family and Consumer Sciences Extension Agent in Sutton County. Unfortunately, many women with breast cancer do not even know that they have cancer until it is in its advanced stages. It is estimated that 1 in 8 women will be diagnosed with breast cancer in their lifetime, and 1 in 30 women will die of the disease, Stapper says.

So what can we do to decrease our risk of dying of breast cancer? Early detection via health screenings, such as mammography, is an important step. Screening examinations can detect breast cancers early, before symptoms occur, which may make it easier to treat the disease. Screening involves getting mammograms, clinical breast exams, and self breast exams, which are optional. There are many factors in predicting the chances of survival of a woman who is diagnosed with breast cancer, but finding the cancer as early as possible greatly improves the likelihood that treatment will be effective.

When should women starting screening for breast cancer? If you are over 40 years old, you need a mammogram every year, according to Courtney Schoessow, Health Program Specialist with the Texas A&M AgriLife Extension Service. A mammogram is an x-ray of the breast that usually involves two views, or

pictures, of each breast. Mammograms help find lumps or growths that are too small for you or your health care provider to feel when conducting an exam. Additionally, women who are younger than 40 and have had breast cancer or breast problems or have a family history of breast cancer need a mammogram once a year.

A clinical breast examination is an examination of your breasts by a health professional, such as a doctor, nurse practitioner, nurse, or doctor's assistant. This exam is also known as a CBE. Clinical breast exams should be part of a periodic health exam, at least every three years for women in their 20s and 30s, and every year for women 40 and over. During your CBE, your health care provider may tell you how to perform a breast self-exam, or BSE. By regularly performing BSEs, you will learn how your breasts normally feel, and you will be able to report any changes in your breasts to your health professional as soon as you find them. Find-

ing a breast change does not mean that there is a cancer. You may choose not to do BSEs, or you can just do them occasionally.

Remember: The most important screening tools we have are mammograms and clinical breast exams. To reduce your risks of dying from breast cancer, you need to follow the guidelines on when to get them. Taking charge of your health now can lead to a healthier tomorrow. Start by getting screened this month in recognition of National Breast Cancer Awareness Month.
