Sonora First Responders Get Hands-on Training Using Jaws of Life

Sutton County and Sonora volunteer firefighters and emergency personnel gathered at the Sonora Fire Hall Saturday morning to take part in hands-on training to learn the latest techniques to extract injured people from cars involved in crashes. They also got the opportunity to learn how to use battery powered jaws of life. the high powered hydraulic tools and battery operated tools would help us do our job faster. We use the jaws of life at least once a month to get someone out of a vehicle."

Volunteers and first responders took turns using high pressure hydraulic and battery powered extrication tools powerful enough to cut through mangled metal with the precision of a surgeon's scalpel. and US Hwy 277 also increases the incidence of crashes involving entrapment.

Training these first responders from various departments at the same time is essential since they are so often called to assist one another.

"Modern cars are becoming more complicated every day and this makes rescuing crash vicincluding a car flipped on its side and a vehicle turned upside down, using both hydraulic and battery powered extrication tools.

Also, glass cutting and breaking devices were available to demonstrate how to safely remove windshields and windows with less risk of injury to the patient inside the vehicle.

Commissioners Recognize Local Eagle Scout for Outstanding Citizenship

The court also heard a presentation by Scout Dakota Castro for his Eagle Scout Project. Castro is raising money to purchase 10 bullet proof vest units to be worn by local law enforcement officers. To date, he has raised \$3000 towards his goal of \$4000 to purchase the gear.

"This is the best way to aid the men and women of law enforcement, Castro said. "Especially when they are the friends and family who serve in our community."

Donations are being accepted at the Sutton County Sheriff's Office. Castro's deadline is July 2017.

Federal Judge Sides with Plaintiffs in Planned Parenthood Case

AUSTIN — Texans who rely on Planned Parenthood as a medical care provider won't have to seek those services elsewhere, pending an upcoming trial.

In the lawsuit titled Planned Parenthood et al. v. Texas Health and Human Services Commission, U.S. District Judge Sam Sparks of Austin on Feb. 21 granted a preliminary injunction to prevent the Texas Department of Health and Human Services from eliminating funding for Planned Parenthood in the state's 2017-18 budget.

"There is no legitimate public interest in allowing Texas to complete its planned terminations (of funding) based on the current facts," wrote Sparks. "Instead, the public interest favors enforcing the individual

plaintiffs' rights and avoiding disrupting the health care of some of Texas's most vulnerable individuals."

Sparks found that an injunction would ensure that Medicaid recipients in Texas "will continue to have access to medical care at their chosen providers" and the Texas Department of Health and Human Service's termination of Planned Parenthood's provider agreements likely violates federal law.

Sparks ordered the plaintiffs and defendants to work out a schedule for presenting arguments within 30 days. The court will then schedule a trial date.

Texas Attorney General Ken Paxton expressed disappointment in the ruling and said he plans to file an appeal.

'Bathroom bill' continues

The Trump administration has reversed last year's Obama administration move to allow transgender students to use the bathrooms and locker rooms of their choice.

The civil rights divisions for the federal justice and education departments on Feb. 22 issued a joint "Dear Colleague" guidance letter reversing the controversial move last May.

In late August, a Fort Worth federal district court enjoined nationwide enforcement of the Obama administration's directive.

Meanwhile, Senate Bill 6 by Lois Kolkhorst, R-Brenham, is awaiting a hearing by the Texas Senate's State Affairs Committee.

The state legislation, considered a high priority by Gov. Greg Abbott and Lt. Gov. Dan Patrick, would require transgender students 🔀 By Ed Sterling to use facilities

Dead Man in the Road

Back in the 1960s flies and screw worms were terrible in the summer months. Ranchers did everything possible to fight this problem. I know I dusted my cattle, I put up oil ropes and finally sprayed with Co-Ral. This gives us the reason that this story happened.

I had gathered all my cattle and had my holding traps full after deciding to spray. At this time I did not own a spraying machine, but my neighbor on a large corporate ranch offered

me the use of theirs. So I got up early and with my son Charlie left to go over to Longfellow Ranch and pick up a sprayer.

This called for us to drive across the ranch to Bullis Gap Road then turn and go to US 90 about 3 miles

I returned to the location and began

enough.

to watch as I was instructed. A short time later a border patrol plane circled and with a loud speaker asked if he could help in anyway, I gave him a wave off and he left. About then the Terrell County sheriff and a deputy arrived and examined the body and decided that no violence had occurred that apparently the man had dropped dead with a heart-attack.

He and his deputy then turned the body over and removed his wallet for identification.

The license showed him to be a white male, 65 years old and from Fluvanna, Texas and named Malcolm Stavely. The sheriff had his deputy cover the body with a tarp as it was getting hot due to the sun. Then he told me he had called Pecos County as he was out of his county and had no jurisdiction here. After about an hour the chief deputy from Pecos County came and had with him the precinct JP and the undertakers wagon. This man ordered a coroner court into order and then examined the body. He found the man's levis were open as if he had stopped to urinate. Then he found that the man had fallen backward and was dead when he hit the caliche road as his head was bruised but no blood. At this point he declared Malcolm Stavely dead.

An Unusual Wedding Ceremony

Greg and Toni Bodin were married in a big chair during Old Sorehead Trade Days in Stanton, an event that draws people from all over Texas and beyond to shop for merchandise from vendors set up in temporary booths on downtown streets. Some people call it a big flea market.

Toni is six and a half feet tall and one day she was sitting on an upturned



bucket in her furnituremaking shop and decided to make a big chair that would be comfortable for her. She made

a huge wooden Adirondack chair, big enough to hold two people. It served as an advertisement for Toni's furniture booth at the trade days event.

Toni and Greg had been together a few years and in 2008 decided to tie the knot. They contacted the Martin County judge in Stanton and asked him to marry them during trade days. They wanted to be sitting in the big chair during the ceremony.

"Several people wanted to buy that chair that day," says Greg. "I told them they couldn't buy it until after three o'clock. That's when the ceremony was to take place. So at three o'clock a convoy of golf carts converged on our booth. We didn't tell anybody about our plans. We just decided to do it so people wouldn't make a big deal out of it and buy us a bunch of expensive gifts. We didn't want that. We just wanted to get married and be left alone."

Greg says the judge showed up with some Old Sorehead Trade Days officials to serve as witnesses. "We were sitting in the big yellow chair getting married when a guy came up and wanted to buy a piece of furniture. I didn't want him to get away, so I stopped the ceremony, made the sale, collected the money and told him I would deliver the piece of furniture to his vehicle as soon as I got done kissing the bride." Toni and Greg set up housekeeping in a two-acre fenced in compound in the community of Sand Springs just east of Big Spring. They put the oversized chair (ten feet long and six feet high) just outside the fence and it became a landmark. Interstate 20 is just a few yards away from their place. "We've had all sorts of people stopping to take pictures," says Toni, "sometimes as many as a dozen a week." The couple went everywhere together, volunteering at frontier forts in West and Central Texas, taking photos and exhibiting them in museums, colleges and other venues. Toni wrote a book about being tall (I See Short People) and made a movie about her favorite sewing shop that was closing. "We're good at saving money," Toni told me. "We have a wind turbine and solar panels to cut down on our electric bill. I supplement Greg's oilfield salary with eggs our chickens produce. I also sew for the public. I use a treadle sewing machine because it's portable and I can take it outside and sew. It's very quiet. I have a collection of those old sewing machines. I also collect wringer washing machines from the 1920s." Toni stays busy. Greg passed away in January at the age of 43. His memorial service drew a huge crowd.

to Longfellow Ranch. I saw a vehicle parked in the county road with

the drivers door open and the head lights on

but not moving. As I drove up to the car and started around it I saw a man lying behind the car on his back. Walking around the car and looking down at the man I saw that he was dead. Going back to his car I found that it was still running in park and idling. I cut the motor off and cut the lights off and saw a pint bottle of whiskey and a .38 special laying on the seat.

Now my son Charlie who was fouryears old at this time was standing on the seat of my pickup and looking at all this. He then ask me, "what's wrong with that man there on the ground Dad?" I answered him as I got in the truck. "Son the man is dead and we need to go back to the ranch."

Charlie asked "What for, to get a shovel and bury him?"

"No," I answered, "we must get to a phone and call the law to handle this." I then drove back to the ranch where I placed a call to the Sheriff at Sanderson, as that was the nearest law. He ordered me to go back and guard the location until he or his deputies could arrive on the scene. I agreed and left Charlie there as I felt a four-year-old boy had seen





The deputy gathered up all the belongings, the wallet, the whiskey, the pistol and a suitcase of clothing. He then informed me that I was subpoenaed to appear at a hearing in Fort Stockton the next day. They loaded the body and left for Fort Stockton.

The Sheriff congratulated me on doing everything in a legal manner and I thanked him for his cooperation. He asked about the car and I told him I would take it to the ranch for now as the man was a distant relative and I would notify his family about what to do with it. Later on I drove the car to Fluvanna and attended Malcom's funeral in Snyder, Texas.

Needless to say my cattle did not get sprayed for several days. So ended the tale of the "dead man in the road."





Sul Ross' Powers Wins All-Around Cowboy at San Antonio Showdown

Sul Ross State University rodeo standout Sam Powers, Sonora, won allaround cowboy honors at the first-ever San Antonio College Showdown, held Sunday, Feb. 12, in conjunction with the San Antonio Stock Show and Rodeo.

Powers placed third in the long round, third in the short round and third in average (18 seconds) in tie down roping, then advanced from an 8/9 split in the steer wrestling long round to place fourth in the short round and fourth in average (11.1).

He was the only competitor to place in the short round in two events.

Powers paired with Gunnar Latham, Martindale, in team roping, but they did not place.

Shay Hudson, Spring Branch, qualified for the short round in barrel racing with an 8/9 split (16.27 seconds) in the long round. Hudson finished seventh in the short round (16.34) for an average time of 32.61 on two runs.

'Sam turned in a superior effort in winning the all-around cowboy," Sul Ross rodeo coach Jacob Gernentz said. "Overall, these rodeo athletes represented Sul Ross very well this past weekend and have done an outstanding job thus far this season."

Powers currently is tied for sixth in tie down roping (155 total points) in the National Intercollegiate Rodeo Association's (NIRA) Southwest Region standings.

He is in a 15th place tie (100 points) in steer wrestling.

Sul Ross begins the spring rodeo schedule Thursday-Saturday (Feb. 23-25) at the Odessa College Rodeo.

CONTINUED FROM PAGE 1 Marshall, Chief Operations Officer for Lillian M. Hudspeth Hospital said. "We have what's called the 'Golden Hour'. This is the time from injury to getting them needed medical attention. If it takes 45 minutes to remove someone from a car, then it only leaves 15 minutes to assess their injuries and begin treatment. That's why all of this is important. Advanced training and tools are essential to saving lives."

Additionally, we want to ensure the safety of both patients and rescuers. For example, cutting through electric cables in hybrid cars and exploding air bags pose as much of a risk to rescuers as patients.

But, of course, new technology comes at a cost.

Small departments like the Sonora Volunteer Fire Department would not be able to afford much needed

equipment to help citizens as well as the people traveling through our highways without financial assistance.

They are currently looking at funding sources to afford the purchase new jaws of life equipment which is used to extract trapped individuals from motor vehicles. Jaws of life tools include cutters, rams and spreaders.

Awaiting approval and funding from a recent grant application, they are also hosting fundraisers such as an 18-hole golf scramble scheduled for late March.

"This benefits everyone, not just us. People count on us to help them when they need it, Duran said. "The money raised through grants, donations and fundraisers will help us update our equipment and maybe a fire truck. Every little bit helps."

The Troopers began the

DPS is currently accepting applications for recruit classes scheduled for 2018. The next application deadline is June 20 for the class beginning Jan. 7, 2018.



Here's how they work:

You get a call from someone who says she's from the IRS. She says that you owe back taxes. She threatens to sue you, arrest or deport you, or revoke your license if you don't pay right away. She tells you to put money on a prepaid debit card and give her the card numbers.

The caller may know some of your Social Security number. And your caller ID might show a Washington, DC area code. But is it really the IRS calling?

No. The real IRS won't ask you to pay with prepaid debit cards or wire

transfers. They also won't ask for a credit card over the phone. And when the IRS first contacts you about unpaid taxes, they do it by mail, not by phone. And caller IDs can be faked.

Here's what you can do:

1. Stop. Don't wire money or pay with a prepaid debit card. Once you send it, the money is gone. If you have tax questions, go to irs.gov or call the IRS at 800-829-1040.

2. Pass this information on to a friend. You may not have gotten one of these calls, but the chances are you know someone who has.





Noted Texas jurist Jack Pope of Austin died at age 103 on Feb. 25.

Born in Abilene in 1913, Pope helped establish formal judicial education

for Texas judges, fought for a voluntary judicial ethics code when judges had none and fought again to make that code mandatory and enforceable. He served for 38 years as a district court judge, court of appeals justice and on the Texas Supreme Court, the last two as chief justice. His judicial tenure, as a whole, was the longest of any Texas

Supreme Court justice.

As a court of appeals justice, Pope's reassessment of water rights conveyed by Spanish and Mexican land grants changed Texas water law forever. As chief justice he forged a way to guarantee income to finance legal assistance for the poor. Concerned with double litigation in the same case, he won legislative support for statutory changes to thwart "forum shopping" for favor-



Signs of Spring Are Here

Officially, spring is not here yet...or is it? But there are signs of it.

1. A month ago, I noticed some peach trees already

in bloom. Most fruit trees need a certain amount of cold weather to end their dormancy and to promote spring growth.

During the fall season, decreasing day length and cooler

temperatures induce a tree to produce growth inhibitor hormones that disrupt its growth. It is these hormones that maintain a tree in dormancy during winter.

Dormancy is interrupted when sufficient cold temperatures break down the growth inhibitors within the tree. A precise number of cumulative hours of chill (temperatures lower than 45 Fahrenheit) are required to break dormancy. When enough chilling accumulates, the buds are ready to grow in response to warm temperatures.

2. The buzzards are back. In winter this efficient scavenger migrates from the northern part of its range, where a carcass will freeze, to the southern part of the United States and south into South America. The Turkey Vulture returns in the spring to feed and rear young.

Actually, two different vulture species of vultures are native to North America: black vultures and turkey vultures. These scavengers play an important role in the ecosystem,

categorized by temperature. So winter is the coldest quarter of the year (December-February), while meteorological summer is the warmest (June-August). The quarter between these periods is meteorological spring, with occurs from March 1 through May.

Astronomical spring is determined by the Earth's position in relation to the sun.

The vernal equinox occurs when the Earth's tilt on its axis is neither toward nor away from the sun, and marks the start of astronomical spring (March 20). Likewise, this event repeats in September for the autumnal equinox.

Additionally, there are solar seasons, which are categorized by the length of daylight hours.

Solar winter is November-January, the months with the shortest daylight hours. Because of this, solar spring began in February.

No matter what way you want to think of the seasons, the start of March will inevitably lead to warmer temperatures and the end of the winter weather.

resentative Andrew Murr (R-Junction) was recently appointed to four committees by the Speaker of the Texas House in the ongoing 85th Session of the Texas Legislature.

He will serve on the Judiciary and Civil Jurisprudence Committee, the Ways and Means Committee, and the Local and Consent Calendars Committee, as well as serving as Vice Chair of the Select Committee on State and Federal Power and Responsibility. Additionally, Murr was selected by his colleagues to serve on the Steering Committee for the House Research Organization.

As a former county judge, Murr is in the unique position of being the only member of the Judiciary Committee with judicial experience.

This committee will review proposed legislation that affects our Texas court systems and judicial processes.

The Ways and Means Committee has jurisdiction over a wide range of topics, from state revenue sources to the state treasury.

Murr brings a rural perspective to the committee, and he is the only committee member from the Texas Hill Country.

The Committee on Local and Consent Calendars is a procedural committee.

This committee sets the schedule for hearing local bills on the House floor; those bills that, in the opinion of the committee, are in fact local or will be uncontested, and have been recommended as such by the standing committee of original jurisdiction.

Local bills are generally passed by the House at once, by unanimous consent,

The Select Committee on State and Federal Power and Responsibility will consider a variety of legislation, including whether Texas should request an Article V Convention of States to draft amendments to the U.S. Constitution concerning certain topics.

Governor Greg Abbott included this topic in his list of emergency items this session.

As the Governor has explained to Texans, there are two ways to amend the U.S. Constitution; one by congress drafting amendments and submitting them to the states for ratification.

The other provides that two-thirds of the states can call for a convention to draft amendments, which are then submitted to the states for ratification.

If three-fourths of all states ratify an amendment, that amendment is approved.

Finally, the House **Research Organization** (HRO) provides impartial information on legislation and issues before the Texas Legislature.

The HRO Steering Committee, of which Murr is now a member, sets policy for the organization, approves its budget and ensures that its reports are accurate and objective.

Murr remarked, "I look forward to my work on each of these committees.

With only three months left in the Legislative Session and a long list of challenges facing our state, time is of the essence. I am confident, however, that we will rise to the occasion and deliver real results for the people of Texas."


pushing the Lady Broncos ahead of Crane ultimately plating 8 runs in the third and ultimately taking the win 14-7.


Decisions regarding the 2017 CIRAService Agreement was tabled for a later date pending further review of option by Deputy Clerk Rachel Duran.

The court discussed the eBench contract-Judge's software and it was noted that Sutton County will share the cost with area counties also in need of the software.

Duran reported that the Clerk's Office has agreed to conduct the upcoming Sonora ISD School Board election.

The county is providing electronic voting machines and staff to man election polls. Early voting will be held at the County Annex Building from April 2 through May 2. Voters may also cast their votes on May 6 at the Sonora ISD Administration Building.

For the record, the court also noted the completion of the Open Meeting training by Carl Teaff. All elected officials are required to complete the course within 90 days after taking office each time they are elected.

Finally, commissioners appointed Judge Smith to finalize the bid details for electric service to be provided by Hunt Energy. The bid specifies service will be provided to Sutton County at a fixed rate of 3.728 cents per kilowatt hour for the next 3-years.

Without further discussion or action, the court adjourned.

Judge Steve Smith presided over the meeting. Commissioners Carl Teaff, Fred Perez, Mike Villanueva and Bob Brockman were present.
