FBC of Sonora Easter Egg Hunt Draws Big Crowd

Dozens of children scurried across the grounds at First Baptist Church of Sonora Sunday during a community Easter egg hunt April 16, 2017.

Members of the FBC youth program scattered about 10,000 candy filled, plastic, eggs for children to collect.

"It's the biggest one [Easter egg hunt] we've done," FBC Youth Director Scott Gaskill said. "It may even be the biggest in our history."

In the past, the church has held egg hunts on Easter. But, this year, Pastor Matt Killough wanted something to bring everyone in the community together on Easter Sunday. His goal was to open the doors to all people in the community to come worship and share in Easter Sunday activities alongside the usual congregation.

It was standing room only in the church sanctuary while people listened to the Easter Sunday message, scripture readings and music.

Following the service, children and adults alike gathered outside to mingle and participate in the fun of gathering eggs.

Of course, the event provided countless opportunities to record the moments with photos and videos

Mollie Taylor and Haley Smith grinned as they watched children pick up the eggs that they had just scattered throughout the prayer garden.

Taylor and Smith are two
of about fifty young people who

of about fifty young people who participate in the FBC youth program. "It's exciting," Taylor said.

SISD Trustees Approve RIF Cut

After five hours of discussion behind closed doors, Sonora ISD trustees emerged into open session and approved two motions regarding district employees during their regular meeting, Wednesday, April 12, 2017.

The board approved a motion to accept the list of contract renewals for current administration, contract, and non-certified contracts as presented. Names of individuals were not provided.

Next. board members

approved a motion to accept the Superintendent's recommendation to propose the non renewal of the term contract of district employee Melinda Valkonen based on application of the reduction in force criteria under the program change and the board designated Superintendent Ross Aschenbeck to serve written notice to Valkonen that the board proposes not to renew her term contract for the succeeding school year. No other individuals or positions were

Aschenbeck prefaced the sessions with a public statement explaining the considerations for discussion.

"The employment areas

affected by the program change, nonexempt employees, employees who have already resigned or employees who are on probationary status and who will not be asked to return are not be included on this list," Aschenbeck said. "Based on contractual obligation, the positions listed below are the only ones who are required to be considered. I just mentioned the concerns about the budget and the loss of revenue. We will not know until the end of May, at the earliest, how much revenues we will actually lose. Therefore, and this happens, I've spoken with the other districts and spoken with the attorney, and they say, you know, often when you declare a change this happens and we only have one, one, position that will be affected by the program change and that is our one 6-12 social studies teaching position. And

When asked by a board member to clarify his statement about only one position being affected, Aschenbeck replied, "There is only one position that is now being affected by the program change because everyone else has resigned."

so. Any questions?"

Without further questions or comments, trustees took a recess then enjoyed a catered dinner before moving into confidential discussions regarding personnel matters.

Ahead of the lengthy closed session, board members moved through a list if agenda items including the usual consent agenda matters, the 2017-18 school calendar and a budget overview.

In regular business, trustees approved consent agenda items, as presented, including the Tax Assessor/Collector report, board financial report and minutes of the March 6, 2017 and March 27, 2017 meetings.

In other business, the board approved the Good Sam Memorandum of Understanding.

They also approved an engagement letter with Eckert & Company for the annual audit of September 1, 2016 through August 31, 2017. As well, they approved a resolution extending the Depository Contract with Bank & Trust for an additional 2-years. Trustee Brady Johnson abstained from voting.

Federal Judge Says Again, Texas Voter ID Law Is Discriminatory

AUSTIN — U.S. District Judge Nelva Gonzales Ramos of Corpus Christi on April 10 ruled the State of Texas has failed to prove that the voter identification law was not written with discriminatory intent and purpose

The ruling came in response to a charge by the New Orleans-based U.S. Court of Appeals for the Fifth Circuit that Judge Ramos re-examine the evidence and her 2015 findings in Veasey et al., plaintiffs, v. Greg Abbott et al., defendants.

Plaintiffs alleged racial discrimination in violation of the U.S. Voting Rights Act of 1965 in response to the passage of Senate Bill 14 by the Texas Legislature in 2011. The law changed the list of acceptable

forms of identification voters may use at polls and enacted other restrictions. The State of Texas argued that the law was passed not with a discriminatory purpose, but to combat voter fraud at the polls.

Ramos wrote that lawyers for the State of Texas failed to demonstrate that the law would have been enacted without a discriminatory purpose. Ramos, under a directive issued by the Fifth Circuit last summer, prescribed an interim voting plan for Texas to overcome discriminatory effects in the voter ID law in time for the November 2016 general election. It is up to the Texas Legislature to craft a state law that does not violate the federal voting rights law.

Meanwhile, legislation filed in the current session of the Texas Legislature by Sen. Joan Huffman, R-Houston, addresses federal court issues with the voter ID law. Huffman's SB 5 was passed on March 28 by the Republican-dominated Senate on a 21-10, party-line vote and now awaits a hearing by the House Elections Committee.

Hegar distributes sales tax revenue

Texas Comptroller Glenn Hegar on April 12 announced his office would send cities, counties, transit systems and special purpose taxing districts \$620.2 million in local sales tax allocations for April.

The amount is 4.9 percent more than in April 2016. These allocations are based on

sales made in February by businesses that report tax monthly.

"The cities of Houston. San Antonio. Dallas and Austin saw noticeable increases in sales tax allocations,' Hegar said. "The cities of Sugar Land, McAllen, Irving and Grand HIGHLIGHTS Prairie saw noticeable By Ed Sterling decreases."

In other news, on April 10, Hegar promoted the upcoming "sales tax holiday" on emergency

Training the Next Generation of World-Renown Computer Scientists

Hurd on the Hill

Coding is the language of the 21st Century economy, and if our kids can't speak it, they're going to be left behind.

I am not just referring to jobs at tech companies. Employers from HEB to Toyota are actively hiring tech professionals, at salaries significantly higher than the statewide average, to deal with everything from inventory and logistics to anti-hacking and privacy protection. I just heard about a cattle rancher from the San Antonio-area who has

created an online marketplace, proving that even agriculture is following the digital trend.

As our traditional industries become more digitized, one common problem has become clear: we are not producing enough computer scientists to meet demand. This comes up over and over when I meet with employers across the 23rd Congressional District of Texas.

In 2015, an estimated 42,000 computing jobs went unfilled in Texas, yet only 2,100 computer scientists graduated from our universities. As a computer science graduate myself, I know there is much more we can do to increase our homegrown talent-pipeline for these types of jobs. This is why I worked with public and private sector members of our community to teach math teachers how to incorporate computer science lessons into their stateapproved curriculum.

Thanks to the University of Texas Center for STEM Education and a nonprofit teacher training organization called Bootstrap, last weekend, 40 middle and high school teachers from 16 school districts between San Antonio and Socorro attended the inaugural teacher training at Bexar BiblioTech in San Antonio, which will expose over 1,000 students to computer science this coming year alone. Six Northside ISD of San Antonio teachers who attended the training will reach over 500 students themselves, and the effort multiplies with each additional school year. Tech companies including Dell, Intel, Facebook, and Brocade sponsored the cost of travel and tuition.



Coding lessons will be administered through a video game platform, which will allow students to interact with technology in a relatable way while learning critical mathematics concepts. "This curriculum will get students much more engaged because they can use a lot more visuals than they normally can. Now that everything is more technology-oriented, I believe these types of lessons will help

motivate my students to continue to study computer science," said Hector Diego, one of the participants in the training who teaches in Eagle Pass.

> We need to add new computer science courses to the state-approved curriculum but this process could take years to be funded and approved. By integrating lessons into existing math courses, schools will be able to introduce students to com-

puter science immediately. "We've all been math teachers for years, and I think this training has opened our eyes to the need for combining the language, structure and discipline of computer science with subjects we're already teaching in the classroom," illustrated Ryan Trujillo of Socorro ISD. "It's just a little adjustment we need in order to really prepare these students to use coding to tackle real problems. I think this is absolutely necessary for

students today." Mr. Trujillo is right – and we can prepare students to solve these real-world problems by designing the pipeline that educates future computer science and STEM professionals to start at the middle school level. Earlier exposure to computer science education may inspire students to choose a STEM pathway in high school, and increase the quantity of locally-grown computer scientists we ultimately let loose into the workforce.

The intersection of mathematics and technology will continue to produce life changing advancements, and it is our responsibility to continue this trend. I am grateful for the teachers who participated in the training, and for the school districts that support them. It is my hope that together we will educate the next generation of world-renown computer scientists right here in TX-23.

the field and my mother kept telling them they had better get out there and get that firewood before their daddy gets in. Well, they went out there.

"My oldest sister Frances always did the chopping. My sister Dolly, just younger than Frances, was full of life and loved to have a good time, sometimes playing pranks with family members. In this particular instance, they had the log down there and were fixing to chop it and Dolly stuck her foot on that log and said, 'chop my toe off.' Now Frances had already come down with the axe and it fell across Dolly's big toe and the next one to it. The big toe was barely hanging on but the one next to came completely off.

"There happened to be a rooster out there and he grabbed that little toe and took off. Well of course they were screaming and hollering. My mother came out and said, 'what in the world?' Well, Dolly was bleeding and Frances said, 'I chopped her toes off and the rooster got a toe.' Their mother said, 'catch that rooster, catch that rooster.' So my brother got after that rooster, tackled him and took that toe out of his mouth and brought it back. Mother told the two older ones to go to the field and get their daddy.

"Daddy came and loaded Dolly in the old farm truck and took her to Lamesa. The old doctor sewed that big toe back on and attached the other toe next to it and told my mother to soak Dolly's foot in kerosene twice a day. So they did.

"Those two toes had no feeling, neither one of them. But she had the toes. And they never gave her any problem."

Dolly was about seven years old when all that happened. She died last February at the age of 92.

'She still had those scars," says Bobby, "and you could see them when she went barefooted in the house. But you never did see her outside the house without shoes; her feet were always covered. We used to pinch those two toes. She couldn't feel anything. Frances died in January of this year at age 96. Marvin died two years ago. He was 92.

'When that happened, Momma told Dolly, 'you better get down on your knees and pray those toes stay on there.' I guess she did."







Following a presentation by Superintendent Ross Aschenbeck, the board approved the Sonora ISD 2017-2018 calendar. The new calendar designates the date of August 22, 2017 as the first day of school for all students. Teachers report on August 11. Spring Break is set for March 12-16 and graduation is scheduled on May 25, 2018. This calendar also allows for 2-weeks off during the winter for

Ashenbeck spoke on budget matters including the expected loss of state funding causing cutbacks for the upcoming school year. He explained that, due to a decrease in expected state funding, SISD expects to realize a significant reduction in revenue going into the 2017-18 budget year.

For example, total revenue for 2016-17 reflected \$14,042,424. The expected revenue total for 2017-18 is \$7,915,087. Further, expenses for 2016-17 totaled \$14,321,890 and they are expected to be \$9,706,331 for the 2017-18 budget year. Aschenbeck said the district's goal is to cut about \$2.8 in expenses. This cut involves a necessary

reduction in supplies, equipment and salaries.

Emphasizing the need cut wage expenses, Aschenbeck stated that 13.5 positions, thus far, are affected as a result of decreased revenue. These positions include, 9.5 teachers, 1 administrator, 1 cafeteria employee, 1 grounds keeper, 1 custodian, 3 football coaching stipends, 1 assistant baseball stipend, 1 assistant softball stipend, 3 track stipends, 1 high school girls basketball coach stipend and 1 boys basketball stipend.

"We will continue to absorb positions through attrition as we move forward," Aschenbeck said.

Finally, trustees appointed board representatives Jerry Jimenez and Cynthia Perez for 2017 graduation activities.

President Dawn Cahill presided over the meeting. **Board Members Brady** Johnson, Jerry Jimenez, Jesse Bustamante, Shana Petty-Castro, Cynthia Perez and Amber Killough were

present. The next regular meeting of the Sonora ISD is set for Monday, May 15, 2017 at 5:30 p.m. at the Vocational Building.



Reader Recipes

"White Texas Sheet Cake"

On May 17, 1918, members of the Sonora Woman's Club volunteered to help educate women in the community on how to vote. These women were also responsible for nominating the first woman to campaign for a SISD School Board Position.

In honor of our current Sonora Independent School District's School Board President, Dawn Cahill, her White Texas Sheet Cake recipe speaks to every one.

- 2 cups all-purpose flour
- 1 cup water
- 2 cups sugar 2 large eggs
- 1 teaspoon baking powder
- 1/2 cup sour cream
- 1/4 teaspoon baking soda
- 1 teaspoon almond extract
- 1 cup butter, cubed

Preheat oven 375 degrees. Grease a 15x10x1" baking pan. In large mixing bowl whisk first 4 ingredients. Melt butter with water- bring to a boil. Stir into flour mixture. In small bowl whisk eggs, sour cream, and almond extract until blended. Then whisk into dry flour mixture. Pour into pan. Bake for 18-22 minutes, or until golden brown and toothpick inserted into center comes out clean. Cool on wire rack 20 minutes.

Frosting:

- 1/2 cup butter, cubed
- 4 &1/2 cups confectioner's sugar
- 1/4 cup 2% milk
- 1/2 teaspoon almond extract
- 1 cup chopped walnuts or pecans

Combine butter and milk in large saucepan; bring to a boil. Remove from heat; gradually stir in confectioner's sugar and extract. Stir in nuts. Spread over warm cake.

presented by Robin Street. In other business, council members approved the distribution of the Main Street bank accounts, designating Belia Fay and Betty Hernandez to close the accounts and transfer the money into the City of Sonora General Fund as reimbursement for paid expenses incurred.

Following a discussion, the council took no action on setting the 2017 Consumer Price Index (CPI) Adjustment to Municipal Telecommunications Rightof-Way Access Line Rates. The rate will remain the same.

Max Howorth spoke to council members about the Sonora Tourism Committee HOTS finances for the second fiscal quarter. He noted the decline in taxes collected and the need for sales tax revenue.

Next, the council approved a grant of up to \$3,000 to Wheless Baker to help offset the cost of the Stevie Smith Memorial Team Roping and Dance event. The event is a fundraiser benefiting the Camp Good Samaritan Program.

The public hearing to expend 4-B sales tax funds for a quality of life project to Sonora Dental and Braces to purchase a Pano/Ceph machine in the amount of \$39,017.93 was tabled due to a clerical error in the wording on the agenda. The hearing notice will again be advertised in the local newspaper and the hearing has been rescheduled for Monday, April 24.

The council also tabled the agenda item regarding appointing Airport Advisory Board members pending further information.

As an addendum to the agenda, the council heard a request to consider a local sale day for merchants and vendors on Main Street. No action was taken.

Finally, the council heard comments from Joe David Ross and Sonora Police Chief William Dudley.

Ross thanked Doug Chandler for his service on the City Council.

Chief William Dudley spoke on matters relating to a current candidate who is contacting citizens in the community and asking them to support the idea of closing the Sonora Police Department in exchange for lower water utility bills.

With no further comments or actions the meeting adjourned.

Mayor Wanda Shurley presided over the meeting. Doug Chandler, Todd Munn, Juanita Barrera and Norm Rousselot were present.

From April 22 to April 24, Texans may purchase tax free items such as batteries, fuel containers and flashlights priced at less than \$75; hurricane shutters and emergency ladders priced at less than \$300; and portable generators priced at less than \$3,000.

Seat belt bill advances

The Senate Transportation Committee unanimously in favor of SB 693, legislation that would require all new school buses purchased by a school district to be equipped with three-point seat belts.

The bill would amend the Transportation Code to expand the type of vehicles to which the three-point seat belt requirement applies to include a "multifunction school activity bus" or a "school-chartered bus."

Multiple school bus accidents in Texas have led to fatalities and caused injuries that could have been prevented if these buses were equipped with three-point seat belts, said the bill's author, Sylvia Garcia, D-Houston. "The goal of this legislation is to protect children, prevent injuries, and demonstrate

that the State of Texas is serious about the safety of school children. We spend a lot of tax dollars educating children to buckle up. Not requiring them to buckle up on the way to school is inconsistent," she added.

Kubota heads for Texas

Gov. Greg Abbott on April 7 announced Kubota **Tractor Corporation North** American headquarters is relocating from Torrance, California, to Grapevine, Texas. The new facility is expected to create more than 340 new jobs and generate \$51 million in capital investment.

At a ribbon-cutting event, Abbot called Kubota "the model business partner." Kubota has been one of the largest tractor producers in the United States since 1969.

TxDOT cautions drivers

The Texas Department of Transportation on April 6 reported work zone fatalities in Texas last year increased 27 percent, resulting in 181 lost lives. Of those fatalities, 174 — 96 percent — were motorists, pedestrians and bicyclists.

The agency asked motorists to take special care when transiting work zones.



Again, in a game changing fifth inning, the Broncos sealed their fate and they fell to the Hawks despite out hitting Wall six to five.


Caleb Galvan hit the Broncos only home run of the night.
