

## Soldier of Fortune author to be on Geraldo show

Ben Green, author of *The Soldier of Fortune Murders* will be a guest Friday on TV's Geraldo Show.

Green's book is based on the murder of Sandra Black, wife of Bob Black, Haskell High School graduate, who has been sentenced to death for hiring John Wayne Hearn to kill his wife. He contacted Hearn through an ad in *Soldier of Fortune* magazine. The book also details two other murders by Hearn.

Hearn, who is now serving a life sentence, also will appear on the Geraldo Show via satellite, as will members of the Black family.

## Drivers' license open two days

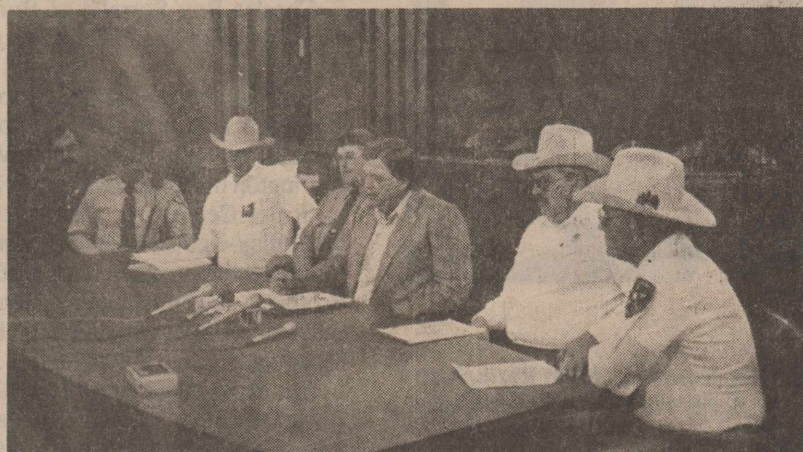

## Announce arrests

Officers from Haskell, Jones and Knox counties held a press conference in the district court room Thursday afternoon to announce the arrests of persons arrested on drug trafficking charges.

# 12 arrested in drug bust

Six persons have been released on bonds and six others remain in Haskell County jail as a result of a roundup last week of alleged drug traffickers.

Officers arrested 12 persons in Haskell County who had been indicted for delivery of controlled substances by a Jan. 22 Grand Jury. Indictments were sealed until the arrests.

The indictments and arrests were the result of a 10-month undercover operation conducted by the sheriff's departments of Haskell, Jones and Knox counties, and the West Central Texas Interlocal Crime Task Force. Other officers, including U.S. marshals, Texas Rangers and FBI agents assisted in the operation.

Another 20 persons were arrested in Jones County and six more in Knox County. Several others, including one in Haskell County, have not been arrested.

All of the local charges are for delivery of either marijuana or cocaine, except for one which is for delivery of a simulated controlled substance.

Several of those arrested in Haskell County face multiple charges. Altogether, the 13 indictments represent 23 charges. Bonds were set at \$15,000 for each charge of marijuana delivery and \$35,000 for each cocaine charge.

-Donna Hoover McCulloch, delivery of cocaine, \$35,000.

-John Franklin Eaton, two charges of delivery of cocaine, \$35,000 each, and one charge of delivery of marijuana, \$15,000.

-Darnell McCulloch, three charges of delivery of cocaine, \$35,000 each.

-Roy Lee Riley, delivery of cocaine, \$35,000. (He also faces two counts of delivery of cocaine in Jones County.)

-David P. Reyes, delivery of marijuana, \$15,000.

-Jeffrey Todd Thompson, delivery of a simulated controlled substance, \$15,000. (Also being held on Knox County charge where bond was set at \$50,000.)

-Stacie Yvette Eddington, two charges of delivery of cocaine, \$35,000 each.

-Servando Rodriguez Jr., delivery of marijuana, \$15,000. (Also being held for revocation of probation for which no bond is set.)

-Freddie Garcia, four counts of delivery of cocaine, \$35,000 each. (He is being held in Knox County jail on a charge there.)

Also arrested in Haskell County was Jon Kendall Strickland, who was picked up on a Jones County indictment of delivery of a controlled substance (LSD).

# Older taxpayers may defer payment

Haskell County taxpayers, 65 and older, can postpone paying delinquent and current property taxes on their homesteads by taking advantage of a tax option called "over-65 deferral."

The elderly homeowner simply signs a deferral affidavit at the Haskell County Appraisal District office.

Once a homeowner files the affidavit with the appraisal district, no taxing unit can initiate or pursue a suit for delinquent taxes as long as that person owns and lives in that homestead.

The tax deferral only postpones paying taxes on the homestead. It does not cancel them. During the deferral period, taxes and delinquent interest continue to add up. When the elderly taxpayer no longer owns or lives in the home, the accrued amounts become due. Taxing units can then sue to collect all of the deferred tax and interest.

Forms for filing a tax deferral affidavit are available at the appraisal district office located at 604 N. 1st St. in Haskell.

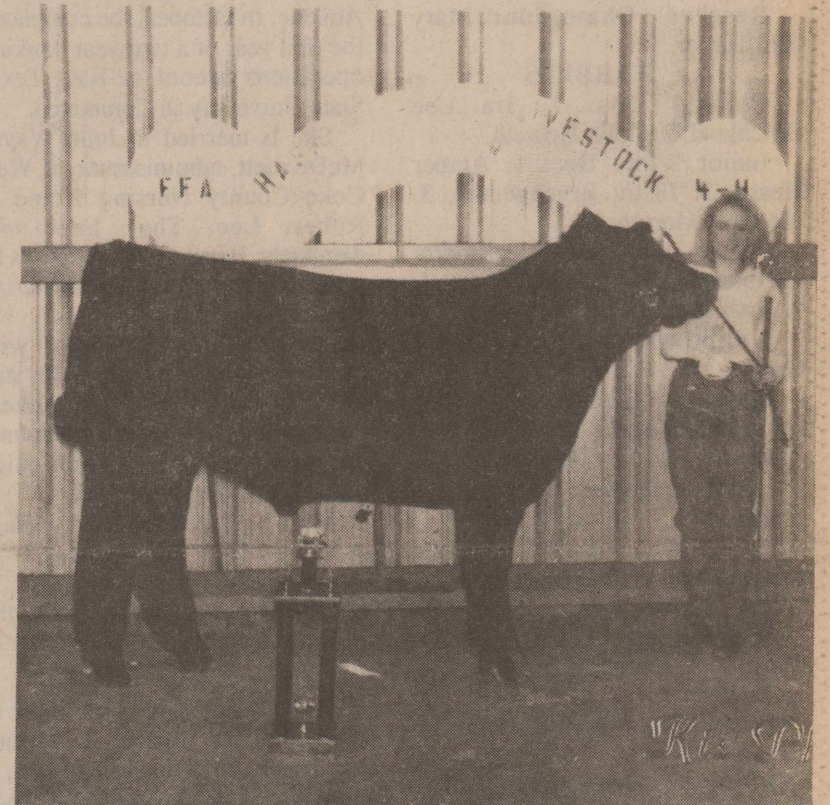

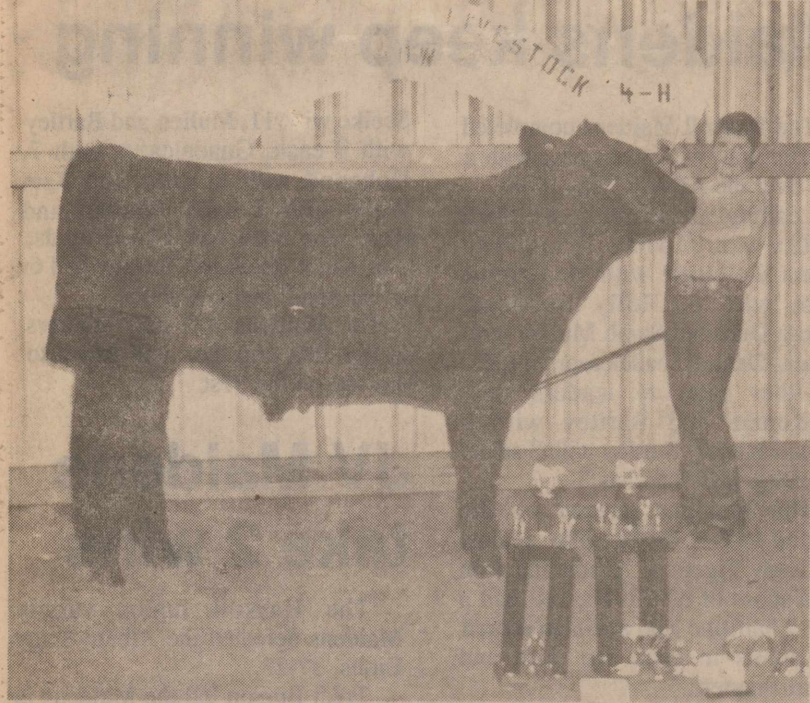

On Friday night, the Indians defeated Anson, 66-50, but on Tuesday they lost to Winters, 61-53.

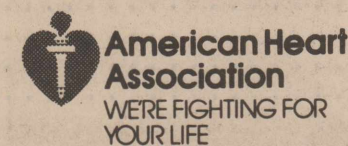

"Dear Mr. Morgan: It is a pleasure to inform you that Paint Creek School has been selected to participate in the Partnership Schools Initiative. This concept will provide the flexibility and support for the school to totally restructure its educational processes and programs with the single goal of improving student performance. The importance of this school's selection is underscored by the fact that less than 100 campuses were selected from a field of almost 2000 applicants.

Paint Creek was chosen because the principal and staff demonstrated a commitment to abandon the status quo, and embark upon an adventure that could become a model for improving student performance statewide. It is our expectation that the result of this initiative will provide the impetus for changes in standard education practices, State Board of Education

rules, and state statutes."

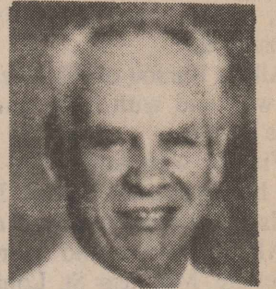

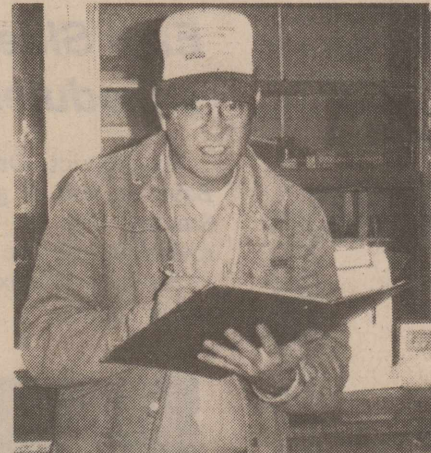

# REMINDER TO TAXPAYERS

## January 31, 1992

is the last day to pay your 1991 taxes and avoid the additional penalty and interest charges

### Homestead Exemptions

You qualify for a homestead exemption if you owned your home on January 1 and used it as your primary residence on that date. If you received a homestead exemption on your home in 1991, you won't need to reapply for 1992. However, if you became 65 or disabled before January 1, file a new application to receive the additional exemption. The last date to file is April 30, 1992. File your homestead exemption with your local appraisal office at the address shown below.

### Productivity Appraisal

Texas law provides farmers and ranchers with a way to lower their property taxes, known as productivity appraisal. If your land qualifies, it will be taxed on its capacity to produce crops or livestock instead of its value on the real estate market. If your land has never received productivity appraisal, you must apply to the appraisal district no later than April 30, 1992 to get tax benefits for 1992. If you miss the deadline, you may still be able to apply, but you will pay a penalty. If your land already receives agricultural appraisal, you do not need to reapply unless the chief appraiser requires you to. You would then be notified by mail.

### Disabled Veterans Exemption

Veterans with a service-connected disability can receive property tax relief in 1992 by filling out a simple exemption form at the Haskell County Appraisal District office by April 30, 1992. The amount of the exemption is based on the veteran's percentage of service-connected disability and can range from \$1,500 to \$3,000. An applicant needs to provide proof of the disability, such as documentation from the Veterans Administration or the branch of the armed services in which the veteran served.

### Renditions

A rendition is a report a property owner files each year listing taxable property he owns. The law requires anyone who owns income-producing personal property on January 1 to file a rendition statement reporting their inventories, furniture and fixtures, machinery and equipment, and other tangible business property. While only business personal property must be rendered, anyone may voluntarily file a rendition. A property owner, who renders, is in a better position to exercise their rights as taxpayers. The last day for filing renditions is March 31, unless you have requested an extra 30 days in writing before the March 31 deadline.

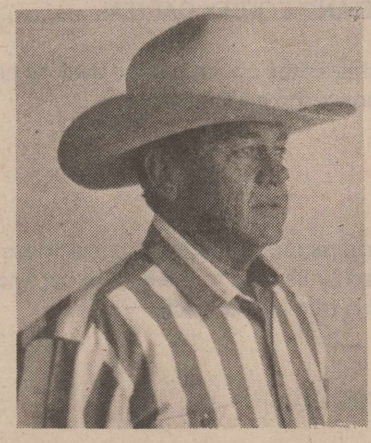

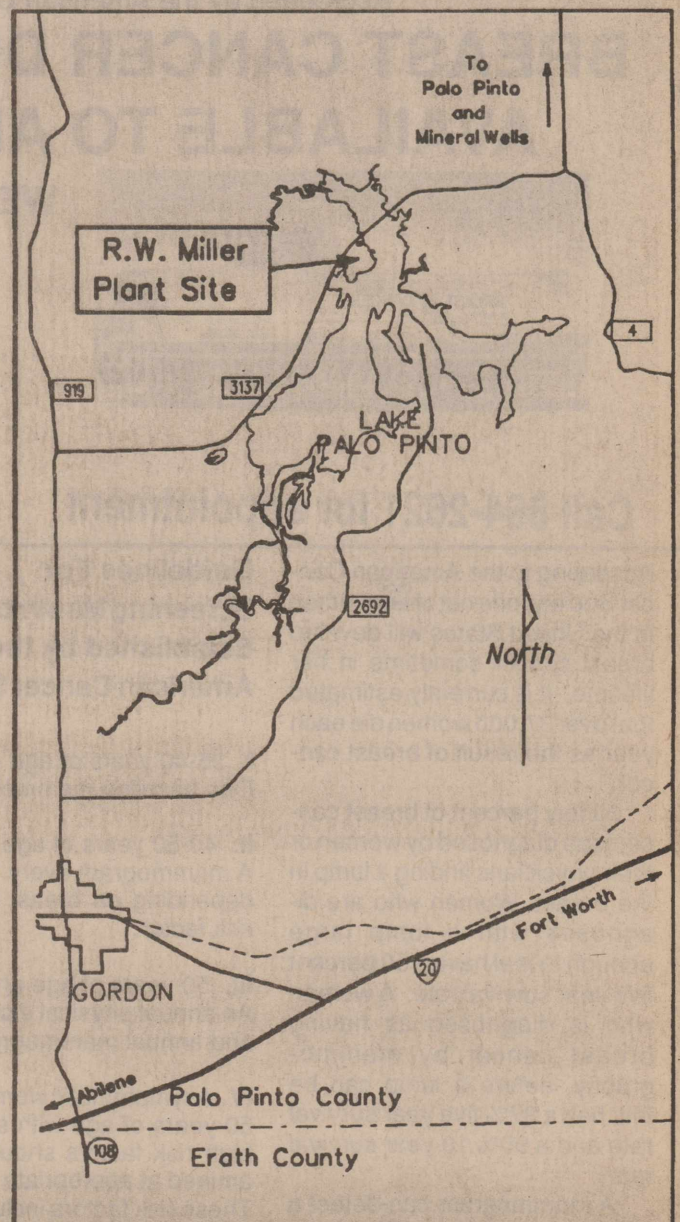

According to the American Cancer Society, one out of ten women in the United States will develop breast cancer sometime in her lifetime. It is currently estimated that over 37,000 women die each year as the result of breast cancer.

Ninety percent of breast cancers are diagnosed by women or their physicians finding a lump in the breast. Women who are diagnosed with a lump large enough to feel have a 50 percent five year survival rate. A woman who is diagnosed as having breast cancer by mammography, before a lump can be felt, has a 97% five year survival rate and a 90% 10 year survival rate.

A screening mammogram is an x-ray of the breast using extremely low dosages of radiation (usually comparable to dental x-rays) and is designed to find very early cancers.

A female technologist who is highly trained in mammography will perform the examination.
