



Haskell teachers at Utah conference

Three Haskell CISD teachers were selected by the Texas Education Agency to attend the New Standards Project Conference in Snowbird, Utah, July 8-14.

Attending from Haskell were Paula Everett and Richard Holloway, math teachers, and Cathy Bartley, English language arts teacher.

Participants were trained for scoring math and language arts tasks which had been part of a pilot program through the states. They then had to score papers in order to practice using the rubric (a scoring guide). Each teacher had to qualify to become a scorer by scoring three sets of 20 papers. After qualifying, the teachers scored hundreds of papers.

The New Standards Project is a vision for the 90s. It began two years ago with support from the Pew Charitable Trusts and the John D. and Catherine T. MacArthur Foundation. NSP is a partnership of states and urban school districts that is adopting a set of very high national education standards and developing a new kind of assessment system designed to gauge student progress toward those standards. The primary goal of the project is to greatly improve the performance of all students.

NSP is run jointly by the National Center on Education and the Economy and the Learning Research and Development Center at the University of Pittsburgh.

The NSP pays special attention to equity, strives to educate all students at high standards, and wants standards and assessments to help bring about better student outcomes. It wishes to build an examination system that wants teachers to prepare students to do well. This system uses teachers n task development, scoring, and using results to improve curriculum and instruction. This national movement for content standards, however, clearly intends these

He was preceded in death by his parents, and a sister, Esmericiana Pimentel.


O. B. Ratliff

Price support loans available from ASCS

Price support loans and loan deficiency payments on 1993 wheat (if applicable) are available from the Agricultural Stabilization and Conservation Service.

All wheat producers in the 1993 farm program are eligible, said Glenn R. Brzozowski, county executive director of the ASCS.

"A price support loan provides immediate cash for farmers and allows them sufficient time to make important marketing decisions, or to hold the grain for feeding later," Brzozowski explained.

The loan rate for Haskell County's 1993 wheat crop is \$2.38 per bushel. Jones County's 1993 wheat crop is \$2.36 per bushel, and Knox County's is \$2.38. The rate reflects relative county market prices.



Irrigation efficiency evaluations conducted last year in Haskell and Knox counties showed the average application efficiency to be 80 percent, pattern efficiency of 60 percent and overall efficiencies of 48 percent.

center pivot irrigation system will show you how productive the system is operating and could point out areas along the system where too much or not enough water is being applied.

The first step in determining the efficiency of the system is knowing the gallons per minute you are pumping through the system. This is done using a flowmeter or velocity gauge.

After the gallons-per-minute is determined, a series of catch cans or gauges are placed along the system and water is caught in them as the system passes over it.

The average amount of water that is caught in the gauges is compared to the amount of water pumped through the system to determine the application efficiency.

The uniformity of the water applied to the field or the pattern efficiency is calculated by comparing the lowest 25 percent of the area under the pivot to the average amount of water applied to the field.

Factors that influence efficiency of the irrigation system are operating pressure, pumping rate, worn or plugged nozzles system leaks, wind and humidity.

Areas of irregular crop growth under the pivot could indicate too much water is being applied in some places and not enough in others. An efficiency test could

show how to correct this problem.





of sugar, it was just mashed squash. After that addition, for me, it was haute cuisine.

Never a gourmet cook, Mama was nevertheless a good cook, with an extremely sensitive nose for the right seasoning. She could smell when gravy was done or salty enough. Her recipes were in her heart. She loved preparing special things for her children, always managing to have each one's favorites when they came to visit. I was her main squash enthusiast and I could eat it until my eyes virtually rolled back in pure hedonism.

Into her 80s Mama continued to preserve, pickle, jar and freeze from the garden and orchard. Every year when the fall garden had "come off" and been "put up", she and Dad spent two weeks on the coast at Corpus Christi deep-sea fishing, having a ball and filling their freezer.

Dad liked to cook fish as much as he liked to catch it and watch his grandchildren eat it---especially Lake Brownwood crappie and catfish.

Invariably getting the deep grease hot enough to set off the smoke alarm, he'd drop the cornmealed fish into his special black iron skillet, meticulously careful to turn each piece only once as it bubbled golden brown.

Being quite deaf he was oblivious to the shrill warning going on around him. Mama's ears being as sensitive as her nose, she always stood by with the electric fan she kept on the cabinet for just that purpose, aiming at the shrieking alarm through the smoky vapor. While she subdued the earsplitting beeps, Dad fried, turned, then drained the crispy, tender fillets on a brown paper bag. With great ceremony he'd announce to the grandchildren, "Let's get after this fish." They always did. A culinary ritual, performed in perfect harmony.

I don't do most things the way Mama did --- partly from choice, partly from circumstance of time and personality---however, seasoning squash is one thing I've consciously tried to learn from her. I haven't mastered it yet. But without saying a single word she taught a truth that I've later come to realize applies to all of life, as well as to cooking squash: Just knowing the necessary ingredients is not enough. The secret of heightening and bringing out exceptional flavor in everything is finding the right balance and knowing when to add a judicial bit of sugar. In nearly 65 years of loving together as a team, Mama and Dad were a living example of how ordinary ingredients, thoughtfully and patiently seasoned together can become an extraordinary blend. Like the one for Mama's squash, their recipe was in their hearts. Mama has been gone for several years now, but she is right here with me this morning as I look at this beautiful yellow squash that Helen Fouts brought over. We're going to take it into the kitchen and she is going to coach me through the squash seasoning process one more time. While it's simmering down she is going to tell me again about the hilarious two days during the hurricane when she and Dad were marooned in an ocean-front Corpus Christi motel, their ice chest filled with fish but no ice.

The following letter was written to Congressman Charles W. Stenholm.

Dear Rep. Stenholm: While I do not reside in your district and therefore do not have a countable vote, I do own property in Haskell County and so have a concern about what you do and say as you represent that part of the state of Texas. Because of my intentions to return to Haskell to live, I subscribe to the Haskell Free Press and by so doing I read your letters that appear in the paper.

I was very interested in your explanation of how you opposed President Clinton's tax bill and yet voted for it so you could oppose it again later. I know that makes sense to somebody---it's bound to--but I guess we will only know for sure when we see your "No" vote on the final version of this proposed "Largest Tax Bill" ever.

Since I can't understand the tax logic, maybe you could explain to me your stand on gun ownership. You voted for the Brady Bill that would keep only law-abiding citizens from purchasing a tool for self-defense for a period of five working days (up to seven days total) because you said you thought it would somehow curtail crime. 



Problems are not corrected by remediation, skill building, vision training, diet control or drug therapies.

Aim of the conference was to train administrators to become peer evaluators as part of the accreditation process for Texas schools.


Conference participants were briefed on new legislation and state board rules and how these will impact accreditation.
