## 148 students attend local singing school

The 41st annual Haskell Singing School, conducted by the Haskell Church of Christ the week of July 9-14, drew 148 students from all across the nation, including the states of New Hampshire, Tennessee, Georgia, Arkansas, Oklahoma, Colorado and Texas.

Directing the school were six instructors, Tom Chapin, Thomas Chapin, Eugene Chapin, Bob Connel, John Connel and Bill Lyon.

Based on the New Testament admonition to "sing and make melody in your hearts" the school is built on the hope and expectation of offering training that will help students of all ages to worship God better, improve their individual skills and be able to go back home to help their congregation with their singing.

The school is for anyone over age of ten who wants to sing, learn song

leading or more about a cappella singing.

When students arrived, they were met by their host family who provided lodging, breakfast and supper during the week. Some visiting families who wished to stay together made reservations in the local RV park and camping area.

Classes began at 8:45 each morning with students assembling for a devotional. After this, warm-up exercises for the voice were conducted. Students then broke up into various groups, based on their musical background. These groups then moved into various classrooms for their classes.

Class subjects included the rudiments of music, song leading, sight reading, song writing, hymn appreciation, music theory, voice,

and included worship, rehearsals, devotional, Bible classes and preparation for the closing program.

After lunch, classes resumed and continued until 4:00, when students were dismissed to their host families for afternoon recreation and supper.

Evening activities began at 7:30

Friday evening, a special program was presented by the students for visitors and families.

Jim Yates is the minister at the Haskell Church of Christ. Charlotte Peiser is the church secretary and the school registrar.

Next year's Singing School will be held July 8-13.

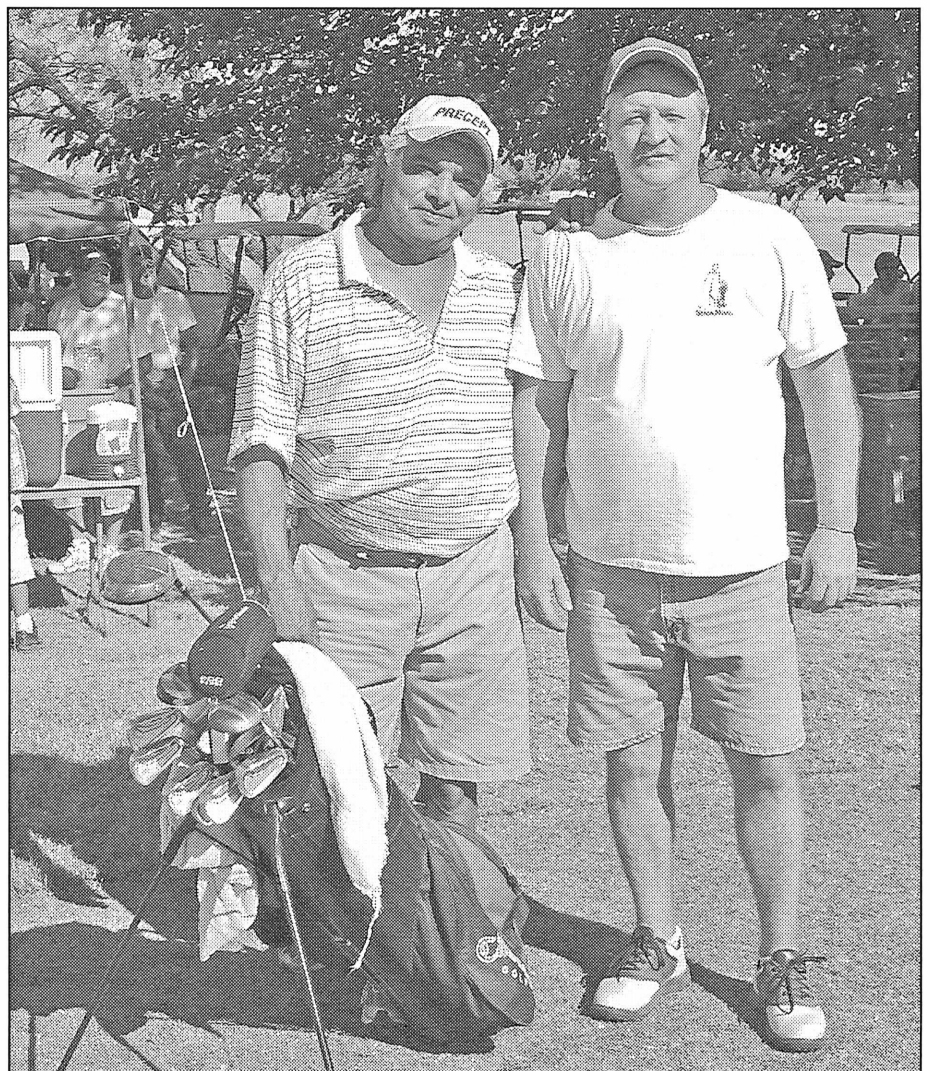
Parents should bring their drivers license and their child's birth certificate, immunization record, social security card and last report card.

**WHAT YOU NEED TO TEACH YOUR TEENAGER ABOUT FINANCES**

What should parents teach their teenagers about finances? How can you help them avoid the lure of easy credit and overspending? First, teach by example. Do you tell your youngster to save for the future when you don't set aside money for retirement? Do you finance your purchases with ever-increasing debt, or does your lifestyle show financial restraint? Children watch their parents, and learn.

Second, hold regular discussions with your kids about the rudiments of personal finance. When they're younger, you may want to provide an allowance to teach them budgeting and saving skills. As they hit the teenage years, you can show them how to balance a checkbook, use financial software, or read the business section of the newspaper. The teenage years are also a good time to discuss the dangers of credit card debt, the miracle of compound interest, and the wisdom of living within one's means. We learn by mistakes, too. That means you may need to let your teenager flounder a bit while learning the financial facts of life. When Joey spends his entire paycheck on pizza and movies and doesn't have enough left for that new bike helmet he wants, well, now he knows.

Third, when your teenager stands at the threshold of college, it's time for a refresher course. This is an opportunity to talk to your student again about credit cards, budgeting, emergency funds, and long-term savings. You may want to help your child open an IRA and choose a bank. This is also a good time to clearly delineate your financial responsibilities and those of your college student. Establish a set amount that you'll pay; anything beyond that amount is the student's responsibility.

Becoming a financial grown-up takes time, but you can give your teen a head start with some sage advice and a good example to follow.

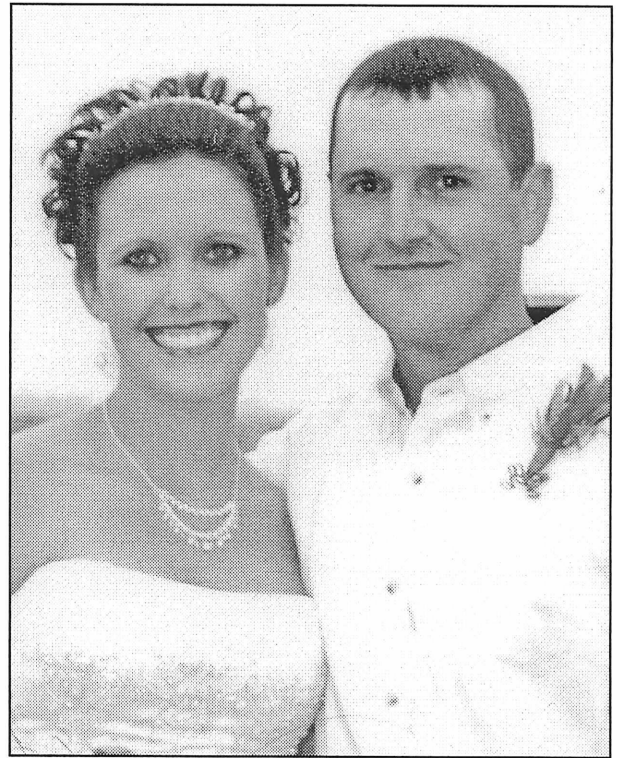

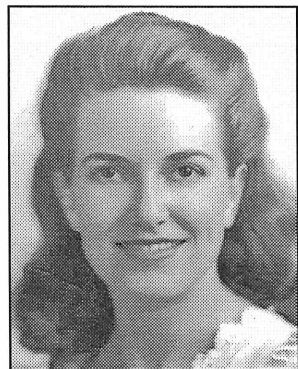
the invoice is included in the minutes.

Born June 27, 1923 in Stamford, she was a member of Hereford Church of the Nazarene and the Bastrop

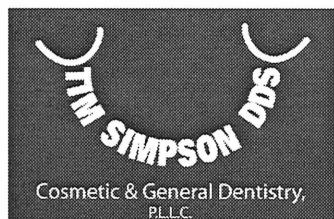

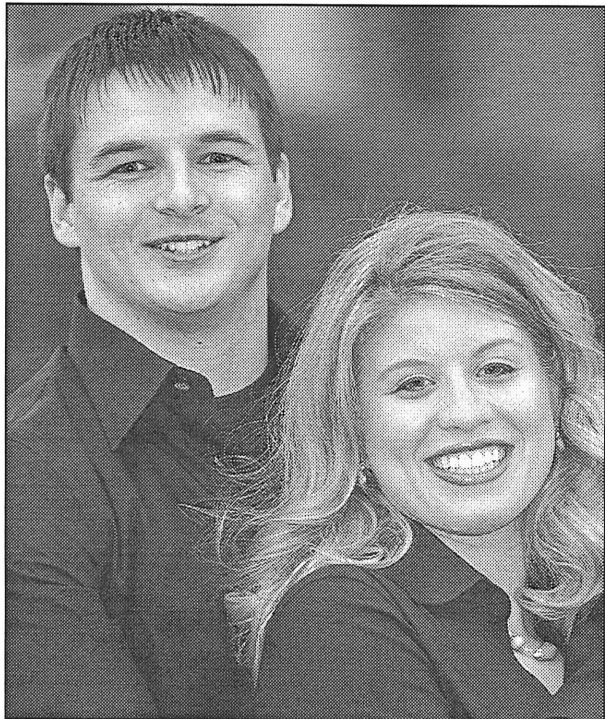

## Lee, Cox plan to marry in September

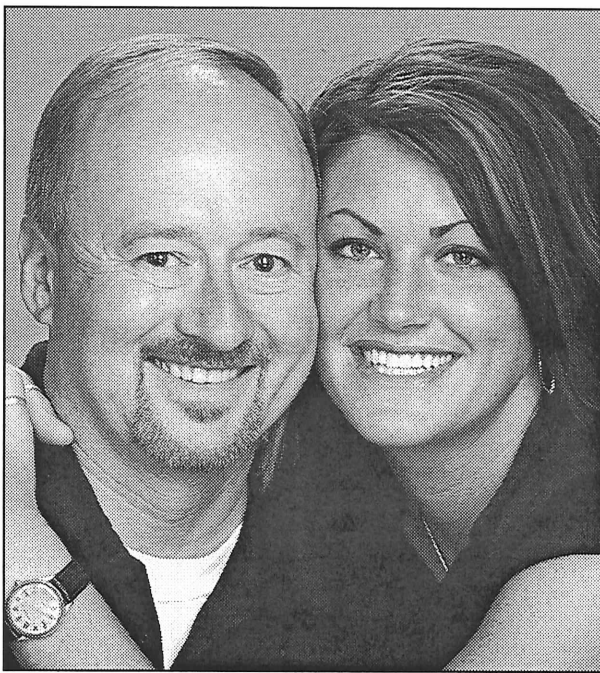

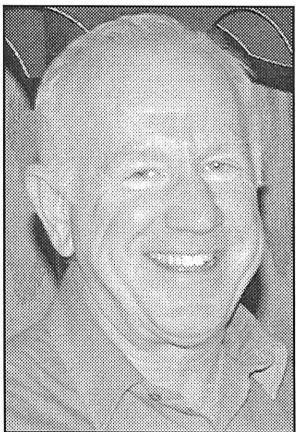

## Mayfield receives award

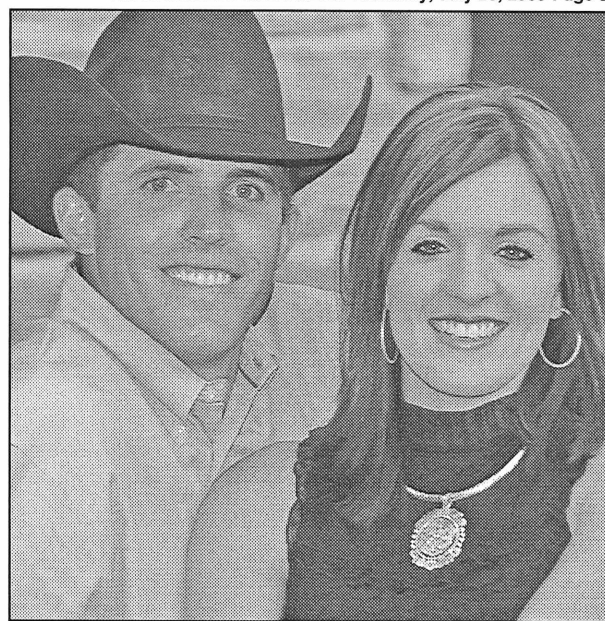

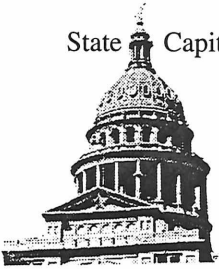

**10 tips to lower risk for foot problems**  
1. Wash your feet daily in lukewarm water but don't soak them. Always test bath water temperature with your hand before you put your foot in. Gently dry your feet, particularly between the toes.  
2. Inspect your feet daily, including the soles, heels and between the toes. You may need to use a mirror to see the bottom of your feet. Report any skin breaks, blister, cuts, or fissures to your nurse or doctor immediately.  
3. Notify your nurse or doctor if you see any changes in the color, temperature or shape of your feet.  
4. Look for corns, calluses and ingrown toenails. Don't treat these problems with over-the-counter remedies. See your nurse or doctor.  
5. The best time to cut your toenails is after washing your feet when your nails are soft. Cut them straight across and smooth them with an emery board. If your toenails are thick and hard or if you don't see well, have your toenails cut by your foot doctor or someone who knows the proper procedure.  
6. Apply lotion to your feet, but avoid putting lotion, cream or oil between the toes.  
7. Never walk barefoot—always wear shoes or slippers.  
8. Always wear socks or stockings with your shoes: cotton or wool are best.  
9. Check the inside of your shoes for foreign objects, worn linings or rough spots.  
10. Your shoes should fit well and feel good when you wear them.

**Kinky gets to stay Kinky; Grandma must stay Carole**  
AUSTIN—Secretary of State Roger Williams on July 10 rendered a decision on how the names of the two independent candidates in the race for governor will appear on the November ballot.

It'll be Richard "Kinky" Friedman and Carole Keeton Strayhorn.

Strayhorn said she would appeal the secretary of state's ruling, and filed suit in an Austin state district court. She wants to be Carole Keeton "Grandma" Strayhorn on the ballot.

Williams, Texas' chief elections officer, went into detail in explaining why "Grandma" won't be listed with Strayhorn's name, as she requested.

In a letter to Strayhorn's attorney, Roy Minton of Austin, Williams wrote: "Your letter does not articulate any facts that would counter my interpretation that the use of 'Grandma,' in the context of Carole Keeton Strayhorn's name appearing on the ballot, is a slogan and as such is prohibited by the Texas Election Code."

Williams said his office also took these factors into account:

•Strayhorn has never appeared on the ballot under the name "Grandma;"

•Strayhorn's declaration of intent lists her name as Carole Keeton Strayhorn;

•Strayhorn's petitions list her candidate name as Carole Keeton Strayhorn;

•The only reference to "Grandma" in communication with the Secretary of State's office appears on Strayhorn's campaign literature; and

•"Grandma" is not found on any of Strayhorn's official letterhead or communication with the Secretary of State.

### Groups submit district maps

After declaring Congressional District 23 in violation of the Voting Rights Act of 1965, the U.S. Supreme Court charged a panel of Texas federal judges to rule on new boundaries that put Texas back in compliance with the act.

The state of Texas, the Mexican

American Legal Defense and Education Fund, and other plaintiffs submitted ideas on how to redraw the unconstitutional map of CD-23. Adjustments to CD-23 will cause districts around it to change shape.

### Tobacco money keeps coming

Although the Carole Keeton Strayhorn running for governor was disappointed over the ballot- name ruling, she still found good news to report as Carole Keeton Strayhorn, Texas comptroller of public accounts.

Strayhorn said her office has distributed \$72 million to three cities, 158 counties and 131 hospital districts from the \$2.2 billion Tobacco Settlement Permanent Trust Account.

But she couldn't resist taking a potshot at the man she considers her main opponent in the race for governor: incumbent Gov. Rick Perry.

"These funds from the tobacco settlement provide a shot-in-the-arm for hospitals that are burdened with the responsibility of treating patients who cannot afford health care, including hurricane evacuees who have sought care at Texas hospitals and tens of thousands of children who have been dropped from the Children's Health Insurance Program under this governor's administration."

Since the first distribution of funds from the Tobacco Settlement Permanent Trust Account in April 2001, local entities have received nearly \$205 million from the fund.

### Rep asks AG tough question

Would a doctor who violates the state law restricting third-trimester abortions be subject to charges of homicide?

State Rep. David Swinford, chair of the House State Affairs Committee, asked Texas Attorney General Greg Abbott for an opinion on the question.

Swinford, R-Amarillo, also asked Abbott if a doctor who does not get parental consent to perform an abortion on an unemancipated minor would be subject to charges of criminal homicide.

The attorney general's office has up to 45 days to render a formal opinion on the questions.

Deputy Secretary of Agriculture Chuck Conner has announced the expansion of Conservation Reserve Program (CRP) acreage eligible for emergency haying and grazing for livestock producers in counties approved for haying and grazing in the states of Alabama, Colorado, Kansas, Nebraska, New Mexico, North Dakota, Oklahoma, South Dakota, Texas, and Wyoming. Conner also announced that producers' CRP rental payment will be reduced by only 10% instead of the standard 25% on CRP lands that are grazed in 2006.

"Drought conditions have created serious hardships for many farmers and ranchers in the Great Plains and other areas across the country," said Conner. "Today, I'm pleased to announce that USDA is expanding the CRP acreage open for emergency practices, such as haying and grazing, to provide relief for producers at a time when it is very much needed."

The expansion will allow livestock producers from eligible counties to obtain needed hay or forage. The expanded area radiates 150 miles out from any county approved for emergency haying and grazing in any above- mentioned

state. For convenience of CRP participants and the public, the Farm Service Agency (FSA) will post a map of counties approved for emergency haying and grazing with an approximate 150-mile radius to its web site by clicking "Conservation" at [www.fsa.usda.gov](http://www.fsa.usda.gov).

CRP is a voluntary program that offers annual rental payments and cost-share assistance to establish long-term resource-conserving cover on eligible land. This action will permit approved CRP participants to cut hay or graze livestock on CRP acreage, providing supplemental forage to producers whose pastures have been adversely affected by drought.

To be approved for emergency haying or grazing, a county must be listed as a level "D3 Drought-Extreme" or greater, or have suffered at least a 40 percent loss of normal moisture and forage for the preceding four-month qualifying period. State FSA committees are reminded they may authorize emergency haying or grazing of CRP in counties currently listed as level D3 drought according to the U.S. Drought Monitor. CRP participants should submit applications with their local USDA Farm Service Agency (FSA) offices

upon approval.

To participate:

\*Livestock producers in counties approved for emergency haying or grazing assistance may purchase hay or conduct emergency haying and grazing of eligible CRP acreage from CRP participants (in the expanded area) willing to provide hay or haying and grazing.

\*Livestock producers in counties approved for emergency haying or grazing assistance must certify they are an eligible livestock producer in an eligible county approved for emergency haying and grazing and that they are requesting emergency haying and grazing of eligible CRP acreage from another eligible CRP participant in the expanded area who is willing to provide hay or grazing.

\*The primary nesting and brood rearing season of the state where the land to be hayed or grazed is located will be respected. For example, a portion of Minnesota is within the 150-mile range of North Dakota counties approved for emergency haying and grazing. Minnesota's nesting season ends Aug. 1. Livestock producers in North Dakota counties approved for emergency haying and grazing and who wish to hay or graze CRP acreage in

## Guide to help protect food supply

The U.S. Department of Agriculture has released a new guide to help agricultural producers enhance security at the farm level, announced Glenn R. Brzozowski, County Executive Director for the Haskell County Farm Service Agency (FSA).

"There is no one-size-fits-all approach to protecting agriculture, but the 'Pre-Harvest Security Guidelines and Checklist 2006' is a guide that addresses potential security concerns for an agricultural operation regardless of type or size," said Brzozowski.

Food and agriculture biosecurity is an important component of USDA's mission. Improving awareness through enhanced outreach and communications is a key element of USDA's homeland security efforts. The voluntary guidelines and checklists were developed based upon recommendations made by producers throughout the United States. Guidelines have been developed for general agriculture; dairy; crops; cattle and poultry security.

According to, Brzozowski, this guide is the latest in a series of materials produced by USDA to bolster food and agriculture security. USDA continues to work closely with its federal, state and local government partners as well as industry stakeholders to develop sector-wide guidelines. For instance, guidance has been issued by USDA for food processors and distributors, and for agricultural transporters in coordination with the trucking industry.

Agriculture and food account for 13 percent of the U.S. gross domestic product, 18 percent of its employment and \$140 billion in revenue. USDA continues to work with its federal, state, local partners as well as industry in protecting the nation's agriculture and food production, from threats such as natural disasters and either the naturally occurring, intentional or unintentional introduction of diseases and pathogens as they do not respect geographic borders. The interconnected global food system contributes to our nation's economic strength by improving production and marketing efficiency and providing timely responses to consumer needs.

USDA's local Farm Service Agency Service Centers are distributing the "Pre-Harvest Security Guidelines and Checklist 2006" to agricultural producers throughout the country.

Minnesota may begin Aug. 2.

Only livestock operations located within approved counties are eligible for emergency haying or grazing of CRP acreage. CRP participants who do not own or lease livestock may rent or lease the grazing privilege to an eligible livestock farmer located in an approved county.

For all land enrolled in CRP that has been approved for emergency haying and grazing, the Farm Service Agency will reduce the payment reduction from 25 percent, which was announced earlier, to 10 percent. This 10-percent payment reduction will be assessed based on the number of acres actually hayed or grazed times the CRP annual rental rate times 10 percent. CRP participants who prepaid the 25 percent payment reduction, will have the difference refunded.

In addition to making forage available on CRP land, USDA is operating a range of programs to assist producers affected by drought or other natural disasters.

A: A landspout is a tornado that has formed from clouds that do not rotate, explains Brent McRoberts of Texas A&M University.

"Because most tornadoes are formed from rotating clouds, they tend to be strong to severe in strength," he says. "But a landspout is generally a weak tornado not associated with supercell thunderstorms. Landspouts typically are short-lived and weak, but some have the potential to cause some fairly severe damage."

Q: Can they occur over water?

A: The answer is yes, and these are called waterspouts, McRoberts adds. "Waterspouts are common over lakes and the Gulf of Mexico region in late spring and summer," he notes. "They often appear white in color because they have water in them. Like landspouts, they are generally not nearly as strong as a supercell tornado, but they can sometimes cause moderate to severe storm damage. Because they develop from non-supercells, landspouts and waterspouts can be almost impossible to forecast, and many of them are never even detected on radar."

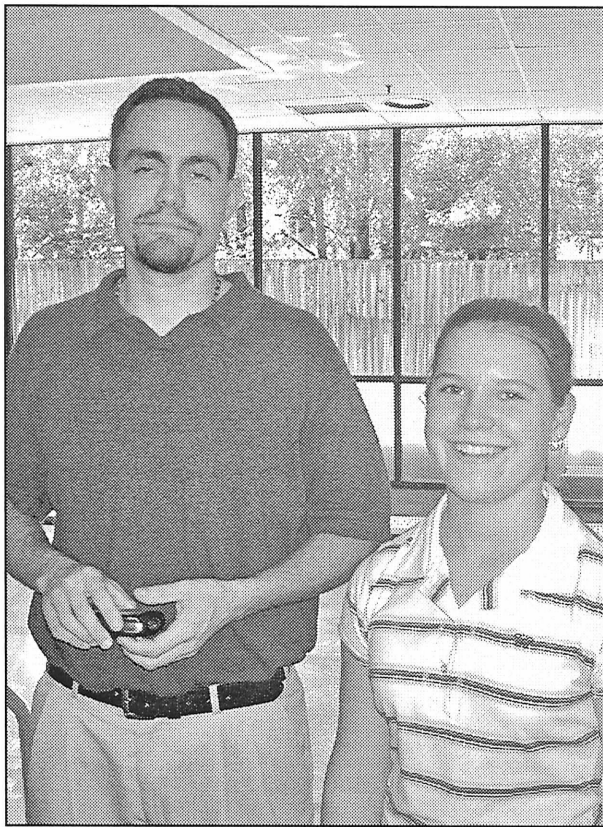

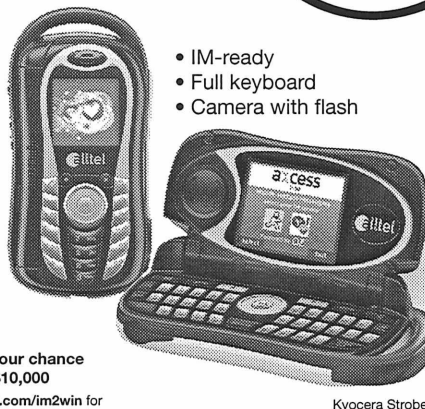
