Ozonans are ready for the Christmas holiday. Those waiting until the last minute to shop today may find shelves empty, as Ozona merchants have enjoyed the best business ever during a Christmas gift-buying period.

### Motorcycle advice for parents

Parents who are thinking of giving motorcycles to children under 18 years of age need to think again, according to DPS drivers license trooper, Joe Miles.

Miles said effective January 1, a person cannot get a license to operate a motorcycle unless he is 16 years of age and has completed a drivers education course in the operation of a motorcycle. Miles said the only course in this area he is aware of is in the school at Del Rio where motorcycle operation is taught in the drivers ed course.

It would be extremely unlikely a person under the age of 18, could get a license in Ozona. Miles said at age 18, a person can take the test and pass it to get a valid motorcycle operator's license.

### Sign replacement for I-10

A sign replacement project has begun on Interstate Highway 10 through Crockett, Sutton and Kimble Counties, and also on U.S. 87 North of San Angelo in Tom Green County.

The Dura-Line Corporation of Oklahoma City is doing the work, under the direction of District 7 Maintenance Engineer, Charlie F. Low of the State Department of Highways and Public Transportation (DHT) in San Angelo.

Low stated that the project will continue for several months, and will "greatly improve visibility, safety and convenience for area motorists." Drivers are asked to observe caution when passing through construction sites.

When work is in progress, barricades, warning signs, cones and in some cases flagmen will be on hand for direction of traffic.

Most of the work will be done from the shoulders of the roadway, with as little inconvenience to the public as possible.

Rozelle received the same sentence for burglaries committed in Sonora, the terms to run concurrently.

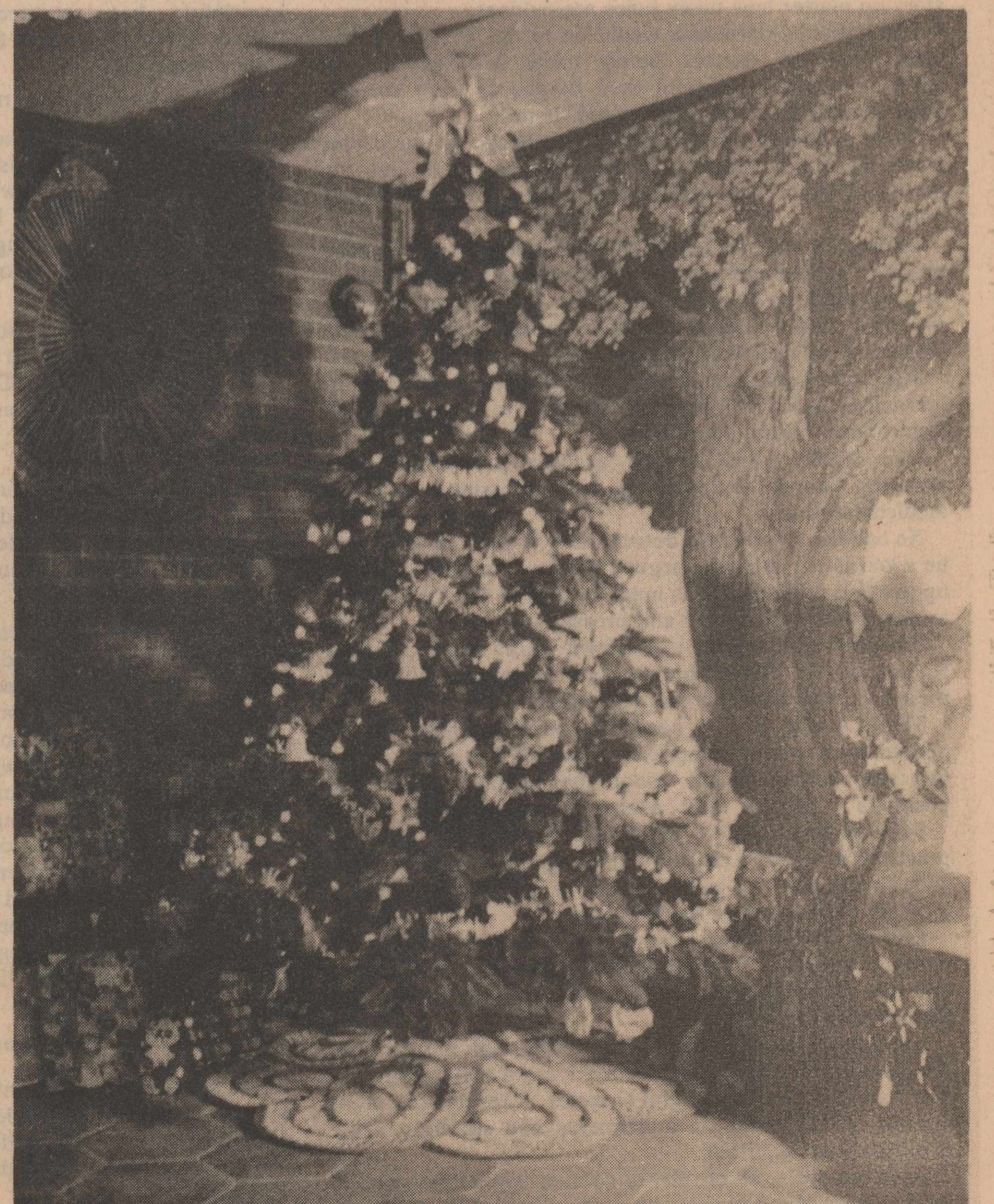

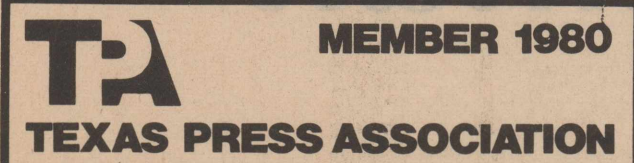

**Ethics**

**Press Fairness**

Writing in Harper's magazine more than a year ago and reporting on the business community's view of journalism, Prof. Louis Banks of MIT (a former Fortune editor) had his article titled, "Memo to the Press: They hate you out there."

Banks did not need to confine his report to business attitudes. In a January study done for the First Amendment Congress, George Gallup Jr. said "the press in America is operating in an environment of public opinion that is increasingly indifferent - and to some extent hostile - to the cause of a free press in America."

In October, the Public Agenda Foundation released a survey even more gloom. Percentages ran very high in reflecting a public view that there should be laws requiring fairness by newspapers and television in coverage of controversial issues and politics.

It needs to be put in terms that cannot be misunderstood. If current attitudes hold and harden over the next several years, the press can expect efforts to rework parts of the U.S. Constitution.

Because the press almost literally slept through the process, the late Sen. Everett Dirksen came astonishingly close to winning a full constitutional convention. His central motive was to try to reverse the U.S. Supreme Court's 1-man/1-vote decision.

As many state legislatures voted for it as have gone for the equal rights amendment. In a series of speeches, supreme court Justice Earl Warren kept saying if a new constitution had to be voted on in the climate of the late 1960s, we would likely come forth with no bill or rights.

Dirksen's drive was derailed because the leaders of the American Bar Association felt the national fabric could not stand the tearing effects of such a confrontation of polarized viewpoints.

The Bar exercised its muscle with the legislatures.

The point is we are not dealing with pipe dreams about antipathy to the press and what might come of it.

What the public isn't aware of is that an internal tug-of-war has been going on in the press for a generation. Journalism includes all types of people - from great to dreadful, with everything else in between.

While they are devout defenders of press freedom as the linchpin of democratic liberties, many news people have been openly critical for years about the trend toward intrusion of opinion into news accounts; about unbalanced reporting; about shabby, outworn drives to be first with a story no matter how many holes are evident.

The nation's journalists would be in hot pursuit if they were to catch doctors being hasty and cavalier in examinations and insistent their diagnoses were correct, even when facts clearly challenged them.

There is intent in drawing this hypothesis. As the doctor treats the bodily functions of individuals, one by one the journalist deals with almost a total population - feeding minds.

Clearly, a serious (even though inadvertent) mistake might be as damaging to a whole community as could be a doctor's error in an individual case. Put this postulate to reporters, and I suggest a majority would reject even the semblance of a parallel responsibility.

The critical missing factor for a meaningful change in journalistic practice is the craft's inability to agree on, much less control, ethical standards.

One wholly valid reason excuses journalists from licensing standards applying to professions such as medicine and law.

No one has the right to determine who shall, or shall not, be a journalist. It can be argued the founding fathers drew up the free press clause as much to protect the Tom Paines as those who owned type and presses.

But granting this, one can ask why more of journalism's leaders do not move more strongly to enforce with vigor their own ethical beliefs and standards?

There would be no need for press councils or for ombudsmen (reader's representatives) if a majority of the directing editors would adopt the simplest of ethical positions - prompt and adequate correction of error.

Some of this goes on, but it still is clearly too casually practiced to satisfy a citizenry growing out of patience with such absurd postures as "We stand by our story" when it is patently clear injustice has been done.

If, for one, have grown weary of the theme that there is nothing essentially wrong with journalism as it is practiced and that the complaining is simply blaming the messenger for delivering bad news.

I hold that the public is sophisticated enough to know that the defeats of life have to be reported, but it also wants news about some of the meaningful victories. It resents the press showing 20/20 vision on indictments and suffering acute myopia about acquittals.

Back full cycle, all of this, of course, applies full well to the business of the society, its economics and its coverage. That may offer more than enough for subsequent comment.

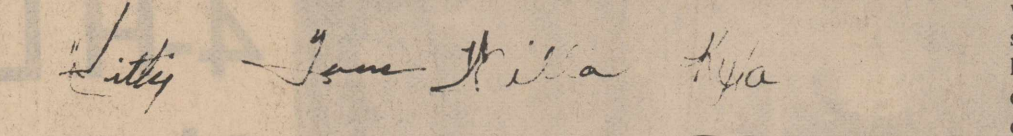

**STATE CAPITAL HIGHLIGHTS**

**AUSTIN** — The Texas Legislature will be appropriating more money to build update prisons this session, an expenditure it has long avoided.

Last week a federal judge ruled the Texas prison system, largest in the nation, violates the constitutional rights of its inmates in virtually every aspect.

Among the violations cited by U.S. Dist. Judge William Wayne Justice of Tyler are routine beatings, other forms of violence, poor medical treatment, unsafe working conditions, and unsanitary living and eating quarters.

The cost of making the sweeping changes ordered by Justice is expected to run into millions.

Spokesmen for the Texas Department of Corrections point out they have not been able to initiate improvements on their own because the Legislature has repeatedly turned down requests for higher budgeting.

Justice's findings are not unexpected in a state where soft treatment of criminals is an unpopular stance with voters. Still, the depth of his court-ordered reform caught many Texas officials off-guard.

His 248-page opinion, which he took over a year to write, notes that the TDC system also violates several state laws and many of its own rules and regulations.

In apparently the first such ruling in Texas, the judge held that state job and safety laws apply to the 18-unit, 25,000-inmate system.

His latest ruling is not the first controversy in Judge Justice's long legal career. In the past his rulings have desegregated Tyler schools, forced a Tyler junior college to accept students with long hair and forced a Tyler high school to stop using the Confederate flag for school emblems. Recently he ruled a Tyler school district must educate the children of illegal aliens without charging tuition.

Texas Atty. Gen. Mark White said he will wait until a final judgment is handed down in February before deciding whether to appeal the TDC case.

**\$536 Million**  
Lt. Gov. Bill Hobby said the Legislative Budget Board is recommending the Legisla-

ture approve \$536 million for TDC over the next two years.

"The prison system is overcrowded. Basically, it is a system built for 16,000 prisoners and it now has 29,000," Hobby said.

"That there are deficiencies in the system is unquestioned."

Texas is not the only state to come under heavy criticism for its penal system. Eleven other states have been similarly chastised by findings.

**Election Miscues**  
The outcomes of some state elections are still up in the air.

State Rep. Al Brown, D-San Antonio, who lost his reelection bid to a retired military man, has charged discrepancies among the election's mailed in absentee ballots. The House of Representatives will decide which candidate to seat when it convenes next month.

**you and the LAW**  
PRESENTED BY THE STATE BAR OF TEXAS

**Q: While I was renting my apartment, the building was sold to a new owner. Now that I gave notice, paid my rent in full, and moved out, the new landlord has refused to return my security deposit. What are my rights?**

**A: Both the new and old owners may be liable for the return of your security deposit. You should write both owners asking for a refund or a written accounting of all deductions. Send the letters certified mail, return receipt requested, and, at the same time, send the same letters to the same people by first class mail. If the answers are unsatisfactory to you, take the lease and the letters to a lawyer to determine whether you might sue for three times damages and other penalties.**

**Q: I own a mobile home. Is it against the law for me to pull off to the side of the road at night or must I pay to rent space at a trailer park? Can I park overnight at a rest stop?**

**A: The Texas law prohibits parking a vehicle on the paved portion of any highway. Because many shoulders of highways are paved, parking on the shoulder would probably be illegal. There is a provision for emergency parking, but police officers are authorized to**

**move any vehicle that is in violation of this law. However, you may park overnight at a rest stop or roadside park.**

**Q: We're planning to sell our home. If we find a buyer who wants to "assume" our loan, could our mortgage company come back to us for the monthly payments?**

**A: Yes, any time you sell your home by having someone assume the balance of your**

**loan, the mortgage company retains the right to look to you for the monthly payments if the buyer fails to meet them. To protect yourself in a sale of this type, the contract between you and the buyer should be written to include provisions allowing you to have title to the home returned to you in the event the buyer defaults. You would then resume responsibility for paying off the mortgage.**

**Q: Recently a lawyer agreed to defend me but he never stated the exact amount of his fee nor did we ever agree on an amount. I received an enormous bill. I don't believe I was charged fairly. What is my recourse now?**

**A: First get an itemized statement of the services and charges and go over the bill with the attorney. If the problem is not resolved, you may refuse to pay the bill, inviting the attorney to sue for the fee. The courts will then determine how much you owe. In addition, an attorney may be professionally disciplined for charging an excessive fee. To determine whether your fee violates the Code of Professional Responsibility, you must file a written complaint with the Grievance Committee in your area. Finally, and only if both you and your attorney agree, you may submit your dispute to a Fee Arbitration Committee if one exists in your area.**

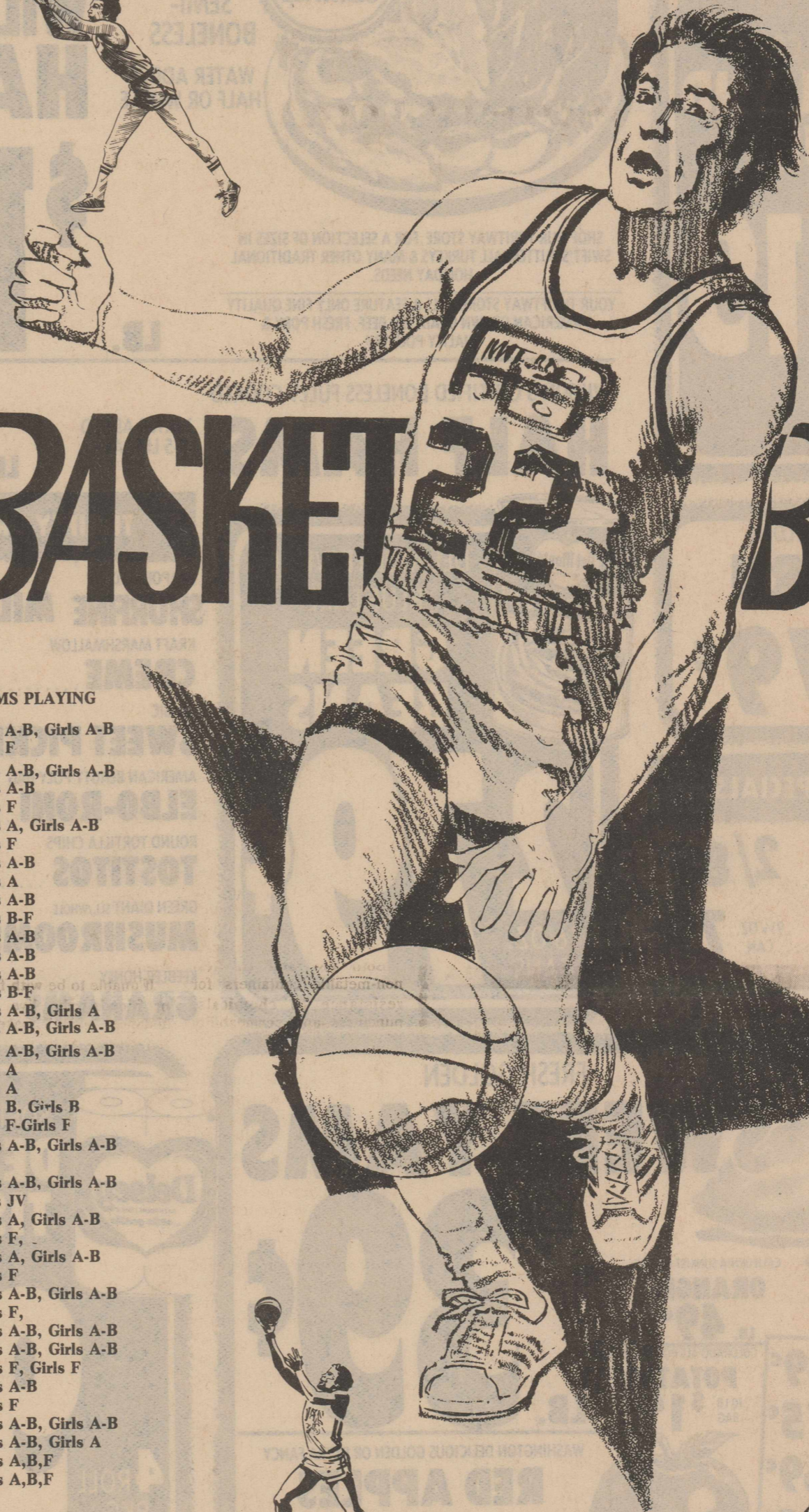
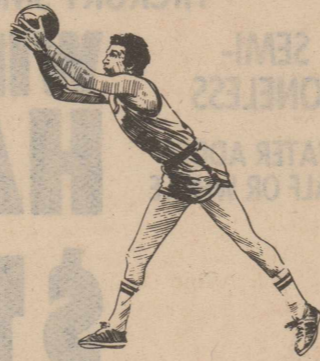

# Scholarships to Japan available to students

Youth for Understanding (YFU) is offering scholarship opportunities for American high school students interested in spending next summer in Japan.

Youth for Understanding, one of the largest teenage student exchange organizations in the world, will award more than \$60,000 in partial scholarships to qualified high school students between the ages of 14 and 18. A total of 315 American high school students will be going to

Japan through the YFU program, leaving home in mid June and returning in mid August. Youth for Understanding has exchanged more than 80,000 high school students since its establishment in 1951.

The scholarships will be awarded primarily on the basis of merit, although need may be taken into account. Among those providing funding for the scholarships are the Rockefeller Brothers Fund and many well-known Japanese companies including: Toyota, Datsun, Mitsubishi Motors, Seiko, Hitachi, Nippon Steel, Toshiba, SONY, Sanyo, Honda, Pioneer, Kikkoman and Minolta.

According to YFU President John Richardson, Jr., former U.S. Assistant Secretary of State for Education-

al and Cultural Affairs, the sponsors of the scholarships believe that greater understanding between Japan and the U.S. will result from affording young Americans the unique opportunity to live with Japanese host families and to experience Japanese culture firsthand.

Before leaving for Japan, the students will attend a three day orientation which

will introduce them to Japanese culture and tradition. The program also includes expense-paid Fall seminars for most participants for three years following the summer exchange experience. This enables students to continue to develop their understanding and appreciation of Japanese life.

Youth for Understanding is a non-profit educational organization dedicated to

promoting greater international understanding by making it possible for young people to have an overseas family-living experience. Each year the organization

exchanges about 7,500 students with 25 countries.

Interested students should apply immediately in order to be considered for this special scholarship opportunity prior to the February 15, 1981 deadline.

## Blue eggs same as others

Despite some claims, "blue shelled" eggs are no more nutritious and are no lower in cholesterol than ordinary white or brown shelled eggs.

The myths originated mainly with the Araucana breed of chickens in Chile, says Dr. Dave Mellor, poultry marketing specialist with the Texas Agricultural Extension Service, Texas A&M University System. The Araucan chicken is the best known breed producing blue shelled eggs. Actually, the eggs vary in color from light green to dark olive, so some

people have tabbed the Araucana the "Easter egg chicken."

In tests at Texas A&M University and other universities, blue shelled eggs have always had as much or more cholesterol than commercial table eggs or any other egg for that matter, points out Mellor. Actually, in a Texas A&M test, Araucana, quail, pheasant and White Leghorn eggs all had the same cholesterol content based on a amount of cholesterol per unit weight of egg.

Blue shelled eggs are usually more expensive to produce than commercial table eggs, notes Mellor. People willing to pay a high price for these eggs should recognize that the Texas Egg Law requires that all eggs graded, have a clean, sound shell and be maintained under 60 degrees F.

## January blues due to appear soon

Oh, you better watch out or you might just cry You better be prepared I'm tellin' you why January blues may appear.

The December holiday season is often followed by a period of depression known as the January blues, says Cindy Wilson, a family life education specialist.

This depression period often occurs because of the heightened amount of activities most people enjoy during the season and because of a variety of other factors, the specialist says. Taking a few steps to prevent or at least soften the January blues can be very effective, she adds.

Mrs. Wilson is on the home economics staff of the Texas Agricultural Extension Service, The Texas A&M University System.

Here are her suggestions for preventing or softening the January blues:

Plan ahead to avoid commitments to too many activities during the December holiday period.

Stay within your budget during the season rather than incurring heavy debts to keep up with the Joneses, or to have a "happy" holiday period. Material possessions do not mean the holiday season will be a happy one. Avoid going into debt.

Be realistic in your travel plans. Too much travel during a short period of time is not only dangerous to your health but can tax everyone's relationships when the travelers are weary.

Be aware of and work to avoid stirring up old conflicts within the family or between friends.

If unable to be with family or friends who live some distance away, make arrangements to be with near-by friends. This can help avoid the feelings of loneliness and depression. However, if you are one who chooses to be cheerfully alone during the holidays, don't feel pressured into joining others.

Realize that some people have particular problems during this period of the year. Perhaps a loved one is sadly missed, or perhaps memories of holidays gone by bring out inappropriate behaviors. Accept these people and their problems and work toward helping them enjoy the holidays. Be

cautious yourself in your behaviors and reactions during the holidays.

Remember, by preventing the January blues, you can work toward having a truly happy New Year.

## Gasoline needs "safety" can

Just because a can has GASOLINE imprinted on it doesn't mean that it's a safety can.

Shopping for an approved safety can for gasoline can be an involved process, says Dr. Gary S. Nelson, safety engineer with the Texas Agricultural Extension Service, Texas A&M University System.

To earn the title "safety can," a container must pass certain tests conducted by Underwriters Laboratories (UL) or the Factory Mutual

System (FM). To get a UL label a can must pass nine different performance tests. FM approval requires 11 tests. Each organization makes some tests that the other does not.

"Safety can" tests are conducted in the following areas, notes Nelson.

First, stability tests tell how easily a can will tip over. Then, leakage tests check out spout valves, seams and joints. No more than four drops can leak out per minute when full cans are tipped upside-down. Both FM and UL requires these tests.

UL tests cans for body strength while FM tests pouring spouts and carrying handles for strength. FM also tests cans under fire conditions. Tested cans must vent internal pressure throughout fire exposure and there can be no spillage.

Another FM test concerns the flame arrester, notes Nelson. A flame arrester is a screen placed within the spout which prevents flame on one side of the screen from reaching the other side by absorbing heat.

FM also tests cans for reaction to abuse. It requires that a full gasoline can, can withstand a three-foot drop to a concrete floor without sufficient damage to leak.

Both FM and UL test non-metallic containers for resistance to chemicals, punctures and permeability (fluid passage), adds the safety engineer.

So look for FM and UL labels when shopping for gasoline safety cans, suggests Nelson. While approved cans do cost a little more, they are built to last longer and to reduce serious fire hazards associated with gasoline and other flammable liquids.

But even with an approved safety can, do not store gasoline and other flammable liquids in car trunks or indoors where pilot lights and other ignition sources may exist, cautions the engineer.

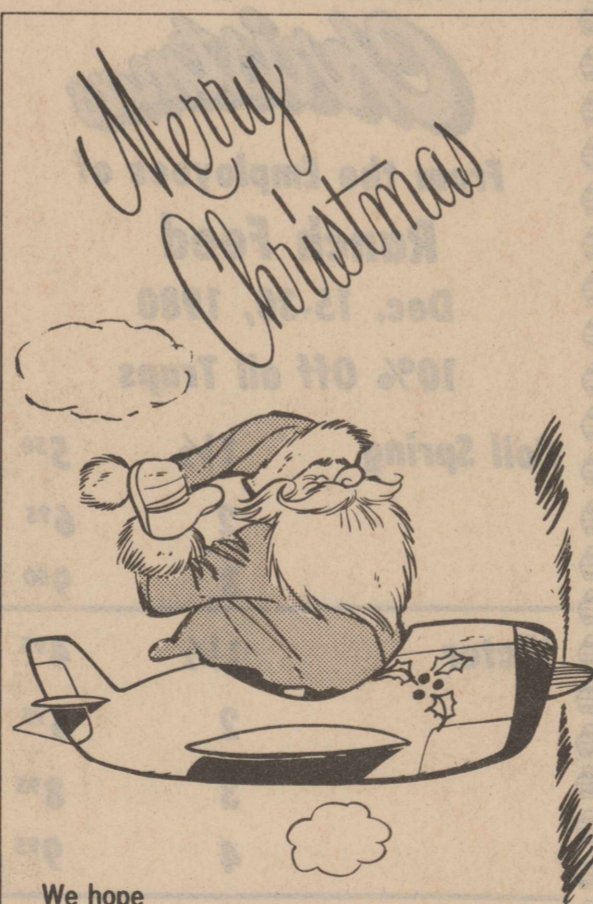

**Bids due for installation**

Bids for installation of raised reflective pavement markers and thermoplastic pavement markings on 142.9 miles of highways in the 13-county San Angelo district are scheduled to be received January 13 by the State Department of Highways and Public Transportation. San Angelo District Engineer Doc Watson said the new markings will reduce future costs and greatly improve night and bad weather visibility of pavement lines. Charlie Low, of San Angelo, is the department's engineer in charge of the project.

**Motorists need to be safety conscious**

The director of the Department of Public Safety today called on all holiday drivers to substantially improve their driving safety consciousness; otherwise, the Christmas and New Year's holiday periods may claim as many as 95 lives. Colonel Jim Adams said "we realize the added dangers of traveling by motor vehicle during these holiday periods and we want to help avoid the tragedy and suffering which could mar this otherwise happy season." Adams believes that "we

don't have to continue suffering the spiraling traffic deaths if drivers use extreme caution in traveling on the streets and highways in Texas." During the first 10 months of 1980 there were 356,896 motor vehicle accidents in Texas in which 153,099 persons suffered personal injuries. Adams said that in the comparable 1979 period, there were 372,448 accidents in Texas during which 153,884 persons were hurt. The total motor vehicle accidents are down 4.2 per cent when compared to the same period last year. Adams said that statewide traffic deaths are presently running about three per cent ahead of the record pace of a year ago, in which 4,229


persons were killed in motor vehicle crashes. When comparing the first 10 months of this year against 1979 figures, Adams indicated that during the January-October period, the state had counted 3,109 fatal accidents in which 3,562 persons were killed. In the first 10 months of 1979, there had been 2,968 fatal accidents, resulting in 3,415 deaths. This reflects a 4.3 per cent increase over the comparable time frame. During the first 11 months of this year, there have been 3,855 motor vehicle deaths, of which 2,044 have been recorded in cities and towns with the remaining 1,811 occurring in rural areas. Adams estimated that 58 persons would be killed in

motor vehicle accidents during the Christmas holiday weekend and another 37 persons would be killed during the New Year holiday weekend. Both holiday periods are 102 hours long. He said the Christmas count starts at 6 p.m. Wednesday, December 24 and continues until midnight, Sunday, December 28. The New Year holiday count starts at 6 p.m. Wednesday, December 31 and ends at midnight, Sunday, January 4, 1981. Adams said that during the Christmas holiday period last year, 72 persons were killed in traffic and 43 were killed during the New Year

holiday period. "During both forthcoming major holidays, our traveling public has an opportunity to take advantage of slower speeds while helping our law enforcement officers across Texas reduce the spiraling death toll. I would certainly urge all drivers to utilize only wise driving habits and caution while on the roadways. In so doing, our motorists would be in a better position to live to enjoy the full holidays," he added. Adams also reminded motorists that many lives would be saved and serious injuries would be reduced during the crowded driving time

through greater utilization of seat belts and other restraint devices. All available DPS Troopers will be on duty throughout both holidays. They will be joining with local officers to place special emphasis on removing drunks and reckless drivers from city streets and highways. # Hay needs testing this year

Hay is now being fed in many areas of the state, yet most producers don't know the quality of hay they have. Since much of the 1980 hay crop was of low quality due to dry conditions, producers should consider having their hay tested for protein content.

A hay test to determine the protein content is helpful in several respects, points out

Don Dorsett, forage specialist with the Texas Agricultural Extension Service. Protein content relates to production practices which influence quality, such as maturity and fertilization, and also provides a guide as to feeding such hay according to its nutritional value.

Different classes or types of beef cattle have different nutritional requirements,

emphasizes Dorsett. Animal nutritionists say that beef cattle cannot meet their requirements for protein when hay is 7 percent crude protein or below. Yet a recent summary of hay tests conducted for producers by the Forage Testing Service at Texas A&M University revealed that 32 percent of the Coastal bermudagrass hay tested 7 percent or below.

The summary also indicated that more than 69 percent of such hay as Bahiagrass, sudan, sorghum, bluestems and Johnsongrass tested 7 percent crude protein or below.

Because of this variability in crude protein levels, Dorsett encourages producers to have their hay tested.

# Understanding men's shirt sizes

In a quandry about men's shirt sizes - and perfect fit? You're smart to be!

Sizes and styles in men's shirts may vary greatly among manufacturers, so, trying on the shirt before you buy is wise consumer action, says Beverly Rhoades, a clothing specialist.

Ms. Rhoades is with the Texas Agricultural Extension Service, The Texas A&M University System.

Selecting the correct size is important. Size is determined by the circumference of the neck and the length of the arm. Measure around your neck with a tape measure just below the adam's apple. Sleeve length is determined by measuring from the base of the neck at center back, across the shoulder and down the back of the arm to the wrist bone, with the arm slightly bent. Collar size and sleeve length are usually marked on the collar band.

Regardless of the style of shirt, difference in body fullness will exist between manufacturers. Body fullness is determined by the relationship of the garment tail to the shoulder width.

The tapered body, often called European fit, is darted rather severely so that the fit of the shirt follows

close to the torso from shoulders to chest to waist, where it flares out again. The armholes are high and relatively close fitting. This shirt is especially designed for the man who has broad shoulders and a slim waist. These shirts worn on other torsos will pull and bulge. Also, remember, because of the extra attention to cut, these shirts may cost more.

On the other hand, a full-cut body has no taper at all, so the dimensions are the same at the chest, waist and tail. Armholes are lower and looser. These shirts are designed for the full torso man. The man with a tapered torso will find that these shirts may appear sloppy.

Then there are the semi-tapered shirts. Semi-tapered shirts are proportioned with casual darning for the average build. This cut may provide the body fullness needed for most men.

In general, when you're shopping for shirts, look for the shirt type that best suits your body build and creates a neat appearance. The labeling terms which relate to the cut of the body may serve only as a "hint" because there really is little uniformity in body contouring among different shirt makers.

Another factor in style is length of the shirt body. Shirt tails should be long enough to remain neatly tucked into a waistband. The tall man or one with a long torso should select styles or brands with long or extra long tails.

Finally, here's one last tip: to reduce frustration and shopping time, find brands that fit you properly and comfortably and stick with them.

# Income tax packages due soon

Taxpayers will receive their Federal income tax packages within the next two weeks, the Internal Revenue Service says.

The IRS sends taxpayers either a 1040 or 1040A package, depending on the form the taxpayer filed last year. Taxpayers who need to file a different form this year, because of a change in tax status, can pick up the proper form and schedules from their local IRS office, or from one of the many post offices that stock them. Extra forms are also available by using the order blank in the back of the tax package.

Whether taxpayers use the form the IRS sends them or order a different one, the IRS encourages use of both the peel-off address label and pre-addressed, coded return envelope provided in the originally mailed tax package. The label and envelope speed up the processing of the return, lessen the chance of making mistakes, and produce a faster refund for the taxpayer.

If there is a mistake on the label's information--the taxpayer's name, address, and social security number--or if the envelope is marked with the incorrect form number, the IRS said the taxpayer should make the necessary changes in ink.

The tax package contains complete instructions for filling out the tax return and any schedules which the taxpayer needs to use. If additional information is needed before deciding what credits, exemptions, or deductions should be claimed, there are over 90 free special publications that can be ordered by mail using the order form in the tax package, or by calling the IRS number listed in the local telephone directory.

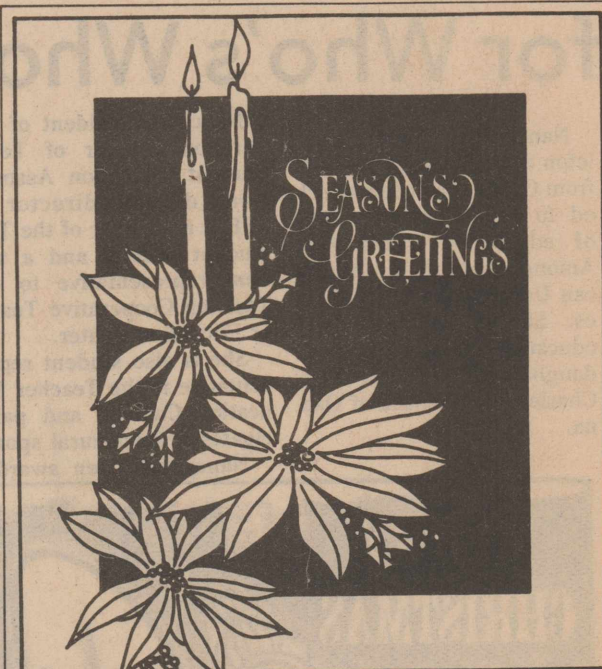

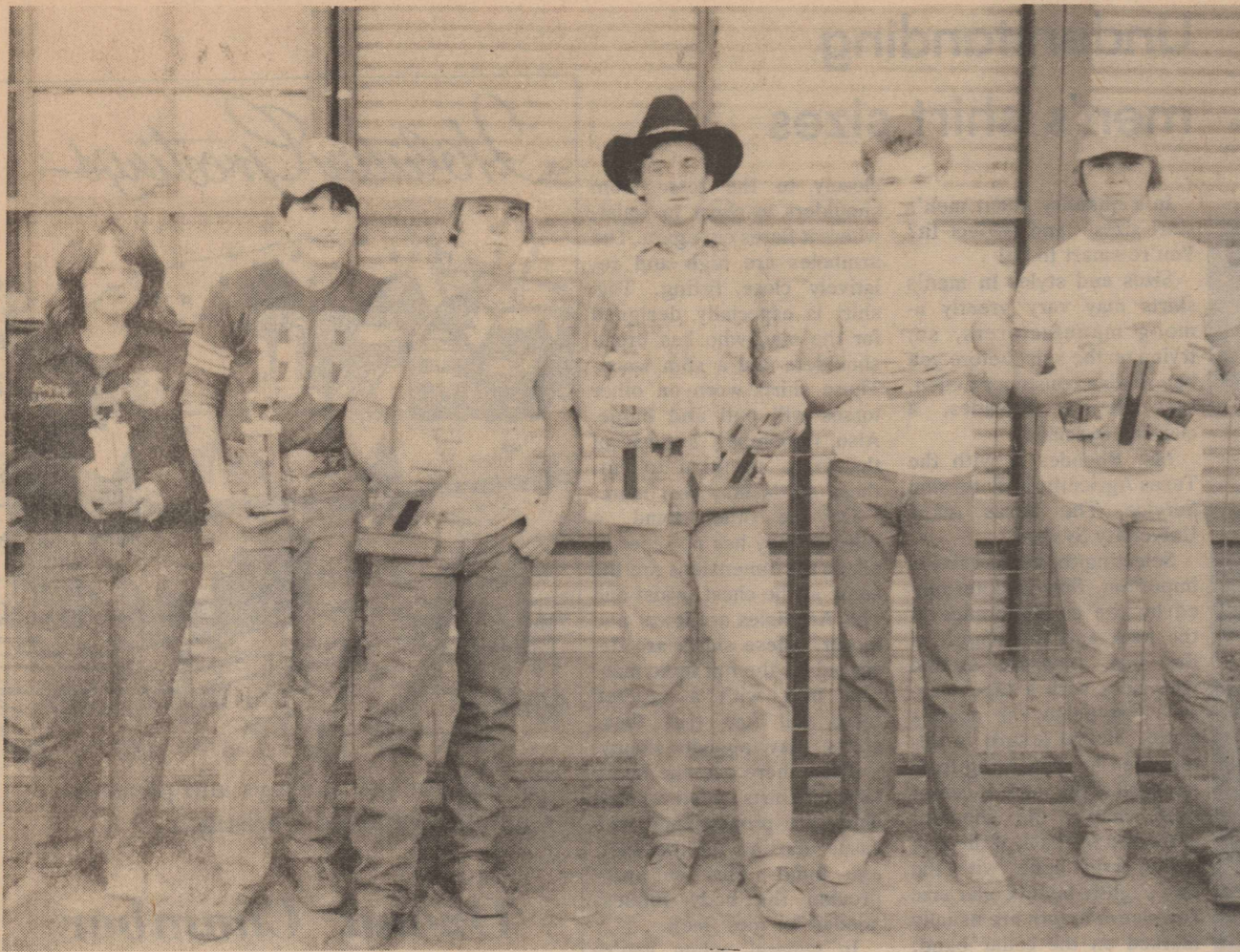

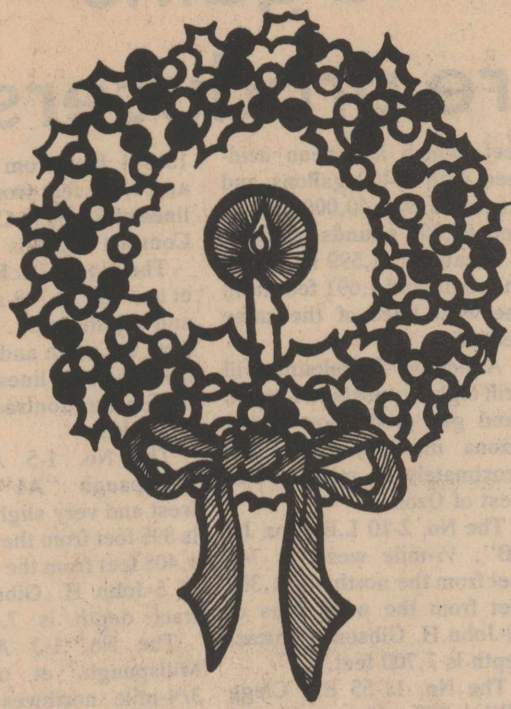

## Reagor offers advice on fireplace safety

Today's popularity of fireplaces - in many shapes and sizes - calls for more emphasis on safe operation, says Billy Reagor, county agent with the Texas Agricultural Extension Service, Texas A&M University System.

The agent offers these fireplace safety tips:

Keep highly combustible materials, such as loose papers, cardboard and fabrics, away from the fireplace area. These materials could easily be ignited by stray hot ashes, glowing embers or flying sparks. Place ashes in a metal container with a tight-fitting lid, pending final disposal.

Make sure the chimney and flue lining are clean and the damper in proper working order. If the flue is obstructed, smoke, carbon monoxide and other toxic gases can escape into the living area. Soot and tar deposits can build up on the walls of the chimney and flue. These deposits are flammable, and if they are not periodically removed, can be the source of a fire.

Open the damper before starting a fire, and keep it open until every ember is completely out - again, carbon monoxide gas can fill the living area.

Place a close-fitting screen or door over the front of the fireplace to prevent sparks and hot coals from popping out.

When building a fire, don't overdo it. Overfiring can make the firebox and flue lining red-hot, causing a flue and chimney fire. Place a moderate amount of fuel in the firebox area. Also, people who use lighter fluid on a wood or coal fire are asking for trouble - a flash-back fire can result, and invisible vapor can travel throughout the room, causing a fire hazard.

Fireplace fires consume oxygen while burning. Therefore, make certain that there is proper ventilation, both for burning efficiency and for the safety of those in the house.

Store wood in a dry area prior to burning. A six-month

storage period is desirable. The drier the wood, the more evenly the fire will burn. Using wood that is not sufficiently dry increases the possibility of soot and tar deposits as well as flying sparks.

A factory-built fireplace or fireplace stove should bear the Underwriters Laboratories listing mark, indicating that it meets recognized safety standards.

When installing a factory-

built fireplace or freestanding fireplace stove, seek expert help and follow the manufacturer's instructions closely. Make certain that

freestanding stoves are placed an adequate distance away from combustible materials.

Keep safety in mind and enjoy warm, pleasant and nostalgic times using your fireplace, adds the agents.

The home was festively decorated with garlands, highlighted by a beautiful tree trimmed in white. Gifts were exchanged and refreshments served from the buffet.

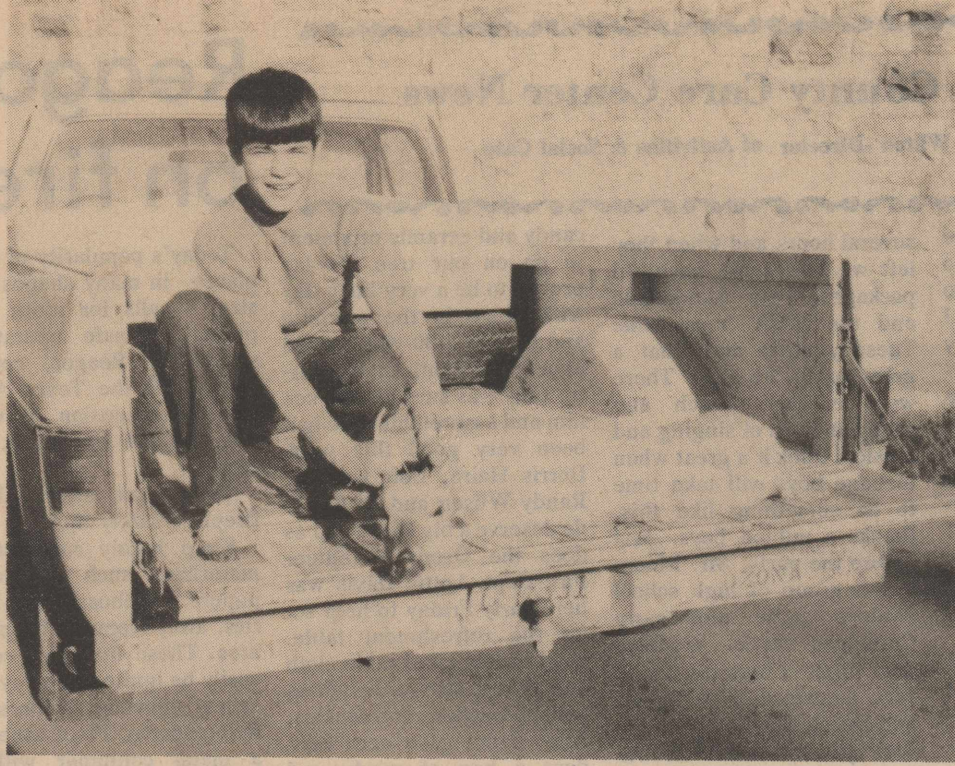

# Aliens need to report

According to Mr. Richard M. Casillas, District Director of the San Antonio Immigration and Naturalization Service office, the information furnished by aliens in reporting their addresses has been declared confidential by statute.

These reports must be submitted during January each year by all aliens in the United States, with few exceptions. Forms on which to submit the reports are available at any Post Office or office of the Immigration and Naturalization Service. Per-

sons who are unable to pick up a form because of illness, or other reasons, may have a relative or friend obtain a card for them. The card should have a 15c postage stamp affixed and placed in the mail.

# County field gains two more producers

The Watson Ranch (Canyon gas) field of Crockett County gained its fourth and fifth producers with completion of two projects by Anderson Petroleum Inc., Ozona, 25 miles southwest of Ozona.

The No. 2-26 Ralph Watson, 1 5/8 miles southeast, was finalized for a calculated, absolute open flow of 1,100,000 cubic feet of gas daily, with gas-liquid ratio of 146,299-1. Gravity of the condensate was 69.6 degrees.

Production was through perforations at 5,921-940 feet, which had been acidized with 950 gallons and fractured with 40,000 gallons and 60,000 pounds of sand.

Location is 1,396 feet from the south and 1,453 feet from the east lines of 26-A-TCRR.

The No. 1-26 Ralph Watson, 1 3/8 miles southeast, was finalized for a calculated, absolute open flow of 899,000 cubic feet of gas daily, with gas-liquid ratio of 26,643-1. Gravity of the condensate was 69 degrees.

Production was through perforations at 6,458-624

feet, which had been acidized with 1,400 gallons and fractured with 40,000 gallons and 60,000 pounds of sand.

Location is 1,599 feet from the south and 1,691 feet from the west lines of the same section.

Anderson Petroleum will drill eight oilposts to Canyon sand gas production in the Ozona multipay field, approximately 24 miles southwest of Ozona.

The No. 2-10 L.B. Cox Jr. "B", 1/2-mile west, is 740 feet from the north and 1,300 feet from the west lines of 10-John H. Gibson. Contract depth is 7,700 feet.

The No. 11-55 Bill Clegg "B" 1 3/8 miles south and slightly west, is 12,738 feet from the north and 3,322 feet from the west lines of Runnels CSL No. 55. Contract depth is 7,000 feet.

By Jerry Lay Here's a football oddity-There was once a major college football player who appeared on the field with a different uniform number every time he scored. He was Bernardo Bramson, who played for the University of Maryland in 1964-Bramson was a kicker, and Maryland got permission from the NCAA to make Bramson a sort of human scoreboard-Maryland changed Bramson's number with each point he scored. For example, in one game against South Carolina, Bramson started the game wearing No. 3, then changed to No. 4, and 5 after extra points, and switched to uniform No. 8 after a field goal.

One of the most interesting football games ever played was a National Football League play-off game in 1965 between Baltimore and Green Bay. Baltimore's 2 quarterbacks were hurt and unable to play, so at quarterback they used a halfback, Tom Matte, who had never played quarterback before in pro ball. Matte had the plays taped to his wrist so he could remember them. As he went into the huddle for each play, he'd study his wrist band. He captured the imagination of the nation as, despite his inexperience, he led Baltimore to a tie with Green Bay in regulation time and lost only in overtime. His wrist band is now in pro football's Hall of Fame.
