

public about the deadly snakebite which can kill its victim if not treated immediately. The last bite victim was a

After Ozona physicians stay clear of the dangerous rattler whatever time of year. The unusually dry range conditions are probably a contributing factor as well, courtroom Monday morning, so it pays to be cautious even in town.

Parents should caution children to be careful around wood piles, rocky ledges, rock piles and even tall grass and weeds. They should be warned never to try to pick up or play with any kind of snake. And the parents should heed their own advice.

Dove hunters, especially, should take extra care when hunting and wear a tall shoe or boot for protection. If there is no weapon to kill a rattlesnake when one happens upon one, flight is the only good advice. In spite of the old saying "a rattler always warns before it strikes," this has not proven true, as a year or so ago, an Ozona woman stepped off her front proch and was bitten before she knew what

Commissioners court has full agenda for meeting

The Crockett County Commissioners Court met in regular session after meeting with the Grand Jury until

around 10:00 a.m. in the with a full agenda. Judge Johnny Jones called

the meeting to order, postponed approving bills until the afternoon, and asked the clerk to read the minutes of previous meetings. Following the reading of the minutes of various meetings, the judge took exception to the minutes of the meeting of July 13, and some controversy followed between County Clerk David Weant

and Judge Jones. The judge and the clerk were at opposite ends of the pole about that particular meeting. Weant contended the court called an unofficial meeting at the road barn following the morning meeting. The judge said everyone knew the time and place of the meeting and it was announced before the court adjourned for lunch. Judge Jones questioned everyone in the court about

their version of the meeting

and all who were present on that day said they understood the time and place of the meeting. Weant expressly denied he

heard it. He said he knew there would be a meeting on the matter but did not know the time and place.

Judge Jones admonished the clerk that the minutes needed to reflect what was done. He said everyone knew the time and place of the meeting and the minutes must reflect the same. He ordered the clerk to amend the minutes, taking out anything that would make the court seem devious and secret and evasive to the public. The clerk acquiesced. 



GLOOMY GOOD NEWS

Judging by what you read in the newspapers and see on the network news, "Reaganomics" is a failure. Not only is it responsible for near-record high unemployment and the continuing economic slump, the story goes, but it has heaped misery on the less fortunate through savage cuts in social services designed primarily to widen the gulf separating rich and poor.

As fallacious as the above statements are, their constant repetition has begun to affect even many of the President's long-time supporters. Though the President's program went into effect less than a year ago - and the first really meaningful personal tax cuts came our way just two months ago — Reaganomics has become the whipping boy for all of our economic ills.



But buried beneath this litany of gloom and doom is an untold story of progress in the war against inflation, high interest rates, and a still generous and expanding federal budget.

When the Reagan administration took office, Americans were groaning under a 12.4-percent inflation rate. Interest rates were running above 20 percent, and government spending was growing by 17 percent per year. Bracket creep, moreover, stole an ever-increasing percentage of personal income in federal tax revenues. So as your wages were pushed up by inflation, the government took a bigger cut — and your buying power went down.

What has happened after a year and a half of "Reaganomics"? Inflation has been more than halved, and in March of this year — for the first time in seventeen years — prices not only didn't increase, but they actually went down! Interest rates have fallen dramatically, though not enough yet to reinvigorate the housing market. Still, the prime interest rate is down to below 14 percent, a sharp drop from the 20-percent high that Ronald Reagan inherited. And the growth of government spending has at least been slowed.

The so-called dog-food budget that President Reagan submitted to Congress earlier this year was, of course, a liberal fiction. This "austere" budget provided for 95million meals a day for needy Americans, medical care for 47-million people, subsidized housing for 10-million Americans, and 7-million loans and grants for deserving and needy college students.

But the outrage with which this budget was met in Congress led people to believe that the President intended to starve the poor and rob the elderly.

Between congressional demagogues and a heady barrage of distortions aired nightly on the network news, is there any wonder that the President has had a difficult time restoring public confidence in the economy?

The President has been doing a herculean job working with his congressional supporters. Perhaps he's done too well. Victory, we all know, is the tonic that makes life worth living to the politician. Sooner or later all politicians find out that victory exacts a high price: compromise. Thus, we have the specter of Ronald Reagan, the great tax-cutter, pushing a tax increase of historic proportions and Ronald Reagan, the great world leader, cozying up to the Red Chinese, at the expense of our long-time allies on Taiwan.

At a time when the economy is showing signs of real improvement, it is hard not to feel a sense of gloom at the sudden turn of events.

Compromise, of course, is fine. But compromise that is damaging and wrong means we're back to business-asusual in the Nation's Capital.

way into sudden changes for the next two months, we may still expect sweltering days, longer and cooler nights. If any of your spring flowering shrubs need pruning this should be done now for the new growth to have time to mature before freez-

ing weather. Some have asked about heavenly bamboo (nandina their spider plant that is domestica), rosemary (roshealthy looking and attractive, but the end of each leaf looks like it is dying. Fluoride in the water often causes tipburn on this plant. One way to prevent this condition is to add one teaspoon of dolomitic limestone per 6inch pot, repeating the appli-

cation every two months. Another way is to use only fluoride-free water for watering the plant using either rainwater or tapwater that has been allowed to stand for 12 to 24 hours. Many are selecting ever-

green shrubs for containers used as accents on a terrace, deck or an entry. Permanence and portability are among their assets.

Choose slow-growing plants that can remain in the same container for a number of years. Also look for a plant that is tolerant of wind and drought. Also one that suits the amount of sun or shade provided by location it will occupy.

Choose a container made of treated wood, stone, or concrete if they are to be subjected to wind and hard freezes. Planting your chosen evergreens in containers should be in a porous, welldrained soil mix composed of equal parts sphagnum peat moss, ferlite and sandy garden soil. The most important part of caring for these container grown plants is to keep them well watered. Always water deeply, until




Morning Glory

Simultaneous filings were made in incorporated towns for retail customers within their jurisdiction and with the Public Utility Commission of Texas for an increase in rural areas, unincorporated towns and in 13 incorporated towns which have ceded jurisdiction over electric rates.

The principal reasons cited for the request were the cost of WTU's construction program, high interest rates and the effects of general inflation on the cost of providing service. The proposed rates would

produce an increase in total retail revenue of \$20,404,166. This amounts to 9.4 per cent.


