issue in August of 1985. Funds for the project arrived in Ozona April 1 after the State Water Development Fund purchased bonds in the amount of \$785,000.

Bids were let in January. Construction is expected to take 150 days for completion. Construction has been delayed pending settlement of a suit by Arlington Helbing who owns land below the site. Helbing's suit, which has been ruled in favor of Crockett County five times, claims the plant would pollute his property. He had originally agreed to let the district build the plant on his ranch if allowed use of wastewater for irrigation according to Dee Keilers, district manager.

The facility will include the plant, line from town and a pump station to get the wastewater across Johnson Draw to the lagoon site on the Sarah

Designed to handle one-half million gallons daily, the plant will have a net outflow of 300,000 gallons with a 24-acre ponding area. The sunlight, natural algae process will produce enough water to irrigate 50

The facility is engineered for a population of 5,040.

Crockett County's present waste system was named to the state's list of 10 worst polluters in 1986.

#### STATE CAPITAL HIGHLIGHTS

TEXAS PRESS ASSOCIATION

AUSTIN-The Texas Senate stepped off the sidewalk and into the street last week to challenge Gov. Bill Clements' threatened quick-draw veto.

Senators gave final approval to a \$40 billion budget, knowing full well it was \$3 billion more activities. than Clements said he would allow without a veto. It will also require that amount in new taxes.

Clements, who earlier signed legislation allowing private companies and local governments to build and operate prisons, called their budget "a giant step in the wrong way.

The budget now goes to the House where representatives are expected to trim a little, but not enough to suit Clements.

Some predict the budget will be presented to the governor in the waning hours of the session, and if he vetoes it, time will run out before lawmakers can get to the bloody, bloody task of overriding with two-thirds votes in both to be decided in a summer special

#### The Senate

In other action, the Senate passed legislation to:

- · Permit universities, colleges and athletic conferences the right to sue boosters whose actions bring on penalties. Court-awarded damages could be sought for lost television and ticket revenues.
- · Help Texas compete for the federal supercollider project site by hiring a private consultant without red tape.
- Broaden the Open Meetings Act to cut down the number of closed-door meetings of public bodies and provide criminal penalties for violations.
- · Give local telephone companies the right to raise or lower competitive rates. Non-competitive rates will still need approval of the Public Utilities Commission
- · Change the name of North Texas State University to the University of North Texas

The governor also opposed Lt. Gov. Bill Hobby's three-point "Build Texas" plan to be financed

"The only reason we were trying some of these smoke and mirrors and bonds and things was to try to appease the governor. Now we get the floor cut out from under us," Lewis said.

#### Texaco, Pennzoil

The Texaco-Pennzoil legal battle reached the Legislature last week with the two oil companies hiring the top lobbyists to work lawmakers.

Texaco wants legislation to help it avoid putting up \$11 billion in bond money while courts sort out their squabble. Texaco claims the amount is exorbitant.

#### Prison Reform

State attorneys last week argued that Texas was working to comply with federal court-ordered prison reforms and should not be fined \$800,000 a day in contempt

However, federal judge William • Drop parental consent for Wayne Justice told them he wants everything resolved in the question of compliance before any line amounts are decided. That will take about three more weeks.

Justice then toured a Texas prison unit to view facilities for handicapped inmates.

In a related event, the Texas Adult Probation Commission approved the state's first "boot camp prison" to be built in the Beaumont-Port Arthur area, if funds can be found.

Prisoners would be placed in a regimented program similar to military boot camp for a period before probation.



Ozona's team total of 113 points landed them a second place victory, just under first place team Iraan, with 134 points.


Kelly Williams received two second place medals in the field events. The two events she placed in were the long jump and triple jump.

#### Seminar for women land owners in May



#### Rachel's Reviews

For years many active people have accepted myths about drinking milk. Is milk good for runners, walkers, aerobic dancers, tennis players and others who like vigorous exercise? Here are the myths and the facts.

1. Milk causes muscles to cramp. Milk may actually reduce rather than bring on, muscle cramps. Dairy products contain calcium which helps muscles to contact properly. A lack of calcium may contribute to

2. Milk causes "cotton mouth". Nerves cause that "cotton mouth" feeling -- not milk. You don't have to be an olympic star to feel nervous before an event. Participating in a local 12 kilometer run or a tennis match with a friendly rival can do it too. Dairy products have no influence on this.

3. Milk makes you tired.

According to the rumors, the sugar in milk -- lactose -- converts

into lactic acid and causes muscle tiredness. But the lactose in milk has no influence on the amount of lactic acid in the muscles. The muscular fatigue caused by lactic acid come from insufficient oxygen, not milk.

4. Milk is hard to digest. Milk is easier to digest than many foods. A light pre-exercise breakfast of cereal with low-fat milk is more desirable than the high-fat steakand-eggs tradition. Fat will remain in the digestive system, but low-fat dairy products such as skim milk, low-fat yogurt and part-skim mozarrela cheese should cause no prob-
