

The money keeps circulating around. The employers have enough business to justify hiring employees and giving them a living wage. In turn the employees spend their paycheck, putting the money back into circulation, completing the cycle. You know, the funny thing. about it is that Lubbock seems to be growing!

When you are in business for yourself, it's easier to understand why this cycle is a must for a thriving community, because your whole livlihood depends upon it.

Florida couple says "No" to drugs

Walking across the Nation . . .

Students at Ozona Junior High were visited last week by a Florida couple making their way on foot across the United States telling children why they shouldn't take

Randy and Peggy Polson began their trek from Citrus Springs to Los Angeles, CA Oct. 31 on a mission of education. The inspiration for the walk came after their six-year-old son was approached with the offer of drugs from a nine-year-old in his

The Polsons believe that children have to learn about drugs before they know why to say no to them. "This can best be accomplished by talking to them," Randy said.

After making arrangements for grandparents in Illinois to care for their two sons, Eason, age three, and Rhett; age six, they began their walk. The Polsons talk to civic organizations and anyone else who will listen, but their primary audience is in the elementary schools where they say drug and alcohol education is most needed.

Their route along I-10 with stops in all communities and side trips into larger near-by cities has inspired their theme of "The I-10 Commandments Why to Say No to Drugs". Randy and Peggy walk 15 to 18

miles daily, taking turns walking and driving their van which is home on the road. "Occasionally someone will comp us a room in a motel," Peggy said, "and we have been told that perhaps it isn't safe to sleep in the roadside parks along the way, so now we are driving into the towns and parking the van there."

The first thing they do when entering a town is to go to the police department. "We are up front, we have nothing to hide, we don't want anything except the opportunity to speak to children and tell them why they shouldn't take drugs," Randy

"I don't have a PhD to show anyone and we don't relate a lot of gruesome stories, we just talk to the kids and listen to them. We are just normal parents who are concerned with the future not only of our own children but of all children.

"Everyone has a theory on curing drug addiction. We think there's an answer and that we can come up with a solution.

After reaching Los Angeles in late summer the Polsons plan to begin a petition carrying two million names to present to the Secretary of Education in Washington by 1991 or 92 making drug education a part of

Much of the funding for the couple's expenses comes from Citrus Springs friends, but some of it is given along the way in small amounts by people who see the value in their mission. The Polsons fully believe in what they are doing and ask no one for help.

Randy and Peggy estimate that they have spoken to more than 4,000 young people along the way. They have received letters from more than 10 percent of the children they have spoken with. "We feel like they are listening, and the main message we leave with them is that we will listen. Communication-after all, isn't that what it's all about," said Randy.

Environmental problem affects all

Local and worldwide environmental problems were discussed recently at a meeting of Ozona Woman's Forum. Gene Ingram of Richardson, who formed her own consulting firm, Environmental Support Services, Inc., told her audience that waste amounting to one ton per person per year is created and must be disposed of. Hazardous waste amounts to 6.4 percent of the total.

Thousands of abandoned or inactive waste sites have been identified nationwide, many in environmentally sensitive areas.

Decontamination is a lot harder than expected, and cleanup of existing problems could cost 300 billion dollars over 50 years, Mrs. Ingram said.

"Can we economically afford to preserve our health?" is a question that may have to be addressed.

Estimates are that the U. S. Defense Department will have to spend 75 million more to clean up a site near Denver. Ten million has already been spent at the Rocky Mountain Arsenal outside Denver.

Cleanup is a monumental task with the Department of Energy looking at 600 sites that may contain toxic waste, some radio-active, that go back to World War II.

In addition to ground contamination, evaporating liquids can release toxic chemicals into the air, harming wildlife and plants and creating catastrophic climate changes.

In 1980, the Title III Comprehensive Environmental Response Compensation Act was the first major response to the industrial waste problem. The Act (1) sets priorities

for cleanup of the worst hazardous waste sites (2) makes responsible parties pay for cleanup wherever possible (3) establishes a 1.6 billion dollar hazardous waste fund called the super fund to provide an avenue to have cleanup at government

Citizens must be protected and also must be prepared to deal with situations which might occur, Mrs. Ingram said. The Emergency Planning and Right to Know Act makes it a requirement for all communities to develop a program on how to respond to any incident that might happen in the area.

Possible explosions from petroleum facilities and transportation of hazardous materials on area highways were cited as the largest foreseeable problems for Ozona. Everyone should know how to act,

not react, Mrs. Ingram said. Businesses with hazardous chemicals must submit emergency and hazardous chemical inventory forms to their local planning committee, fire department and the State Emergency Response Commission. This information is open to the public.

Of close concern to many in Crockett and surrounding counties is the problem of dumping into rivers or along roadsides by trucks carrying petroleum products. Mrs. Ingram urged anyone witness to such activity to get as much information as possible on the vehicle and contact the Texas Water Commission or the Environmental Protection Agency Region 6 in Dallas. Sources of information do not have to provide

their names, she said.

Around the home or some business areas, lead leaking from batteries can leach into soil and groundwater, and children playing in the soil can be at risk. "State and federal laws prohibit that sort of thing," said the consultant. Seventeen percent of pre-school children have dangerous blood lead levels which affect mental abilities. Car batteries should be properly disposed of at a dump that is willing to take them.

Many household products result in hazardous waste. Consider pest strips, moth balls, antifreeze, rust removers, wood preservatives, metal polishes, deodorizers, degreasers, gasoline, bleach, drain cleaners, oven cleaners car waxes, nail polish removers and many more.

Indoor air pollution occurs from such things as asbestos, radon, cigarette smoke and formaldehydes.

'As responsible citizens, we must be aware and determine when we need to do something," Mrs. Ingram urged her listeners.

Gene Ingram holds a B. S. degree in science from Texas Tech University at Lubbock, a master's degree in science from the University of Texas at Austin and has done post graduate work at the University of Texas in Dallas.

She is currently managing environmental waste cleanups in Oklahoma and Utah estimated to cost 350 million dollars.

Gene is married to former Ozonan Don Ingram, son of Huey and Lu Ingram. The couple make their home in Richardson with their six-monthold son David.



Lions open second half with two victories

The Lions repeated last year's performance by winning the first half of district play outright. After doing so last year, the Lions then lost their next three games, and some had wondered about this year.

Despite these worries, the Lions have already picked up two more wins as of last week's beating of Iraan and Forsan and look down the road to a perfect district record.

"The guys are more intense," Coach John Curry said. "They remember last year and due to the experience, better understand how to handle it and not let the same thing happen again."

Tuesday, Jan. 26's game opened similar to the 101-51 pounding of Reagan County as the Lions scored almost every time down the court and stifled Iraan's momentum.

But by the quarter's end, another shot at the century mark had already been forgotten as the Lions led by only four, 23-19.

The difference in the game's outcome arrived in the second quarter when the Lions scored 16 points to Iraan's ten and took a 39-29 halftime lead.

In the third quarter, the Lions scored 20 points but Iraan followed right behind with 19 and an increasing momentum.

Within a matter of two minutes, the Lions went from 63-53 to 63-61. Ozona had to struggle to hold their lead as the final seconds ticked

away, winning 70-64. "That's one of those games where if it had been two minutes longer, we probably would not 'have won,' Coach Curry said. "Iraan was gett-

ing better as the game progressed. Leading scorers for the Lions

included Will Seahorn with 22 points and Scott Denman with 19. Denman also had ten of the Lions 26 rebounds. Seahorn and George Ybarra had eight and six assists

respectively. The Lions erupted in Friday's game as they stormed to a 21-4 first quarter lead and a 37-12 halftime

"Our defense was very good," Curry said. "They (Forsan) just barely scored over ten points before halftime.' The second half proved fairly

even as the Lions scored 26 points to Forsan's 25, but the damage had already been done as the Lions won

Denman had 14 points and ten rebounds in this game. Seahorn and Oscar Galindo had 12 and seven points respectively while Mike Morrow pulled down six rebounds. Danny Sanchez and Lalo Rodriquez had five assists apiece.

The Lions next host Rankin on Friday, then travel to McCamey on Tuesday for their fourth and fifth games of the second half.

Coach Curry hopes to avoid a district playoff but points out that there are still four more games

"Those that still have a chance will be fighting for it, while those who are completely out could be loose and play above their heads on any particular night. I still figure it will be us and Stanton in the long

Flu virus in Ozona

Ozona, along with other area West Texas towns, has been invaded by influenza. High fever, runny nose and coughing, generalized aching, and in some cases, abdominal cramping and diarrhea, characterize

the illness. The number of patients is beginning to decrease according to Dr. Robert M. Owensby. Few patients have suffered bad complications, Owensby said, and in Ozona, the intestinal symptoms have not been very prominent.

Simple home treatment is adequate unless fever gets too high, or pneumonia develops, said the doc-

Younger people have not been affected as much from the illness.



STATE CAPITAL HIGHLIGHTS

AUSTIN-Texas and the federal justice system - - it never seems to end these days.

The governor last week headed off a prison system crisis and the wrath of one federal judge, only to find the state faced with possible fines from another judge for violations of court-ordered mental hospital reform.

Governor Bill Clements, with Lt. Gov. Bill Hobby and Speaker Gib Lewis, used the new emergency provision to clear the way for construction of an additional prison which will keep Texas on schedule with prison reforms ordered by Judge William Wayne

But Judge Barefoot Sanders said his court also expects compliance from the Department of Mental Health and Mental Retardation, which he said is understaffed.

Pro-reform advocates urged Sanders to levy huge fines against the state if the violations continue, and he issued a last warning state-

Dukakis fell short of two-thirds needed for MAD endorsement, but led with 38 percent over second-place Jesse Jackson with 21 percent. Other candidates garnered less than 10 percent, except for Gary Hart, who was not nom-

Dukakis' list included two Texas state senators, Carlos Truan of Corpus Christi and Hector Uribe, of Brownsville, as well as Mary Alice Cisneros, wife of the San Antonio Mayor.

Robertson May Sue

On the GOP side, Pat Robertson said he will challenge, and sue if necessary, to change the state party's ruling making all six candidates eligible to win lexas delegates.

Robertson contends only he and Vice President George Bush submitted enough legal ballot petition signatures, and his challenge would effectively narrow the race here to those two.

The official polls are still out on Bush's progress after his televised confrontation with CBS anchor Dan Rather, also a native Texan, but word around the Capitol is it didn't help.

Social Security base increases for 1988

The annual earnings base - the maximum amount of earnings that counts for Social Security - will increase to \$45,000 for 1988, up from \$43,800 for 1987. In addition, the 1988 tax rate for employees and their employers will increase to 7.51 percent, up from the 1987 rate of 7.15 percent, Franklin H. Upp, Social Security manager in San Angelo, said recently.

The increase in the wage base is based on the change in average earnings levels from 1986 to 1987. The tax rate increase was already a part of the Social Security Law. The effective tax rate for self-employed people will rise from 12.3 percent to 13.02 percent for 1988.

The increase in the tax rate will amount to \$7.20 a month for a person earning \$2,000 a month.

He's America's No. 1 family man, due in particular to an equally No. 1 television show, which, by the way, had syndication sales top one billion dollars and since he's entitled to one-third...gosh, he's rich.

He's also fifty. Bill Cosby has seemingly been know in practically every household for at least a decade. Adults may have been slow to recognize his talent in his I Spy and The Bill Cosby Show roles in the seventies but kids easily warmed up to his The Fat Albert Show and Jell-O commercials.

Now that his career has taken off with the enormously popular Cosby Show, he has explored the movie scene (Leonard Part Six), continued his nightclub acts at places such as the Hilton in Las Vegas for \$250,000 a performance, and he has taken pen to paper and produced a best-selling book, Fatherhood, which set a hardcover record of 2.6 million copies

Of course that calls for a sequel. This time Cosby put forth another record-setter, a first printing of 1.75 million copies for his Time Flies.

Since October it has held the No. 1 spot (there's something about being Number One with Cosby) on the best-seller list, only recently falling to No. 2. Not bad for 150 pages of pen scribblings.

Expectedly, Cosby provides a humourous outlook on some aspect of life. This time it being the process of growing older: gaining weight; losing hair; gaining hair in unwant-

The book opens with an introduction by Alvin F. Poussaint, M.D. He takes a serious look at growing older, providing the most informative part of the book with a logical explanation of why growing old is

The book is broken up into six parts, and each of those is further processed into short anecdotes that very much sound like his tales he tells at live concerts.

In fact, much of the material Cosby, age 50, recites in Time Flies, appeared on the best selling videocassette, Bill Cosby: 49. On stage, Cosby is able to give these experiences life, something that surfaces infrequently in his book.

Occasionally, Cosby's writing style proves totally Cosbyish and produces a chuckle or even a hearty laugh. But a lot of the book's material reads more like filler than what is expected from No. 1.

In the end, the book seems to go nowhere at all, and Cosby turns the last part into more of a thank-you note than a conslusion to the previous selections.

However, perhaps that was Cosby's underlying intention: by providing a lighthearted reading, he could ease the burden of growing old for a few folks across America and the globe.

Futher down the road Cosby will likely dish out another book on a new subject and set some more records, and learn a bit more of reaching the hearts of millions through putting the pen to the

Winter months historically are the worst for home fires, primarily because of faulty heating systems, says Billy Reagor, county agent with the Texas Agricultural Extension Service, The Texas A&M Univesity System.

Reagor suggests regular maintenance and following these tips to assure safe operation of your heating system:

· Check out all heating equipment--furnace, fireplace, stoves, portable heaters. Perform recommended servicing and repairs as appropriate to avoid unnecessary fire risk, excessive energy consumption and breakdown.

• Check flues and chimney. They must be clean and provide unobstructed exit of smoke and com-


