## Sanchez sets records

Senior Danny Sanchez broke two records, one a division record and the other an overall meet record, in last weekend's Division IV action at the San Angelo Relays.

The Lions managed eight placings and accumulated 49 points at the meet which had 17 team participants in that one division. The meet was broken into four divisions with schools set in divisions according to size.

Sanchez' time of nine minutes, 48.66 seconds in the two-mile set a new record for the entire meet. The record that fell was his own from the previous year, but some seven seconds slower.

Then, Sanchez barely set a new

division record in the mile run, clocking at 4:37.00 compared to the old record of 4:37.70.

Sanchez also competed in the long jump, soaring 19' 9 1/4" to secure fourth place.

Jose Gutierrez ran a 10:52.88 two-mile to finish third in that event while Luis Rico followed in fifth place with a time of 10:58.40.

Finishing in a time of 4:54.53, John Sanchez placed sixth in the mile run.

Robby Tambunga's 41.03 in the 300m hurdles earned him a fourth place showing.

The mile relay team of Ruben Borrego, Robby Tambunga, Martin Urbina and D. Sanchez placed third overall.

With all the chips on the table the Lions head to the track again on April 15, as the district track meet takes place.

## Absentee voting period short

Absentee voting for the Democratic runoff election will begin Monday, April 4, and continue through April 8. Balloting will take place in the law library at the courthouse daily from 8 a.m. to 5 p.m.

Those wishing to vote absentee by mail should send in their requests now if they have not already done so.

Persons eligible to vote absentee by mail are those over 65, regardless of where they live, and those under 65 who swear they will be out-of-town on election day.

Requests for mail ballots should be sent to County Clerk Debbi Puckett, Drawer C, Ozona, TX 76943.

Statewide, only one Democratic Primary race went into a run-off. James M. Jordan and Rene Nunez will be on the ballots for Member, State Board of Education, District 1.

Local run-offs county-wide include Kathryn Mayfield and B. W. Stuart, County Judge, Unexpired Term; Jim Wilson and Aldo Gonzales, sheriff; Raymond P. (Bear) Borrego and Gene Williams, Constable, Pct. No. 1.

A Pct. 1 run-off for commissioner has Sostenes DeHoyos and Richard Berry in the race.

Pct. 3 commissioner candidates are Jimmy D. House and Beth Boyd.

Registered voters who did not vote in the primary may vote in the run-off election.

## Firemen fight county grass fires during Firemen Appreciation Week

Volunteer firemen in Ozona did what they do best during Volunteer Firemen Appreciation Week - fought fires.

A major fire north of Ozona March 23 and 24 was at times four miles wide and covered an estimated 1500 to 1600 acres.

The runaway fire began in a pasture east of the John Childress home and rampaged across the Childress, Jones, Upham, Bailey, Clayton, Luckett and Chandler ranches before being stopped.

Units from Big Lake, Mertzon, Barnhart, Eldorado, Sonora and Menard joined local volunteers and ranchers with sprayers as they struggled for control.

"The county has always been good to help us with fires," said Dorris

Haire, fire chief. Three county water trucks, four maintainers and one fuel truck were sent to the scene from Crockett County.

Barnhart and Big Lake were forced to withdraw to take care of fires of their own before the fire was pronounced under control Thursday night.

"Fire came at the house from every direction," said Randy Upham whose home was threatened more times than one during the ordeal. Fire also came near the home of Cheryl Clayton.

A re-ignite Friday morning was extinguished by volunteers on two Ozona trucks.

This was a strange fire according to Haire. "It might miss two sections then have long fingers going up a

draw."

Another fire in Crockett County on March 23 was handled by the Sheffield Fire Department.

A Hondo Oil heater treater caused a March 22 grass fire on the Jack Williams place. A pumper was at the site and shut the heater off.

Two trucks answered the 5:17 p.m. call and used 500 gallons of water on the blaze.

Volunteers made calls Thursday and Friday to a Crockett County fire eight miles south of Big Lake. First reported at 3:37 p.m. Thursday on Farmer's Field Road, the fire required two local trucks, three bladders and two water trucks. A total of 2,700 gallons of water was used Thursday and 250 gallons more required on a re-ignite the next day.

## Petition distributed for vote on liquor

A petition calling for a vote on the sale of alcoholic beverages for off-premise consumption in Crockett County has not conformed to legal requirements according to County Clerk Debbi Puckett.

A petition cannot be distributed until an application for the local option election has been signed by 10 registered voters and returned to the clerk's office to be dated and filed.

Once this process has been completed, 30 days are allowed to obtain signatures amounting to 35 percent of the votes cast in the most recent

gubernatorial election. Based on election figures for 1986, 394 names of registered voters would be required, Mrs. Puckett said.

Petition forms must include the signer's name, address and voter registration number, then be returned to the clerk's office to be dated and filed.

Both the application and petition then go to the tax office for verification of the names against the voter registration list.

Once this process proves that enough names are on the petition,

the forms are sent to commissioners court and an election called.

Petitions circulating in the county since early February are not valid because an application was never returned to her office.

Previous elections for off-premise consumption were held on January 10 of 1978 and April 8 of the same year. Both failed.

Ozona currently has six private membership clubs where liquor is available by the drink but is a "dry" county because no sales for off-premises consumption are legal.

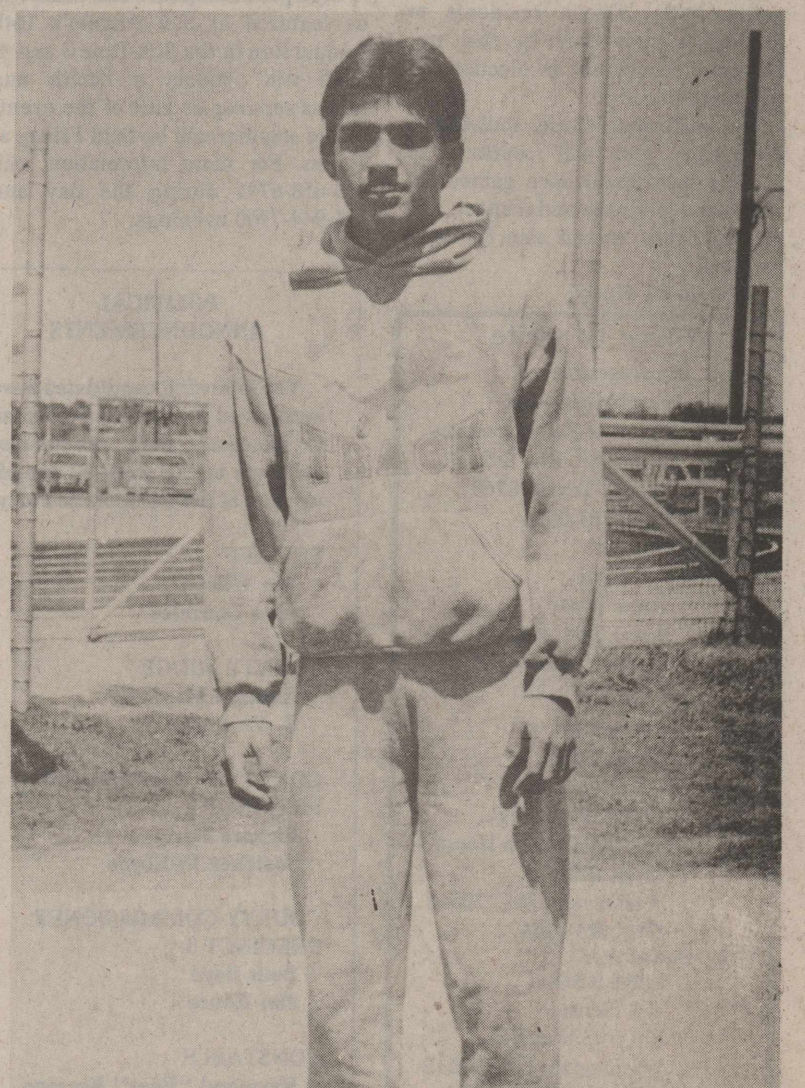
This information came from a general membership meeting of District II Texas Sheep and Goat Raisers March 25 at the Jack and Janie Riggs Ranch.

## STATE CAPITAL HIGHLIGHTS

AUSTIN—Texas Attorney General Jim Mattox declared war on eight insurance giants, and the Texas horse racing agency moved closer to the starting gate last week.

Meanwhile, officials monitoring the state's oil and gas production joined in calling for a Texas energy policy, and a new pact between Texas and Mexico may enhance trade.

Mattox's action against the insurance firms—an audacious lawsuit accusing them of conspiring against consumers to increase rates—caught almost everyone by surprise.

He had stated his suspicions months ago in a battle with the State Insurance Board over consumer protection, but he lost that one and the issue seemed over.

Then last week, joining the authorities of seven other states, Mattox accused the eight companies of taking Americans to the cleaners and "sucking the economic lifeblood out of us."

### All Charges Denied

The industry denied the charges and retorted the antitrust suit was politically motivated, particularly in the case of Mattox, who was accused of running for governor by picking on the insurance industry.

The stakes are high. If Mattox wins, grateful consumers will likely aid his stated political ambitions; if he fails, the momentum could take him down.

Mattox said the companies conspired to avoid insuring doctors, teachers, clergy and other opinion-maker professionals to get them in line to change the country's thinking about insurance rates.

### Parl-mutuel Advances

Gov. Bill Clements filled the final spot on the new Texas Horseracing Commission with his top aide, Hilary Doran Jr., and various pro-racing groups urged the commission to pick up speed in installing the new industry.

One public relations obstacle disappeared after a state judge ruled a pro-racing group, currently under fire for questionable campaign fund reporting, did not have to turn over records to a public watchdog group.

Shortly thereafter, the nation's largest operator of betting race tracks, Delaware North Co., Inc., hired two prominent Texans to lobby for a license for a Galveston greyhound track.

The two hired guns are no less than former attorney general and Supreme Court chief justice John Hill and former Galveston state Sen. Babe Schwartz.

### S&L Losses Grow

Texas savings and loan associations last year lost \$6.9 billion, leading the nation's thrift industry to its worst performance since the Great Depression.

The Federal Home Loan Bank Board said last week the nation's 3,147 thrifts together lost \$6.76 billion in 1987. But excluding the 279 thrifts in Texas, the nation's S&Ls had profits of about \$100

million.

The thrift figures, coupled with the state's banking problems, are an indication of the state's severe economic slump. Texas' problems, centered in oil and real estate, are straining federal officials' ability to keep the nation's financial system afloat.

In 1986, all U.S. thrifts recorded a profit of about \$140 million, and Texas thrifts lost \$2.9 billion.

### Other Highlights

- The Texas Association of Taxpayers, a private group which monitors the Legislature, predicted lawmakers can balance the next budget without a tax hike or curtailed services. The prediction is based on two percent-per year growth expectations. Comptroller Bob Bullock's office agreed with the projection. Three weeks ago, Treasurer Ann Richards warned the state faced a \$1 billion shortfall following the next budget.

- A tax researcher told lawmakers when Congress took away the federal deduction for state sales taxes, it raised taxes for Texans an average of \$173 per income tax return. It also pressures the state to adopt a state income tax.

- Mattox, in an opinion, said lawmakers and the state auditor

are intruding on the comptroller's constitutional duties when they tell him how to estimate state revenues or certify the budget.

- A recount was requested in the Lubbock-area House race where Delwin Jones defeated Dr. John Selby in the GOP primary by 103 votes.

- U.S. Treasury Secretary James Baker shot down rumors he will run for governor in 1990, saying he has no concrete plans past the end of the Reagan Administration. Baker ran for attorney general in 1978, losing to Mark White.

- Gov. Clements set an August 13 date for the special election to fill the North Texas Senate seat vacated by Ray Farabee.

- In Houston, several precinct judges have called for the Democratic primary run-off candidates, State Rep. Al Luna and constable Raul Martinez, to voluntarily take a drug test as an example for youth.

Martinez said he would do it. Luna's campaign manager said the issue is crazy.

The Martinez camp has insinuated that Luna takes drugs, and Luna's retaliates with charges that Martinez is an alcoholic. The fast flying slurs prompted the precinct judges to step in.

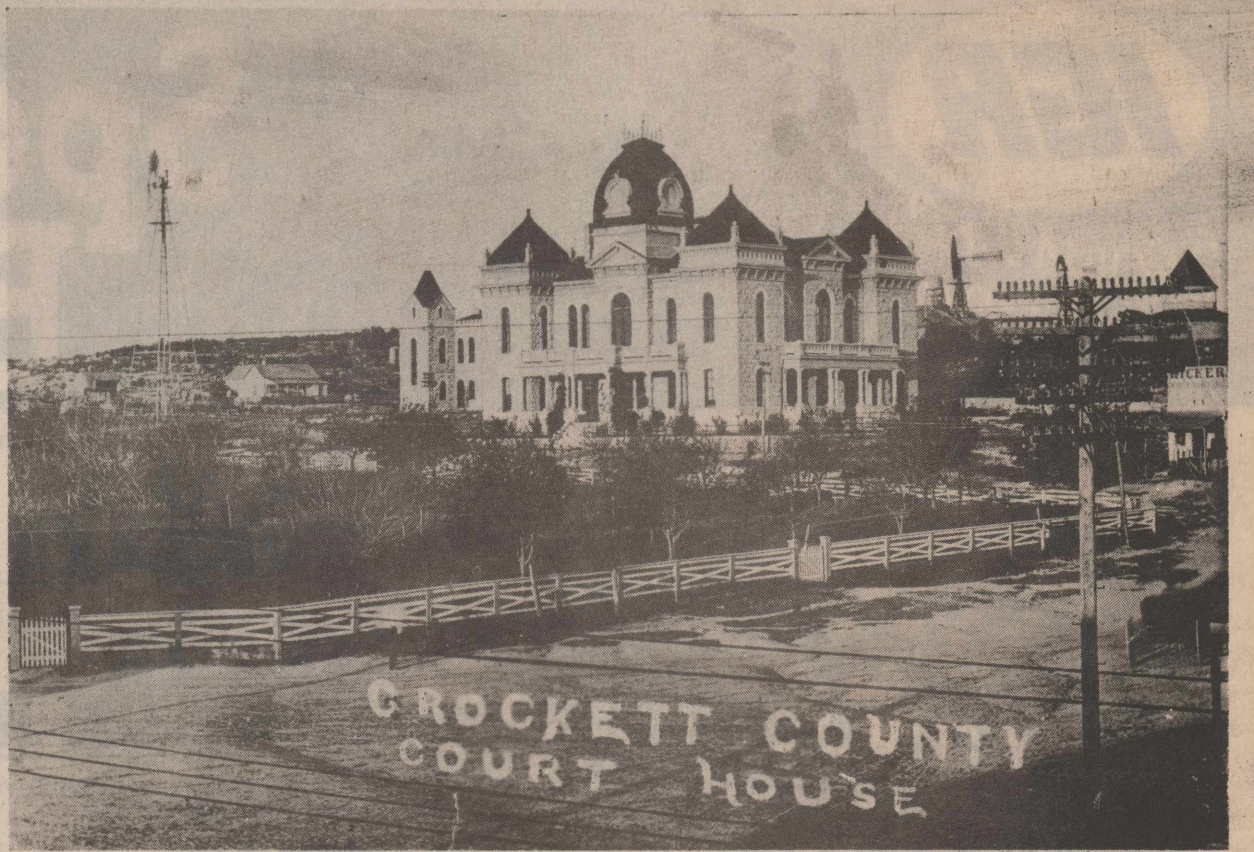

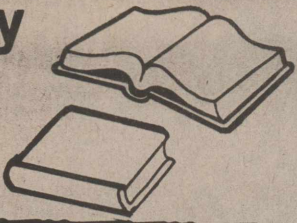

## ★ Sheriff's Report

### Board filing ends

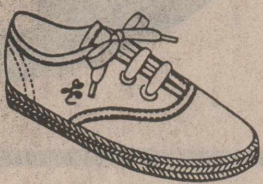

## Accidents

## Major crimes up in Texas

The overall number of major crimes showed a moderate increase in Texas last year, according to the Texas Department of Public Safety.

"The total of major index crimes in 1987 was up to 1,296,829 compared to 1,235,834 in 1986," according to DPS Director Col. Leo Gossett. "However, this rise of 4.9 percent was only a third of the percentage crime increase which occurred in 1986."

All four violent crime categories went down, with murder decreasing by 13.1 percent and rapes declining by 6.3 percent. Robbery cases fell by 4.9 percent and aggravated assault was down by 1.9 percent.

The three property crime categories rose, but the percentage

increases did not reach the level they did in 1986," Col. Gossett said.

Thefts were up by 7 percent, burglaries by 4.1 percent and motor vehicle thefts by 3.6 percent.

Seven law enforcement officers were killed by criminal action during the course of duty in the state last year, while duty-related accidents caused four deaths. The number of assaults on Texas officers increased by three percent in 1987 to 4,515.

The crime statistics were compiled based on reports provided by 805 law enforcement agencies in Texas which together represent 99.9 percent of the state's population.

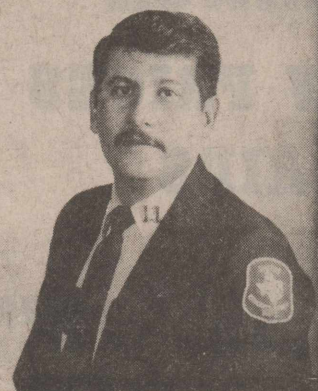

"Because Texas has so many research institutions, the National society allocates additional funds here."

"Programs that help people are our priority. We keep a tight control over our administrative costs and keep them within acceptable limits as this breakdown indicates," Mrs.

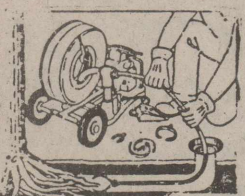

She was later married to J. D. Nairn who also preceded her in death.

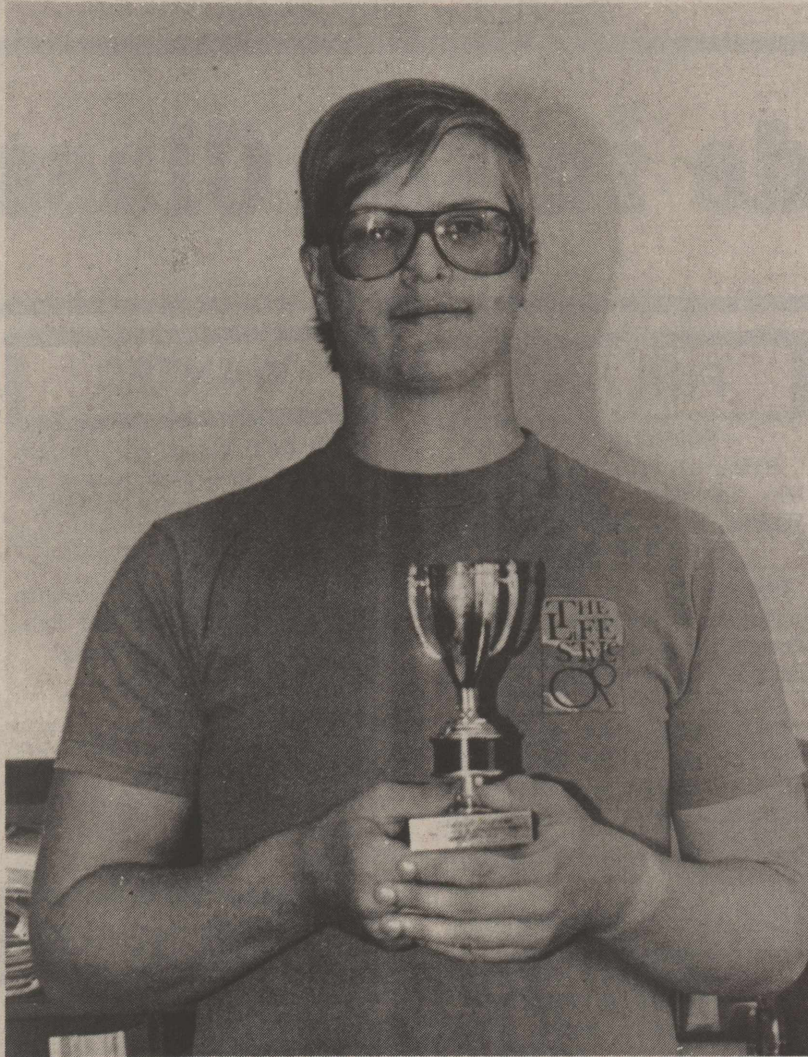
A former mail carrier, Mrs. Nairn

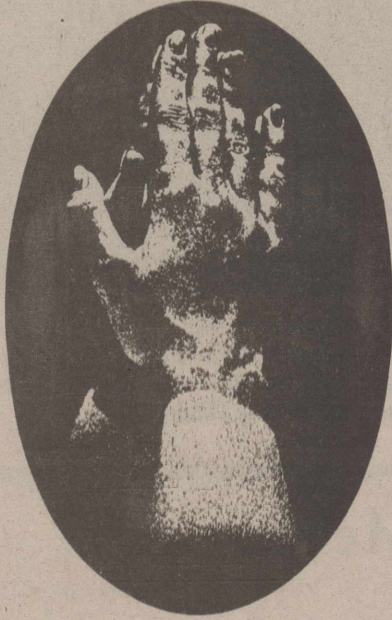
Myra Wilson and C. J. McKinney lost their first match but cruised through their next two before

## Christ Or Caesar

"Then Pilate took Jesus and had Him scourged. The Soldiers twisted some thorns into a crown and placed it on His head and put a purple garment on Him. They went up to Him and said: 'Hail, King of the Jews!' and slapped His face. Pilate went outside again. 'I'm bringing Him out to you,' he told them, 'to let you know I don't find Him guilty of anything'. Jesus came outside wearing the crown of thorns and the purple cloak. 'Look at the Man!' Pilate said to them. When the ruling priests and the servants saw Him, they shouted, 'Crucify, crucify Him!'. 'Take Him yourselves,' Pilate told them, 'and crucify Him. I don't find Him guilty of anything.'

"We have a law," the Jews answered him, "and according to the law He must die. He has claimed to be God's Son." When Pilate heard them say that, he was frightened more than ever. He went into the palace again. 'Where are You from?' he asked Jesus. But Jesus didn't answer him. 'Don't You speak to me?' Pilate then asked Him. 'Don't You know I have the power to free You or to crucify You?' 'You wouldn't have any power over Me,' Jesus answered him, 'if it hadn't been given to you from above. That is why the man who handed Me over to you is guilty of a greater sin.'

This made Pilate anxious to let Him go, but the Jews shouted, 'If you let Him go, you're no friend of Caesar. Anyone who makes himself a king is against Caesar.' When Pilate heard this, he took Jesus

outside and sat in the judge's seat at a place called Stone Pavement, or Gabbatha in the Jewish language. It was the Friday of the Passover and about six o'clock (am). 'Look at your King!' he said to the Jews. Then they shouted, 'Away with Him! Kill Him! Crucify Him!' 'Should I crucify your King?' Pilate asked them. 'We don't have any king but Caesar,' the ruling priests answered. Then Pilate handed Jesus over to them to be crucified."

(John 19:1-16)

Jesus tried to the very last to bring Pilate to repentance. When Pilate insisted that he had the power to either free or crucify Him, Jesus pointed out that Pilate would have no power at all if it were not given to him from above. Pilate did not know God, but he was still under God. On the other hand, the Jews claimed to know God and insisted that God is the Ruler of all. Therefore, theirs was the greater sin. They still did what they did, even while confessing God - in whose sight all is done, and through whom alone all can be done. This is also our greater sin when we confess that we believe in God the Father Almighty, and then live on our own, worry ourselves half to death, and act as if this world were in the hands and under the power of men who hate God.

What finally swung it was the accusation that letting Jesus go would prove that Pilate was not Caesar's friend. Being Caesar's

friend meant everything to Pilate. What is it that has the final control over our decisions and our actions? That is our last court of appeal? That is our 'god'. And it is always either Jesus or Caesar, Jesus or something else. It cannot be both, because we cannot have two gods!

The Jews insisted that they had no king but Caesar. With that they disowned God's purposes and promises, and claimed to be like all the other people, ruled in precisely the same way. So shall it be! This King forces Himself upon no one. He rules us by His love or He does not rule us at all. And if we are not ruled by Him, we are ruled by brute power. If we insist loud and long enough, we get our way - even with God. He finally gives us what we want most. It will be salvation or damnation, depending on what we insist upon concerning Jesus Christ!

In Him, however, we have the King who established a new Kingdom, the Kingdom of God. His Kingdom is not of this world. His Kingdom does not consist in the rules and the powers and the judgments of the world. He is the King who gives Himself instead of demanding for Himself. His glory is what He is able to do for us, not what He is able to get out of us. His power is not force which compels, but love which wins us to love God because He first loved us. His rule is that of mercy which does not threaten to break us, but breaks every bondage that would draw us away from the love of God.
