Readers of The Ozona Stockman got a preview of the Ozona section of a promotional tabloid in their papers last week. The section you received will be part of 30,000 tourism tabloids to be distributed along a large section of Interstate 10.

The tabloid will include information on Kerrville, Junction, Ozona and Fort Stockton. This is a cooperative effort by the newspapers and will be published by the Kerrville Daily Times for the first time on April 13. The feature will be circulated in all the newspapers involved, and extra copies will be given away at prime tourist locations in each community.

The Ozona section previewed last week has been warmly welcomed locally. Massive distribution during the third week of April will put the publication in the hands of many travelers, giving them opportunity to learn about Ozona's attractions and services before they arrive.

Lady Lions increase district golf lead

The Ozona Lady Lions continued their total domination of District 6-2A golf last Tuesday, April 4, by firing a 402 on the Comanche Trails Golf Club course in Big Spring and increasing their lead to 27 shots.

After taking a 17 shot lead over Stanton through the first three rounds, Ozona smoked the Lady Buffalos on a course only a short drive from Stanton.

Gina McCollum, who is shattering

Crockett Detention Center Inc.'s proposal that the county be part of establishing a prison near Ozona was withdrawn Monday three months after the plan was submitted to commissioners.

In a letter read by Judge Kathryn Mayfield, Elza Smith, president of the corporation, cited strong opposition of "some elements of the community", and "half-truths and misinformation" as preventing an agreement "between us and Crockett County at this time".

Smith went on to say that the corporation expects "to continue

pursuing the use of this facility as a detention center through other counties or agencies which are more ameniable to our proposals. By this letter we are, at this time, withdrawing our proposal asking Crockett County to participate with us in developing a detention center.'

DC drops county

Read as the first item on the agenda at the request of CDC, the letter removed the need for a court vote on the proposal to have a detention center at Crockett Heights six miles east of Ozona.

Smith's letter was followed by presentation to the court of two petitions opposing the facility. Frank White handed the court a petition bearing 447 names, and the second petition, from Crockett Heights homeowners, carried 17 names.

Judge Mayfield also reported that the majority of the six-person advisory committee to study the proposal had recommended dropping the project.

The withdrawal of the proposal comes after three months of controversy over the center. Should the project be pursued, problems of service for water, sewage and trash disposal remain to be dealt with by Crockett County W.C.I.D.#1.



K's motel tax

County commissioners Monday voted to adopt a four percent motel occupancy tax effective May 1. The tax was approved following a presentation by Ozona Chamber of Commerce president Stephen Williams outlining possible benefits of the tax to the community.

A long term plan formulated by the chamber to attract more tourists to Ozona includes advertising through signs, colored brochures and post cards and publications directed toward the traveling public. Improvements in the downtown and east parks are being considered along with developing new parks or uses for existing parks.

Historical preservation and restoration through extension of museum space and opening hours and sandblasting of the courthouse and repainting its trim are included in the master plan.

Other community facilities and projects mentioned by Williams included the library, civic center, airport, rodeo arena and ball parks.

'Ozona is a beautiful community, but with a little money and imagination, it can be the best town of its size around," Williams said. He believes the chamber projects being considered are important not only to sell Ozona to travelers, but to promote unity and pride within the community.

Although several nearby communities assess as much as a seven percent motel occupancy tax, law limits Ozona to four percent because there is no city taxing entity. Based on local rates for double occupancy. the tax will add \$1.50 per night to the most expensive lodging and 80 cents to the least, Williams told the court. All of the money will remain in the community.

Under the law providing for collection of the tax, counties with no municipality may use the funds for promotion of tourism, encouragement, promotion, improvement and application of the arts and for historical preservation and restoration. All these categories have a wide scope in Crockett County. In most counties, 95 percent of the tax is allocated for use by the chamber of commerce. A committee of five will be

appointed by the court to administer the funds, which will be dispersed through the county. Motel owner Dean Phillips at-

tended the court meeting to register his opposition to the tax. Owners of local motels were notified by mail of a chamber meeting to discuss the proposal before it was presented to the court, Williams said.







Gandhi reaffirms that he will end his fast only when the Hindus and the Moslems stop fighting. The Hindu, with hatred in his eyes, says he will continue to fight. To justify his resolve he tells Gandhi how the Moslems took his little boy and crushed his head. He, in turn, captured a Moslem boy and killed him in the same way. Then he added, sorrowfully, "I have been living in hell".

Gandhi reflects on this a moment and then says softly, "I think I know a way out of hell". And with the Hindu hanging on his words, Gandhi tells him, "Go and find a boy similar to the son the Moslems killed, take raise him as a Moslem."





The Ozona Stockman

Red, ninety, still plays like a pro

In his ninetieth year and still playing golf!

Lee Allen Greer, fondly known as "Red", may be seen out on the goli course of Ozona Country Club almost daily. He is easily recognized with his tall, lean frame and long, determined stride heading for his ball. This gentleman, born in the last century, is still enjoying life to the fullest, and continues to play a great game, just recently having shot an 80 on 18 holes!

Visiting with Red is an interesting experience, and I had the privilege of doing that the other day. The first thing he stressed was his thankfulness for a good life and for his many fine friends. He is a modest gentlemen and I felt, in spite of his remark "there's nothing spectacular about my life", that were I persistent enough I might find much to the contrary.

Red was born to Alvis and Allie Greer on February 17, 1899 in Limestone County, which is east of Waco. He was the fourth child in a family of 10--nine boys and one girl -- and the family traded in the small community known as Kossie. His father, originally from Louisiana, was a share-cropper and the family moved quite often, each time loading up the covered wagon with a conglomeration of possessions and kids! "It was crowded" Red tells.

Having moved to Runnels County, just south of Ballinger, at the age of seven Red had his first educational experience in a one-room school house in tiny Dry Ridge. "In those days children didn't start school until they were seven," he explained. Some other places Red lived in his youth were Spur, in Kent County, near Jayton and, eventually, they moved east to Rosewood around the year 1913. There the family stayed for quite a few years and the youngest boy was born there in 1915. I remarked to Red that it surely was a large family and, with a smile he said "Well....it took 'em a long time to find out what was causing it!" Also, in 1915, an older brother joined the Navy. He stayed in for 20 years, and then re-enlisted in World War II. Red remembers going to church, but in most places the Baptist preacher took care of several communities and they might only see him once a month. Revival meetings were big affairs with an arbor being

built with a brush roof for shade, and everyone bringing food to share. By the time 1923 rolled around

Red said he had had enough of the "pick sack," and along with some friends headed for Fort Worth to attend barber school. A six-month course of instruction cost forty-five dollars and it was there that he perfected his art. To begin with, after some instruction, the students would be employed in a back room giving haircuts to anyone who could not afford to pay. Eventually, after gaining some experience, the students were moved up to a front room where customers were charged 10 cents for a shave and 15 cents for a haircut. At last, the big day arrived for Red, and he was moved up to the paying trade and promptly managed to clip off part of his first customer's ear! "I stopped him bleeding with needle and thread," Red hastened to assure me - "that is what we called the powder we used to staunch the flow!" Red then asked the poor man, "Would you care for a shave?" "No!"

terms, "I believe not!" In spite of this somewhat disastrous beginning, Red gained his confidence and his diploma and then worked in a barber shop in Fort Worth across from the courthouse. From there he joined a barber friend in Idabel, Oklahoma. Red remembers riding the train from Fort Worth to Paris, and then through Hugo to Idabel.

On September 6, 1928, still a single man. Red moved to Ozona to work in a barber shop owned by a Mr. Lumpkin. This was located where Baker Jewelers is now. Later, Mr. Lumpkin sold out to a John Pettit, and the shop and Red moved to the Cox building behind what is now Westerman Drug. This was a

Pettit for some years.

On his birthday in 1930, Red married Alma Poteet who was from Summerville, Texas, but at the time was living with a sister in Ozona. She passed away in 1974 and Red has lived alone since, managing for himself. Just the other day, Dorothy Montgomery was saying that Alma baked the very best chocolate cake and that she still uses her recipe.

After working for Pettit, Red worked with Sam Beasley in a shop where the Ozona Stockman is now located.

Then Sam leased premises from Wilse Owens where Childress Real Estate is now located on the corner of highway 290 and 163. It was from

this shop that Red retired in 1975. The barber shop was always a gathering place for local ranchers any anyone who had the time to shoot the breeze. From what I understand quite a lot of problems were settled during those times, the conversation manily centering on the weather and the condition of various markets; Red assured me that no idle gossip was exchanged during these sessions. A few of the regular visitiors and customers one might find gathered there were Paul Perner, Pleas Childress, Sr., bankers Scott Peters and Lowell Littleton. Also Lee Childress, Roy Henderson, Boyd Clayton, Bascom Cox, the late Pon Seahorn and Bill Seahorn. Others well remembered are Bill Hoover, Sr., Armand Hoover, Sr., Arthur Hoover and Hillery Phillips. Red recalls that he has cut the hair

of as many as four generations in some families, such as the Davidsons. In answer to my inquiry as to whether he could remember any specific incidents during his barbering days in Ozona, Red told about a

three-chair shop, and he stayed with the school football games were played on Saturdays. Mr. Sorrells, another barber in town, and Mr. Lumpkin had a gentlemen's agreement that they would both close their shops during the games. One Saturday, another of Lumpkin's barbers by the name of Brown, was sitting outside the closed shop and a customer came by demanding to know why he was not open. Brown explained the situation, and the customer said "Well, Sorrells' barber is over there open and cutting hair!" Brown thought it over and decided that he had better open up too and started working. After the ball game was over and business returned to normal, Red noticed that the owner of the other shop, Sorrells, was outside pacing up and down and looking pretty hostile and then, not being able to contain himself any longer, came in and lunged at Lumpkin.."I took the headrest out of my chair and told him to get out!" Red explained. When the smoke cleared and Sorrells was told that it was his barber who had opened up first, all ended amicably.

A few weeks later, Red remembers he was fixing up a young fellow about to be married, and a local rancher was sitting in a visitor's chair apparently asleep, and was grinding his teeth rather noisily. 'My God!" Red exclaimed loudly to the prospective bridegroom, "do you hear THAT?" Unfortunately, the rancher was now very much awake and countered "Oh yeah! You're that tough guy from Oklahoma!' 'No, I'm not," argued Red, and with that, the rancher, still sitting in seat, pulled out a "hog leg" (pistol). Brown jumped forward yelling "here, here, put that thing back!" "I was only going to shoot through the ceiling" the rancher explained to Brown who, still excited yelled "No, No! My wife's up there!". Red says this particular rancher is still around and may recognize himself should he read this. Anyone want to 'fess up? Red's first Ozona golf was played out on the Will Baggett ranch where an area for about nine holes had been cleared and they had sand greens. This was put in by the Lions

Club on the south side of the Big Lake highway behind where the first drive-in theater used to be. He also played at Texon, Iraan, McCamey and Crane. Then, 1950, the Ozona Country Club was formed and he

became an associate member. He usually plays nine to 12 holes with Dub Reeves now, and occasionally with Demp Jones; sometimes he plays 18. In the fall tournament, when a team consists of two men and a woman. Red enjoys playing with Hank and Jeannie Wellman.

Jeannie says "Red is a real joy to be around; he's an inspiration! He will help anyone who asks with their golf game. I think he has kind of adopted me!" And, in talking to Dub Reeves, he said much the same thing -- "He's so congenial and he loves his friends and neighbors"

Red was, and still is, very athletic, from the days in the school yard playing a fast game of "Steal the Sticks" to early days in Ozona on the semi-pro Ozona Giants baseball team. B., W. Stuart told me that when he was recruited by Joe T. Davidson, Sr., president of the Giants in 1935, along with two or three other professionals from San Antonio, Red was playing right field, but it was Red's last year to play as "he was getting too old". Red? Old? NEVER

Naturally, I was anxious to know Red's secret as to what he could attribute his energy and longevity. "I never did anything bad to myself, and I never smoked or chewed" he answered. 

# Time is Running Out. March 1989

Subject: Deadline for Conservation Plans

#### Dear Producer:

The conservation compliance provision of the Food Security Act of 1985 (the Law) provides that anyone who farms highly erodible cropland must develop a conservation plan for the land and have it approved by the local soil conservation district by Dec. 31, 1989, in order to remain eligible for many USDA farm program benefits.

Producers who do not have an approved plan will be giving up USDA program benefits on not only their highly erodible acres, but on all of the land they farm. Program benefits include not only price supports and commodity-related payments from ASCS, but also federal crop insurance and Farmers Home Administration loans.

Remember, cropland in the Conservation Reserve Program is in compliance. And, we anticipate additional Conservation Reserve Program sign-up periods.

Nationwide about 65% of farmers participating in USDA crop programs have already obtained approval for their conservation plans. I commend those producers. Nevertheless, I am still concerned about the thousands of farmers who will need a plan to remain eligible for USDA program benefits.

If you have highly erodible cropland, you must have a conservation plan by Dec. 31, or you will be ineligible for farm program participation until you have a plan approved. Time is running on, so don't let it run out on your program benefits.

## Extension Connection

### Peer pressure-good or bad?

You have peers, I have peers--we all have peers. But what are they?

Peers are people our own age. If we're adults, they are the adults we associate with, work with or socialize with. If the peers are your childrens' they are their fellow students and friends. Whether we realize it or not, peers--friends and acquaintances-have a great deal of influence on all of us.

This influence is known as peer pressure, and it can be good or bad.

Think about it--why does a particular brand of jeans, style of shoes, or fashion fad seem to spread so rapidly through a school? It all begins with the influence of one or two people and grows from there. Today, that influence often originates from a popular movie or television show.

Although peer pressure can be either good or bad, we generally hear only about the bad kind. For example, your child is in a store with some friends and the friends decide to shoplift. Your child refuses, and the friends call him or her a chicken.

But good peer pressure also exists--very strongly in many cases-among our young people. An example of this would be a group of friends getting together to study for a big test, and asking your child to join them.

The hard part for most young people is deciding which peer pressure is good and which is bad. Some of it is pretty obvious, as in the shoplifting example. But sometimes, it's hard to decide.

Some guidelines that may help your child (or you) resolve this dilemma include:

--First, they should decide how they feel about the situation. Do they really want to go along? Or do they feel like they want to get out from under the pressure?

--They should say no--and keep saying it in a firm manner. Never back down.

--It doesn't really work to make

excuses. Saying "I just don't want to" is all right, but it gives the others a chance to "talk around" the excuse, and then you find yourself in a corner. -- Teach your children to "use their

credit." When you're part of a group of friends, you like them and they like you. They should value you for who you are and you should have a special credit with them.

For example, your child could say, "You mean I have to-----to be your friend?" and "If I have to---to be your friend, then I don't want to be your friend."

--Recruit a friend. There's usually someone else who may feel the same way you do, and you can suggest that it's fine if the group does what they've planned--but you'll be just fine not participating.

An example would be saying, "If you're going to steal something, we don't want to be involved."

--Delay the decision. Some things you can say to put off making a decision would be "I don't feel like it right now," or "I'll tell you later." This works when you need time to think about making a commitment-but you do have to give an answer eventually, so the problem isn't solved, just delayed.

Peer pressure is difficult for anyone to handle--even adults. As parents, we can help our children deal with peer pressure by giving them strong values and the techniques to get out of bad situations without losing face among those important people--their peers.




The 8th grade finished fourth overall with 107 points. Only 17 points kept first and fourth places apart.




