## Commissioners vote for proposed tax decrease

Taxpayers got a raise Monday when commissioners voted for a proposed tax decrease of 1.5 cents per \$100 valuation. The decrease brings the county tax rate down from 59.5 cents per \$100 to 58 cents per \$100.

Under the proposal, taxes on a home valued at \$18,710 would decrease \$2.24 from \$89.07 to \$86.83 or .025 percent compared with last year's taxes.

Required wording of a notice of public hearing on a "tax increase" elsewhere in this issue confuses. Although the proposal increases total tax revenues from 1988 by .0476 percent, an increase in property valuation actually causes a drop in rate of taxes assessed.

Judge Kathryn Mayfield presented the 5.2 million dollar 1990 budget to the court for review. The budget will be typed in its final form for the Sept. 11 meeting of commissioners.

Results of a safety inspection at the airport were outlined by Judge Mayfield. Main findings included grass encroachment, improper color and placement of some lights and too much loose gravel.

Commissioners voted to accept a committee recommendation selecting West Texas Consultants as the engineering firm to formulate a master plan for airport improvement. The master plan is part of a process to obtain grant money for the project.

Three members of a committee appointed to make recommendations regarding use of revenue from the hotel/motel occupancy tax met briefly with the court. Don Long, committee chairman, Steve Williams and J. D. Brown were given copies of statutes pertaining to use of these funds.

The committee members were joined by J. B. Miller for a planning meeting later in the morning, but no proposals for fund use were finalized due to the absence of Geniece Childress. Mrs. Childress represents the museum on the committee.

Court members voted to have employees medically screened before allowing them to resume work if the patient's doctor determines permanent disability. Where possible, job descriptions will be provided for the

doctor.

Job descriptions for all employees will be formulated in future months.

Commissioners agreed to curtail use of the street sweeper on a trial basis in an effort to cut the need for repairs on the machine. The sweeper will be used three times a week instead of five in the downtown area and once a month in each residential precinct area instead of twice.

In other business, commissioners voted to accept a one year contract with the Immigration and Naturalization Service to house INS prisoners at \$15 per day, officially declared the north end of River Road closed, agreed to table action on county-wide sewage regulations and accepted a fuel bid submitted by Shelton Oil and Gas. Other bidders were Sherwood Oil and Sonora-Ozona Oil Company.

Regular monthly reports were received from Sheriff Jim Wilson, Parks Supt. Onecimo Ortiz, Garland Young for the civic and youth center, Louise Ledoux, librarian; Eddie Moore, road department superintendent; Janet Hill Hill for Helping Hands, Bill Boswell, hospital administrator; and the County Extension Service.

Moore reminded the court of legislation prohibiting burning of trash after Aug. 31. Covering trash at the dump daily to prevent blowing will require that a heavy equipment operator be available for the duty, Moore said.

Disposal of dead animals in a trench at Vannoy Veterinary Clinic continues to be a problem. A site away from town is being sought for this purpose.

The Meals on Wheels program served 488 meals during July, up 76 over the previous month. Commodities were distributed to 101 families representing 229 people, Mrs. Hill said.

The Sheriff's Department received 275 calls for assistance during July and placed 45 persons in county jail. There were five civil papers served.

Directors of the civic and youth center and Teen Council members decided that all eating and drinking will be done in the kitchen only during teen dances, Young said.

Young told the court Lillie Lujan has resigned from the board and a replacement will need to be appointed.

## FmHA loan applications accepted

Applications for emergency farm loans for losses caused by drought conditions which occurred Jan. 1 through Aug. 31, 1988 and continuing are now being accepted, FmHA County Supervisor Ben T. Rucker, Jr. said.

Crockett County is one of four counties in Texas recently named by Secretary of Agriculture Richard E. Lyng as eligible for loans to cover part of actual production losses resulting from the drought.

Rucker said farmers may be eligible for loans of up to 80% of their actual losses or the operating loan needed to continue in business or \$500,000, whichever is less. For farmers unable to obtain credit from private commercial lenders, the interest

rate is 4.5%.

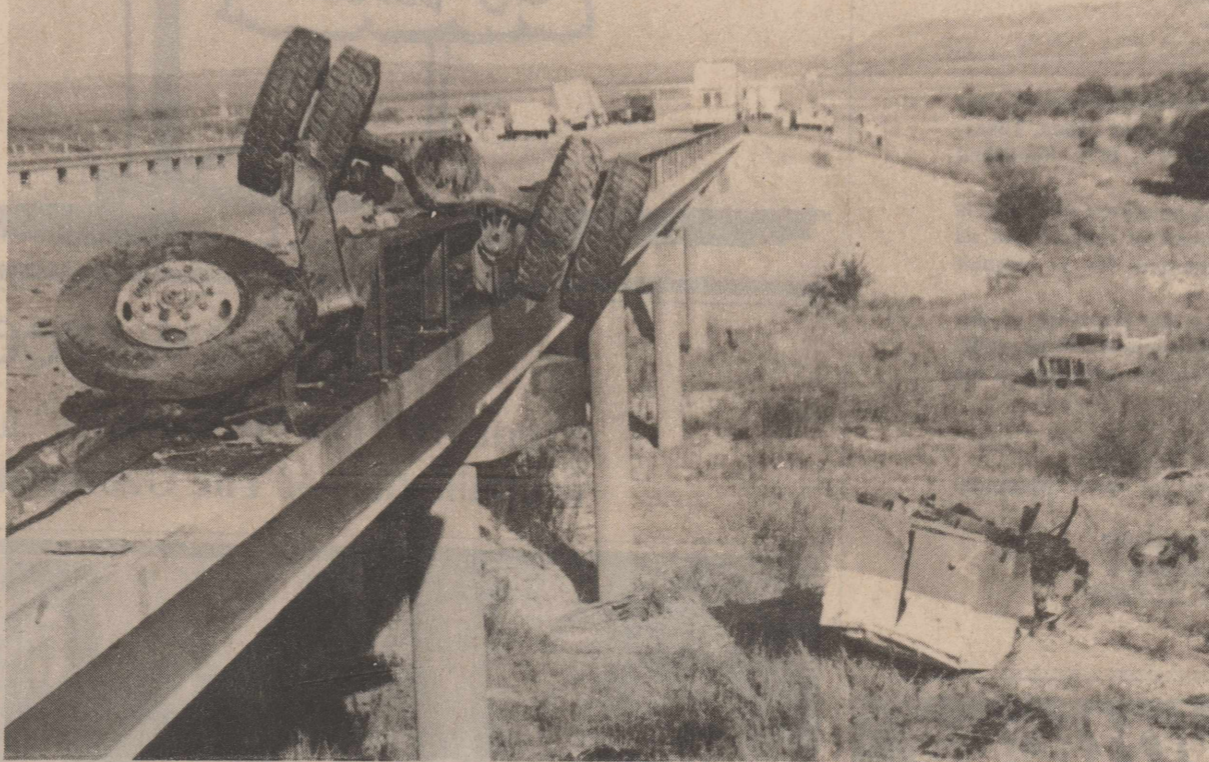
"As a general rule, a farmer must have suffered at least a 30% loss of production to be eligible for an FmHA emergency loan," Rucker said. "Farmers participating in the PIK or Federal Crop Insurance Programs will have to figure in proceeds from these programs in determining their loss."

"Applications for loans under this emergency designation will be accepted until Aug. 29, 1989, but farmers should apply as soon as possible. Delays in applying could create backlogs in processing and possibly over into the new farming season," Rucker said.

FmHA is a credit agency of the U.S. Department of Agriculture. It is authorized to provide disaster emergency loans to recognized farmers who work at and rely on farming for a substantial part of their living. Eligibility is extended to individual farmers who are U.S. citizens and to farming partnerships, corporations, and cooperatives in which U.S. citizens hold a majority interest.

The FmHA office in Ozona is open on the fourth Thursday morning of each month from 10:30 to 12 and is located in the ASCS office.

The Ozona FmHA office is serviced by the Eden FmHA office, Box H, Eden, TX 76837, phone (915) 869-3941 and is located in the Eden ASCS office. The Eden FmHA office is open from 8 a.m. to 12 noon and 1 p.m. to 5 p.m., Monday through Friday.

## I-10 truck accident injures one

A one vehicle accident Tuesday morning placed a man in Crockett County Hospital and damaged a bridge on I-10 14 miles west of Ozona.

According to a DPS report, Jerry Dale Glick of Alice fell asleep and lost control of the 1982 International Truck he was driving owned by Dresser Atlas. The vehicle left the road and struck a bridge railing before turning over and landing upside down in the draw below.

The vehicle's axles and tires were left hung on the side of the bridge as the truck overturned.

Firemen were dispatched to the accident, reported at 8:25 a.m., but a small blaze caused by the mishap was extinguished before they reached the scene.

Glick, who was the only person in the truck, remained hospitalized Tuesday afternoon, but his condition was not released.

Department of Public Safety Trooper W.D. Taylor of Ozona investigated the accident.

## Sohl hired as reading teacher

The Ozona School Board, meeting in regular session on Tuesday, August 8, approved the employment of Mr. Mark Sohl as a reading teacher in Ozona Junior High School for this coming year. Mr. Sohl is a 1973 graduate of the University of New Mexico and received his Master's degree in 1986 from Sul Ross State University. He has taught reading in Marfa and Alpine and will take the place of Mrs. Joyce Maness, who retired at the end of this past school year. During the meeting, President Jeffrey Sutton presented Mrs. Maness with a plaque as an expression of the Board's appreciation to her for twenty-six years of service to the school district.

Mr. Curtis Keith, school maintenance supervisor, met with the trustees to give them information on a coin system which could be used to control light usage during the evening at the tennis courts located at the school stadium. The consensus of the Board was to refer the topic back to Mr. Keith for further study. Mr. Keith also

gave the members information on the status of the asbestos abatement project.

Board approval was granted for allowing the district to participate in the Region XV Education Service Center Math/Science and Drug Education Cooperative Training Program, and the members also approved a request from the Texas Department of Health for permission to bring the TDH Dental Van to Ozona this year. The dental van will be used to test, clean, and, if necessary, repair the teeth of children who come from economically deprived homes. Also gaining approval was a bid from Gandy's Dairies for dairy products for the 1989-90 school year. Gasoline bids were rejected and will be considered by the Board during its regular meeting in September.

The trustees reviewed a proposal from Franklin Life Insurance Company, the district's present carrier, for school employee insurance but decided to postpone consideration of

employee health insurance until a later meeting of the Board. During the meeting, Superintendent Garland Davis conducted a review of the proposed 1989-90 school year budget.

## Hospital legislation again in Justice Department snag

State approved legislation allowing a hospital district election for Crockett County has been held up in the U. S. Department of Justice for the second time. Bill Boswell, administrator of Crockett County Hospital received notification requesting additional information last week through Richard A. Muscat of the Texas Office of the Secretary of State.

The Justice Department found the information it received insufficient to determine that the proposed changes "do not have the purpose and will not have the effect of denying or abridging the right to vote on account of race, color, or membership in a language minority group."

A request for population breakdown within the four commissioner precincts including a color coded map depicting Hispanic population concentration, number of registered voters by race and by Hispanic origin, election returns by precinct for each county, city or school district election since Nov. 1986 in which a Hispanic candidate participated and number of registered voters by election precinct and by race and Hispanic origin are among the items of information requested.

Also requested by the Justice Department is a description of the opportunities of minorities in the community to be part of the process leading to adoption of the changes in the

legislation to comply with requests by the Justice Department at the time of its first rejection of the legislation.

A detailed chronological description of the process leading to the adoption of the submitted changes was also requested.

Responses to the requests will be prepared and submitted according to Boswell.

## Community Center registration begins

The Ozona Community Center will register students for its preschool, all-day child care and after school care programs on Thursday, August 24, from 9-11 a.m. at the center, located adjacent to the Ozona Primary School. Those who pre-registered in May need to come by the center to pay the annual \$10.00 per child registration fee in order to finalize their enrollment. When pre-school classes are filled to capacity, students will be placed on a waiting list in order of registration. Classes will run concurrently with the public school calendar and will begin on Wednesday, August 30.

## Hospital board holds meeting

Hospital board members were told the care center and hospital have spent less tax dollars than allocated by the budget when they met Aug. 10. Administrator Bill Boswell stated that the hospital has spent \$22,832 less for the first six months and the care center has spent \$56,619 less for the same period.

The hospital has received revenues of \$334,379.13 through July compared to \$234,536.35 for the same period in 1988. Cash deposits year to date are \$544,268.91 compared to \$430,432.54 in 1988.

Disbursements reported through July are \$685,369.15 compared to \$626,018.83 for the same period in 1988. Total emergency room and clinic visits through July were 2,512. Laboratory procedures totaled 2,026 and x-rays were 542. The ambulance service totaled 116 runs through July.

A new ambulance requested by the EMS will cost approximately \$52,000. Between \$4,000 and \$6,000 will be required to outfit a new ambulance if the old vehicle is kept in service.

Board members voted to purchase six new wheel chairs for the care center and three used over-the-bed tables for the hospital. Consideration of purchase of a FAX machine was tabled until the Sept. meeting.

A July board decision to extend the kitchen range hood was reversed following a report that a Medicaid inspector believes Life Safety Code inspectors will require the entire hood to be replaced.

In other discussion, the board was told that in two to three years, approximately 165 feet of five inch sewer line will have to be replaced at the care center.

The board was instructed that House Bill 95 authorizes counties with a population of 50,000 or less to adopt a sales and use tax to support county hospitals. The tax rate may not exceed one-half per cent, and combined with other political subdivisions, may not exceed two percent.

### Fire rages for days on Taylor ranch

A pasture fire accidentally started by a stranded motorist kept volunteer firemen running for four days and ate thousands of acres of rangeland last week.

The blaze on the J. O. Taylor ranch in Val Verde County began when a stranded Kansas woman set her spare tire on fire to attract the attention of passing motorists.

According to a Val Verde sheriff's deputy, the woman had a flat and no one would stop to help her.

Ozona sent 10 men, two trucks and the van to the location 12 1/2 miles northeast of Juno after receiving the initial call July 8 at 5:57 p.m. Local volunteers used 1,100 gallons of water while working to contain the fire with five units from Sonora, four from Del Rio, two from Comstock and two from Eldorado.

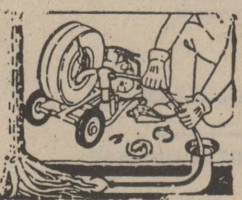
The trucks returned at 11:50 p.m., but were called back the next day along with a county water truck, expending 2,200 gallons of water.

Ozona was again called to the Taylor Ranch on the 11th, sending three men and one truck. No crew was available to respond on the 12th, but Fire Marshal Steve Kenley went to the scene.

The woman accused of causing the fire was arrested, but was later released.

08-14-89...An Ozona citizen reported that someone had sprayed silver paint on the victim's car while it was parked on 12th Street. The investigation in this case is continuing.

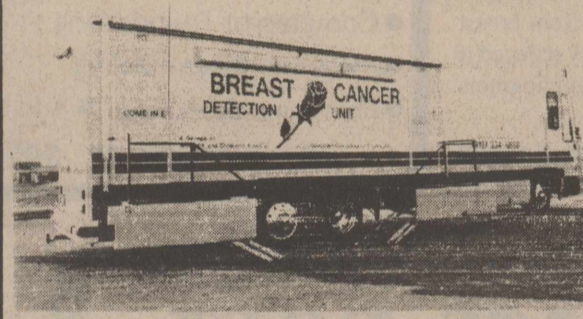

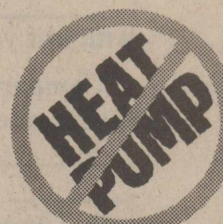

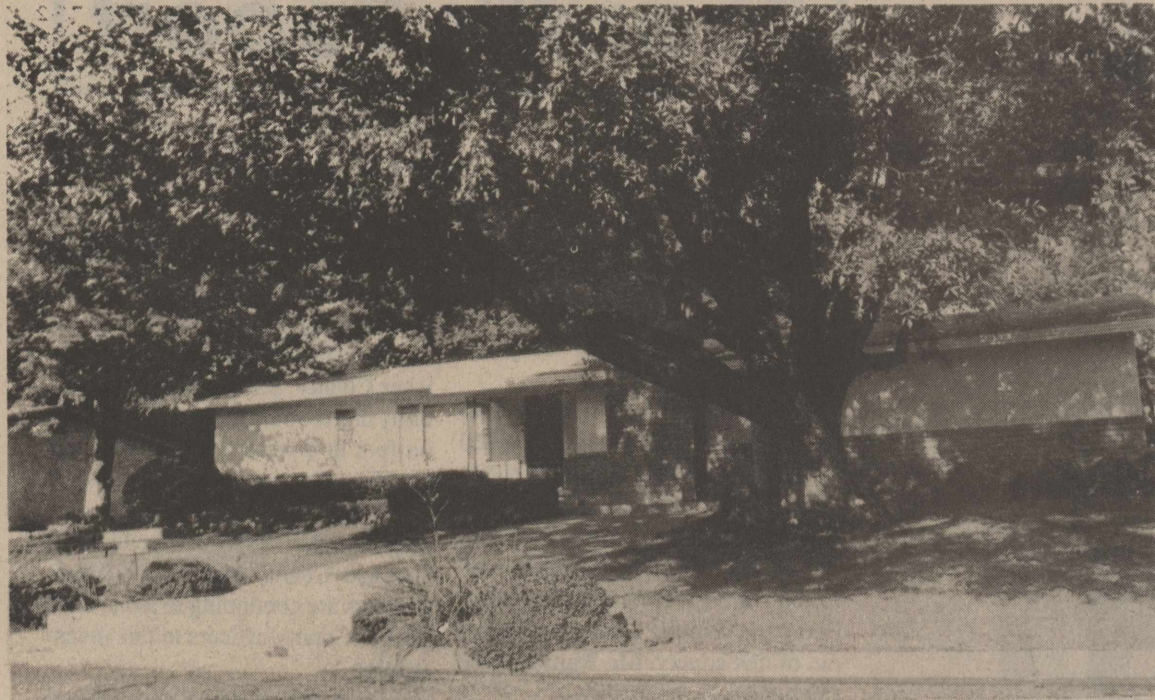

### Mobile cancer detection unit accredited by ACR

The Mobile Breast Cancer Detection Unit of Odessa, which services Ozona, received the certification of the American College of Radiology Mammography Accreditation Program.

Mammography is an x-ray examination of the breast which the American Cancer Society and other medical experts see as the best means for the early detection of breast cancer.

The program is voluntary and is designed to ensure that women receive optimum quality mammographic examinations. The process is done through a peer review evaluation of the facility's staff qualifications, equipment, quality control and quality assurance programs, image quality, and breast dose. The accreditation must be renewed every three years.

The accreditation was instituted because of the concerns of radiologists, other national medical organizations, and the public that qualified personnel perform and interpret mammograms and that dedicated mammographic equipment be used. The American College of Radiology received an American Cancer Society Control Grant which was used to pilot test the accreditation program.

Breast cancer will strike one in 10 American women. The American Cancer Society predicts that about 41,000 women will die of breast cancer.

The American Cancer Society recommends that women do monthly breast self-exams and have regular physical breast exams by a doctor. It further recommends mammography on the following schedule:

In an effort to find cancers at the earliest possible stage and prevent unnecessary deaths, a mobile breast cancer detection unit will be made available to local women on Friday, Aug. 25, at Crockett County Hospital.

Appointments may be made by calling 392-2671.

According to the American Cancer Society, one out of every ten women in the United States will develop breast cancer sometime during her lifetime. Every year, over 37,000 women die as a result of breast cancer.

According to a spokesman from the Regional Breast Care Center at Women's and Children's Hospital in Odessa, "The death rate from breast cancer could be drastically reduced if women would have mammograms done before a problem exists."

By using modern state-of-the-art X-ray equipment, breast cancers can

An annual mammogram from age 50.

be found when they are about the size of a grain of rice and well before the cancer can be felt. A woman who is diagnosed with breast cancer at this fairly early stage has a 90%-97% survival rate. 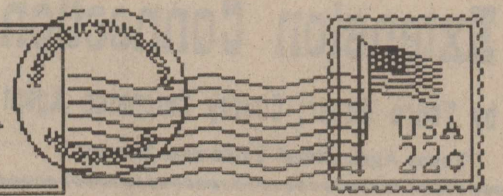

Dear Editor:

I am writing to you in order that I may express my appreciation for the quick response and the professional manner in which my emergency health treatment was performed by the doctor and the nursing staff of your local hospital.

My husband and I were returning from a combination vacation and business trip in the upper part of Arizona and decided to drive back to our home in South Houston via Interstate 10. We stopped at a small town just east of El Paso and had dinner. Later that night, while staying in a motel located in Van Horn, I became very ill, so ill that I was in need of medical treatment. My husband and I, not being familiar with the area, drove for sometime along the interstate before he was able to locate a hospital in your town of Ozona. Within minutes your doctor R.M. Owensby, M. D. was at the hospital, and having been advised of my problem by the nurses on duty, proceeded with treatment.

I would like for the people of Ozona to know how fortunate they are to have this small hospital with Dr. Owensby, the nurses, and all of its staff. Where we live is a suburb of Houston, and over the years, we have had many occasions to seek medical help including one of the medical teams of Dr. Denton Cooley at St.

Luke's Hospital, located in the huge medical complex, one of the largest in the world, and I have to tell you that we have never been treated with more professionalism than we were that night. The facility was clean and appeared to be well equipped. The staff was efficient and courteous and very attentive to both mine and my husband's needs. My husband is a heart patient, and the staff showed a lot of concern for him and his comfort while tending to my medical needs. I spent approximately eight hours in your hospital, and it will be eight hours of my life that I will be forever grateful to you, the people of Crockett County, Dr. Owensby, the nurses, and the rest of the staff at Crockett County Hospital.

We here in the Houston, Harris County area are so used to having a hospital or other medical facility within ten minutes or so of our homes that we don't stop to think that there are people such as yourselves and the people of the surrounding area that may have to drive for as long as an hour and a half or so to seek medical help. Mat I say again, keep up the good work, and if we are ever in Ozona again, I hope it is to shake the hand of each and every one of you for keeping this small hospital going.

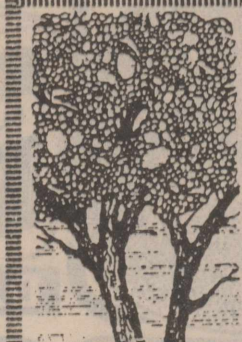

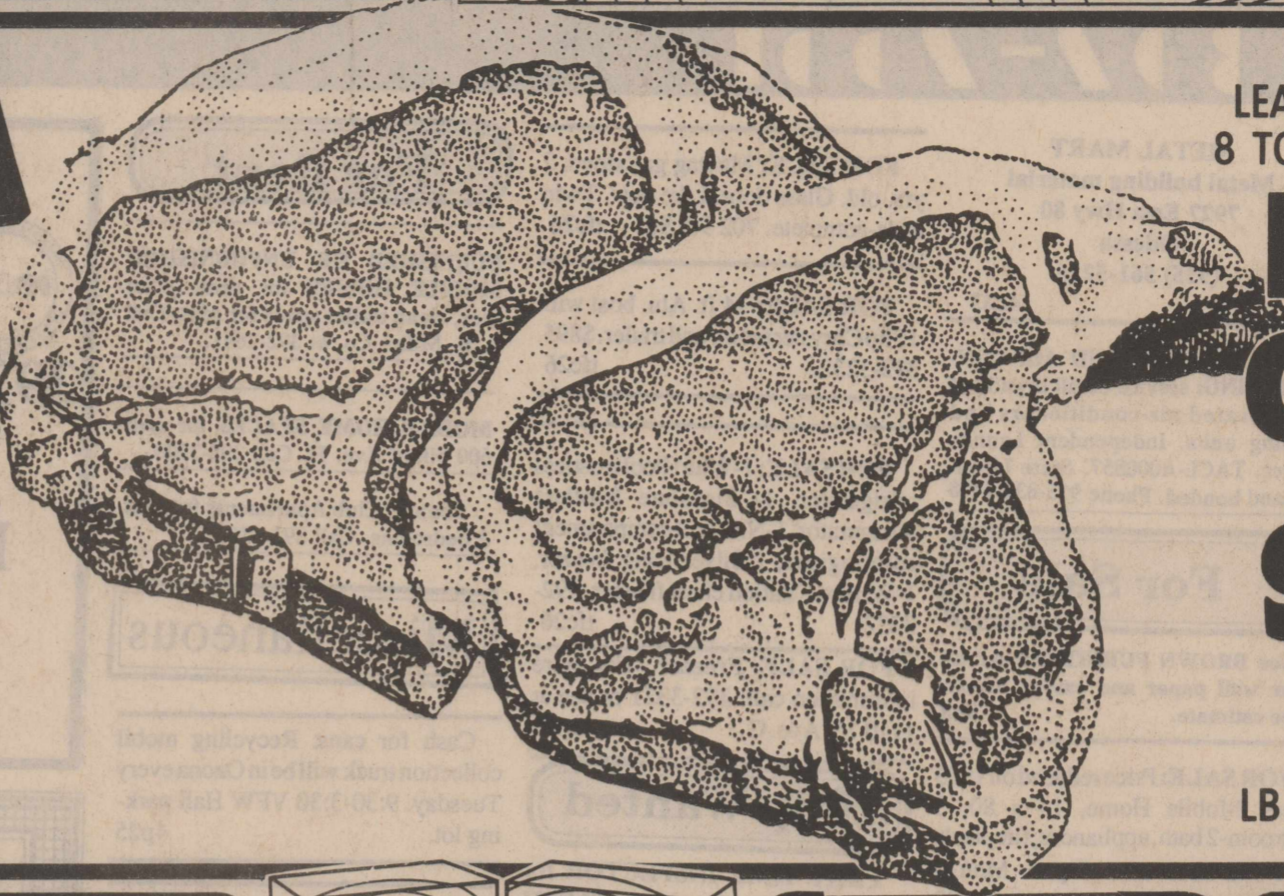
