

Measles outbreak a threat

The measles outbreak in South that is affecting many lives. People around the state should take precautions, and be immunized.

This year alone, more than 600 confirmed measles cases have been reported in over 20 counties in South Texas, primarily in Hidalgo County. Recently, and 18-month-old, unimmunized child, died of suspected measles. The Public Health Region 3 communicable disease staff of the Texas Department of Health is cur-Once the winners are selected, rently monitoring measles cases in the region and providing vaccine to all Public Health Clinics.

According to Charles Mallory, Program Manager for the Communicable Disease Programs for Region 3, "Even though no measles cases have been reported in the region this season. it is still very important for chilnized against measles. It is not just a Scholarship decisions will be disease of young school children, in fact, more than one third of all cases occur in people 15 years of old and older." Anyone having questions regarding immunizations should call the local Public Health Region 3 field office clinic, county health department, or your private doctor for information.

People catch measles by breathing the measles virus that an infected person spreads by coughing, sneezing or simply talking. It takes from 10 to 14 days for a person to begin to show the symptoms of measles: high fever, rash, runny nose, watery eyes, or cough.

Babies and adults who catch measles are often much sicker and are more likely to suffer longer than elementary school children and teenagers with measles.

Measles is often a severe disease, with frequent complications such as middle ear infection, or, more rarely, convulsions, hearing loss, and mental retardation. In the United States, one child out of every 500 to 10,000 who gets measles dies.

Public Health Region 3 recommends that infants and children be immunized at 15 months of age, and again at 4 to 6 years (before entering school). Children will receive a combination vaccine, MMR (Measles, Mumps, and Rubella).

Adults born after 1957 who have not had the live measles virus vaccine on or after their first birthday, had a case of measles diagnosed by a doctor, or had a blood test for measles, should be immunized.

**PARALLEL OR DIAGONAL?**



However, the few persons that are causing all the vandalism need to be stopped, and they need to realize that our mother has been through more than enough in the last one and a half years to last a lifetime. One law, the windfall elimination ords). provision, affects Social Security retirement and disability benefits. It requires that a modified formula be used that results in lower benefits for government employees who also qualify for Social Security. That's because the formula is geared to giving more generous Social Security benefits (when compared to pre-retirement earnings) to lower-paid workers. Due to a guirk in the formula, government employees were treated as lower-paid workers and received the generous benefits in addition to their government pension. The provision eliminates the windfall.

The other law, called the government pension offset, affects Social Security benefits that may be payable to a spouse or widow. It requires that a direct offset be used, which essentially prevents a person from getting a hefty government pension AND a dependent's benefit from Social Security. Spouse's benefits were meant to be paid to people financially dependent on their husbands or wives, not to people who worked for a government agency and earned a pension.

## **New HIV regulations benefit women** and children disability applicants

Social Security recognizes that HIV - the virus that causes AIDS - can develop differently in women and children than in men. The agency has published proposed regulations and also issued new operating guidelines that Social Security is now using to assess all HIV cases, including those for women and children with HIV infection.

The new criteria list certain gender-specific manifestations of HIV infection - such as gynecological cancers and infections - that is considered in evaluating a woman's disability claim. In addition, the new guidelines note that the course of HIV disease in children is also different from that in adults, and contain a specific list of criteria severe enough to pre-

HIV. The number of children with HIV infection is, unfortunately, also expected to rise.

Social Security administers two separate programs that pay benefits to people disabled as a result of HIV infection - the Social Security Disability Insurance (SSDI) program and the Supplemental Security Income (SSI) program. Under both programs, applicants must meet the definition of disability in Social Security law - basically, for adults, the inability to work because of medical impairments that are expected to last at least one year or to result in death. For children to be found disabled, they must have an impairments of comparable severity.



SSI makes monthly payments to people with disabilities, including children, whose income and assets are below a certain level. In our state, SSI eligibility usually means entitlement to Medicaid benefits.

Social Security's proposed rules also significantly expand the authority of SSA field offices to presume a person is disabled and make immediate payments to SSI claimants when it is confirmed that the impairment due to HIV infection is severe enough to keep the person from working. These payments can continue for up to six months while the formal disability determination process takes place.

## Habla usted Texan? More and more Texans are talk- Language school officials say there residents will be Hispanic within a

ing these days - in Spanish. In a state where one out of three residents is Hispanic, Anglos by the thousand are deciding to become bilingual.

Spanish is hardly a new language in Texas. It has been spoken here since 1514 when Alonzo Alvarez Pineda, the first European to touch these shores, arrived to map the Gulf of Mexico.

Most graduates of state high schools have had at least a beginning course in Spanish as a second language. In cities like San Antonio. where about half the population is Hispanic, almost everybody has a rudimentary knowledge of the language. Many Anglos along the border speak it fluently.

Only in the last couple of years, however, has bilingualism become the vogue. Now schools like The University of Texas at Austin, UT San Antonio, UT El Paso and other institutions around the state are being hard put to find enough teachers for the spiraling enrollment in Spanish classes.

Interest in learning to "habla espanol" is not limited to college students, however, Berlitz Language Centers in Texas report a 60% increase in Spanish class enrollment.

The National Autonomous University of Mexico (which operates its only U.S. campus in San Antonio) has been forced to rent space from a nearby hotel to handle the overflow of students wanting to take Spanish. Enrollment already has increased 50% over a year ago and is still going up. Why the sudden interest in learning a second language one that has been spoken here for almost 500 years?

## Foot care important for diabetics

For diabetics there is no sidestepping good foot care.

"Fifteen to 20 years into the disease, poor circulation and nerve damage can threaten the limbs," said Dr. Glenn Cunningham of Baylor College of Medicine in Houston. "But proper preventive measures can help avoid infection, gangrene and amputation."

Cunningham urges diabetics to practice proper foot care, including: wearing shoes with good arch support and proper fit, and wearing clean socks or hose; avoiding walking barefoot; checking inside shoes for pebbles, tacks or tears; cutting toenails straight across to prevent ingrown nails; buffing down corns or calluses with a pumice stone or an emery board. Do not cut them or use a chemical corn remover

# Screwworms found within 140 miles of Texas border

COLLEGE STATION Screwworm cases found in Mexico in Texas, fueling worries about the health of the livestock industry on this side of the border.

The nearest case was found on May 21 in Soto la Marina in the state of Tamaulipas, 136 miles from Brownsville, said Dr. Ed Gersabeck of Hyattsville, MD, senior entomologist with the U.S. Department of Agriculture's Animal and Plant Health Inspection Service (APHIS).

The latest infestations were reported in cattle on May 25 in Los Choapas in the state of Vera Cruz, and in Gonzalez in Tamaulipas, Gersabeck said.

The May discoveries bring to 45 the number of cases reported in Mexico since the beginning of the year.

Studies have shown that screwworm flies can travel up to 100 miles on wind currents, and these new finds definitely pose a threat to Texas livestock, said Dr. Cliff Hoelscher, entomologist with the Texas Agricul-
