## Family Health Center Shines For Open House

Open house at Family Health Center of Ozona gave residents an opportunity to tour the facility Sunday afternoon. Renovations at the former hospital were admired by some 50 guests. The center opened July 1 as a part of Shannon Health System.

Here from Shannon for the event were John Geanes, chief executive officer; Dan Stultz, chief medical officer; Lawrence Leonard, senior vice-president; and Paul Adams, assistant vice-president.

The clinic is directed by Peggy McWilliams, R.N., and Marcus Sims, D.O., provides patient care. A physician's assistant is being sought for Ozona.

"Some physician's assistants specialize in surgery and some in clinics; some have been medics in the military," said Geanes. "It is a good way to keep from wearing your doctor out by having a P.A. available."

Others working at the health center include four registered nurses, two licensed vocational nurses, three nurses' aides, one part-time nurse aide, two part-time registered nurses, two clinic receptionists, and three lab technicians.

Dr. Sims expressed pride in the new quarters. "The facilities are nice and modern. It will provide a lot better atmosphere," he said. "We are still in the experimental stages. Like any experiment, there are always problems and bugs to overcome. Hopefully, we will get those worked out and things will run more smoothly."

The doctor's professional services were required during the open house. Emergency patient Daniel Aguilera, young son of Maribel Limon, required three stitches in his head after being hit with a golf club.

Lawrence Leonard also indicated his approval of the facility. "We are very pleased about the way the clinic turned out. With what we have in place, it will serve the needs of Crockett County." The clinic has been busy, and after hours care is also going well, Leonard said. Across the country small hospitals are having a hard time and are turning to outpatient clinics to help out according to Leonard.

Wherever they have clinics, there is a partnership between the community and Shannon, Leonard continued. "Everything we do in this clinic is to

serve the patients of Crockett County."

Dan Stultz expressed confidence that Dr. Sims, the community and the future P.A. will decide what additional medical services may be needed in Ozona. "It will be up to them to determine the right mix. We're interested in doing the right partnership with Marcus and the clinic," he said. "We want to utilize Crockett County's EMS and facilities as best we can."

Geanes spoke of the access to specialists through Shannon. "We did rural heart research and knew there was a big demand for that." Shannon sends two cardiologists to Del Rio twice each week where they see some 35 patients, he said. In November Shannon will have a mobile mammography unit for use at its community clinics.

Judge Jeffrey Sutton officially welcomed Shannon Hospital to Crockett County. "I think this is a good facility for the county in that we can provide the services we were providing more efficiently and more economically," the judge said. "This will be a tremendous savings for the county in the long run."

## OHS Football Workouts Begin Aug. 8

The Ozona High School 1996 football season opens with athletes receiving their workout uniforms and shoes beginning Wednesday, Aug. 7, at 5 p.m. Coaches have been busy preparing themselves for the upcoming season.

Seniors will receive their clothing from 5 to 5:15 p.m., juniors 5:15-5:30 p.m., sophomores 5:30-5:45 p.m., and freshmen 5:45-6 p.m. There will be a team meeting from 6:05 to 6:25 p.m., and the first workout will start at 6:30 p.m.

On Thursday and Friday, football

workouts will be from 5 to 6:30 p.m. and 7:30 to 9 p.m. Saturday workouts will be from 10 to 11:30 a.m. and 1 to 2:30 p.m. Athletes will work out in full pads after their first day of classes on Monday, Aug. 12.

Heading up the 1996 Ozona Lions as athletic director and head football coach is 43-year-old Walter Hargrove. He started his new position in May of 1995. Hargrove is a native of Rotan, has coached 19 years and was a coach four years at Haskell High School before starting in Ozona.

Hargrove will coach the quarterbacks, safety and raiderbacks. Two assistants who joined the high school staff last year were Alan Phillips and Dane Vickers. Phillips last coached at

Haskell and will coach the running backs, punters and defensive ends and will continue as the head girls' track coach. Vickers last coached at Anson and will coach the offensive linemen, place kickers and inside linebackers and will be the assistant boys' track coach.

Also assisting will be Ronnie Casey who will coach the split receivers and corner backs. Lee Gonzales will coach tight ends and Sam linebackers, and Rod Schneider will coach the offensive linemen and defensive tackles.

The Lions, who went 2-8 in 1995, will return 6-6 starters and 15 lettermen. They are rated sixth in the district by Dave Campbell's 1996 Texas Football.

Ozona players to watch for in the 1996 season are quarterback Justin Browne, running back Darin Jackson, wide receiver Jon Sanchez and offensive tackle Steven Montez.

Other returning starters and top prospects to keep an eye on include running back and quarterback Pete Castaneda, running backs Brian Badillo and David Gutierrez, wide receiver Jason Stuart, linemen Lalo Guadarrama, Robert Kelly, Jason Baker and Jason Hignight, and nose guard Albert Flores.

At press time, the exact date or time had not been set for the first scrimmage with District 15-A members Rocksprings to be held in Ozona

## Man Injured In Hit And Run

Alan Anthony of Ozona received a concussion and whiplash when his vehicle was knocked into the parking lot at Fierro Shell Sunday night. Anthony, who braked and did everything he could to avoid the accident, was left unconscious by a driver who didn't stop, said DPS Trooper Ben English.

Anthony was driving north on Hwy. 163 when a car turning east on Santa Anna Street hit his vehicle at 9:05 p.m.

"This is an unconscionable act and should not happen in our community," said English. The officer is asking anyone who saw the accident

or has information about the car or driver to contact him at the DPS office. "I will return your call," English promised.

The injured man is not certain which way the car went, but he did see that it was a large white 4-door American-made car. English believes the vehicle was made in the 1970's judging by chrome parts at the scene.

"I will appreciate any and all assistance," said English. The accident is a felony hit and run, and Anthony's injuries would have been much worse if he had not been wearing a seatbelt, English said.

### New Promotion Fund Update . . . . .

Mohair growers will learn how their new promotion fund is developing when they attend the summer meeting of directors of the Mohair Council of America in Kerrville Aug. 14-15.

Layton Black of Goldthwaite, council president, said a highlight of the summer meeting at the Inn of the Hills will be a report on the voluntary deduction program that was just initiated June 1 by the reorganized Texas Mohair Producers Board. The producers commodity board will meet at 10 a.m. Wednesday, Aug. 14, and growers are invited to attend.

Other matters on the Mohair Council agenda, Black said, include an update on the value added program proposal and how the National Sheep Improvement Center funding programs can benefit the Angora goat and mohair industry and the Market Assistance Program available under the U. S. Department of Agriculture.

"We are working hard to come up with alternative financing for future mohair promotion and market development programs that were previously paid for through funding from deductions made under auspices of the Na-

tional Wool Act," Black said.

The Mohair Council's executive committee will meet at 2 p.m. on Wednesday, Aug. 14, followed by a reception at 6 p.m. for growers and directors at the Kerrville residence of Council vice-president Lanny Leinweber.

The summer directors' meeting will begin at 9 a.m. on Thursday, Aug. 15, in the Medallion Room at the Inn of the Hills. Registration and coffee will be at 8 a.m.

Black said the council is celebrating its 30th year of operation, and he urged growers to attend and provide input for future planning of industry promotion and market development programs.

### Consumers Warned About Mercury Face Cream, Necklace

Last week another consumer alert was broadcast by the Texas Department of Health regarding a mercury-containing product. Not only is this something everyone should be aware of, but it's important because this is the second recent alert involving mercury.

What is mercury and why should we be concerned? Mercury is a silvery-looking metal which is liquid at room temperature. Most of us have seen it in thermometers, where it is enclosed by the glass. However, it is a toxic hazardous substance, and if spilled, can be inhaled as vapors and can be absorbed by the skin.

Exposure to mercury, particularly prolonged exposure, can affect the brain and nervous system, causing vision, hearing, memory and learning impairments. Nervousness, short-temperedness, appetite loss, impaired nerve-muscle coordination, digestive problems, skin rashes and kidney damage and failure are also potential consequences. Asphyxiation can occur, and other severe symptoms include nausea, vomiting, bloody diarrhea, and severe abdominal pain.

Somewhat nasty stuff and we'll just stay away from it - right? Unfortunately, two products - a face cream and a popular type of necklace - have been found to contain high levels of mercury in recent months.

Testing by the Texas Department of Health's laboratory has determined a suspicious silver liquid in glass-vial necklaces which are popular among school children in the lower Rio Grande Valley is mercury. The necklace consists of a clear glass vial attached to a waxed cord. The vials vary in shape and are filled with mercury and another liquid in assorted colors.

"This is a protective measure," said Dr. David Smith, Texas Commissioner of Health. "The last place we should find a hazardous substance is hanging from a child's neck." The danger comes if the vial breaks and releases the mercury. Necklaces should not be thrown in the trash, but should be taken to the nearest hazardous waste disposal site. A location can be obtained by calling the Texas Natural Resource Commission at 512-239-2334, or the local Health Department at 392-2996.

If you have information about where the necklaces are being sold or manufactured, call the TDH's Product Safety Program at 512-834-6773. The people manufacturing the necklaces could also be at risk from prolonged exposure to mercury vapors.

The face cream is also a dangerous product, and users who have been tested show elevated mercury levels and mercury poisoning symptoms. The cream, sold as Crema de Belleza-Manning (Manning Beauty Cream) or Nutrapiel Creaming, was manufactured in Tampico, Tamaulipas, Mexico. The cream has turned up from Texas to California, and contains about 1,000 times the amount allowed for use in the U.S.

Although the cream is sold primarily in Mexico and production has now been halted, it is turning up everywhere from store shelves in the U.S. to flea markets, door-to-door perfume salesmen, and multi-level marketing. Some labels may be in English as well

as Spanish. Instructions say to use the cream for greasy skin, acne, pimples and blackheads.

The Department of Health warns consumers who have the cream to stop using it immediately and to dispose of it like other hazardous household wastes such as paint, pesticides and motor oil. Anyone having used the cream should see their physician at once.







## 4-H'ers Asked To Apply For Annual Awards

"This is a new system, and we need everyone's cooperation to get applications in so awards can be ordered," said Ulmer, who noted the final deadline for third through eighth graders to turn in applications is Friday, Aug. 16, at 3 p.m.

Awards applications will be handed out in the intermediate school during registration week and should be turned in immediately to the school offices, or may be brought to the Extension Office located at 1301 Ave. AA.

Senior 4-H members will receive a medal and can also apply for major awards such as Gold Star, I Dare You, Dan Bean Memorial Scholarship and Mother Davidson.

Information and applications for both junior and senior 4-H members will be mailed out this week in the regular 4-H newsletter. Also, any senior 4-H member who completed a record book does not have to fill out an application for Gold Star, I Dare You or Mother Davidson. They will automatically be turned in for consideration. However, the memorial scholarship does require an additional form.

A record book is required to apply for Gold Star and Mother Davidson. A 4-H member should have already

received or concurrently receive the Gold Star before receiving the Mother Davidson award for outstanding 4-H member.
