

## Ozona team back to work . . . . Community sending aid to Del Rio flood victims

"As usual, residents and businesses of Ozona are answering the call from people in need," said Shannon Hunnicutt of Ozona Chamber of Commerce. "Throughout the community, donations of food, clothing, household items and money are being gathered to aid flood victims in Del Rio.


In an effort led by Carmen Sutton, the Ozona Chamber of Commerce has set up donation boxes at T&T Village Supermarket, T&C Village Market, Small Fashions, Monica's Hair and Nails, and the chamber office. J. R. Bhakta of the Comfort Inn has pledged that for one month, \$1.00 for every room rented will be donated to this cause. Also, Joe Tobar of El Chato's Restaurant has pledged that for one week, \$1.00 of each plate served will be donated to these flood victims. T&T Village Supermarket has donated bottled water and canned goods. The local T&C Village Market and Town & Country Convenience Store, through Town & Country Food Stores, Inc., and in conjunction with their suppliers, donated over 7,600 gallon jugs of water, which were distributed in the first two days of the disaster, to flood victims and to household residents of the affected area.

Helping Hands sent two trailers filled with clothes and other needed items last weekend. Local churches are also involved in the relief effort, as well as many individuals who have traveled to Del Rio to help with clean up efforts.

In addition to the donation boxes in Ozona, there is a collection point in Del Rio at the corner of Sixth Street and Highway 90, in the old HEB Building. They are in specific need of the following items: money, household items, non-perishable canned goods, flour, rice, cereal, peanut butter and jelly, towels, wash cloths and insect repellent. If you have clothes to send, please sort them by size and gender. This will expedite the process of getting the clothes to those who need them.

## Commissioners address drainage problems

Heavy rains and high water in Johnson Draw created a problem with access to Chandlerdale West last week. The ongoing drainage problems were discussed by commissioners at a called meeting Aug. 25. The possibility of placing a bridge or culverts in the draw and temporary emergency outlets off I-10 were considered by commissioners.

"The Soil Conservation said we can't do anything to the draw until their engineers approve," Eddie Moore told commissioners.

A meeting has been set for 9 a.m. Sept. 2 with a state engineer regarding options for a bridge or other passage to Chandlerdale West.

Status of health insurance for county employees was also discussed by the court. Representatives of West Texas Rural Counties Association have been to Ozona five times in the past two weeks to meet with groups of employees and to help resolve claim problems.

Returns from the Aug. 22 school bond election were canvassed. The court attested to 20 votes for and 158 votes against the election.

An agenda item to approve payment to Sunwest Construction was tabled pending assessment of the air conditioning system at the new annex building. Sunwest had been in Ozona for two days of work on the air conditioning, but humidity remained high in the building. A Carrier representative was to come look at the equipment.

In the absence of County Attorney Bill Mason, the agenda item to discuss and approve policy on county attorney charges was tabled until the next meeting of the court.

No action was taken on an agenda item regarding conflict of interest of Gerald Creel as a member of the care center administrator screening committee. The work of the screening committee was already complete when the court met Aug. 25.

Applicants for the care center administrator were screened down from 22 to 10 with six of those 10 to be interviewed by the health services board. Their recommendation will be made to the court.

During the budget workshop, a number of citizens appeared to support a request for a salary increase for Helping Hands director Janet Hill McDaniel. Mrs. McDaniel has been working for considerably less than other county employees and will work even more hours once the new senior citizens building is completed. The court agreed to the increase and an increased budget for the building to cover utilities, etc.

They also approved a budget request by Deputy Dan Griffith who teaches the D.A.R.E. program in Ozona schools to cover increased expenses from addition of another campus to the program.

Bids for the new senior citizens building are to be opened and examined Sept. 9 at 10:30 a.m. A vote will be taken at the regular meeting on Sept. 14.

## Board approves tax rate for improvement project

In a special meeting of the Ozona School Board that was held on Wednesday, Aug. 28, trustees approved an interest and sinking fund tax rate of \$0.089 per \$100.00 of assessed value. The interest and sinking fund tax rate will be for a period of five years and will be used to fund the

district's \$2,965,000.00 capital improvement project approved by local voters on Saturday, Aug. 22.

The capital improvement project calls for the remodeling of Ozona Middle School with additional classrooms, restrooms, offices and a computer lab. New construction will also include new library facilities. Ozona Middle School Gymnasium will be remodeled to provide additional seating and storage areas, and Davidson Gymnasium will be remodeled for the purpose of making this gym Americans with Disabilities Act (ADA) handicapped accessible.

The members also voted to approve the taking of bids for the purchase of a large diesel bus for school activities.

## Lions tackle Mendard Yellowjackets

The Ozona Lions football squads put together an impressive short passing game combined with some talented running as they played a fairly even-handed game against the Mendard Yellowjackets in the final scrimmage matchup before the real season begins. A nice size crowd of followers were treated to an exciting afternoon of football. The varsity and junior varsities combined for a total of four touchdowns while giving up three to the Yellowjackets.

The JV kicked things off in a hurry when Luis Cruz raced 17 yards through the Yellowjacket defense for a score on only the sixth play of Ozona's first offensive set. The defen-

sive effort by the junior varsity was a little bit porous, giving up a pair of scores, but the offense came back to even the match on a 19 yard scamper by Leon Garcia. Stephen Tarr engineered both scoring drives at the quarterback slot.

Ozona's varsity also marched the ball the length of the field in their first set of 20 plays, but the going became tough when they got inside the Yellowjacket 30-yard line. Menard forced the Lions to fight for every inch of ground, including the last three inches. The Lions ran eight plays inside the 30 and two of those were fourth down situations before Ross Crawford sneaked across on 4th down and inches to go.

The varsity defense gave up a quick score before shutting down the

Yellowjackets. In Menard's last set of 10 plays the defensive backfield batted away or intercepted three deep passes.

Late in the scrimmage, with the varsities knotted at one score apiece, Tarr came back in to guide the offense. After Tarr ran for about 25 yards himself, the offense worked the ball into scoring position. Tarr connected with Ken Sessom for a touchdown pass that gave the Lions a 2-1 edge for the evening.

The junior varsity next takes on Grape Creek on Sept. 3 while the varsity hosts the Eagles in what is going to be the history-making first varsity contest for Grape Creek High School. The Ozona Lions are gearing to make it a night the Eagles will want to forget. That game is Friday, Sept. 4, at 8 p.m. in Lion Stadium.

## Millspaugh legacy shared with Museum

"The Sid and Dorothy Baker Millspaugh Estate has graciously given the Crockett County Museum a collection of antique and vintage memorabilia pieces," announced Geniece Childress. Many of the articles are from the Sterling Baker and John Martin of Sonora families.

Dorothy and Sid Millspaugh married in Sonora and came as young ranchers to Crockett County. They made their home on the ranch and in Ozona all their lives. He died in 1952 and she in 1997.

"The Crockett County Museum is deeply indebted and grateful for the unselfish, generous gift," said Mrs. Childress. "Dorothy and Sid and their children will long be remembered."

### State Capital HIGHLIGHTS

AUSTIN — Texas Insurance Commissioner Elton Bomer is considering a rollback that would save Texans more than \$700 million on insurance premiums next year.

The proposed rate cut was made possible by tort reform legislation limiting lawsuits against insurers and others in Texas.

Money that insurers save from fewer court cases and lower claims is offset by corresponding rate reductions set by the commissioner, under a bargain struck between legislators and insurers in 1995.

**Lawyers Seek Better Image**

Four hundred lawyers met last week in Austin and discussed how to improve the public's perception of the legal profession.

Surveys by the State Bar of Texas show most Texans believe they are less ethical than members of any other profession except politicians.

Richard Pena, president of the State Bar, encouraged his colleagues to spread the word that lawyers are "the glue that holds this country together" and to make that message part of the State Bar's ongoing campaign to restore public trust.

Panelists in the discussion agreed lawyers should stop filing frivolous lawsuits and refrain from

bashing judges and each other.

In a report by *The Dallas Morning News*, lawyer-lobbyist Denise Brady, an advocate for the disabled, said the state bar campaign is a good idea, but "as long as the majority of people feel that if they need a lawyer they won't be able to afford one, then the perception is not going to change."

**Flooding Taints Water Supply**

Flooding caused by tropical storm Charley could affect other public water systems and private wells, the Texas Natural Resource Conservation Commission warned last week.

The city of Del Rio's public water supply was shut down due to contamination by floodwaters.

The Texas Department of Health recommended that residents in stricken areas avoid ingesting water that may be flood-contaminated and use bottled water or boil water before drinking.

**Other Capital Highlights**

John Hill said he won't seek reappointment to the Texas Lottery Commission when his term expires in February. Hill said he wanted to avoid the appearance of a conflict of interest after his law firm announced plans to merge with the law firm of Lottery Commission Chairwoman Harriet Miers.

Major daily newspapers have filed open records requests to learn how much profit Geac, the firm that operates the Texas Lottery, has earned from running the state's games of chance.

The Texas Low Level Radioactive Waste Authority last week downplayed the opinions of two hearing examiners (judges) who impugned the agency's proposal to build a nuclear waste repository near Sierra Blanca. The judges said a fault beneath the site has not been sufficiently studied.

Attorney general candidate John Cornyn, a Republican, last

week said Texas should allow counties to handle child support collection cases and let private contractors handle the rest of child support enforcement. To do that would require a waiver from the federal government.

State Auditor Lawrence Alwin has recommended two pay raises — 3.9 percent in 2000 and 3.9 percent in 2001 — for about 150,000 state employees. Alwin estimates the cost to total \$472 million and says the raises are needed because valuable workers are leaving for higher pay in private-sector jobs.

Rice University, at No. 18, is the only Texas school in the nation's top 50 public and private colleges in 1998, as ranked by *U.S. News & World Report*. For the past 12 years, the magazine has ranked schools based on academic reputation, retention, faculty, student body, finances, graduation rate and alumni support.

The Department of Public Safety and local police seized cash and 68 "eight-liner" video gambling machines at four businesses in the Dallas area last week. The ban on the Las Vegas-style machines has been in place for six months.

Larry Paul Manley has resigned as executive director of the Texas Department of Housing and Community Affairs to resume his career in law and investment banking. Manley recently had been criticized for his agency's failure to spend more than \$100 million in federal funds to help poor families secure better housing.

Insurance Commissioner Elton Bomer will hold a public hearing Sept. 24 to gather information on how best to enforce Texas law that prohibits managed care organizations from offering financial incentives to physicians or providers that result in limiting medically necessary services.

## New \$20 bill features anti-counterfeiting devices

Don't be alarmed when the bank teller hands you \$20 bills that look like play money. September 24 marks the date the new Andrew Jacksons will be showing up around the country.

Designed to improve the security of our currency, the Series 1996 \$20 note is the first widely used bill to be redesigned. New \$50 and \$100 notes already have been introduced, but it's the twenty that is given most often in change at banks, retail outlets and through ATM machines.

The new note is the result of a five-year study focused on staying ahead of the counterfeiting threat. In addition, the new U.S. currency incorporates features that will make it more readily identifiable, especially for the visually impaired.

The first noticeable change on the new \$20 bill is a larger and off-center portrait of Jackson, the nation's seventh president. The larger portrait incorporates more detail making it difficult to counterfeit and easier to identify.



*Tips from Your Community Banker*

But beware of counterfeiters who may try to take advantage of those who are not familiar with the bill's new design.

- Federal Reserve Indicators:** The entire Federal Reserve System is represented by a new seal. The letter and number under the left serial number identify the issuing Federal Reserve Bank.
- Fine Line Printing:** Behind the portrait and around the historic building on the back, there are fine-line printing patterns. This makes the line structure appear normal to the eye but difficult to replicate.
- Serial Numbers:** An additional letter is added to the serial number.
- Watermark:** A watermark identical to the portrait is visible from both sides against a light.
- Color-Shifting Ink:** The numeral on the lower right corner of the face of the note changes from green to black when viewed from different angles.
- Security Thread:** Each denomination is positioned with the use of a unique security thread. This is a type of thread or ribbon that runs through a bank note substrate. The new \$20 bill features the thread to the far left of the portrait and glows green when held under ultraviolet light. The words "USA Twenty" and a flag can be seen from both sides against the light.
- Microprinting:** "The United States of America" is on the lower edge ornamentation of the oval framing in the portrait. On the front of the note, "USA 20" is repeated within the number in the lower left corner.

**Jean Marshall's Gourmet Peanut Brittle**

In a buttered 3 qt. saucepan, combine 1 1/2 c. (each) of light corn syrup and sugar with 1/2 c. water. Cook over low heat. Stir until dissolved and comes to a boil. Put in candy thermometer. Boil over high heat without stirring until temperature reaches 280 degrees.

Lower heat and stir in 2 cups unsalted peanuts and 2 T butter. Cook, stirring until 300 degrees is reached. Take away from heat.

Stir into hot brittle 1 tsp. soda. (Use wooden spoon.) Stir well.

Have ready two buttered pieces of heavy duty foil. Pour peanut brittle into two batches, making rounded puddles. When cool enough, work around edges, pulling outward until very thin. Turn over to cool. Store in airtight containers.

Note: have warm water ready to put hot candy thermometer into, and a sink full of hot water to put pan used for cooking brittle.

**Shrimp Luncheon Dish**  
3 T butter or margarine  
1 onion, minced

- 1 green pepper, minced
  - 1 clove garlic, minced
  - 1/4 c. pimiento, minced
  - 1 c. rice
  - 1/2 c. mushrooms
  - 1 1/2 c. shrimp, cleaned
  - 1 tsp. salt
  - 1 bay leaf
  - 2 c water
- Melt butter or margarine in pan over medium high heat. Add onion, green pepper, garlic, pimiento and rice, then mushrooms and shrimp. Add salt, bay leaf and water.

Cover. When steaming, turn to low heat and simmer for 30 minutes. (Cook in electric skillet.) Serves 4.

**Key Lime Pie**

- 1 pkg. (3 oz.) lime Jello
- 1 c. boiling water
- 1 to 2 tsp. grated lime rind
- 1/2 c. lime juice
- 1 egg yolk, well beaten
- 15 oz. can sweetened condensed milk
- 1 egg white, stiffly beaten
- Few drops green food coloring
- 9 lady fingers, split (Regular pie crust may be used.)

Dissolve gelatin in boiling water. Add lime rind and juice. Pour slowly into beaten egg yolk, stirring constantly.

Add condensed milk and chill until slightly thickened. Fold in beaten egg white. Add coloring. Pour into a 9" pie pan lined with lady fingers. Chill until firm. Garnish with whipped cream.

**No Peep Casserole**

- 2 lbs. beef cubes
  - 1 can mushroom soup
  - 1 pkg. onion soup mix
  - 2 1/2 oz. can mushrooms
  - 1/2 c. red wine
- If necessary, cut beef into one-inch cubes. Place in a 2-qt. covered casserole. Spread mushroom soup over beef. Sprinkle onion soup mix over mushroom soup. Add canned mushrooms and wine and stir mixture. Place cover on casserole and cook in 300 degree oven for 3 hours without peeking. May be served over rice or noodles. This recipe is easy to freeze.

## Obituaries

### John Held Jr. buried August 28



John Held Jr., long-time Ozona restaurateur, died Aug. 27, 1998, at the Crockett County Care Center. Services were held Friday at 5 p.m. in First Baptist Church with the Rev. Bill Fuller officiating. Masonic burial was at Cedar Hill Cemetery next to his wife of 60 years.

John Held was born June 24, 1901, in Greenville, second child and eldest son of Dr. John A. Held and Annie Hardie Held. Dr. Held was a distinguished Baptist minister in central Texas and Natchez, MS, for more than 50 years. As Dr. Held filled pastorates in successive cities, John lived in McKinney, Tyler, Natchez, Taylor, San Marcos, Stamford (where he graduated from high school), Bryan (where he attended Texas A&M University), and Mexia.

In 1918, while the family lived in Bryan, John left home and worked his way to California. There he joined the U. S. Army and served for three years, primarily in the Philippine Islands.

During this time, he learned something of the restaurant business and, in the Quartermaster Corps, about the logistics of food management. Back in Texas, he worked briefly in Houston, Shiner and Lubbock, then in the mid-1920s turned to the operation of restaurants, a business he continued almost without interruption for more than 60 years.

He owned or managed restaurants in Mexia, Ennis (where he married Berta Mae Howard in 1931), Navasota, Temple, Longview, Vinita, OK, Odessa and briefly, Victoria, before moving to Ozona in 1958 to take over the Hiway Cafe.

He operated the Hiway from 1958 until 1978, longer than any other restaurant among the 11 he operated. Even after closing the Hiway, he was engaged to consult on and virtually manage the Circle Bar restaurant and later to play the same roles in the Inn of the West Restaurant, working a full day well into his late eighties.

John Held and the Hiway Cafe became a joint legend in Ozona. Many years before most of the local restaurants began operation, the Hiway served as the town social center, beginning at 5 a.m. each morning - an hour before the restaurant officially opened. Ranchers and hunters sat around large tables drinking coffee, eating doughnuts, matching notes and regaling one another with the latest jokes and unlikely tales. John's hot rolls, pies, and chicken fried steaks were not only local favorites but were highly regarded by bus passengers and others passing through town.

Scores of Ozonans worked for John Held and still attest to his openness, firmness and fairness as an employer. It was quipped that everybody in Ozona either worked at the Hiway or ate there or both. John's welcoming smile, and for some years the smile of his wife, Berta Mae, was as familiar to Ozonans as the county courthouse.

Maintaining an optimistic, cheer-

ful outlook was second nature to John, who genuinely liked people and avoided arguments and holding grudges, calling them damaging to the spirit, mind and body. His enjoyment of people was shown in his enthusiastic presentation of Dale Carnegie courses in the 1960s. He claimed to be only a "pretty good country restaurant operator".

John's generosity with money, time and especially food was characteristic. No broke and hungry person was ever refused food at his restaurants - a compassionate echo of his own youthful penniless time of working his way to California. Many needy families received Thanksgiving and Christmas meals from the Hiway Cafe, as did persons and families who had suffered bereavement and persons confined to homes by severe illnesses. John considered that sharing food was the most rewarding aspect of having a food business.

Hundreds of Ozonans expressed personal concern when in January, 1971, John was critically injured when he fell from the roof of the Hiway Cafe building and landed on the concrete steps below. San Angelo doctors gave little hope for his survival, but after a few weeks he was back in the restaurant, in some pain but smiling again.

In the mid-1980s because the Helds' only son, John Charles, a distinguished Houston lawyer, was suffering a steadily advancing case of leukemia, John and Berta Mae reluctantly moved from Ozona twice, in 1985 and 1987, to be near him. Tragically, Berta Mae died in October, 1991, and John Charles less than three weeks later. As soon as he recovered from the shock, John returned to his beloved hometown of Ozona in early 1992. Incredibly, for the third time he recovered his original home and post office box number. Only in early 1998, after two bouts of hospitalization in San Angelo, at age 96, did John finally consent to give up living alone and to move to the Crockett County Care Center - so long as he could take his little dog, Missy, with him. Although he had earlier expressed high regard for the center, he still resisted moving to "an old folks home".

In fact, John enjoyed his months at the care center, where several of the staff were former employees of local restaurants he had managed. He and Missy contributed to the good spirits of the center.

John took his civic responsibilities very seriously. He helped organize the Ozona Chamber of Commerce and served as its president. He was active in regional restaurant association affairs and was president of the Texas Restaurant Association. He was a 32nd degree Mason for 71 years and was a Shriner for 56 years, in both of which he took great pride. He received a presidential citation for his five years with the regional selective service board. He was a lifelong Baptist and a strong supporter of the Ozona First Baptist Church.

John Held was preceded in death by his wife, Berta Mae, and his son, John Charles, as well as three sisters: Emilie Byars of Peoria, IL; Elizabeth Davis, Waco; and Ann Adine (Deanie) Johnson, Waco. He is survived by two brothers, Dr. McDonald Held, Billings, MT; and Dr. Colbert Held, Waco; one sister, Mrs. Helyn Davis, LaGrange; two daughters-in-law: Martha Held and Joanne Held, Houston; eight grandchildren: John Charles Held Jr., Jeffrey Held and James Held, all of Denver, CO; and Julie Held Moorhead, Houston; Slay Schlemeyer, Austin; Shane Schlemeyer, Houston; Shawn Schlemeyer, Odessa; and Shelly Rice, Houston; and several great-grandchildren, nieces and nephews.

Pallbearers were: Jeffery Held, James Held, George Schlemeyer Jr., Michael Schlemeyer, Bill Mason and Joe Tobar. Honorary pallbearers were all past employees.





## Texas monthly oil and gas statistics

### July Permits to Drill

The Railroad Commission of Texas issued a total of 769 original drilling permits in July compared to 1,180 in July 1997. Total drilling permits for 1998 year to date is 6,238 down from 8,164 recorded during the same period in 1997. The July total included 516 permits to drill new oil and gas wells, 30 to re-enter existing well bores, and 223 for re-completions.

Permits issued in July included 168 oil, 239 gas, 340 oil and gas, 11 injection and 11 other permits.

### July Oil and Gas Completions

In July operators reported 448 oil, 446 gas, 46 injection and two other completions, compared to 396 oil, 354 gas and 30 injection completions during the same month of last year.

Total well completions for 1998 year to date is 6,696 up from 5,413 recorded during the same period in 1997.

Operators reported 702 holes plugged and 152 dry holes in July

compared to 630 plugged and 147 dry holes during the same period last year.

### May Crude Oil Production

Texas preliminary May 1998 crude oil production averaged 1,253,420 barrels daily, down from the 1,315,166 barrels daily average of May 1997.

The preliminary Texas crude oil production figure for May 1998 is 38,856,005 barrels, a decrease from 40,769,528 barrels reported during May 1997.

Production in Crockett County for this period was 242,674 barrels.

### May Natural Gas Production

Texas oil and gas wells produced 465,593,741 Mcf (thousand cubic feet) of gas based upon preliminary production figures for May 1998, down from the May 1997 preliminary gas production total of 468,077,584 Mcf.

Texas production in May came from 158,349 oil and 51,853 gas wells. Crockett County was ranked sixth in the state with production of 12,154,520 Mcf.

## Wildlife officials express concern over tainted corn

AUSTIN - Hunters looking for a bargain on deer corn this fall may be getting more than they bargained for, say state wildlife officials concerned about the threat to many game and nongame animals from grains tainted with a harmful biological toxin.

Aflatoxins are potent biological toxins produced by fungi of the genus *Aspergillus* and can be found on any high starch food item, like corn or other grains that are grown under drought conditions or are stored in hot and humid conditions. Animals ingesting corn containing aflatoxins are susceptible to liver damage and other diseases as the toxins suppress their immune response.

While there is no mandatory testing for aflatoxin, Federal Drug Administration rules do not allow corn tested at more than 20 ppb (parts per billion) of aflatoxin to be fed to dairy cattle, and Texas law requires corn containing more than 20 ppb to be labeled with the concentrations found in testing. Corn exceeding the allowable levels of aflatoxin for livestock is often sold as DEER CORN in untagged sacks to unsuspecting hunters.

Wildlife officials fear poor crop production this year, combined with stressful storage conditions, are ripe for aflatoxin, and could result in an abundance of tainted deer corn on the market. "Because there's not as much clean corn available this year, prices may escalate," said Jerry Cooke, program director for upland wildlife ecology with Texas Parks and Wildlife. "Land managers and hunters who implement supplemental feeding programs for wildlife, or who simply use corn as bait, will likely be looking out for good deals. When I buy corn or other grains for wildlife use, I don't buy anything that hasn't been tested and proven to contain less than 100 parts per billion aflatoxin. If it doesn't have a tag, I won't buy it, period."

"You've got to remember that just because you intend to feed it to deer, doesn't mean that only deer will be eating it," said Cooke. "There are many other species that will have access to that feed, and few of the other species are as hardy as deer." According to recent research conducted by the Southeastern Cooperative Wildlife Disease Unit (SECWDU) in Athens, GA, white-tailed deer fawns fed a diet of corn having 800 ppb of aflatoxin begin to show clinical signs of liver damage after only a few weeks of being on the diet. Eastern wild turkeys fed a diet of corn with 125 ppb of aflatoxin showed liver lesions after only three weeks. Chickens and quail are known to be more susceptible to aflatoxins than are turkeys. Samples

processed in 1996 from across the country by SECWDU showed corn labeled as deer corn routinely contained 90-98 ppb aflatoxins.

In 1996, Texas unlabeled deer corn tested as high as 450 ppb and there is good indication that aflatoxins may be more prevalent and in higher concentrations this year than in 1996. Nearly all the corn tested this year (in dry land fields primarily in East Texas) has been positive for aflatoxins.

"Another problem with aflatoxins are that they are concentrated in individual kernels, rather than being spread uniformly throughout a sack, and a bird eating one kernel might ingest an extremely high level of toxins despite a moderate test average for the whole load from which the sack

came," Cooke explained. "Levels of aflatoxins may also continue to increase in tainted corn that is stored in a hot, humid place."

Cooke cited several examples of situations where aflatoxins could flourish, such as in deer feeders, when corn is packed in plastic bags, or when sacked corn is stacked in the open as it often is for DEER CORN at many stores. "These situations can result in significantly higher concentrations of the toxin in a relatively short period of time. If I were using deer corn, I would take precautions to limit the potential for aflatoxin. I don't buy unlabeled corn, I don't use poorly constructed feeders which can allow corn to become wet, I don't pour large piles of corn onto the ground, and I store it like I intend to eat it myself," says Cooke.

## A new goal for people with high blood pressure

For decades, blood pressure higher than 140-over-90 has added up to hypertension. Now studies indicate it may pay to be more cautious and bring the second number down even lower.

"Until recently, doctors thought it was unnecessary, even harmful, to reduce blood pressure below 90," says Dr. C. Venkata Ram, clinical professor of internal medicine at UT Southwestern medical center at Dallas. "But new research suggests correcting the level to 80 or below may dramatically reduce morbidity and heart attack rates, particularly in patients with pre-existing health conditions such as diabetes and coronary heart disease."

The first number - the systolic pressure - measures blood pressure when the heart contracts. The second number - the diastolic pressure - is the reading when it relaxes. Ram says people who take medication to treat hypertension should consult with their physicians about lowering the diastolic pressure even more.

"The bad news is that many of those who once thought they were stabilized at an ideal blood pressure level now have jumped back into the hypertensive category," he says. "The good news is that with proper medical care and medication, their blood pressure can be easily and effectively corrected."

## Ten tips to get back in the swing of studying

If your brain remains on vacation mode after the first school bell has rung, you may need help getting back on the academic track. Before homework and tests overwhelm you, put these study tips into practice:

- Get enough sleep! A rested mind is a sharper mind. Eight to 10 hours of sleep a night will aid both attention span and concentration.

- Schedule study/homework sessions for the same time each day. A consistent schedule makes it easier to establish study time as a daily habit.

- Choose a quiet, comfortable place for study where basic supplies, such as paper, sharpened pencils, erasers, scissors, dictionary, etc., are handy. Again, consistency is helpful. Turn off the television and any loud music.

- Use a calendar or planner to keep track of daily assignments.

- Don't procrastinate! Begin working on assignments the same day they are given, even if it's just to break the assignment into steps and set deadline dates for each task.

- If you get bored, switch to another subject/task for a while.

- Take short breaks every 30 to 60 minutes (the older the student, the longer he/she can go between breaks).

- Read every day; elementary students should begin with a minimum of 15 minutes.

- Whenever appropriate, encourage children to do their homework independently.

- Eat healthy meals and snacks. Just as with adequate sleep, nutrition can influence performance.

### Layers of blankets put a chill on deep sleep

For people who turn the air conditioner on full blast then crawl under a pile of blankets to compensate for summer's hot nights, sleep expert Dr. John Herman has bad news: The practice is counterproductive.

Herman, associate professor of psychiatry at UT Southwestern Medical Center at Dallas, says the body's natural thermostat is set to drop every 24 hours, normally about bedtime. The cooler the body, the better the sleep.

"If we sleep under too many covers, it gets too hot underneath, even though the room is chilly," he says. "Our body temperature can't drop, so we can't maintain a deeper level of sleep."

Sleeping under a pile of blankets can be especially aggravating for people whose sleep is interrupted by involuntary leg movements. If the body temperature doesn't drop, the movements can increase.

## Internet prompts revolution in education: new opportunities abound to fill need for students

A young female cable installer with two small children wants to get a college degree but cannot leave her children alone in the evenings to attend classes. A middle-aged construction worker wants to take college courses but there is no campus nearby. A female executive needs to get her master's degree in order to get promoted, but is too overworked to attend a three-hour evening class two times a week. Are their educational goals out of reach?

Not at all, according to D. Quinn Mills, Harvard University professor and chairman of New Promise, a Web site (www.newpromise.com) that helps people find the college courses they need on the Internet.

Cost, convenience and accessibility are driving a cyberspace revolution in education. Thousands of college courses are now being offered on the Internet, allowing people to attend class at home or while taking a break at work, at a very affordable cost.

Today, you can find more courses under more topics on the Internet than on any one campus anywhere, states Professor Mills. And new methods of Internet teaching are improving at a rapid pace, including perfect audio, real-time and 3-D images.

Soon course texts will include

frequent updates from the author of the text, as well as the professor who is teaching the course, and you'll be able to key in questions that come to mind as you're reading the assignment. New software will immediately answer your questions as well as search the entire course reading assignments in search of possible themes.

Students across the nation are embracing education via the Internet. Eighty-five percent of the students taking classes on the UCLA Extension Internet say their learning experience is as good as or better than that of the on-campus classroom. Many prefer the e-mail chat groups with fellow students that help them explore assignments together, as well as the ability to view a lecture or a visual demonstration again and again. Many students also find it less intimidating to ask questions through e-mail than in a traditional classroom setting.

Online courses are also a great alternative for physically challenged students, traditional students who have a conflict in their class schedules, and individuals who simply can't afford the usual tuition fees.

But, how do individuals who want to pursue their education locate and sort through the thousands of college courses being offered on the World

Wide Web? This dilemma prompted the creation of the New Promise Web site, which helps people carefully select the appropriate college courses by describing and rating them, then listing them by title, topic (math, economics, etc.), college or university, and degree program.

"We've positioned New Promise at the forefront of the coming revolution in cyberspace," notes Mills. "It's the portal to higher education on the Internet." He adds that New Promise lists only fully accredited schools and is the only comprehensive source of its kind. Currently New Promise lists over 600 courses, including ones from Harvard, UCLA, and Michigan State University.

Certainly, online education is only expected to increase, as the quality of Internet education skyrockets and the cost of computers and Internet Service Providers (ISPs) continues to decline. Today there are more than 100 million users accessing the Internet; in the next seven to 10 years, experts predict the numbers will top one billion.






