


which is for newspapers with a circulation of 1,800 or less.







Ozona Family Health Center celebrates fifth anniversary

To the eyes of the residents of Crockett County, the relocation and operation of Shannon Health System's clinic for Dr. Marcus Sims on July 1, 1996, only meant moving to a different building. For the employees, old and new alike, it meant an entirely different job. Everything had changed, from the patient rooms and equipment, to the order of the patient's chart. It was soon discovered that the only things that hadn't changed for Dr. Sims and his employees were the support and trust from their patients; hence the Family Health Center of Ozona evolved into one of the finest medical clinics and urgent care facilities off Interstate 10. Now, five years later, Dr. Sims and his staff still strive to maintain the highest quality of care possible.

The month of July marked the fifth anniversary for the employees of Family Health Center. "The employees would like to express our appreciation to the Crockett County Commissioners, Judge Johnny Jones and Crockett County Medical Board for the decision to maintain the contract with Shannon Health Systems," said a spokesperson for the staff. "We at the FHC enjoy the close relationships we maintain with our patients and their families." The clinic is under the medical direction of Dr. Marcus Sims with Susan Bilano, LVN as clinic manager.

The clinic has experienced very few changes in staffing over the years, making it possible for many of the nurses and staff to broaden their skills by becoming certified in Advanced Cardiac Life Support (ACLS), Pediatric Advanced Life Support (PALS), Trauma Nurse Core Course (TNCC) and Certified Professional Coders (CPC). The Family Health Center currently has 19 full and part-time employees and is open for clinic hours from 8:00 a.m. to 5:00 p.m. Monday through Friday, with urgent care available 24 hours a day, seven days a week. The clinic sees in excess of 600 patients per month and continues to maintain a busy urgent care facility, frequently due to the interstate traffic.




"My gosh, will ya look a yonder,"

WEST TEXAS AUTHOR

Dearen makes his home in Midland with his wife, Mary, (lifestyle editor of the Midland Reporter-Telegram) and their 11-year-old son, Wesley.

A finalist for the Spur Award of the Western Writers of American in 1995, Dearen is the author of 13 books. His newest venture is a threebook series of historical novels geared toward nine-to-13-year-olds. The "Lone Star Heroes" series consists of Comanche Peace Pipe, On the Pecos Trail and The Hidden Treasure of the Chisos. Dearen's aim is to interest readers of all ages in Texas history and legends through fascinating fiction stories. The series tells the stories of wagon trains and Comanche Indians. cowboys and cattle drives, and lost treasure hunts.

Through his six nonfiction books, Dearen has come to be recognized as an authority on the Pecos River country and cowboy life. 

Laughlin has served in various capacities in every segment of the wool and mohair business, but it is his work with young people and 4-H and FFA that has brought him the most recognition and joy. He opens his warehouse year after year to youngsters, patiently explaining the importance of the wool and mohair industry in their day to day lives. 



Sales tax holiday Aug. 3-5

Just in time for back-to-school for the tax exemption. shopping, many clothes and shoes can be purchased tax-free Aug. 3-5, during Texas' third annual Sales Tax Holiday, Texas Comptroller Carole Keeton Rylander announced.

"On the first Friday, Saturday and Sunday of August, no state or local sales tax will be charged on most clothing and footwear priced under \$100.00," Rylander said. "The Sales Tax Holiday provides much-needed tax relief for hard-working Texas families and lets them stretch their budgets a little farther as they shop for school clothes for the kids and work clothes for mom and dad."

This year, the Sales Tax Holiday is expected to save Texans \$31.2 million in state sales tax and \$8.4 million in local sales taxes. Cities have the option to not waive local sales tax during the tax holiday, but no community has opted out of the event this year.

The rules for the 2001 Sales Tax Holiday are the same as in previous years. They include:

*Most children's and adults' clothing and footwear priced under \$100.00 are exempt from sales taxes. Customers may purchase as many taxexempt items as they wish.

*Clothing and footwear used primarily for athletics or protective wear, such as golf cleats or football pads are shoes, baseball caps, jogging suits and other athletic clothes that are com-

"Earlier this year, I asked the Legislature to extend the list of tax-exempt items to include backpacks, school supplies, sewing supplies and safety gear such as bicycle helmets and car safety seats," Comptroller Rylander said. "I also proposed expanding the tax holiday to five days to avoid the three-day traffic jam.

"However, the Legislature did not make the Sales Tax Holiday a priority, and the proposal died. Next session, I will again urge the Legislature to make Texas families and the Sales Tax Holiday expansion a top priority," Comptroller Rylander said.

During the first two Sales Tax Holidays in 1999 and 2000, Texans saved an estimated \$69.6 million, including \$54.8 million in state sales tax and \$14.8 million in local sales taxes.



The four-year clinical trial of 250 children is approaching the midway mark. Half of the children have been given age appropriate books to take home after well-check visits, as well as one-on-one counseling with parents on the importance of reading. The other half has not received any intervention.



"We're hoping that by developing an early love for reading, the child will be better prepared for school and have a decreased rate of school failure," she said.

Another goal is to design a program that pediatricians can easily adopt in their offices. The pediatrician's individual role would only be a couple of minutes, Rice said, but a program in which a volunteer reads to children in the waiting room could complement that effort.

Rice modeled her study after the National Reach Out and Read Program, which uses health care providers to encourage parents to read to their children. The Houston READ Commission provides administrative support for Rice's study.

"The word is out that reading is important, but I still see parents just struggling to get through the day with their families and everything they have going on. Devoting 15 minutes a day to read to a 9-month old is not something they think about, but it offers a great opportunity for bonding," she said.

USDA's Children's Nutrition Research Center at Baylor College of Medicine in Houston. This limits skill development, which can increase frustration and lead to discouragement.

Parents can teach their children how to pace themselves. "Encourage your children to talk to you when you walk or bike together. If they can't keep up a conversation, slow down. If they can sing, they're not working hard enough, so pick up the pace,' Fiorotto said. Over time, children will be able to play longer before tiring.

Fiorotto recommends that children engage in some form of vigorous activity at least 20 minutes three to five times per week. Swimming, rollerblading, biking and dancing can help build fitness levels.

"Fitness benefits children both physically and mentally. And, because active kids tend to stay active as, adults, those benefits can last a lifetime," Fiorotto said.




