CX Debate Team is heading to state

The CX Debate Team of Barbara Caperton and Iris Vergara are heading to the state meet.

The duo placed second at the district team in Kermit qualifying them for the UIL State Cross-Examination Debate Meet to be held March 16-21 at the University of Texas at Austin.

"We have been working on our case since September. The team has made it to the finals round at three invitational meets as well as the district tournament this year," said Coach Dottie DeLeon.

In CX Debate, the affirmative has two eight minute arguments in the Constructive part, followed each time by a three minute cross-examination of the negative.

In the rebuttal, the negative and the affirmative each go twice, for five minutes each time.

Each member of a team shall deliver a constructive speech and a rebuttal speech.

"UIL debate competition develops skills in our students that directly prepares them for real world situations by challenging their problem-solving and critical thinking abilities," said Jana Riggins, UIL

Debate Director. "This year's crossexamination debate topic required students to research extensively the issue of alternative energy."

Through participation at the UIL Academic State Meet, students qualify for Texas Interscholastic League Foundation scholarships.

Since its inception in 1954, the TILF has provided more than \$22 million to more than 16,000 students.

The TILF ahs more than \$8 million in endowed funds and receives direct scholarship grants, each year of more than \$800,000 from foundations, individuals and corporate sponsors throughout the state.

During a typical academic year, the TILF will distribute more than \$1 million to more than 600 students attending colleges and universities throughout Texas.

No matter how old you are, you will find it, and once you do you will get that gushing, overwhelming feeling of God's joyous purpose for vour life.


Each one of us is different, which means God has a different purpose for us all. This also means everyone's path is different.

AUSTIN - Texas House Speaker Joe Straus on Feb. 12 exercised one of his most important duties in naming standing House committees.

Straus, R-San Antonio, assigned leadership roles and responsibilities in an egalitarian fashion, reflecting a near balance of 76 Republican seats to the Democrats' 74.

Straus said 15 of his 34 new chairs have not chaired standing committees in prior sessions, and of the 34, 18 are Republicans and 16 are Democrats.

Here are just a few committees and chairs: Appropriations, Jim Pitts, R-Waxahachie; Ways & Means, Rene Oliveira, D-McAllen: State Affairs, Burt Solomons, R-Carrollton; Calendars, Brian McCall, R-Plano; Human Services, Patrick Rose, D-Dripping Springs; Criminal Jurisprudence, Pete Gallego, D-Alpine; and Public Education, Rob Eissler, R-The Woodlands.

State Rep. Harvey Hilderbran, R-Kerrville, lost his post as chair of the Culture, Recreation and Tourism Committee.

Hilderbran was simply named as a member of the Redistricting, State Affairs and Ways & Means committees.

As for the state Senate, Lt. Gov. David Dewhurst stuck with his chairs from the 2007 session, with the exception of the Administration Committee. Kim Brimer, R-Fort Worth, former chair of the committee, lost his re-election bid last fall, so Dewhurst named Sen. Tommy Williams, R-The Woodlands, as the committee's new chair.

Senator Carlos Uresti, D-San Antonio, was named to the Administration; Natural Resources; Agriculture and Rural Affairs; and Health and Human Services Committee.

STIMULUS MONEY WILL

FLOW TO TEXAS On Feb. 13, Congress passed the conference report of House Resolution 1, the American Recovery and Reinvestment Act of 2009, without a "yea" vote from any Republican member of the Texas congressional delegation.

H.R. 1, President Barack Obama's \$787 billion economic stimulus package, got a thumbsdown earlier this month from Gov. Rick Perry, who said he would be against the package unless it offered

more tax cuts and less spending.

But the president got all the support he needed in a 60-38 filibusterproof vote in the Senate and 246-183 vote in the House that included "yeas" from Texas' 12 Democratic reps.

Texas' share of the stimulus spending has been estimated at \$16 billion, but the money must be used as directed. Details on that will come.

As finally passed, H.R. 1 is about two-thirds stimulus spending and one-third tax cuts.

WATER MUST PLAY **INCREASING ROLE**

Texas Comptroller Susan Combs'

new report, "Liquid Assets: The State of Texas' Water Resources" studies Texas' current and future water resources, the issues facing water planners and funding methods that could be used to develop water resources.

Combs said, "By 2060, more than 46 million people could be living in Texas, and demand for water will increase by an estimated 27 percent.

"According to the Texas Water Development Board, failing to meet this demand could cost businesses and workers in the state approximately \$9.1 billion per year by 2010 and \$98.4 billion per year by 2060."

AG LAUNCHES RESTITUTION PROGRAM

Attorney General Greg Abbott on Feb. 11 made public a restitution program he said is for eligible Countrywide Financial Corp. residential mortgage customers who lost their homes to foreclosure.

In 2008, Abbott initiated an investigation into allegations that Countrywide encouraged homeowners to accept loans they could not afford, failed to fully disclose risky loan terms to borrowers and wrote loans for unqualified borrowers in an effort to increase market share.

AG HALTS

2 RETIREMENT SCHEMES On Feb. 13, Attorney General Abbott charged the owners of two investment plans with orchestrating a fraudulent scheme that targeted retirees and teachers.

Howard G. Judah Jr. of Houston and Gregory F. Jablonski of Castle Rock, Colo., falsely guaranteed lucrative investment returns, misrepresented their "life settlement" policy investment offerings, failed to disclose material information to investors and committed multiple violations of the Texas Securities Act.

Travis County District Judge Suzanne Covington granted the attorney general's request for receivership and issued an order seizing more than \$19 million held in several bank accounts under the defendants' control.

Abbott's office said the enforcement action charges the defendants with failing to make required disclosures, selling unregistered securities and other violations of the Texas Securities Act.







WHAT IS ONE DUTY THAT YOU PER-FORM THAT MOST PEOPLE MAY NOT **REALIZE FALLS UNDER YOUR POSITION?**

The commissioner's court is the governing body for Crockett County. Although the other government entities and their board members in the county, such as the Crockett County Consolidated Common School District and its board members agree on a tax rate or agree to have a bond election, the commissioner's court has the final decision on setting the tax rate for the school and allowing a bond election to take place.

WHAT ARE SOME DUTIES THAT YOU OFTEN GET QUESTIONS ABOUT THAT DO NOT FALL UNDER YOUR POSITION?

I always get calls from people complaining about others speeding down our neighborhood street. This is a law enforcement issue. I have even received calls from people wanting me to waive a citation. This is a Justice of the Peace issue.

IF YOU COULD CHANGE ANYTHING ABOUT YOUR POSITION,

WHAT WOULD IT BE?

Allow more opportunity for citizens to attend our open public meetings. Possibly going back to when I first started as commissioner where we were meeting twice a month during the day and in the evening when people are off and have a chance to attend. Also, right now a request from a commissioner to our county road department could take several weeks, in some cases months, before it is completed. Most requests come from citizens that do not understand how our unified road system works and we often get accused of commissioners doing nothing about their request. I would like to have our unified road system arranged to where the commissioners had a small crew that each could direct to attend to work requests in a timely manner while maintaining the same budget in that department.

WHAT DO YOU WANT THE PEOPLE OF **CROCKETT COUNTY TO KNOW ABOUT** YOUR POSITION?

My position as commissioner is to be the voice of the people in my precinct in our county government. However, I hope everyone understands that I will listen to how you view different issues. Your views are very important to me, but as I represent you my actions must be on how it affects the entire county. I am well aware that if my actions are not satisfactory to the people, I represent I can easily be replaced. My actions are not made because I am scared of not getting reelected. My actions are what I feel are the right thing to do. ANY ADDITIONAL INFORMATION YOU WOULD LIKE TO ADD: I am grateful for the opportunity that I have been given in representing the people in my precinct. I really appreciate everyone's support.

WHAT IS ONE DUTY IN YOUR JOB THAT YOU ENJOY THE LEAST?

The duty or responsibility I enjoy the least is meeting and paying for unfunded mandates handed down from and counties throughout Texas.

WHAT IS ONE DUTY THAT YOU PERFORM THAT MOST PEOPLE MAY NOT **REALIZE FALLS UNDER YOUR POSITION?**

The Crockett County Commissioner's Court creates the budget for the county, which includes all depart- the commissioner's court can "acments, boards and elected officials quire property for rights-of-way or of the county. The court works with each different branch and their needs. We balance these needs with the tax dollars available for that next year. We combine these separate budgets to create the total county budget for the next calendar year.

WHAT ARE SOME DUTIES THAT YOU OFTEN GET QUESTIONS ABOUT THAT

DO NOT FALL UNDER YOUR POSITION?

Many people ask about water problems and trash collections. These services are not controlled by the Crockett County Commissioners. They are managed by a separate board, which is the Crockett County Water Control and Improvement District #1.

IF YOU COULD CHANGE ANYTHING **ABOUT YOUR POSITION.**

WHAT WOULD IT BE? The position of county commis-

ioners is provided by law in the Texas Constitution (Article 5, sec. 15). This process has been working for many years in all 254 counties in the state. It would take an act of Texas State Legislation to modify or change it. I feel the process is working well and no changes are needed. WHAT DO YOU WANT THE PEOPLE OF

CROCKETT COUNTY TO KNOW ABOUT YOUR POSITION?

There are many times that voters ask a' commissioner to make decisions or changes in county activities. One commissioner cannot act alone and has no authority to act or speak for the county. The commissioner's court is made up for four commissioners and the county judge. County business can only be conducted when the court is in session and a quorum is present (three to five). Each meeting must be posted for 72 hours prior to the meeting. A special "called" meeting is an exception to the 72-hour rule if emergency criteria is met. PLAN: Gallego to discuss details at a meeting Thursday in Austin from page 1

The plan, which would create a new authority that would control water usage rights along the Pecos in the 17 Texas counties that make up the river's watershed, is tentatively scheduled to be discussed at 10 a.m. Thursday (Feb. 19), at a meeting in Austin. Red Bluff officials said they are not sure if Gallego will be at the meeting, or if just Carlton will be there.

But before that, Red Bluff board members voted during their Feb. 10 meeting to hire a lobbyist to oppose Gallego's efforts, and said they have received support in their efforts from landowners both along the Pecos and in affected areas from as far away as Fort Davis.

Members approved a proposal by managing director Randal Hartman to hire V.A. Stephens, a former Texas Department of Agriculture employee now running her own consulting business, to represented Red Bluff on the Pecos River Authority issue at a salary of \$4,000 a month through June.

"She is currently working for the Brewster County water district, has been on (State Sen. Frank) Madla's staff, and on the water commission on rural development for the governor," Hartman said, adding, 'I don't know if it wouldn't be better to look into retaining somebody after that, because this thing is not going to go away."

Pecos River water usage is currently controlled by the Red Bluff Water Power Control District board, which was created following the construction of Red Bluff Lake in 1936. The district sells water to the seven sub-districts in Reeves, Loving, Pecos and Ward Counties, which operate from the lake south to Girvin. From Girvin to Amistad Lake, there is currently no oversight authority. If created, the Pecos River Authority would have jurisdiction over the entire river, including Red Bluff and the sub-districts.

Gallego (D-Alpine) announced his plans to file a bill on Jan. 29, the Enterprise and other newspapers Ozona Stockman did not receive the details on what would be in the bill. A staff member in Gallego's office said on Feb. 2 that details on the Respectfully submitted, Orlando F. DeHoyos plan would be released when the bill OHS Class of '77 was ready to be filed and after the longtime area representative had had a chance to talk with people who would be affected by the plan. Last week, Carlton said he planned to

"The problem is they haven't read their own statutes," he said, explaining that the settlement money should be used for projects on the entire length of the Pecos within Texas, and not just within the area from the New Mexico state line to Givrin. He also said the district wasted funds in their lawsuits four years ago against Ward 1 and Ward 3 over their conversions from Water Improvement to Water Irrigation districts.

Hartman said as of now, Red Bluff officials and other area landowners have been kept in the dark about the plan, even though officials in Austin may have been given different information.

"The people who said they talked to us misrepresented themselves. Nobody ever spoke to us," he said. Hartman added that supporters of the plan have also listed state agencies as backers of the new Pecos River Authority based only on initial briefings on the proposal.

Hartman said he had talked with members of the sub-district boards as well as other groups like the Davis Mountain Heritage Association that are outside of Red Bluff's jurisdiction on water matters, but would fall under the guidelines of a new Pecos River Authority.

"I think everybody is going to support us. This isn't just a thing in the water district. This is also the counties," Hartman said.





"But if they're going to avoid doing what they're supposed to do for the stewardship of the river, we'll take that authority away from them and give it to people who will handle it correctly."

ORDER RESTRICTING OUTDOOR BURNING

The Commissioners' Court finds that circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning; and NOW, THEREFORE, IT IS HEREBY ORDERED by the Commissioners' Court of Crockett County, Texas, that outdoor burning is restricted in Crockett County for 30 days from the date of adoption of this Order, unless the restrictions are terminated earlier based on a determination made by the Texas Forest Service or this Court. This Order is adopted pursuant to Local Government Code 352.081, and other applicable statues. This Order does NOT prohibit outdoor burning activities related to public health and safety that are authorized by the Texas Natural Resources Commission for: (1) firefighter training; (2) public utility, natural gas pipeline or mining operations; (3) planting or harvesting or agricultural crops; or (4) burns that are conducted by an approved Prescribed Burning Association, Natural Resource Conservation Service, the and/or Texas A&M Agricultural Experiment Station, or prescribed burn manager certified under Section 153.048, Natural Resources Code, and meet the standards of Section 153.047, Natural Resources Code.

All burns shall be reported to the Crockett County Sheriff's Office (325) 392-2661 and the Fire Chief (325) 392-2626 prior to commencing, together with the name of the landowner, location involved and expert to be on hand.

This Order does NOT prohibit outdoor cooking in a properly contained area which is attended at all times.

In accordance with the Local Government Code 352.081 (h), a violation of this Order is a Class C misdemeanor, punishable by a fine not to exceed \$500. ADOPTED this the 9th day of February, 2009.


