# Gas or electric? That is the heated question

A missed line prompts school board discussion on change in utilites for new elementary

regular meeting of changing from electric to gas heating. During the meeting, architect Aida Latorre said SKG Engineering did not specify in their survey of the site that

there was a gas line available. Officials from Waldrop Construction estimated that to change the entire school from electrical heating to gas heating would be around

\$230,000. Willie Vargas, the school district's maintenance and transportation director, said he found the line after he noticed in the plans that the school's cafeteria kitchen would be using propane instead of natural gas.

"My concern is the kitchen and the big areas," Vargas

Dr. Marcus Sims, board president, said that SKG Engineering shouldn't be paid for their work and that the architects should have to "eat the cost" because the board was never asked what type of heat and air conditioning system was going to go into the new school.

"That is an oversight on your part," Sims said to the architects during the meeting. "It seems like gas heat is the right way to go, but \$230,000

scares me off a little bit." "There was a big gas meter right at the front (of the building). As far as I know, the cost of gas is cheaper," added Dwight Childress, board mem-

Architect Douglas Koehne said that during the last four to five years he has seen a shift in most school construction for buildings to be

"Energy costs are so close. We are designing the best economical system for you guys and the electrical system is the best system," Koehne said.

Schools built in more urban or cities areas tend to go more electric, while schools out further west still have gas, said Paul Waldrop Jr., presi-

"I think we could look at

very inexpensive. We will find that out," Waldrop said.

The board agreed to keep the two-story main building electric but for the architect and construction company to look into the costs for using gas heat in the larger areas like the gymnasium and the cafeteria. The board asked that hard numbers be brought to the next regular meeting on May 20.

The board also approved \$5,537 for override lighting switches.

pletion was July 1. With the extension it is now set for Aug. 1.

#### TEL-PRO REPRESENTATIVE SPEAKS ON **TECHNOLOGY BIDS**

Mickey Scott, a representative with Tel-Pro out of San Angelo, spoke to the board about the technology bids for the new elementary school.

During the February regular meeting, the board approved a \$370.803.79 bid from Caroll Fire & Safety and NSYNC for technology and data for the new elementary

The bid covers cabling, phone system, paging system, audio visual, clock system, sound systems in the cafetorium and gymnasium, CCTV system, burglar alarm system and a card access system.

Tel-Pro was one of the companies that bid. Scott said he was upset that during the meeting Latorre said that the bid was too low.

Scott said that his company installed the new phone system for CCCCSD and that while his bid did not cover the security systems for the school, it was a better bid than the one the board approved.

"I felt like I needed to come back and defend my company," he said. "She (Latorre) stood up and said we didn't know what we were doing. We could be more expensive. I certainly respect your decision. It's your school, your money and you can spend it like you

Latorre said part of the issue was that Tel-Pro's proposal was one page and did not have a thorough explanation like the other bids.

"That with the low bid made us suspicious," she

**County Auditor** 

The county auditor maintains the integrity of financial administration of county government.

The county auditor's primary duty is to over see fi-

nancial record-keeping for the county and to assure that all expenditures comply with the county budget. The county auditor, by law, has continuous access to all books and financial records and conducts detailed reviews of all county financial operations.

The office of county auditor is neither created by nor under the hierarchical control of the administrative body - the commissioner's court. While commissioners court is the budgeting body in county government, both the county auditor and commissioner's court are required, by law, to approve or reject claims for disbursement of county funds. The integrity of county financial administration is entrusted to a dual control system of "checks and balances.'

The county auditor has general oversight of all the books and records of all county officials and is charged with strictly enforcing laws governing county finances.

As we celebrate Earth Day today (April 22), the idea of going green is easier than you may think.

I'm not saying you have to go out find solar panels for your house and buy a hybrid car, but there are some simple, inexpensive things that all of us can do to start living green.

· Using old towels and T-shirts instead of disposable wipes and paper towels will cut down on waste and save you money. Plus, cloth is softer, so it's better for cleaning delicate items.

## House passes \$178 billion budget for fiscal years 2010-2011

**AUSTIN - The Texas House of** Representatives spent Friday and Saturday, April 17-18, amending and finally passing SB 1, the upper chamber's proposal for the 2010-2011 state budget.

The House version of SB 1 totals \$178 billion while the Senate version totals \$182.2 billion. The House version represents a 2.5 precent annual increase for the two years, a rate below projected rates of inflation and population

growth for Texas. Now, SB 1 goes back to the Senate, where the body either can accept or reject changes made by the House. If any of the House version's more than 400 amendments rubs senators the wrong way, the bill will go to a conference committee of senators and House members.

Differences must be reconciled before the bill can be forwarded to the governor.

The tax-writing House Committee on Ways and Means is working on legislation to fund the appropriations.

**COMMITTEE EYES SMOKING BAN** Two dozen other states have outlawed smoking in public

venues. Texas would join them if SB 544, considered April 14 by the Senate Health and Human Services Committee, passes.

The bill, by Sen. Rodney Ellis, D-Houston, would extend the ban to all cities in the state.

Already, 28 cities in Texas have ordinances against smoking in public places.

In laying out his bill for consideration, Ellis said there is no safe level of exposure to second-hand smoke, and second-hand smoke presents a public health risk.

"Our state and our state's employers need to embrace policies and programs that will truly clear the air, improve health for every Texan, and make a positive contribution to managing rising health care costs in Texas," he said.

> **TOBACCO PURCHASE AGE MAY RISE**

The Texas Senate on April 15 approved a bill by Sen. Carlos Uresti, D- San Antonio, raising the minimum legal age to purchase cigarettes and other tobacco products from 18 to 19 years of age.

Senate bill analysts say Uresti's SB 1049 may cost the state about \$12 million in tax revenue from tobacco sales. But Sen. Jane Nelson, R-Lewisville, pointed out, "You are going to save the state multiple times this amount of money in tobacco related illnesses that we would see on down the line.'

**STATE GRANTS** TO STEM TOBACCO USE

Grants available from the Texas comptroller's office are intended to help keep tobacco away from underage users.

Grants ranging from \$1,000 to \$150,000 can be used for tobacco education, keeping schools and school events tobacco free and sting operations to catch retailers selling tobacco products to minors. Texas teen-agers illegally buy

or smoke more than 67 million packs of cigarettes each year, and combating the threat to children's health is critical, Texas Comptroller Susan Combs said.

The deadline to apply for 2009-10 grants is May 4 for schools

with on-campus law enforcement and May 11 for police departments, sheriffs, constables and district attorneys.

> SENATE PASSES **MESOTHELIOMA BILL**

Following a four-hour floor debate, the Senate on April 16 tentatively approved CSSB 1123 by Sen. Robert Duncan, R-Lubbock.

The bill would expedite the process of lawsuits filed by patients with mesothelioma, a type of lung cancer related to exposure to asbestos.



Melvin Conner recently received the Scoutmaster Award of Merit.


He was nominated by members of Ozona Troop 153 and a committee.

## Hilderbran bill proposes lock in tuition rates at public universities

AUSTIN - The Texas House Committee on Higher Education Wednesday considered a bill by Rep. Harvey Hilderbran, R-Kerrville, that would freeze undergraduate tuition for public universities at its 2008-09 rate and would ensure that the voters, through their elected officials, have a say in future tuition increase proposals.

"In 2003, the Texas Legislature made the mistake of deregulating tuition. We gave the power to each university's board of regents, and we didn't set a cap on how much schools could charge,' Hilderbran said. "Between the fall of 2003 and fall of 2007, the statewide average tuition for a student taking a 15-hour course load increased 53 percent. HB 3837 proposes to repeal what we did then."

For example, the Texas Higher Education Coordinating Board reported that, from 2003 to 2007, the total academic charges for a student taking a 15-hour course load at The University of Texas at Austin have increased from \$2,721 to \$4,065. The UT System Board of Regents has also proposed a 4.5 percent increase in tuition for next year.

Hilderbran added that the Legislature would have to ensure that schools received enough funding from the state to remain world-class institutions.

The bill was left pending in committee.

Webb said he hasn't been satisfied with phone system that Tel-Pro installed for the district, and that a year later he still doesn't have all the pieces for his phone.

Scott attended the February meeting. He never addressed the board when the bids were being discussed and after the bids were approved, he stormed out of the board room not saying a word.

"If he was upset he should have explained it that night. He didn't say one word. When we awarded the bid, he got up and left," said Laurie Hale, board vice president.

Superintendent Abe Gott said a meeting was held with all companies who bid on the technology and that since Tel-Pro did not bid for the entire amount of work a true comparison cannot be made. Caroll Fire & Safety and NSYNC put their bids in together as a package.

Gott also said that he contacted the district's attorney, Sarah Leon, and that she stated since the district went through the legal, public bidding process, if the board retracts the bid they approved they could open up the district to a lawsuit.

"I think we need to go over her head (Leon) and get the full information. I want to know in business law if that will hold up," Childress said.

"You can't reject once you award. You can, but you will put the district in a legal liability mode," Gott added.

#### SALARY INCREASE **APPROVED**

The board approved a three percent raise in salaries for teachers and staff, along with covering the \$160per month cost to the employees on their insurance.

The board also approved \$161,028 in stipends, which included a request for an \$800 stipend for the flag sponsor. Money for the stipend is already in the OHS Band Budget, Gott said.

#### **CONTRACT WITH** JOHN KING APPROVED

The board approved a contract with John King to perform a superintendent search for the district and to be interim superintendent.

Cost for King to conduct the superintendent search would be around \$3,000 plus expenses, along with a \$475 per day plus expenses for a consultation fee.

King was interim superintendent before Gott was hired in February 2006. Gott will be leaving Ozona in June to become superintendent of Black-

According to the district's application brochure, applications are due May 8; interviews will be held May 11-June 9; a finalist is expected to be announced around June 9 with hiring around June 30 and date to assume office July 6.

The next regular board meeting will be held at 6:30 p.m. May 20 at the Administration Building.





The White House on April 14 announced the relaxing of restrictions on travel to Cuba and on sending money to the Caribbean island nation that has been under communist rule since 1959.

ture Commissioner Todd Staples wrote a letter to President Obama asking for two more changes:

1. The easing of travel restrictions for Cubans seeking trade opportunities with the U.S. and those traveling for educational purposes; and 2. The authorization of a Texas-based air service that will

offer direct flights to Cuba. "While I disagree with Cuba's political philosophy, Staples said, "I believe by expanding trade, Cubans can see the success of democracy and embrace a free market society, and at the same time, Texans will benefit through job growth."


