Lions beat Broncos 31-28

LION STADIUM - With eight seconds left in the game, a victory over the Sonora Broncos came down to Senior Ozona Lion Nathan De Hoyos and his foot.

From 37-yards, De Hoyos delivered a perfect field goal kick to seal Ozona's 31-28 win and give the state-ranked No. 8 Broncos their first loss of the season.


"I was big-time nervous, but I knew we could do it," De Hoyos said in the San Angelo Standard-Times article. "As soon as I could see it going, I knew it was going to go in."


Ozona is now 3-0 in district and stands alone at the top of the District 13-2A Division II standings. The Lions are now 6-2 overall.

With the upset, the Broncos fell to 2-1 in district play, 7-1 overall and out of the state rankings.

"Our kids played with great intensity and passion. They prepared and executed the game plan very well," said Coach Ray Brown. "I was

Early voting ends Friday, **Election Day** Tuesday

Early voting for the Nov. 2 General Election ends Friday, Oct. 29, at the Crockett County Courthouse Annex.

Early voting hours will be 8 a.m.-5 p.m. Monday-Friday at the courthouse annex. Voters can cast their ballots during the noon hour.

On Tuesday, Nov. 2, polls will be open from 7 a.m.-7 p.m. Polling locations are: Precinct 1 - Crockett County Courthouse; Precinct 2 - Crockett County Senior Center; Precinct 3 - Crockett County Civic Center and Precinct 4 -Ozona Chamber of Commerce Visitor Center.

Voters can bring their light blue voter registration cards.

If a voter does not have their voter registration card, they can still vote by using their drivers' license or peridentification card issued by the Texas Department of Public Safety; a form of identification containing the voters' photograph; a birth certifi-cate; U.S. citizenship papers; U.S. passport; official mail address to

OHS Freshman Saul Vargas is making his first trip to the Region I Cross Country Meet.


Vargas placed eighth Monday at the District 7-2A meet in Wall. The top 10 finishers and the top 3 teams advance to the region meet.

Employers: take a positive approach with employees

Seat seekers stage final blitzes before Election Day

STATE CAPITAL HIGHLIGHTS By Ed Sterling | Texas Press Association

AUSTIN — Political candidates, now in their final week of campaigning before the Nov. 2 election, are hailing Texas voters with the traditional march of television and radio spots augmented by newspaper ads, direct mail and those increasingly popular socialnetworking messages.

For those who haven't voted and want information on candidates, places to go are the League of Women Voters of Texas, www.lwvtexas.org, and the Texas Secretary of State's Office, www.sos.state.tx.us.

Those whom voters choose to put in the state House, Senate, governor's office and comptroller's office will have their hands full. Estimates of the projected state budget deficit have ranged from as low as \$8 billion to as high as \$25 billion.

And the always-challenging task of redistricting will be waiting at the Capitol steps when the 82nd Texas Legislature convenes in regular session on Jan. 11, 2011.

COURTS GET TICKET INFO DIGITALLY The Texas Department of

Public Safety on Oct. 14 announced it is now making available its traffic citation information to Texas courts

and precincts electronically and on paper. Before, courts received ticket information from Texas Highway Patrol citations either by mail or via hand delivery by the

troopers who wrote the tickets.

Nearly 24,000 Texas employers could lose their tax-exempt status because they have not filed required returns in the last three years with the Internal Revenue Service, the Texas Workforce Commission said.

Oct. 15 was the deadline for small nonprofit organizations with 501(c)(3) status to comply with the law under a one-time relief program the IRS announced in July. Non-filers could be liable for filing and paying Unemployment Insurance taxes for the first time if they failed to meet the deadline.

Among organizations that could lose their tax-exempt status if they failed to file are local sports associations and community support groups, volunteer fire and ambulance associations and their auxiliaries, social clubs, educational societies, veterans groups, church-affiliated groups, groups designed to assist those

with special needs and others, the Texas Workforce Commission said.

> PRE-REPUBLIC HISTORY IS SUBJECT

The Texas General Land Office will host a history symposium on Nov. 6 at the Stephen F. Austin State Office Building in Austin, titled "Discovering Spanish and Mexican Texas."

The focus will be on the settlement of Texas before 1836.

"It's important to remember the first illegal immigrants in Texas didn't come across the Rio Grande - they crossed the Sabine River into Spanish and Mexican Texas," said Land

Commissioner Jerry Patterson, in inviting students of Texas history.

Symposium registration fees will help fund the preservation of more than 35 million historic maps and documents archived at the General Land Office.



Laura's proficiency in speaking Quechua, the language of the majority of those who came to the clinic, as well as Spanish, was a special blessing. Laura never lost her energy or enthusiasm. Daily she served both children and adults suffering from many debilitating diseases, malnutrition, respiratory infections, typhoid and TB and gastro-intestinal problems. The sick, as many as 100 who came to the clinic daily, knew that they could receive the kind of care that Jesus, the Healer, extended to the poorest of the poor during His days on earth. Laura served in the Center Health Unit at Maryknoll from 1977 - 1979, before returning to her beloved Bolivia, where she continued serving in Santa Ana parish dispensary.

In 1998, Sister Laura returned to Maryknoll Center for renewal and to celebrate her Golden Jubilee. She was assigned to the Rogers Community at the Maryknoll Center. The Coordinators defined her as "a truly genuine person with gentle ways and a quiet sense of humor.'





Driver Responsibility Program changes app

The Texas Public Safety Commission adopted proposed changes to the Driver Responsibility Program rules during their meeting today. The adopted rule will be published in the Texas Register as a final rule in November, and will consist of the following reduction programs:

The Amnesty program: Will apply to individuals who have been in default, and the Department will determine the time in default for each amnesty period

Will reduce amount to 10 percent of total surcharges owed, not to exceed \$250

Will rescind suspension for those who receive amnesty while payments are being made

The Indigency program: Will apply to individuals at or below 125 percent of poverty continued compliance

level, using a sworn affidavit Will reduce amount to




