From elementary to high school, Ozona students learn to hit their notes


Sounds of all kinds come from the room. Students sitting in a circle or at tables play from a variety instru-ments as Ozona Elementary Music Teacher Justina Saunders keeps time.

After a minute at each station, the students rotate to a different instrument. Pianos, drums, Native American flutes, xylophones and a bucket turned upside down with a mallet all make sounds as their young performers learn about rhythm.

Blocks away, Ozona Middle School and High School students take these basic elementary skills, along with more musical knowledge, and perform notes on a page to produce sounds of the Christmas season.

Music education flows through all three school buildings in Ozona and touches every student that attends.

# Sheriff's officials issue energy scam warning

Crockett County Sheriff's Officials are warning local and area residents about a door-

to-door energy scam.
People claiming to be representatives from Just Energy are hitting citizens in Crockett County, as well as Sutton and Schleicher counties.

Chief Deputy Bo Semmler said the company, previously known as GeoPower and U.S. Energy, is based out of Canada and run by ex-Enron executives.

People who have signed up with Just Energy for low-cost electricity will see a savings their first two months, and then the energy prices increase after that, Semmler said. Customers who try to cancel or get out of their contracts are then charged even mor

Semmler said people who solicit door-todoor are asked to come by the sheriff's office to register.

All of the Just Energy representatives the Crockett County Sheriff's Office has questioned are convicted felons or possibly illegal aliens, Semmler said.

# Duckwall's closing Jan. 9

Ozona's Duckwall's Store will officially close its doors Jan. 9.

As part of the Duckwall-Alco company's plan, the Ozona store, along with 43 other Duckwall's stores are closing, according to a press release. Stores in nearby Eldorado and Iraan are also scheduled to close.

One Duckwall's store in Hettinger, N.D. will reopen as an ALCO store, the release stated.

The 44 Duckwall's stores have a total of 267 full-and part-time associates. The Ozona store, located at 914 11th St., has four employees, said Mary Jenkins, Ozona manager. Jenkins has been manager of the store for around five years.

"These stores account for only 3.9 percent of sales and little or no profit. Duckwall locations, averaging just 6,755 square-feet, consume a disproportionate share of resources in distribution, back-office support, inventory investment and other costs. Plus, the necessary technology upgrades to bring these stores into the corporate IT infrastructure would be cost-prohibitive. These factors led us to conclude that the best course of action is to close

the Duckwall stores. We expect that redeploying the resources used in the Duckwall stores to our more productive ALCO stores will improve the Company's earnings," said Rich Wilson, President and Chief Executive Officer of Duckwall-ALCO.

Money will be redeployed into the company's ALCO stores. Currently, 214 ALCO stores are located in 23 states, including one in Sonora.

The company expects to record expenses of approximately \$1.8 million during the fourth quarter for closing costs attributable to severance, lease liability, inventory liquidation and other related costs. Upon conclusion of the closing process, the company expects to redeploy approximately \$4.0 million in capital to the ALCO stores, the release stated.

"This was not an easy decision to make, and we know it will have an impact on our employees and the local communities we serve. We wish to express our thanks to the many customers who have become our friends over the years, and we also thank all of our Duckwall employees who have served our company faithfully during that time," Wilson said.

# Business owners need to be resourceful, keep an open mind

There are many traits future entrepreneurs have that distinguish them. Two of the most valuable traits are being resourceful and keeping an open mind.

Often, future business owners walk into my office with a very distinct idea of what they would like to start or accomplish, and on numerous occasions those ideas morph into something different by the time they leave. These are the instances where being resourceful and open-minded come in handy.

So why do they change their minds? Sometimes new entre-

preneurs realize their idea in its current form is not feasible because of lack of resources, time or expertise or the lack of a

they are not ready to take on the responsibility of owning their own business yet. Overall, starting the right business is more important than simply starting any business.

For example, a client may walk into my office with the idea of starting his own restaurant. The new business will be a full-service location in downtown and will provide late-night meals for weekend patrons.

The problem lies in the fact that the entrepreneur does not have the financial resources to purchase or lease a building, lacks substantial credit or collateral and has never owned a restaurant before. Under these circumstances, the odds of the potential business owner to secure financing are slim.

During our conversation, the client realizes he does not need to have a building to be part of the food industry in San Angelo. Instead he makes adjustments to his plans and starts a mobile unit he can construct himself and still serve the type of food he wants. This is having an open mind and being resourceful.

There is a place in Austin that epitomizes this spirit. The Odd Duck Farm to Trailer mobile restaurant is such an example.

The owner initially wanted to provide his patrons with the

opportunity to experience his food but did not have the resources to start a full-size restaurant.

Instead of focusing on the things he could not control, the owner decided to start serving his non-fast-food product in a mobile food unit that fit within his current resources.

Today the Odd Duck serves dishes such as a half quail with grilled sweet potato, raisins and pecans; and soft-boiled duck egg, grits, mushrooms, with butternut squash. These dishes reflect nontraditional mobile-unit food with mobile food overhead.

Entrepreneurs are, above all else, determined risk takers. They take on projects others may shy away from, but the successful ones are also innovative and think outside the normal scope of projects to find solutions to challenges. Therefore, when thinking of the next business venture to jump into, often it helps to start by destroying the cookie mold and finding new ways to arrange it.

Sea squirts never have to notify all the magazines of their change of address, get new checks from the bank or order new business cards.

# High court rules against release of birth date information

AUSTIN — Reporters' longheld practice of using dates of birth for fact checking before publication comes courtesy of the Texas Public Information Act — the law that governs the release of data held by state agencies and other governmental bodies.

The law currently includes no prohibition on the release of most state employees' date of birth information. However, on Dec. 3, the Texas Supreme Court ruled birth dates may be kept confidential and need not be released to the public.

Grounds for the case, Texas
Comptroller of Public Accounts
v. Attorney General of Texas and
The Dallas Morning News Ltd.,
originated in 2005, when the
newspaper requested payroll
information on 145,000 state
employees. Most of the request
was granted, but the comptroller disallowed the release of
date of birth information.

Although no evidence of identity theft resulting from the release of date of birth was presented in the case, the court's main argument for closing off the information was that

> SECT LEADER BROUGHT TO TEXAS

Warren Steed Jeffs on Nov. 30 was returned to Texas to stand trial for sexually assaulting a child, the Texas Attorney General's Office announced.

Law enforcement officers with the Texas Rangers and the attorney general's office escorted Jeffs to San Angelo after taking custody of him in Utah.

Jeffs is being held without

bail and is to be tried in a Tom Green County state district court on two charges of sexual assault of a child and bigamy. Jeffs is the former president of the Fundamentalist Church of Jesus Christ of Latter Day Saints, a group that split from the mainstream Church of Jesus Christ of Latter Day Saints in the 1890s. The FLDS group bought land near Eldorado in

Schleicher County and created

the YFZ "Yearning for Zion"

Ranch and compound. The ranch was the site of a multi-government agency intervention in the spring of 2008, in which agents removed more than 400 children and placed them in safe housing after allegations of sexual abuse at the ranch were communicated to authorities.

To date, seven of 12 YFZ Ranch-related suspects have been convicted of sexually assaulting children, according to the Texas Attorney General's Office.

RECOUNT FAVORS
INCUMBENT REP

After a recount of mail-in ballots cast in the Nov. 2 election, state Rep. Donna Howard, D-Austin, last week was declared the winner in the House District 48 race, by 12 votes over Republican challenger Dan Neil.

There is a procedure to follow if Neil contests the recount. He would have to file papers with the secretary of state and the secretary of state would forward the matter to

House Speaker Joe Straus, who in turn would assign a House member to lead an investigation and a special investigating committee.

If Neil had won, the GOP would have had 100 seats to the Democrats' 50 seats in the upcoming 82nd Texas Legislature, which convenes Jan. 11.

A 50-seat difference would have

# MUSIC: from page 1

Like reading, writing and arithmetic, music is also a fundamental part of learning. Along with Saunders, middle and high school teachers Stephen Martin and Elizabeth Bouquin teach that music is more than just notes on a page and tooting a horn.

"You can teach kids fun and amazing things through music," Saunders said.

In her ninth year teaching in Ozona, it's hard to imagine Saunders loving anything but music. However, when she graduated from Eldorado High School Saunders entered Angelo State University as a physics major, for one week.

After a week practicing with the Ram Marching Band, Saunders knew music was her calling. Since then, she has taught students through clapping, singing, instruments and instruction about the magic of

"I love learning music with the kids. They make it fun," she said. "You can integrate everything with music, such as cultural aspects, science, social studies, math and most important reading. Students are able to read better if they have been musically trained."

Just like teachers in those core subjects, music education in Texas also has TEKS. The Texas Essential Knowledge and Skills (TEKS), help educators structure instruction around what students should know and be able to do by the end of each grade level, according to the Center for Educator Development in Fine Arts.

The TEKS are vertically aligned to provide for a cohesive curriculum from one grade to the next. Furthermore, the TEKS mandate consistent and rigorous student learning in the fine arts throughout the state, the CEDFA stated.

A Harvard-based study has found that children who study a musical instrument for at least three years outperform children with no instrumental training - not only in tests of auditory discrimination and finger dexterity (skills honed by the study of a musical instrument), but also on tests measuring verbal ability and visual pattern completion (skills not normally associated with music).

Children' exposed to a multi-year program of music instruction involving training in increasingly complex rhythmic, tonal, and practical skills display superior cognitive performance in reading skills compared with their non-musically trained peers, according to a study published in the journal Psychology of Music.

"Music teaches discipline and focus," said Martin, the OHS Band Director. "Students also have better test scores if they stay with music and really work it."

Like Saunders, Martin and his assistant Bouquin work with middle and high school students in the school district's band program, a program that has started rebuilding this year.

On the football field this fall, the OHS Band was seen marching during every half-time. Along with OHS students, a middle school student, Jadie Marshall, marched as well on the field filling in for a student who moved at the first of the school year.

During the last home

joined Jadie and the rest of the band to perform on the field. While the high school program is part of Martin's focus, the middle school bands are also receiving focused attention.

"So much of the progress is behind the scenes," Martin said. "There is no way for anyone to know how things are until you get in there. The middle school is the nuts and bolts of our program."

Sixth grade has been divided into two bands, one period for woodwinds and another period for brass and percussion. Concentration is on reading music, as well as learning to play instruments, Martin said.

"It's getting dramatically better. They sound like a beginning band with two-piece harmony," he said.

At the start of the school year, school district administrators changed the middle school schedule so that every student is taking band this year.

and Boquin are teaching 150 to 160 students this year, compared to around 80 last year.

"We are giving every student a chance to see how a band can be run," Martin said. "We are keeping students that we may have never been able to keep."

For seventh and eighth grade students, this year's band is about catching up and learning new skills, including the possibility of some marching and a performance with the high school band in the spring semester for eighth grade.

"We've just about buried them in teaching. They are learning a life skill. Working hard as music students and playing hard, they can get scholarships," Martin said.

Saunders attended ASU on music and academic scholar-ships. She came from a family

that loved music and had some success in high school music competitions due to the dedicated training from the Eldorado music faculty and private lesson teachers.

"If it was not for the hard work that Mike Marsh, Gina Muela, and Janet Nelson put into my musical upbringing I would not be the teacher that I am today," said Saunders.

Now, she incorporates this knowledge to students ranging from kindergarten to fifth

"We all grow in music together," she said. "The younger students can be more challenging."

No matter what grade comes into her classroom, Saunders makes sure to go over her classroom rules at the beginning of each period. These rules can be sung, clapped or set to instruments depending on what the students are studying.

In the elementary school, public programs are a production and are a success due to Saunders and her supportive staff.

"It's very challenging. I am blessed to work with a great group of people," she said.

During her performances, whether it's a patriotic program or Christmas carols, Saunders is always teaching.

"I want them to actually learn something through music," she said. "We have some fun and learn some amazing things, and we keep learning fun."

At this festive time of year, music will be filling Ozona as the middle school and high school bands will take the stage on Dec. 14 at the Fair Park Convention Center, and elementary students will perform at Ozona National Bank's Open House on Dec. 15 and Crockett National Bank's Open House

Practices by each class, then each group and then each grade are coming together as the next performance draws near for the elementary students. Another week of long days and long nights approaches, but Saunders keeps teaching her love of music.

"A week before any performance it's a little sleep and a lot of caffeine," she said.

When students leave Saunders classroom and enter into Martin's and Bouquin's teaching, she said she hopes they will always include some aspect of music in their lives.

"Life is short, but art is long. I hope they take a lifelong appreciation for music and music eduction," she said.

Also, most of the representatives carry false identifications, or do not carry any type of identification at all.

The first group sheriff's officials questioned were from Dallas. The second group was from Houston.

"Some states have filed suit on the company. We want the citizens of Ozona to be aware and contact the sheriff's office if anyone comes in contact with this group," Semmler said.

In a voluntary statement, one Ozona resident said the Just Energy representatives never introduced themselves and asked the resident for a ride. The resident also said that the people were "very rude" and "angry." When the resident refused to switch to Just Energy, the representatives kept pushing a contract at the resident until the resident tore it up and asked them to leave.

"They mainly come at

night and are targeting low income and elderly residents. We don't want people to be taken in by scams," Semmler said.

Officials at the Better Business Bureau of the Permian Basin said Just Energy has the lowest rating of "F" and that 47 complaints have been filed against the company, mainly in customer service, billing and selling.

The BBB recommends asking door-to-door salespeople if they have permit. If the resident doesn't see a permit, then don't give any information, especially private information.

Semmler said they are investigating and will be contacting the Texas Attorney General's Office for assistance.

"These people may appear to be legit. There are so many of these scams going around that seem too good too be true," Semmler said.

Anyone with any information about this or any other suspicious activity, call the Crockett County Sheriff's Office at 392-2661.







# ORDER RESTRICTING **OUTDOOR BURNING**

The Commissioners' Court finds that circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning; and NOW, THEREFORE, IT IS HEREBY ORDERED by the Commissioners' Court of Crockett County, Texas, that outdoor burning is restricted in Crockett County for 30 days from the date of adoption of this Order, unless the restrictions are terminated earlier based on a determination made by the Texas Forest Service or this Court. This Order is adopted pursuant to Local Government Code 352.081, and other applicable statues. This Order does NOT prohibit outdoor burning activities related to public health and safety that are authorized by the Texas Natural Resources Commission for: (1) firefighter training; (2) public utility, natural gas pipeline or mining operations; (3) planting or harvesting or agricultural crops; or (4) burns that are conducted by an approved Prescribed Burning Association, Natural Resource Conservation Service, the and/or Texas A&M Agricultural Experiment Station, or prescribed burn manager certified under Section 153.048, Natural Resources Code, and meet the standards of Section 153.047, Natural Resources Code.

All burns shall be reported to the Crockett County Sheriff's Office (325) 392-2661 and the Fire Chief (325) 392-2626 prior to commencing, together with the name of the landowner, location involved and expert to be on

This Order does NOT prohibit outdoor cooking in a properly contained area which is attended at all times.

In accordance with the Local Government Code 352.081 (h), a violation of this Order is a Class C misdemeanor, punishable by a fine not to exceed \$500.




