### Survivor dinner discusses upcoming Relay For Life

"We are celebrating cancer survivors and remembering ones who lost cancer," said Kellye Howard, with the American Cancer Society in San Angelo. "There is a lot of symbolism in the event being from dusk to dawn. By the time dawn comes, we hope the cancer patient is in remission.'

### Hilderbran, Uresti begin session filing legislation



During the first week in session, State Rep. Harvey Hilderbran, R-Kerrville, and State Sen. Carlos Uresti, D-San Antonio, both were busy filing legislation.

The 82nd Texas Legislature began Jan. 11 and two days later, Hilderbran filed House Bill 250, which would require voters to show photo identification before casting a ballot.

"Voter identification requirements will fulfill the intent of the voter registration system by ensuring that only eligible individuals are participating in elections,' Hilderbran said. "Deceptive voting practices aren't hypothetical. Voter fraud is occurring in our state, and Texans have called on the legislature to provide stronger safeguards for our elec-

Under the bill, voters would need to show a current driver's license or photo identification card issued by the Texas Department of Public Safety, an unexpired

port or a US citizenship certificate.

Hilderbran said his legislation will allow Texans to obtain state-issued photo ID cards for voting purposes at no cost.

Currently, voters can present their voter registration card without a photo ID before voting.

"We can no longer allow voter fraud to plague our state, but at the same time we don't want to create a system where anyone is disenfranchised," Hilder-

bran said.

The bill will also allow individuals not carrying photo identification to cast a provisional ballot. Voters must then provide proof of their identity within six days in order to have their vote counted.

In the State Senate, Uresti has filed many bills, some prior to the start of the legislative session.

Senate Bill 269 would create a Foster Children's Bill of Rights, which would enumerate a child's rights under state and federal law

relating to the full range of their care and well being. That includes the right to be free from abuse, neglect, exploitation, discrimination and harassment, and the right to food, clothing, shelter, education and health care.

"Most of the children in foster care were abused, exploited or abandoned by their birth parents,' Uresti said. "While they adjust to foster care and learn how to trust again,

this bill will clearly lay out all the rights available to them under the law and protect their health, safety and other interests.'

The bill would also address rights relating to privacy, health treatment, behavior intervention, placement with siblings and contact with family members, participation in extracurricular or community activities; interactions with teachers, church members and others outside the foster care system, and religious activities.

Promoting means you need to determine who your target market is in order to identify the methods to attract them. For example, if you have a new venue for high profile events, then donate your space on some occasions to organizations whose members include attorneys, bankers, doctors, or other members of your target market.

· Find your competitive niche. While you might decide a restaurant or a bar is your next project, the big question is what type? Just because you enjoy eating Mexican food does not mean you need to establish another Mexican restaurant. Look around and find a competitive niche you can fill.

Downtown San Angelo is an excellent example of this process. Today you can find bars dedicated to the following niches: wine, Tejano, country, rock, daiquiris, and live music. By finding their own niche each of these bars has essentially grown the overall market of customers that experience downtown on a weekly basis and thus increased their chances of survival.

Before you make that jump, it is important to analyze the business venture and think about the details that can see you through 2012.

### Legislature opens Jan. 11 with budget issues heavy and present

STATE CAPITAL HIGHLIGHTS By Ed Sterling Texas Press Association

AUSTIN --- The 82nd regular session of the Texas Legislature commenced Jan. 11 with high spirits and rousing speeches, coupled with the gravity of a never-deeper budget deficit for the freshly sworn-in lawmakers to deal with, and an interstate call for solemn reflection.

On Jan. 10, Texas Comptroller Susan Combs delivered the biennial state revenue estimate for budget years 2012-13. Combs' estimate shows the state is projected to have about \$72 billion available for general-purpose spending during the 2012-13 biennium.

That means lawmakers, even with a steadily improving economy in the forecast, will have about \$27 billion worth of hole to fill in order for the state to maintain its current level of services to a growing population. And that suggests the likelihood of a combination of taxation and fee adjustments and cutbacks in state services.

State Rep. Jim Pitts, R-Waxahachie, said the budget-writing House Appropriations Committee, which he chairs, may have to consider state worker

terminations and furloughs as possible ways to help offset the lower state revenue projection.

Meanwhile, questions over who would be the next speaker of the Texas House were largely answered in a Republican caucus on Jan. 10, in which incumbent speaker Joe Straus, R-San Antonio, received 70 votes out of a possible 101. On Jan. 11, when the whole House voted, Straus won by a wide margin over challenger Ken Paxton,

R-McKinney. Solemn reflection: both the House and Senate, in their opening ceremonies, observed moments of silence in honor of the dead and wounded, and their loved ones, in the Jan. 8 shooting in Tucson, Ariz. A gunman fired into a crowd at a "Congress on Your Corner" public event, critically wounding U.S. Rep. Gabrielle Giffords and 13 other people and killing U.S. District Judge John Roll and five other people. The shooting suspect, identified as 22-yearold Jared Lee Loughner, was captured while reloading his 9

mm handgun. He is in custody.

### **HUTCHISON** WON'T RUN IN 2012

U.S. Sen. Kay Bailey Hutchison last week announced she would not seek another term in office.

Her announcement prompted media questions to Lt. Gov. David Dewhurst, who earlier had signaled his interest in succeeding Hutchison, if she were to step down or not seek reelection.

Dewhurst, who presides over the state Senate, answered that his hands are full with the current legislative session but did not rule out a run for the U.S. Senate seat when the time

comes. Bill White, former mayor of Houston and Democratic gubernatorial candidate said he would not be a candidate for the Senate seat to be filled when Hutchison completes her term of office.

Besides Dewhurst, other Republicans that have emerged as likely candidates for the Senate seat are Texas Railroad Commissioners Michael L. Williams and Elizabeth Ames Jones.

All 22 counties in the Texas Pecos Trail Region are eligible to apply for the grant and attend the Del



There are approximately 35 million Americans age 65 and older, a number that is projected to more than double by 2030.

The number of those age 85 and older has increased 30 fold over the twentieth century. Currently one in 10 Americans are over 65 and half of those over 85 are affected by dementia.

Dementia is the overriding diagnosis for cognitive impairments in older adults.

It refers to a global loss of cognitive and intellectual functioning, caused by damage to the brain that is severe enough to interfere with social and occupational performance.

There are several different types of cognitive disabilities that fall under this diagnosis. Alzheimer's Disease (AD) is the largest category.

Caring for those with

patience and special care, but how can people be empathetic when they have never experienced demen-

It is the only area of care-giving that has no ability to identify with the victim's plight.

Most people can experience what it would be like to be confined to a wheelchair, have vision problems, arthritis, etc. But a person caring for someone with dementia has no idea what it might feel like.

Yet, decisions for and about them are made by others who try, but cannot understand what the person copes with. Lessening the chasm

between us and our elders with dementia gives us a greater chance of meeting their needs. Research has demonstrated that caregiv-

dementia requires empathy, ers of cognitive impaired patients overestimate the patients' functional performance in telling time, counting currency, making change, brushing teeth and using eating utensils.

> This misunderstanding of ability can result in anger on the part of the caregiver and frustration on the part of the patient.



Senate Bill 268 would raise the legal age to smoke and purchase tobacco products from 18 to 19, which could help break the cycle of tobacco addiction that usually begins in the teenage years.

According to the Centers for Disease Control, almost one in five Texans age 18 and older are regular smokers-more than 3.2 million people.

Research has shown that simply delaying access to smoking reduces the risk of adolescents becoming addicted during their most formative years, but that's difficult to do when 18-yearolds can legally purchase cigarettes, then bring them to school and hand them out to their younger friends, according to a press release from Uresti's office.

In fact, most underage smokers do not purchase cigarettes for themselves. One study revealed around 60 percent get their cigarettes from other sources, and a significant amount has others buy cigarettes for them, Uresti's office stated.

Uresti also filed Senate Bill 270, which would require that newborns be screened for hearing-related problems. This bill follows the 2009 passage of Greyson's Law, which expanded the state's newborn screening program from 29 to 49 disorders.

"It's vitally important that we add hearing disorders to the screening list,' Uresti said. "The sooner we find out about the health problems of newborns, the less costly and easier they are to treat."

Uresti's office also sent a "Session Watch" column on the issues facing the legislature after week one.

On the Senate side, Fi-Chairman Steve nance Ogden, R-Bryan, was elected as president pro tempo-

re, a largely honorary position that will allow him to serve as gover-

nor for a day when Gov. Rick Perry and Lt. Governor David Dewhurst are conveniently out of the state, Uresti said.

The legislature is facing a budget shortfall of more than \$27 billion. Perry has ruled out any tax increases, and, inexplicably, any use of the state's Rainy Day Fund, which contains more than \$9 billion.

'The fund was created for difficult times just like this. It is unavoidable that some painful budget cuts will have to be made. That's why it would be irresponsible to leave this fund untouched in the midst of so much need," Uresti said. "Sadly, other issues have taken the lead. Under the Texas Constitution, the Legislature can't act on a bill during the first 60 days of the session unless the governor declares an emergency. In the earliest days of the session, Perry fast-tracked the course for two bills on sanctuary cities and imminent domain. Perhaps later our children will become a priority.'



### **Boquillas crossing to re-open**

BIG BEND - People will again be able to legally cross the US-Mexico border to the tiny town of Boquillas, Coah., when a "Class B" Port of Entry is completed near Rio Grande Village in the park in about April, 2012.

US Customs and Border Protection Commissioner Alan Bersin told news media representatives at Rio Grande Village Visitor Center last week that he was going to report to Homeland Security Secretary Janet Napolitano that a port of entry between the park and Boquillas is going to proceed.

The press conference in the park was on production day for the News Leader and we were not able to attend.

But Brooks told the paper this week that construction on a small visitor center on the US side of the river is scheduled to start this summer and it should be ready for use by the public in April, 2012.

"It will be a Park Service building and not very big," he said. "It will be a visitor center, primarily to explain what documents are needed to make a crossing."

Brooks said the Western Hemisphere Travel Initiative spells out requirements for border crossings that include a passport, enhanced drivers license and the like.

"It [the Boquillas crossing] will only be daylight hours and it may not be year round," Brooks said.

The Boquillas crossing and those at Lajitas, Redford and Santa Elena were totally closed in May, 2002. They had remained un-

officially open after the US government closed them and La Linda in 1996 and

The closings left the area with no border crossings between Presidio/Ojinaga and Del Rio/Acuña, a distance of more than 300 highway miles.

The tiny village of Boquillas just across the river from Rio Grande Village was virtually cut off from the rest of the world by the lack of decent roads in Mexico and the closed crossing.

Boquillas residents had provided a rowboat for US visitors to come visit the town to shop, eat tacos and drink cerveza in the tiny

Boquillas artisans fashioned numerous crafts items which US residents bought to help sup-port the town.

Some of the Boquillas art work such as metal insects, walking sticks and others had become known around the area.

US citizens like Dorothy Marquart of Sanderson said she and her late husband Daniel Ray Marquart, among others, would take supplies to Boquillas residents.

Brooks said the activities will be able to resume when the crossing is com-

pleted but used clothing may be out, not because of a US requirement but he said he was told the Mexican government will no longer allow used items to be brought into the country.

Park spokesman David Elkowitz said the park "certainly requested" the crossing be re-opened. "It has to be combined effort" between the CBP, Park Service and others.

"We see it as desirable for visitor experience," he said. "We also try to provide a positive experience on the border."

He said the action at Boquillas will bring the park service one step closer to a "decades-old goal" of an international park on both sides of the river.

The idea was first proposed in the 1930s but has not yet come to fruition and there are many obstacles still in the way of it becoming a reality.

"We are focusing on a one-rowboat crossing at Boquillas," Elkowitz said.

Brooks said when the crossing is operational and the visitor center manned, people returning to the US will go through kiosks operated remotely by CBP.

Crossers will scan their documents and stand in front of a camera.

"Someone elsewhere, probably at the Port of Entry in Presidio or somewhere, will determine if the entrant can pass," he said. The passport has biometric data on it.

"They can scan it and the record will pop up," he said.

"Then they will look at the camera and the agent will make sure it's the same guy."

Until the crossing opens, Brooks said, workers, scientists and people "with a need to cross" will be able to move across the river.

"They are enrolled in CBP's 'trusted traveler' program, a network for travelers' rapid inspection," he said.

Brooks said there was a question last week about other Class B points of entry at Santa Elena or Lajitas.

"We will take this one step at time," he said. "There are no other plans.

"This was done to facilitate the park service," he said. "It is part of border experience and they want that."

### Man sentenced to eight years in prison for ranch shooting



### **ORDER RESTRICTING OUTDOOR BURNING**

The Commissioners' Court finds that circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning; and NOW, THEREFORE, IT IS HEREBY ORDERED by the Commissioners' Court of Crockett County, Texas, that outdoor burning is restricted in Crockett County for 30 days from the date of adoption of this Order, unless the restrictions are terminated earlier based on a determination made by the Texas Forest Service or this Court. This Order is adopted pursuant to Local Government Code 352.081, and other applicable statues. This Order does NOT prohibit outdoor burning activities related to public health and safety that are authorized by the Texas Natural Resources Commission for: (1) firefighter training; (2) public utility, natural gas pipeline or mining operations; (3) planting or harvesting or agricultural crops; or (4) burns that are conducted by an approved Prescribed Burning Association, Natural Resource Conservation Service, the and/or Texas A&M Agricultural Experiment Station, or prescribed burn manager certified under Section 153.048, Natural Resources Code, and meet the standards of Section 153.047, Natural Resources Code.

All burns shall be reported to the Crockett County Sheriff's Office (325) 392-2661 and the Fire Chief (325) 392-2626 prior to commencing, together with the name of the landowner, location involved and expert to be on

This Order does NOT prohibit outdoor cooking in a properly contained area which is attended at all times. In accordance with the Local Government Code 352.081 (h), a violation of this Order is a Class C misdemeanor, punishable by a fine not to exceed \$500.
