## Ozona mourns loss of young family

The mom is described as "beautiful," while the dad is "hard-working." The children are cute.

Loved ones are mourning the death of this young family that was killed last week in a vehicle accident.

Jasmine Alexis Gonzales, 20, Daniel Raul Gonzales, 20, Kierra Haitey Smith, 3, and Emori Jade Gonzales, 6 months, all of Ozona, were killed in two-car vehicle accident near Mertzon on June 16. The family was pronounced dead at the scene by Irion County Justice of the Peace Donna Smith.

Funeral services for the family have been set for 2 p.m. today, June 22, at

Our Lady of Perpetual Help Catholic Church with burial in Lima Cemetery.

The community of Ozona was shocked and sudden by the incident. Friends and family described the young couple as "the best of friends" and

"amazing people." Jasmine enjoyed movies, shopping and her favorite book was the Bible.

## Change of plans: No fireworks for the fourth

### Firefighters battling mutliple blazes

Fireworks will not be allowed this Fourth of July.

After approving the use of fireworks at their June 13 meeting, the Crockett County Commissioners' Court met again Monday and decided to not allow the sales or use of fireworks this year.

Commissioner Frank Tambunga, who is also head of the annual Knights of Columbus public show, also said that after discussion over the weekend the Knights will not hold their annual show.

"Whatever is best for the county is what we want to do," Tambunga said.

County Judge Fred Deaton issued a declaration of disaster Monday that will prohibit the sale, use or possession of fireworks for 60 hours, from 8 a.m. July 2 to 8 p.m. July 4. Deaton then submitted a letter to Texas Gov. Rick Perry's office to approve extended the ban request for the entire Fourth of July fireworks season.

The Crockett County Sheriff's Office has been informed that a ban is in place and told Deaton they will enforce the ban.

Deaton also said he talked with Fire Marshal Steve Kenley and Fire

## Water district implements drought plan

The drought is making its presence known in Crockett

Crockett County Water Control & Improvement District has implemented Stage 1 of the Drought Contingency Plan.

According to a notice from the district, the plan is due to no significant rainfall in the past six months.

Stage 1 asks residents of Ozona for a voluntary reduction of water use, such as water lawns and gardens early in the morning or in the evening, wash large loads of laundry and dishes, shower instead of bathing and repair all leaks (see full notice, page 5).

CCWCID oversees water regulation within the town of Ozona. Water use outside the town is regulated by the Crockett County Groundwater Dis-

Many residents have expressed concern over oilfield water use, especially with the drilling north of town.

Knowing I have a responsibility as a reporter to keep my readers abreast of all the trends in food and agriculture, my wife recently handed me an article about a fad that is all the rage in France. It seems that in some Parisian restaurants the customers are dining in the dark. No, not with the lights merely dimmed, I'm talking total darkness. The idea is that with the sense of sight turned off, the diner's other senses, such as that of taste and smell, become more alive and the food tastes better.

I contend that the darker the restaurant the worse the food, the smaller the portions and the higher the price. I've also found that people will eat at a dimly lit restaurant that if they saw in the daylight you couldn't drag them into with a six horse hitch. But this idea of eating in complete blackness appealed to my darker side, so I proposed to my wife that we try it. She liked the concept that she could just throw my food on the plate without regard to artistic presentation, and that she wouldn't have to worry about "gently nestling my green beans in a bosom of risotto." As if she's ever done that before. And so my wife reluctantly agreed to dining in the dark with one strict rule: that the lights be

The last time we tried something like this things did NOT work out well. Following an idea she read in a woman's magazine, we once ate alphabetically; only eating food that began with an "A", then a "B" and so on through the alphabet. I dreaded the suppers created around Q, X and Z but I

alized at the last minute that this would be a very good opportunity for my wife to feed me rat poison or to clean out the refrigerator of all the green and moldy stuff hiding inside. But it was too late. I was already committed and so the soup arrived.

Right away there were problems I hadn't foreseen: I knocked over the water pitcher and stabbed myself in the forehead with a fork that I thought was my spoon. I've always practiced safe eating habits and always use condiments, and so I pounded on the bottom of my water glass trying to make the ketchup come out. I also reached for the pepper to season my soup but it tasted like the library paste we used to eat in kindergarten. My wife informed me later that I had in fact seasoned my soup with the goldfish food.

You'd be surprised at how not being able to see your food changes its taste. And so we began the game of me guessing what food I was eating. My wife's salad tasted like sweet and sour pancakes and the dinner rolls like Fig Newtons®. I got my recommended daily dose of fiber by accidentally eating part of my placemat. (Not that bad, really.) Strangely, few of the foods tasted like any of the four food groups I was used to: fat, grease, starch and sugar. And who in their right mind would serve artichokes to someone who couldn't see what they were doing? But my wife, with the sick

sense of humor, did. When my wife served the main course I guessed that it was either corn on the cob, ribs still wrapped in Saran Wrap, Velveeta cheese in a delicate root beer gravy, fish sticks, (which I haven't eaten since the third grade) or hamburger my wife forgot

My wife hinted, "It's something we eat all the time.'

"Leftovers?" I guessed. Incorrectly as it turns out. I finally got it right when the smoke alarm went off. "Either the house is burning down or you burned the roast again.'

In summary, I don't think that dining in the dark will catch on in this country and I'd suggest that you NOT try this at home if your marriage is already a little shaky to begin with, or your Doctor has told you to watch what you eat.

## Governor releases list of decisions on legislation

**STATE CAPITAL HIGHLIGHTS** By Ed Sterling | Texas Press Association

AUSTIN — Will he or won't run? If Gov. Rick Perry's presidential candidacy intentions could have been symbolized by a green, yellow or red light last week, it was arguably yellow, even though he spoke at Republican gatherings in New Orleans and New York.

Regardless, Texas' chief executive had plenty on his desk, namely a heap of legislation awaiting his final decisions. June 19 was the last day for the governor to sign or veto bills passed during the Legislature's regular session, which ended May 30. He released his finalaction list on June 17.

Perry signed the 2012-2013 state budget, a document \$20 billion lighter than the current 2010-2011 state budget. Perry praised the bill for not dipping into the so-called rainy day fund and not creating new taxes. As of June 20, Senate Bill 2, the fiscal matters legislation that makes the budget balance, had not reached the finish line in the still-in-progress special session of the 82nd Texas Legislature.

SB 9, the sanctuary cities

bill that allows local police to question persons stopped for due cause about their immigration status, was approved by the Senate and has moved to the House for consideration. Lt. Gov. David Dewhurst praised the work of the body he presides over, saying: "Drug traffickers and transnational gangs should think twice before they step foot in Texas."

SB 4, the congressional redistricting bill, was heavily amended on its trip through the House. Now back in the Senate, upper chamber lawmakers must accept or reject the amendments. Following SB 4's approval by the House, Speaker Joe Straus, R-San Antonio, said, "I am particularly pleased that we have passed all four redistricting maps required this year. The members provided much input and direction on maps that reflect the population changes in our state. The redistricting map for the State Board of Education (HB 600) is now law. The House (HB 150) and Senate (SB 31) redistricting maps were simultaneously passed and now await the gov-

ernor's signature."

#### NOW, ABOUT THOSE VETOES

Perry, after reviewing the bills on his desk, said "there were some bills that would have done more harm than good to Texans, and I have used my authority to veto them." He vetoed 23 bills.

One of the more attentiongetting vetoes was of HB 242, legislation that would have made it a misdemeanor offense to send a text message while

driving a motor vehicle. Perry said the bill, by the dean of the House, Rep. Tom Craddick, R-Midland, "is a government effort to micromanage the behavior of adults. Current law already prohibits drivers under the age of 18 from texting or using a cell phone while driving. I believe there is a distinction between the overreach of House Bill 242 and the government's legitimate role in establishing laws for teenage drivers who are more easily

distracted and laws providing further protection to children in school zones."

Here are a few more:

-- HB 992 by Joaquin Castro, D-San Antonio, relating to excess undergraduate credit hours at public institutions of higher education. Perry said the bill "would encourage students to waste time and money, along with taxpayer dollars, and would prevent students and community colleges from being held accountable for responsible academic planning and advising." a leader I understand the importance of demonstrating an attitude of enthusiasm as well as one of servitude and partnership to my fellow educators," she said.

During the meeting, McWilliams said she has been contacting and visiting with the OMS staff and learning what she needs to learn.

"Ozona has been very fortunate to have Tammy serving student in the classroom for two decades. She will have an even greater impact on students as an instructional leader," said Superintendent Chris duBois. "She is very quickly building a knowledge base and assembling strategies in cooperation with OMS staff to get right after programming and instructional needs for 2011-2012. is monitored by the Texas Commission on Environmental Quality and the Texas Railroad Commission. The Crockett County Groundwater District has no say in oilfield water reg-

The groundwater district is working on a research project on the usage of water and the problems with oilfield injecting. The project is being conducted in conjunction with Crockett County.

"Crockett County residents are enduring one of the worst droughts in Texas history. This year's drought rivals the historic droughts of the 1930s and 1950s," said Cary "Dr. Doppler" Burgess, weather forecaster for KYXX-KHOS FM Radio in Ozona and Sonora.


According to the Texas Forest Service, since the first of the year there are only five counties in Texas (Bowie, Red River, Lamar, Fannin, Grayson) that are not below normal rainfall.


Over the last 60 days, around 70 percent of the state has rainfall deficits running 50 percent or less of normal rainfall, and over the last 30 days, around 90 percent of the state has rainfall deficits running 50 percent or less of normal rainfall, the forest service stated in their daily report.

The Keetch-Byram Drought Index (KBDI) is a mathematical system for relating current and recent weather conditions to potential or expected fire behavior. A drought index number ranging from 0 to 800 that describes the amount of moisture that is missing. A rating of 0 defines the point where there is no moisture deficiency and 800 is the maximum drought possible.

Crockett County is listed at 700-800, which is often associated with more severe drought with increased wildfire occurrence. The U.S. Drought Monitor lists Crockett County as exceptional.

"The drought this year is not unprecedented. We've had severe droughts in the 1930s,





1950s, 1990s and even as recently as 2009. Even so, most Texans find themselves wondering how we went from wetness in 2010 to extreme drought in 2011," Burgess said. "Last year at this time, we were faring well and dealing with flooding across Texas. Last year's rainfall is actually part of the problem believe it or not."

In 2010, Texas saw "good" rainfall which caused grasslands and pastures to grow, Burgess said.

Since the first freeze of the season, the majority of the state has not received any beneficial rainfall or snowfall. Forecasters last summer and fall warned of a dry winter coming up due to what was called a La Nina weather pat-

NOAA states, "La Niña is characterized by unusually cold ocean temperatures in the Equatorial Pacific."

"When Pacific ocean temperatures are colder than normal, the jet stream shifts north of our region leaving Texas south of the pathway that major storm systems take. This usually keeps Texas drier than normal. It is also normally windier than normal in the spring months," Burgess said. "This year is puzzling though.

La Nina's effects on our weather usually subside in March. Humidity levels usually begin to increase by late April into May and we see spring showers or storms before we enter the summer months. That didn't happen this year."

happen this year."

In May, high pressure developed and parked over Texas resulting in dry weather and hot temperatures because there is no soil moisture to absorb suplight. Purgoes said

sorb sunlight, Burgess said.

"The soil is so dry that it is reflecting heat much like concrete does on city streets. Temperatures soar during the day to record levels in many cases. Until it rains, we can expect the heat to continue," Burgess

Long range forecasts are not encouraging at the moment with most of the Climate Prediction Center models indicate hotter than normal temperatures and below normal rainfall through August, Burgess said.

The Climate Prediction Center expects the drought to persist or intensify through the end of September. "That's probably not what

"That's probably not what you wanted to hear. In the meantime, try to stay hydrated and cool during this extremely hot and dry year," Burgess said.

Chief Bob Falkner and both recommended a ban this year.

"We've certainly heard from everybody on this issue," Deaton said. "We have fires going on right now in the county, and we have no idea when we are going to get rain."

Last week, the commissioners voted to allow fireworks sales, except for aerial fireworks, and to allow the Knights of Columbus show. Commissioner Eligio Martinez voted against that motion.

"I think we acted a little hastily," said Commissioner Pleas Childress III.

Rancher Art Roane read a letter he wrote to the commissioners stating that he has "never seen a more burnable scenario" than this year.

"Any spark has the potential to destroy more life than property. Twelve years ago fire started in one of our pastures due to the public display. We have much drier and winder conditions. Even a sparkler could start a catastrophic event," Roane said. "Our freedom should be celebrated.

Use our God-given freedom of choice to send care packages to military or active service members or make a donation to our volunteer fire department."

Over the weekend, local, area and Texas Forest Service firefighters battled 15 grass fires in Crockett County, Falkner said.

The first one started Saturday on the Reagan-Crockett line. As of Tuesday morning, the Texas Forest Service reported the fire had burned 2,200 acres and was 95 percent contained in one county and 900 acres and 40 percent contained in another. The fire is burning southwest of Big Lake.

On Sunday, a storm system blew into the county and brought lightning causing several fires. The fires were located off of County Road 204, the old 290 highway, around Lancaster Hill, Pandale Road and County Road 406.

Falkner said Tuesday morning the only active fire was on the Mitchell Ranch in the southwest part of the county. The forest service reports that fire has burned 3,000 acres and is 5 percent

contained.

"We have been a little bit of everywhere," Falkner said. "I filled up with fuel three times yesterday (Monday)."

No damage to structures or injuries have been reported from the fires. Falkner said along with the forest service, Ozona received assistance from Eldorado and Val Verde Fire Departments and the Crockett County Road Department.

The forest service currently is responding to 22 large fires that have burned 132,750 acres throughout the state. As of Tuesday, 225 of the 254 Texas counties are reporting burn bans, including Crockett County.

Since fire season started on Nov. 15, 2010, Texas Forest Service and area fire departments have responded to 12,362 fires that have burned 3,080,013 acres.

During Monday's meeting, the commissioners also approved a Director of Nurses contract with C.J. Tinc and routine airport maintenance program. The next regular commissioners' meeting will be July 11.



#### **NO SIGNATURE** ON SOME BILLS

Friends described the young woman as "sweet, strong and very happy."

Working at Venture Mud, Daniel did everything he was asked to do without complaint, said co-worker Susan Cantu.

"He was a hard working man. He was our number one worker for the yard," Cantu said. "He will be missed at work. To replace him, it might take three other men to do his work. He was always ready to work no matter what time or how many hours it would take the do the work.'

The day before his death, Cantu said she talked to Daniel about his hard childhood and that now, since he had a family, he wanted to do things right.

"He had just bought a car. He was fixing to buy a house and he just had so many plans for his future. He was very responsible and respectful," Cantu said.

According to DPS trooper Joel Callaway the family died on impact.

Callaway said a passer-by saw the collision before the car caught fire and turned back from the direction he had come to where a sheriff's deputy was parked. When the deputy arrived at the scene, the occupants of the car were dead. Callaway said the deputy began removing one of the girls from the back seat.

"(The deputy) tried to pull one of the girls in the back seat out, but it had already caught fire," Callaway said, "and it started to burn pretty quick."

The driver of the other vehicle involved, Glen Hodges, was lying on a piece of ply-

wood and "in a lot of pain," when the trooper reached the scene. Hodges, 60, was flown to Shannon Medical Center with a broken pelvis, legs and ribs. Callaway said Hodges' injuries

were not life-threatening.

The crash occurred about 11 p.m. on June 16 about one mile south of Mertzon, an Irion County Sheriff's Office dispatcher said.

DPS spokesman Trooper Shawn Baxter said Jasmine Gonzales was driving the family's 1997 Nissan Altima south on U.S. 67 when it collided with a 2010 Chevrolet Silverado, driven by Hodges, of Fort Stockton, heading north on that highway.

Troopers said fatigue is suspected to be a contributing factor in the crash. Baxter said troopers examined the scene and, by inspecting the skid marks, determined the Nissan drifted over the center stripe and hit the Chevrolet.

Hodges, who was wearing a seat belt at the time of the crash, is an oil field worker, according to DPS.

Baxter said that Hodges was heading from Fort Stockton to San Angelo. The occupants of the Nissan were driving from San Angelo to Ozona. No charges have been filed in the case, which is still under investigation.

Callaway said when a massive impact takes place that causes a fire, a lot of times it's caused by severed fuel lines and battery acid that can react to sparks from metal on metal or spark plugs.

He said in this case the truck started to run over the car and peeled back the roof. It is unclear how the fire started.

Review by the Appraisal Review Board

If you can't resolve your problem informally with the county appraisal district (CAD) staff, you may have you case heard by the appraisal review board (ARB).

The ARB is an independent board of citizens that reviews problems with appraisals or other concerns listed above. It has the power to order the CAD to make the necessary changes to solve problems. If you file a written request for an ARB hearing (called a notice of protest) before the deadline, the ARB will set your case for a hearing. You'll receive written notice of the time, date and place of the hearing. If necessary, you may request a hearing in the evening, Saturday or Sunday. Prior to

your hearing, you may ask to review the evidence the CAD wil use to uphold their determination. The CAD may ask you for a copy of the evidence you plan to present. The hearing will be informal. You or a designated agent may appear in person to present evidence or you may send notarized evidence for the ARB to review at your hearing. The CAD representative will present evidence about your case. You may cross-examine the CAD representative. The ARB will make its decision based on the evidence presented. You can get a copy of a protest form from the appraisal district office at 909 Avenue D, Ozona, TX (325) 392-2674.

NOTE: You shouldn't try to contact ARB members outside of the hearing. The law requires ARB members to sign an affidavir saying that they haven't talked about your case before the ARB hears it.

#### **Review by the District Court**

After it decides your case, the ARB must send you a copy of its order by certified mail. If you're not satisfied with the decision, you have the right to appeal to district court. If you choose to go to court, you must start the process by filing a petition within 45 days of the date you receive the ARB's order.

#### **Tax Payment**

If you appeal and your case is pending, you must pay the lesser of the amount of taxes due on the portion of the taxable value not in dispute or the amount of taxes due on the property under the order from which the appeal is taken.





# **CROCKETT COUNT**

#### ORDER RESTRICTING OUTDOOR BURNING

The Commissioners' Court finds that circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning; and NOW, THEREFORE, IT IS HEREBY ORDERED by the Commissioners' Court of Crockett County, Texas, that outdoor burning is restricted in Crockett County for 30 days from the date of adoption of this Order, unless the restrictions are terminated earlier based on a determination made by the Texas Forest Service or this Court. This Order is adopted pursuant to Local Government Code 352.081, and other applicable statues. This Order does NOT prohibit outdoor burning activities related to public health and safety that are authorized by the Texas Natural Resources Commission for: (1) firefighter training; (2) public utility, natural gas pipeline or mining operations; (3) planting or harvesting or agricultural crops; or (4) burns that are conducted by an approved Prescribed Burning Association, Natural Resource Conservation Service, the and/or Texas A&M Agricultural Experiment Station, or prescribed burn manager certified under Section 153.048, Natural Resources Code, and meet the standards of Section 153.047, Natural Resources Code.

All burns shall be reported to the Crockett County Sheriff's Office (325) 392-2661 and the Fire Chief (325) 392-2626 prior to commencing, together with the name of the landowner, location involved and expert to be on hand.

This Order does NOT prohibit outdoor cooking in a properly contained area which is attended at all times.

In accordance with the Local Government Code 352.081 (h), a violation of this Order is a Class C misdemeanor, punishable by a fine not to exceed \$500.


