According to data from the U.S. Small Business Administration, companies that engage in international trade are 20 percent more productive, produce 20 percent greater job growth than non-exporters, and they are 9 percent more likely to stay financially solvent.

No business is too small that it cannot become a successful exporter. Indeed, the U.S.

Small Business Administration estimates small businesses are responsible for 25 percent of U.S. export volume (in dollars).

competitiveness is through expanding the customer base abroad. This provides an excellent opportunity to compete with foreign companies and encourage the creation of business efficiencies and product development.

One way to enhance business

Another milestone of international trade is the development of economies of scale. Small business can take advantage of products that already have an acceptance worldwide.

For example, a small company that produces pecans can

benefit from the acceptance of this product globally. Therefore, there is no need to spend resources in adapting it to each national or local market around the world.

A major benefit of engaging in international trade is market diversification. Expanding to other markets offers a way to diversify the economic risk. When one's local market is in a downturn, the income from the foreign market can compensate the losses caused by the home market.

Advancements in technology have significantly improved

and widened the ways to export. Large logistics companies such as FedEx, UPS and DHL have developed a large distribution network that facilitates and simplifies the export process for small enterprises. It is surprising how fast and easy an international shipment process can be.

In the past few decades, the U.S. government has been working toward opening and granting access to more markets abroad for American companies through new free trade agreements and other international trade instruments.

Going global not only represents a big challenge for small businesses but a great opportunity of unlimited growth.

Engaging in international trade provides many advantages, but to be successful overseas, the small companies should prepare carefully before deciding to go for their international adventure.

## **Holiday traditions**

s we celebrate another holiday season, I thought it would be fun to see where some of our Christmas traditions come from.

**Dec. 25** – The Christian Church designated Dec. 25 as the official date of Christmas to coincide with Roman winter festivals, notably those of the pagan gods Mithra and Saturn. The choice of Dec. 25 was made by Pope Julius I in the 4th century A.D.

**Kissing under the mistletoe** - The ancient Norse associated mistletoe with their goddess of love.

Holly - To Christians, the berries are symbolic of Christ's blood, and the thorny leaves suggest the thorns in His crown.

**Poinsettias** - Dr Joel Poinsett, the first U.S. ambassador to Mexico, brought the plant back in 1828. Mexicans had long revered poinsettia because it resembled the Star of Bethlehem. The flower portion of the plant is the small yellow blossoms. The large red or white 'flowers' are actually leaves.

Christmas Trees - Germans, in the 7th century A.D. The practice of bringing evergreen trees indoors and decorating them for winter festivals predates Christianity in Northern Europe. Although German-American Christmases featured trees from Colonial times, it was Queen Victoria's marriage to her German cousin, Prince Albert, in 1840 that brought them to the forefront. Albert carried the practice with him to England, and Christmas trees quickly caught on in the United Kingdom and United States alike. In the 16th century, Martin Luther supposedly awed at the brilliance of stars shining through evergreen branches. Luther attempted to replicate the vision for his family by placing candles on his Christmas tree. NOTE: Don't try this at home! In addition to literally making the season brighter, Ralph E. Morris' electric lights in 1895 made it safer, as they were an alternative to candles

and open flames.

Christmas Cards - Britain Sir Henry Cole commissioned the first cards in 1843, and fellow countryman John Calcott Horsley

dy Canes - Candy canes are generally considered to be modeled after shepherds' crooks, and the first record of them dates back to 18th century France, where they were given to children to keep them quiet during church services. Christians believe the significance of the read and white striping is symbolic of Jesus' blood

(red) and purity (white).

Fruitcake - The exchange of fruitcakes during the holiday season has become a perennial joke. But the custom originated out of the need to make sweets from foods available in winter - and in pre-industrial times, that meant using fruit preserves. In America, fruitcakes have been a popular Yuletide delicacy since Co-

lonial times. Santa Claus - Saint Nicholas was a fourth century bishop in Asia Minor. Known for his generosity toward children and the poor, he suffered persecution until the Roman emperor Constantine embraced Christianity in 312 AD. After that. Nicholas became a high Church official. Early Dutch settlers in America called St. Nicholas "Sinterklass". Later, English settlers adopted the name but changed the pronunciation slightly to Santa Claus. A 19th century European folk legend told of "Christkindlein," or the Christ child, who brought gifts to good children on Christmas Eve with the aid of an elf (sometimes called Pelznickel or Belsnickle). Eventually, this legend was combined with that of St. Nicholas, and in America, the pronunciation became "Kris Kringle."

## Courts figure heavily in Texas redistricting battle

AUSTIN — Texas' redistricting maps that employ data from the 2010 U.S. Census are now under the scrutiny of a three-judge federal district court panel in San Antonio.

Passed by the Texas Legislature in May, the maps failed to receive preclearance by the U.S. Department of Justice. The U.S. Supreme Court then gave the U.S. District Court, Western District of Texas, the job of redrawing the state Senate, state House and congressional district boundaries in accordance with the Voting Rights Act of 1965.

Critics of the proposed maps claim lines drawn by the Republican-dominated state Legislature dilute the voting power of communities of interest in several areas of the state.

House Speaker Joe Straus, R-San Antonio, issued a statement on Nov. 22, asking the federal judges who drew a preliminary set of lines earlier this month, "to take into account the will of the people of Texas as expressed by their elected representatives."

Straus went on to say, "If the

final order of the court is not substantially closer to the plan we passed, I will urge (Texas Attorney General Greg Abbott) to seek an immediate stay from the U.S. Supreme Court so that several issues under the Voting Rights Act can be clarified before the federal judges impose their new map on Texas voters for the 2012 elections."

On Nov. 27, Abbott filed emergency stays with the U.S. Supreme Court, challenging the House and Senate redistricting maps drawn by the three-judge panel.

#### INPUT RECEIVED ON DNA ISSUES

A Nov. 22 interim hearing of the House Committee on Criminal Jurisprudence focused on DNA testing, a subject drawn to the fore after the recent exoneration of an Austin-area man after he served 25 years in prison on a murder sentence. Under the direction of Chairman Pete Gallego, D-Alpine,

man Pete Gallego, D-Alpine, the committee heard invited testimony. Topics of discussion included testing technology, the integrity of evidence testing, testing centers and crime labs, the practicality of not destroying but retaining and storing evidence, and the cost of testing.

Also discussed were wrongful convictions, exonerations, the death penalty and criminal laws, all of which may be affected by changing technology in DNA testing and the handling of DNA evidence.

#### LAWMAKER PLEADS IN FELONY

State Rep. Joe Driver, R-Garland, has pleaded guilty to abuse of official capacity, a third-degree felony. First elected to the Texas House in 1992, Driver earlier said he would not run for reelection next November.

Driver's pleading was made public Nov. 22 by Travis Coun-

ty District Attorney Rosemary Lehmberg, who said Driver is accused of converting more than \$20,000 of state travel reimbursement funds intended for his campaign office holder account by depositing those funds into his personal ac-







## Abbott: Elections should use legislature's maps

TEXAS TRIBUNE

Even if the U.S. Supreme Court decides not to intervene in the Texas redistricting controversy, the maps drawn by federal judges in San Antonio could be knocked down by another federal panel, Attorney General Greg Abbott told the Tribune Monday.

Within the last few days, a panel of three federal judges in San Antonio ordered the state to hold congressional and legislative elections under interim maps drawn by the court.

The maps drawn by the Legislature haven't been pre-cleared under the federal Voting Rights Act and can't be used, and the maps used in past elections are out of date in view of new population numbers produced by the 2010 census.

The San Antonio judges remedied that by drawing maps of their own.

All three judges signed off on the court's Senate map; the congressional and House maps were approved by a 2-1 vote.

In an interview with the Tribune, Abbott said the court goofed, incorrectly replacing a legislative map that hasn't been ruled illegal. His office asked the Supreme Court to stay the San Antonio court's orders, even if it means holding some primary elections in May instead of March.

That could mean a March primary on the presidential and other statewide races and on local races but legisaltive and congressional races delayed until May, after the courts have settled the disputes over

The San Antonio maps could be replaced even if the Supreme Court denies the state's request, Abbott said.

The state sought preclearance from a panel tino, and Asian American of three federal judges in Washington, which decided to hold a trial on that issue as early as next month. Abbott says a green light on the state maps could "largely nullify" the maps ordered by the San Antonio court, throwing yet another variable into the already volatile election calendar.

"When there has not been a rejection of the state plan, but there have been efforts by the state to get it pre-cleared, there has to be deference given to the state map created by the state Legislature." Abbott said.

"The court refused to apply that standard here and instead created a map out of their own whole cloth, out of their own standard.

"The map that we have right now — the one the Legislature drew — has not been held by anyone, anywhere, anyhow, anytime [to bel illegal in any way," he said.

Democrats defended the court's maps, saying the Legislature ignored the law, and the courts had to intervene.

"Today, Attorney General Greg Abbott applied for an emergency stay of the maps from the United States Supreme Court, once again, putting the 2012 election cycle in jeopardy," said Rep. Trey Martinez Fischer, D-San Antonio, who heads the Mexican-American Legislative Caucus. "The leadership in the Legislature chose to ignore overwhelming Latino growth in our state and refused to adhere to the Voting Rights Act, now the courts have had to step in and apply the law. The leadership of Texas defaulted on their opportunity to enact fair and legal legislative maps. Instead, they sought to expand their politcal power on the backs of African American, La-Texans. To date, six federal juges have rejected Attorney General Abbott's fiction that Texas' redistricting maps comply with the law and should be implemented for Texas elections."

Abbott, accused Democrats of slowing down the proceedings by asking the courts for pre-clearance instead of seeking it from the Obama administration's Department of Justice, said "foot dragging" by those lawyers has pushed the case into conflict with the candidate filings.

"Texas has been and


continues to move aggressively for preclearance from the court. However, it has been and remains to be the DOJ that continues to drag its feet and slow things down," Abbott said.

He said the state has asked for a trial on Dec. 12 and the Justice Department lawyers asked the court to abate that hearing.

The delays would have been as bad or worse had the state gone to DOJ for pre-clearance, he said: "In hindsight, the strategy that we did take was the best strategy that we could have taken.

Abbott hired Paul Clement, a noted Supreme Court advocate, to help his office with the case (at a rate of \$520 an hour, which he called "a steep discount"). Clement worked with Abbott on a lawsuit over the display of the Ten Commandments on the grounds of the state Capitol.

Late Monday afternoon, U.S. Supreme Court Justice Antonin Scalia asked the lawyers in the case to file responses to Abbott's request by Thursday afternoon.





## **DPS** having success sidelining dangerous trucks

At today's Public Safety Commission meeting, DPS Director Steven C. McCraw highlighted the Texas Highway Patrol's efforts to get dangerous commercial vehicles off the roads.

Since the first of the year, Commercial Vehicle Enforcement personnel and specially-trained Highway Patrol troopers have inspected 331,505 commercial vehicles. As a result of these inspections, DPS removed 66,189 unsafe commercial vehicles and 12,301 unsafe commercial vehicle drivers from Texas roads for a variety of safety violations.

"Commercial vehicles are responsible for approximately 15 percent of the fatalities in Texas crashes,' said McCraw. "Most commercial vehicle operators obey the law; however, those who choose to drive unsafe commercial vehicles or drive a commercial vehicle unsafely pose a serious threat to the motoring public."

McCraw cited Operation Texas Thunder initiatives, which are DPS surge enforcement operations in a targeted area, as one example of how DPS deals with unsafe truck and bus operators.

After complaints about truck traffic in McMullen County, a recent Operation Texas Thunder effort put 64 percent of the vehicles inspected during that operation out of service.

Another recent Texas Thunder operation in the Corpus Christi area resulted in almost 400 citations and 206 vehicles placed out of service.

"The outstanding work by our troopers and inspectors has undoubtedly prevented accidents and saved lives," said Public Safety Chairman Allan Polunsky. "Our enforcement efforts send a message to unsafe drivers and companies inclined to violate the law and place innocent people in danger."

## Farmers, ranchers benefit from Section 179 tax deduction

Farmers and ranchers purchased or financed have until Dec. 31, 2011, to utilize a \$500,000 depreciation allowance under the Section 179 tax deduction.

For 2011, farmers and ranchers can expense new and used farm equipment purchases up to \$500,000 if the equipment is purchased and utilized this year. In 2012, the Section 179 tax deduction depreciation limit will decrease to \$125,000.

The Section 179 tax deduction also allows further depreciation on new farm equipment. As explained by Beef Magazine, "Say you've \$650,000 in equipment, either new or used but new to you, this year. Under the Section 179 provision, you can deduct \$500,000 in 2011. If any of that equipment was new, you can deduct the additional \$150,000 under the bonus depreciation provision. Assuming a 35 percent tax rate, that gives you a \$227,500 write-off on your 2011 taxes, and a \$422,500 net cost in the equipment."



## ORDER RESTRICTING **OUTDOOR BURNING**

The Commissioners' Court finds that circumstances present in all or part of the unincorporated area of the county create a public safety hazard that would be exacerbated by outdoor burning; and NOW, THEREFORE, IT IS HEREBY ORDERED by the Commissioners' Court of Crockett County, Texas, that outdoor burning is restricted in Crockett County for 30 days from the date of adoption of this Order, unless the restrictions are terminated earlier based on a determination made by the Texas Forest Service or this Court. This Order is adopted pursuant to Local Government Code 352.081, and other applicable statues. This Order does NOT prohibit outdoor burning activities related to public health and safety that are authorized by the Texas Natural Resources Commission for: (1) firefighter training; (2) public utility, natural gas pipeline or mining operations; (3) planting or harvesting or agricultural crops; or (4) burns that are conducted by an approved Prescribed Burning Association, Natural Resource Conservation Service, the and/ or Texas A&M Agricultural Experiment Station, or prescribed burn manager certified under Section 153.048, Natural Resources Code, and meet the standards of Section 153.047, Natural Resources Code.

All burns shall be reported to the Crockett County Sheriff's Office (325) 392-2661 and the Fire Chief (325) 392-2626 prior to commencing, together with the name of the landowner, location involved and expert to be on hand. This Order does NOT prohibit outdoor cooking in a properly contained area which is attended at all times. In accordance with the Local Government Code 352.081 (h), a violation of this Order is a Class C misdemeanor, punishable by a fine not to exceed


