Federal judges order May 29 primary elections

As voters headed to the polls in 10 states yesterday, Texas' moment in the national spotlight has been put on hold until May 29.

An order last week by a three-judge panel of the U.S. District Court, Western District of Texas in San Antonio, set May 29 as the date of the 2012 general primary election and July 31 for the primary runoff election.

Despite continuing questions and objections over redrawn state House and U.S. congressional districts, the order written by Judge Orlando Garcia and dated March 1 includes a list of primary-related deadline dates for federal, state, county and local offices.

Early Voting - May 14-25 at the courthouse annex.

Primary Election Day - May 29, Precinct 1 voting at the Crockett County Courthouse; Precinct 2 voting at the Senior Center; Precinct 3 voting at the Civic Center and Precinct 4 voting at the Ozona Chamber of Commerce.



Pain at the pump: gas prices rising due to crude oil costs

As spring approaches, the tem- to rise - accordperature is not the only thing on the rise. So is the price Americans are paying at the pump.

According to the Department of Energy, gasoline prices in Texas averaged \$3.56 per gallon for the week of February 20th and have risen approximately 30 cents over the past month. Gas prices are even higher in other states, such as California where the average cost of a gallon of gasoline has already topped \$4.

Gas prices are high because the cost of crude oil continues


A Victory for Texas Landowners

ebruary 24, 2012, was an important day for Texas landowners, and for all Texans who care about property rights. On that day, the Supreme Court of Texas issued its opinion in a case called Edwards Aquifer Authority and the State of Texas v. Burrell Day and Joel McDaniel. The court spoke definitively to an issue of enormous importance to all landowners: their right to use the waters under their properties.

As a fourth-generation West Texas rancher myself, I know full well how important that water can be, and what it would feel like if a government agency told you that you couldn't use the water under your own land.

But too often, that's just what happens. Conservation goals that could be accomplished with open communication and negotiation between agricultural producers and Texas' water districts are pursued by administrative edict instead.

a "use it or lose it" approach to ground water ownership based on regulations that say, in effect, that landowners can be deprived of nearly all use of their groundwater simply because they hadn't used it before.

That's why I was pleased to file an amicus brief in the case, and even more pleased to learn that the court had supported the landowners involved, concluding "a landowner cannot be deprived of all beneficial use of the groundwater below his property merely because he did not use it during an historical period." now the Supreme Court

Bureaucrats In Training

Some Washington DC grown-ups making mischief have proposed changes to the Fair Labor Standards Act what would forbid youths under the age of 16 from operating tractors on operations other than their own family farms.

Are these people nuts? That's a rhetorical question; of course they are, they're government bureaucrats. Their job is to stifle ambition, creativity and humanity. Next thing you know they'll say kids under the age of 21 can't ride horses without helmets, knee pads, shin guards, a rollover bar, seat belts and training wheels.

The proposed changes are in response to a new study that says agriculture is the most dangerous profession. But that's just because the same government bureaucrats have put most of the loggers and fishermen out of business with their endless regulations. We're told that the feds are also considering making rules that would forbid kids from working when it gets too hot. My, my, get little Hortense and Farnsworth out of the sun, hand them their sippy cup, blanky, video game and some junk food. And mothers, don't forget to disinfect with one of those disinfectant wipes you carry in your purse. The kids will be safe that way. And you'll still be handing them their allowance when they come back to live with you at age 26 because all the jobs have been taken by foreign kids who weren't nurse-maided and mollycoddled.



When I was the age they are talking about I got a job so that one day I could buy my own pickup. And when I got that pickup I knew how to drive because old Mr. Moore let me drive his equally old Fordson tractor to pull the spray rig. Believe me, the only safety device that tractor had was a rear view mirror with Mr. Moore in it, checking on my driving. Occasionally he even let me drive it when

he wasn't around, but he later studied my tire tracks to see if I deviated from the straight and narrow. If these proposed new rules had been in effect then I wouldn't have been near the driver I was when I got to drive the family car and, who knows, I might have hit another car head on as we both were traveling at 65 miles an hour instead of hitting the occasional slow-moving lemon tree while going three miles per hour on the tractor.

I learned important things while driving my first tractor, such as, watch your gauges, know your implements, keep air in your tires, keep your hitches low, don't run out of fuel. look behind you as well as in front of you, don't exhaust in a closed building, and don't be in a hurry to take chances.

These all turned out to be important lessons for life as well as driving a tractor.

We figure things out better and faster when we're kids, just look at six year olds with their cell phones. I was a workhorse at an early age and sure I got hurt. I was riding a bike to my work all over town, and of course I fell down once in awhile, but I got right back on and explored the world. At least that part accessible to a kid on a Schwinn bike that I paid for myself by doing jobs the feds wouldn't let me do now.

Years ago a tractor company issued their ten commandments for tractor safety. One of them was, "Keep your kids off and away from your tractor." It's the worst advice I ever heard. Kids ought to be required to be around tractors. Maybe then they'd be better drivers when we hand them the keys at age 16. Bureaucrats worry that kids are "at risk." I have news for them, kids are born at risk. If you don't want them to be in danger don't have any.

There's a fine line between being careful and being overprotective, and we've crossed that line. Most urban American kids today don't work outside in the sun much, that's for farm kids, foreigners and migrant workers. Instead they sit on their duffs spending hours Facebooking, Tweeting, and producing nothing except text messages and high video game scores. They're in training to become government bureaucrats.

1995, with the late Senator Teel Bivins, I wrote and passed the Texas Private Real Property Rights Preservation Act. a law that has been called "a basic charter for the protection of private real property rights in Texas.'

The act specifically defined real property as including groundwater rights rights that shouldn't be taken away without just compensation.

When government regulations limit your ability to use your land as productively as you can, they've cut its value. And when they devalue your land, it's called a "taking." Article I of the Texas Constitution says it clearly:

"No person's property shall be taken, damaged, or destroyed for or applied to public use without adequate compensation being made."

It's a bedrock principle of our state.

It was the issue before the Supreme Court in the Day case: "Whether land ownership includes an interest in groundwater in place that cannot be taken for public use without adequate compensation" as guaranteed by the Constitution?

The Court looked at how the Edwards Aquifer Auhas set it in stone: you have an ownership interest to the water under your land, just as you do oil or gas. And if state or local authorities want to interfere with your constitutionally protected rights, they have to pay you for it.

This opinion was critical to ensuring the stability of land titles and market value of lands and to the continued sustainability of investments made by communities across the state in acquiring groundwater rights from landowners to support the water supply needs of their growing economies.

As Texas' population growth continues its breakneck pace, greater demands inevitably will be placed on our precious water resources. These will have to be managed wisely and well through a shared responsibility. But if we ignore private property rights, we've lost a fundamental part of what makes Texas what it is.

Fortunately, it looks like we're staying on the right path.

Coach puts face on Alzheimer's, announces fund

Darrell K. Royal, head coach of the University of Texas Longhorns football team from 1957-76, appeared in the state Senate Chamber on Feb. 28 to promote efforts to understand and deal with Alzheimer's disease. Royal, 87, suffers from Alzheimer's.

Royal's wife Edith spoke to the Joint Interim Committee on Alzheimer's Disease, an assembly of lawmakers tasked with studying the economic impact of the disease over the next five years and working toward mobilizing assets to combat it. Standing with the Royals were celebrated Texans Lance Armstrong and Matthew McConaughey.

State Health Commissioner Dr. David Lakey estimated 340,000 Texans suffer from the disease and the state's minimally funded Alzheimer's disease program was cut by 50 percent by the Legislature. While most of the estimated \$65 million cost of Alzheimer's treatment in Texas is covered by Medicare, Lakey said, many Alzheimer's sufferers don't receive needed services.

estimated there are 2.7 million Texans providing informal caregiver tasks for Alzheimer's sufferers.

RRC ELECTS NEW CHAIRMAN

The Texas Railroad Commission on Feb. 28 elected current Commissioner Barry Smitherman chairman.

Smitherman, who joined the agency in July 2011, succeeds former Commissioner Elizabeth Ames Jones as chair. Ames Jones resigned from office last month to run for a state Senate seat.

"As Texas energy production is increasing at an unprecedented rate, the Railroad Commission must continue to maintain a fair and predictable regulatory climate in this state," Smitherman said, and expressed eagerness to work with the state Legislature and the Sunset Advisory Commission in the 83rd regular session, scheduled to convene in January.

The Railroad Commission will undergo Sunset review, a process that scrutinizes each state agency and recommends whether an agency should continue or be dissolved.

MOST SCHOOLS ARE ACCREDITED

State law gives the Texas education commissioner authority to impose sanctions against any school district or charter school that receives a lowered accreditation status.

This year, 97 percent of school districts and charter schools earned state accreditation based primarily on academic and financial performance.

In a March 1 Texas Education Agency new release, Education Commissioner Robert Scott said 1,185 out of 1,220 districts and charter schools met the requirements. Crockett County CCSD was one of the districts that earned state accreditation.

PHONY EMAIL TARGETS CITIZENS

Texas Attorney General Greg

Abbott on March 1 warned citizens not to open attachments, click on links or respond to fraudulent email that looks like it came from the U.S. Internal Revenue Service.

"Taxpayers should remember that the IRS does not use

email or text messages to contact taxpayers about issues related to their income tax returns," Abbott said.



Family Health Center of Ozona chosen as business of the month

Family Health Center of Ozona is a Rural Health Clinic, currently operating under the direction of Shannon Clinic in San Angelo, Texas.

The purpose of the Rural Health Clinic is to provide access to primary care in under served rural areas. Rural Health Clinics are required to use a team approach of physicians and mid level practitioners such as nurse practitioners, physician assistants, and certified nurse midwives to provide services. They are also required to provide out-patient primary care services and basic laboratory services.


The clinic currently staffs two providers on a full-time basis; Dr. Marcus Sims, D.O., and Buren "Ike" Whitten, P.A.-C. The clinic employs seven registered nurses; Martha Vickers, Cristina Gutierrez, Linda Coates, Ada Castilleja, Beth Sims, Martha Alvarez and Manual Tobias and three licensed vocational nurses; Nadine Johnson, Kary Johnson and Susan Bilano.

There is one certified med tech, Melory Galindo and seven nursing assistants. Those include Felix Trujillo, Juanita Delarosa,

The clinic offers children's immunizations one afternoon per week, and have flu pneumonia and Tetanus vaccines available to adults on an as-needed basis.

The clinic maintains a fully staffed moderate complexity lab department for any diagnostic testing that our providers choose to do as well as an on-site x-ray department. Although there is a radiologist on-site, the xray department is linked up to Shannon Health Systems and x-rays are read by a radiologist there.

"After 5 p.m., our clinic area closes and our urgent care staff takes over. An RN and nursing assistant are on-site all night long, and either a doctor or PA is on call. We also have a lab and x-ray tech on call. We maintain a close working relationship with our local EMS and Shannon Airmed, so if your particular situation requires more specialized care than we can give then you will be taken to a hospital for further evaluation and care," said Susan Bilano, Vocational Nurse and Director. 





Commissioners visit animal shelters

After touring several facilities, the Crockett County Commissioners discussed what the next step should be in constructing an animal control facility for the county.

Some of the county commissioners toured the facility in Junction, Commissioner Frank Tambunga visited the facility in Bowie and Janet Pullen visited the one in Big Lake. Pullen is working with the county on a local facility due to Ozona Veterinarian Dr. Gary Vannoy retiring.

"This needs to happen pretty quickly," Pullen said, due to Vannoy's last day being March 1. "I'm really concerned. We have to do something temporarily really quick.

All three facilities that were toured had one employee working in them, had cages with access outside for exercise, guarantine areas and ventilation systems for the smell.

The Junction facility was built with both grant money and city funds.

"We can make it as fancy as we want or as inexpensive as we want," Tambunga said.

commissioners The agreed that they need to review the state requirements for a facility and discuss the issue more at their March 12 meeting.

The commissioners did appoint Pullen as the Rabies Control Authority for the county, replacing Vannoy. Rabies Control Authority is not a paid position, but Pullen said she would be attending school later this month to get certified.

"I will accept this as long as I can rely on Dr. Vannoy until I go to school. I will take this very seriously," Pullen said.

The commissioners also

awarded a bid for \$350,630 to Decker Custom Homes for an addition to the court records vault in the courthouse annex. The motion was unanimously approved contingent on reviewing the bid for deductions.

The county originally budgeted \$250,000 for the project.

Decker Custom Homes was the lowest bid submitted. The commissioners talked about work that the county could do on the project and possibly lower the bid price.

"I think we can work together and bring the price down bit," said County Judge Fred Deaton.

"I think we can look for ways to cut this a bit, but not compromise the integrity of the building," added Commissioner Pleas Childress.

The next regular commissioners meeting will be March 12 at the courthouse annex.



"It is early in the season and with several of these athletes participating in more than one sport, practice time for field events is minimal



In the 1,600-meter run, Marissa Held was sixth at 6:33


Held placed third in the 3,200-meter run at 13:42.





Tejano music faced a number of challenges after the superstar's death: the lack of new artists with crossover star power, a ratings decline and hard times for Tejano music radio stations, and the rise of norteño music, among others.

Norteño music, which originates from northern Mexico, has similar roots to Tejano, but Tejano's Texas-born sound incorporates more influences, from

American rock to country to hip-hop, the article stated.

Badillo, who goes by the stage name Marko Mc, said touring, performing and promoting with K1 is very exciting and fun, but also hard. The group just came out with a new album "Resurrection," which is available on iTunes, Android market and CDBaby.com.

"I'm enjoying it very much. We are moving across Texas," he said.

Badillo also said that Tejano music has taken a downturn since the 1990s, but that without it he wouldn't be where he is today.

"It's very home grown. A lot of it is very romantic and very fun," he said. "You have to do a lot with interacting with people and crowds and fans making sure you stay in the public eye.'

Tijerina said landing venues are hard due to competition of bands. He also said band often try to underbid each other for a venue.

"Downfall of the music business is politics," Tijerina said. "West Texas is more Tejano. You have to learn to adapt to different crowds and different styles."

Cervantez said Internet radio is enabling Tejano music to be exposed nation-

wide. "I think it's picking up a whole lot more," he said. "As long as I can still do it, I'm going to keep on doing it."






